In Australia alone, YouTube removed 75 per cent of video ads posted by the pro freedom United Australia party.

One of the great myths peddled by governments and corporate media is that the material being censored is 'misinformation' or 'disinformation' online tittle-tattle from 'conspiracy theorists', the uneducated and the uninformed. Yet many of the world's leading doctors and scientists are among the victims.

Dr Robert Malone, the inventor of mRNA, and Dr Peter McCullough, a leading U.S. cardiologist, are among thousands who have been driven to 'alternative' platforms as the only way to share their fears and warnings about vaccine dangers.

Heartbreaking posts from relatives of people killed or maimed by jabs are also routinely taken down under Big Tech's nebulous 'community guidelines'.

The hounding of dissenting voices has in turn spawned a host of new platforms in recent years, such as Rumble, BitChute, Odysee, $BrandNewTube\ and\ Telegram.$

The UK already has extensive legislation to ensure what is unlawful offline is also unlawful online. What is new is that the overarching protection of free expression under the Human Rights Act 1998 will no longer apply.

overreach that the Online Safety Bill instructs Ofcom to draft codes requiring platforms to address content that is 'legal but harmful'.

Chillingly, the Bill's scope extends to surveillance of private messaging between individuals.

In short, it is a blueprint for totalitarian control of information. All

The Bill defines 'harmful' content as that which presents 'a material risk of the content having, or indirectly having, a significant adverse physical or psychological impact on an adult of ordinary sensibilities'

Is it really the government's responsibility to protect adults of 'ordinary sensibilities' from psychological harm through exposure to the written word?

Defining 'harmful' content is mission impossible and suggests either a gaping error in the Bill or a deliberate design flaw to give the private censorship enforcers carte blanche to remove anything that might offend an adult of 'ordinary

Add to that the threat of heavy penalties against platforms failing to remove such ill-defined content and it is not hard to see that private platforms are all but guaranteed to take an even bigger sledgehammer to what you say.

The war on free thought and democracy is worldwide, with many Western governments using covid as a Trojan horse to entrench censorship through the statute book.

Legislators in Canada and Ireland are in sync with the UK's efforts.

In New Zealand, the police can issue a 'take-down notice' against anything considered 'objectionable'.

In Greece, lawmakers are trying to criminalise journalists for publishing 'false news'

And so on. With few exceptions, the Western world is increasingly resembling a giant banana republic as its claim to liberal democracy grows ever more farcical.

The UK government denies its responsibility for causing vast real-life harm through destructive lockdown policies, while simultaneously pretending to care about online 'harm' by saddling companies with an absurd psychological duty of care over digital interactions between members of the

This rank hypocrisy suggests a psychopathy not exhibited by Western governments in recent history. It must not be allowed to continue.

Fluoride the destroyer

Adding fluoride to water is forced experimentation

FLUORIDE was added to 10% of England's drinking water between 1955-1987. Claimed as being a way of preventing dental decay, fluoridated water became by presentation and function a medicine.

The British Standard(1) which controls the composition of the fluoridating acid – hexafluorosilicic acid – reveals in Annex A that "hexa(hydro)fluorosilicic acid is added to drinking water to increase the resistance of consumers to dental decay". Therefore, it is not water treatment but people treatment.

Another nugget in the annex reveals how much acid is added to each litre of treated water – 6.3 mg - to achieve 1 mg fluoride/litre. So, what's in the other 5.3 mg of the acid?

Page 8 lists antimony, arsenic, cadmium, chromium, lead, mercury and nickel. Page 7 states that 1.5% of the acid is the contaminant, hydrofluoric acid (aka HF - hydrogen fluoride).

Additionally, the scrubbing liquor used to trap hydrogen fluoride and silicon tetrafluoride gases in the chimney of phosphate fertiliser facilities is contaminated with other undesirable elements.(2)

As a contaminated soup of

ingredients, it is justly described as being industrial hazardous waste.

Water treatment practitioners aim to remove undesirables – not add them. It cannot be medically ethical to deliberately add heavy metals, a corrosive acid and a carcinogen to consumers' treated water.

By turning drinking water into a compulsory medicine, water quality standards do not apply (Drinking Water Directive retained as UK law post-Brexit).

For example, the standards state that maximum allowable arsenic is 10 micrograms/litre, but once drinking water becomes a medicine, any amount of arsenic is too much. The ALARP (as low as reasonably practicable) principle should be invoked in respect of arsenic and lead which should be as low as reasonably practicable. Nothing easier to attain: just do not deliberately add them.

I fail to comprehend why the Nuremberg Code was not applied in the UK in 1955 when the first fluoridation experimental 'demonstrations' were initiated by Andover, Watford, Kilmarnock and Anglesey councils, just eight years after the publication of the code, which states that individuals have the right to refuse to be experimented on.

Why did health authorities who decided to add a medicinal substance to drinking water not link forced experimentation on non-consenting humans during World War II and forced

experimentation on non-consenting human subjects between 1955 and now?

They have never admitted that fluoride destroys enzymes and disrupts endocrine function. Nor has there even been an official acknowledgement that swallowed fluoride delays the growth of teeth,(3) meaning that primary teeth are in the mouth for a shorter time and are not exposed to decaycausing factors for as long, before the fluoridated child's first dental examination. Just think of the scandal if it was admitted.

Now we have another scandal on our hands: that of fluoride reducing human intelligence(4). Health ministers seem rattled about this: they are attempting to tie us up in yet more fluoridation legislation.

Serious heart problems and DEATHS among sports players following shots

28-year-old bodybuilder Jake Kazmarek also died 'unexpectedly' four days after taking the covid jab.

New study shows mRNA vaccines DOUBLE chances of heart attack

A NEW study published in the American Heart Association's online medical journal, Circulation, shows that patients who have received their second shot of the Moderna or Pfizer covid 'vaccines' have more than doubled their chances of having a heart attack.

A group led by renowned cardiologist Dr Steven Gundry used the PULS cardiac test - a blood test - to accurately detect risk of heart attack in the coming five years.

The PULS score is based on changes from the norm of multiple protein biomarkers; elevation above the norm increases the score and decreases below the norm the lower the score.

The score has been measured every 3-6 months in Dr Gundry's patient population over eight years. With the advent of mRNA vaccines, dramatic changes in the PULS score became apparent in most patients.

566 patients - an equal mix of men and women aged between 28 and 97 - were seen in a preventative

cardiology clinic and had new PULS tests (blood samples) drawn from 2 to 10 weeks following their second covid vaccination.

The new test results were compared to patients' previous PULS tests performed 3 to 5 months prior to their first covid injection and showed an increase from 11% to 25% of the risk of developing acute coronary syndrome (ACS) within five years.

The changes persist for at least 2.5 months following the second dose of the iab.

The conclusion is that the mRNA vaccinations dramatically increase endothelial inflammation and T-cell infiltration of the cardiac muscle and may account for the increased thrombosis, cardiomyopathy, and other vascular events.

Endothelial cells line the blood vessels and lymphatic system and play a major role in the regulation of blood flow, clotting, and normal function of the immune system. A T-cell is a type of white blood cell that protects the



body from pathogens.

Acute coronary syndrome is caused by decreased blood flow in the coronary arteries, which means part of the heart muscle is unable to function properly, or dies.

Meanwhile, the CDC are admitting

that: "As of November 10, 2021, VAERS has received 1,793 reports of myocarditis or pericarditis among people aged 12–29 years who received covid-19 vaccines. Most cases have been reported after mRNA covid-19 vaccination (Pfizer-BioNTech or Moderna), particularly in male adolescents and young adults after the second dose. Through follow-up, including medical record reviews, CDC and FDA have confirmed 1,049 reports of myocarditis or pericarditis".

In a powerful broadcast on freespeech platform BrandNewTube, The Light columnist Dr Vernon Coleman emphatically announced that, "This is the moment when the jabbing has to stop... this is the death bell for the covid jab".

Not only are the shots clearly ineffective, it has now been proven beyond doubt that they are unsafe and downright harmful. They should be withdrawn immediately, before any more damage is done in the name of 'science' and 'public health'.

Human face of 'no jab no job' in care homes

Many staff resisted mandates, knowing they could be sacked

ONE in ten of the care home workforce held out against the government's 'no jab no job' law, which was enforced on 11 November.

They resisted the course of injections, knowing that they faced the sack.

Fortunately, many joined the Workers of England, the trade union defending workers against the callous covid regime. Leading to the vaccination deadline, I alone represented almost 300 members in their hour of need. We are fighting every case, and expect to win sooner or later. Already we have saved over 300 jobs by using the Equality Act.

The carers coming to us are mostly female and of all ages and ethnicities. When the government picked on this sector for the first occupational vaccine mandate, they thought that these women would take an offer they could

not refuse. But while thousands relented to coercion, a significant minority stood their ground.

Who are they, personally? I observed some common character traits. First, they are highly principled, with too much integrity to take a jab that clearly prevents neither infection nor transmission, or for cowardice masked as virtue.

Not intellectual in the accredited way, they are more awake than the vast majority of society. Their knowledge of covid, the vaccines and the globalist plan is in stark contrast to that of their peers and managers who follow the narrative without question.

Their outlook is not merely common sense, of which they are well endowed, but critical reasoning. They are not easily fooled, and saw the propaganda of fear and control for what it is. As unvaccinated workers, they frequently cover for vaccinated colleagues off sick with covid (or adverse vaccine reactions).

Some took strength from God,

others from a humanistic commitment to freedom and choice.

But most importantly, they came across as the most genuinely caring of people. After working through the covid crisis in care homes last year (caused by the government's evicting older patients from hospital), they continued to care for residents despite knowing that they would be rewarded with dismissal. Often in hearings their wonderful work was acknowledged.

So who are the managers sacking them? Mostly the final 'consultation' meetings were conducted by senior managers or directors, knowing that they would be challenged by an assertive trade union rep versed in the law and ethics.

Many managers were decent, genuinely regretting the situation forced on them by the powers-that-be.

Some were keen to accept the Workers of England exemption certificate, but generally they failed to understand that fundamental rights cannot be overridden by the flick of a pen in Whitehall or the latest diktat by the Care Quality Commission. They conflated guidelines with the



law, thinking that the covid pass is a formality despite having no legal force. After years of spouting politically correct messages of equality and diversity for their own promotion, they showed themselves to be woefully unaware of the Equality Act.

I regret to report that some senior managers appeared to relish their role in dumping employees who they viewed as misinformed or selfish. How the elite declared silent war on all of us

Bilderberg manual sets out plan for total control

These excerpts come from an updated document published 25 years after the original. The *Introduction Programming Manual* was discovered - apparently by accident - in 1986 when an employee of Boeing Aircraft bought a surplus IBM copier for scrap parts at a sale.

- Engaging their emotions, increasing their self-indulgence and their indulgence in emotional and physical activities, by a) unrelenting emotional confrontations and attacks by way of constant barrage of sex, violence, and wars in the media especially the TV and the newspapers, and b) giving them what they desire in excess "junk food for thought" and depriving them of what they really need.
- Rewriting history and law and subjecting the public to the deviant creation, thus being able to shift their thinking from personal needs to highly fabricated outside priorities.
 These preclude their interest in and discovery of the silent weapons of social automation technology.
- The general rule is that there is profit in confusion; the more confusion, the more profit. Therefore, the best approach is to create problems and then offer solutions.
- Diversion Summary Media: Keep the adult public's attention diverted away from the real social issues, and captivated by matters of no real importance
- Schools: Keep the young public ignorant of real mathematics, real economics, real law, and real history.
- Entertainment: Keep the public entertainment below a sixth-grade level.

 Work: Keep the public busy, busy, busy, with no time to think; back on the farm with the other animals".

Does any of this sound familiar? Does it not also resonate strongly with those who 'woke up' during covid and saw there was something very wrong with our world during 2020?

Although when viewed through the lens of 'right minded' people, the content is outrageous, sinister and warns of a crime almost beyond comprehension, to the rulers it seems the logical, perhaps only, course of action. it was necessary to create, secure, and apply new weapons which, as it turned out, were a class of weapon so subtle and sophisticated in their principle of operation and public appearance as to earn for themselves the name "silent weapons".

One persistent theme is the signs the elite are looking for that the population is 'ripe for capitulation'. These include the 'number of public citizens who pay income tax despite an obvious lack of reciprocal or honest service from the government'.

In order to implement this objective,

armed forces, widely viewed as a very positive step in both career and personal development by the general public, but an indication of ignorance and willingness to consent to tyranny by the rulers:

A woman must, however, be conditioned to accept the transition to "reality" when it comes, or sooner. As the transition becomes more difficult to manage, the family unit must be carefully disintegrated, and state-controlled public education and state-operated child-care centres must be become more common and legally enforced so as to begin the detachment of the child from the mother and father at an earlier age".

Junior: The emotional pressure for self-preservation during the time of war and the self-serving attitude of the common herd that have an option to avoid the battlefield - if junior can be persuaded to go - is all of the pressure finally necessary to propel Johnny off to war. Who checks the fact checkers, and who pays them actually?

They cannot be impartial or unbiased

HOW much fact could a fact checker check if a fact checker could check facts?

Big tech and highly philanthropic businesses have put their hands in their deep pockets in an effort to combat misinformation, disinformation and conspiracy theory relating to the pandemic. Global conglomerates such as Google and Facebook have donated millions of pounds to specialist covid-19 myth busting units.

Media outlets across the world are outsourcing their information scrutiny by using 'certified' fact checking entities.

There are numerous sites available, such as Snopes, Politifact and ProPublica. In the UK, we have the forerunning London-based charity Full Fact. They were set up in 2009 to fight 'bad information' by using a 'team of independent fact checkers and campaigners who find, expose and counter the harm it does'.

In America, there is the popular 'non-partisan', non-profit Factcheck. org who have the mission to 'reduce the level of deception and confusion'.

These online platforms have large sections of their webpages aimed at the pandemic – many having their own dedicated covid misinformation pages.

They scour social media, newspapers, websites and broadcasting to find anything that goes against the mainstream view of the pandemic. They then seek to counter and discredit these opinions and statistics in an effort to 'protect people from harmful content which may discourage them from being vaccinated'.

Examples of Factcheck.org headlines include: 'Japan Continues to Use Vaccines, Not Ivermectin, to Fight Covid-19' (November 4, 2021), 'Why It's Easy to Misinterpret Numbers of Deaths Among the Vaccinated (November 1, 2021), 'Tucker Carlson Misrepresents Vaccine Safety Reporting Data' (October 26, 2021).

Full Fact headlines follow in a similar vein: 'Guardian wrong to suggest unvaccinated deaths are the majority currently' (November 5, 2021), 'Vaccine rap battle full of

misinformation' (October 20, 2021), 'Trafalgar Square "Freedom Rally" speech littered with false claims' (August 19, 2021).

Both Full Fact and Factcheck.org claim to have a remit of independence and neutrality. They state that the people they hire to check facts are unbiased and that any funding they receive will not influence their editorial control in any way.

However, when you look into the funding streams of the fact checkers it becomes clear that companies with an ulterior motive are infiltrating them.

Factcheck.org's covid-19 misinformation page, with titles such as 'How do people who have not been vaccinated against covid-19 pose a risk to people who have been vaccinated?' are sponsored by the Robert Wood Johnson Foundation. Does the name 'Johnson' ring any bells? How about 'Johnson and Johnson'? The 80 billion dollar a year medical and pharmaceutical company are makers of the new one-shot covid vaccine, and issuer of millions of already administered covid shots.

In the 12 months leading up to June 2021, Factcheck.org were also funded by Google (\$104,000), Facebook (\$389,925) and the Annenberg Foundation (\$406,159).

The Annenberg Foundation, built upon the wealth of Walter Annenberg's Triangle Media, claim to be a philanthropic foundation dedicated to 'addressing the critical issues of our time'. Perhaps one reason they can claim to be so benevolent is their sizeable endowment portfolio, worth \$1.33 billion according to their 2019 financial overview.

Part of this portfolio includes corporate stocks in British-Swedish multinational pharmaceutical and biotechnology company AstraZeneca PLC (\$794,270), German multinational pharmaceutical Bayer AG (\$129,623) and Hong Kong based Sino Biopharmaceutical (\$93,727). They also have investment bonds in Forest Laboratories (now Allergan plc - a global pharmaceutical company), as well as many other medical health and insurance companies.

The Annenberg Foundation are themselves funded by the Bill and Melinda Gates Foundation – who, according to Bill Gates's own blog (gatesnotes.com), have a total investment of \$1.75 billion in covid-19-related industries such as the Pfizer/BioNTech Covid-19 vaccines and mRNA technologies.

Full Fact are also the beneficiaries of 'philanthropy'. In 2020, they were given £235,000 from Google.

Nearly half of this (£115,000) was purely for 'covid-19 fact checking' according to their website. They were also gifted £583,000 from Facebook, of which £325,000 was to support a 'framework for collaboration during misinformation crises'.

Conglomerates such as Google

and Facebook own, between them, the world's largest internet search engine and social media outlets such as Instagram, Messenger, WhatsApp and YouTube – so what is their motivation in preserving the 'truth' of the pandemic?

You have to dig a little deeper to understand their philanthropy and anxiety towards covid misinformation. Both Google and Facebook have investment arms – and this is where it gets a little complicated. Google's parent company, Alphabet, runs an investment arm called Gradient Ventures (Formerly Google Ventures), who are invested in immunotherapy and vaccine company Vaccitech. This particular Oxford start-up just happens to own the biotech platform behind the AstraZeneca covid-19 vaccine.

Facebook's investment in the pandemic and subsequent interests in squashing any objection could relate to one of their biggest investors. Aside from Mr Zuckerberg himself, Facebook's next biggest investor is Vanguard. They own nearly 68 million shares of Facebook (now Meta) with a market value of more than \$22 billion as of April 30, 2021 according to Investopedia.

Vanguard, an investment advisory multinational, have massive stock holdings in covid-19 vaccine makers Pfizer, Johnson & Johnson, Moderna and Novavax, as well as Merck, the makers of the new 'wonderdrug' - Molnupiravir.

The answer to the riddle is not

always clear. How do you decide on the virtue of the fact checkers? Are they calling 'hoax' on anything anti-pandemic narrative for the good of the people, or for the good of their own investors' reputations? They may indeed be unbiased, free from the editorial eavesdropping of Big Tech or Big Pharma - but imagine if a restaurant critic was paid by the restaurant to leave a review. Would you trust it?

To find the motivation behind the vehement defence of the pandemic and vaccines there may be two paths to follow:

Take the left path and you follow the mainstream narrative – you believe in the pandemic and vaccines.

You believe that companies such as Google and Facebook, as well as charities like the Annenberg Foundation and the Bill and Melinda Gates Foundation are financially and morally invested in the greater good the health and wellbeing of the world. All is good.

Take the right path, and you believe that the world is influenced by shady, vast entities such as Vanguard and Blackrock, who are capable of manipulating everything you hear, see and do. Their trillions upon trillions of dark money are used to control media and politics in a merry-go-round of greed and deception. All is not well.

The choice is yours, but next time you see or hear someone claim 'fact check', ask yourself – who paid for it?

Bowing to the Covidian Church

Big Pharma and the medical establishment are the new all-powerful priesthood

WE see unprecedented use of 'unprecedented' today.

Yes, it applies to putting entire nations under house arrest.

Yes, it applies to the nearuniversal wearing of masks (more accurately muzzles).

Yes, it applies to needing a passport to be normal. But perhaps the entire phenomenon we are experiencing is not unprecedented.

Let us look back in time to AD 380, when Rome became the superspreader of Christianity by making it their empire's official religion. Within 100 years the Roman Empire collapsed but despite the death of its host, Christianity survived and for more than 1,000 years, the head of the Catholic Church was the most powerful figure in Europe.

You may ask how the Church came to have and maintain such power. The answer is simple: faith and fear.

They had agents throughout the land, with a church in every town. The priest class, from archbishops down to parish priests, were the most highly-educated and respected sector of society. The priesthood was a sought-after secure profession, and people had faith in the truth of what the priest told them. It was often sound advice they could find nowhere else.

The Church had a near monopoly on education, with part of the core curriculum being God and creation, Jesus and miracles, sin and salvation, as well as good deeds, forgiveness,

and useful guidance. Most priests were good people, people of faith, and following their advice was the passport to Heaven.

Then there was the fear. The Devil can manifest anywhere in the world, tempting people to stray from the path of righteousness.

The Devil can be lurking unseen within any one of us, prompting urges that God wants us to suppress. We must be on our guard from those he may have corrupted. We must follow the priest's advice to avoid the fearsome prospect of Hell.

Believers knew that if they behaved badly during their 50 or so years of this existence, they would suffer a miserable and horrific afterlife in Hell, for eternity. What a terrifying prospect! This was the picture the Church taught and most people absolutely believed what they were told by the priests.

Bastards, born out of wedlock, were a product of sin and not welcome in society. Those who missed church on Sunday were avoided. Just speaking with these dangerous people could infect one with sinful thoughts.

Not all the 'common' people bought into the Church's teachings or went to priests for advice on things spiritual or material. Some chose a more direct spiritual interface with the living world. Many were women who also practised unlicensed healing, whether through herbs or 'occult' practices invoking natural energies of the earth and human body.

Tens of thousands of these women were burned, drowned or tortured to death as witches, for their deviant beliefs

Of course, being a God-fearing churchgoer did not stop people from being sinners, but at least you were trying and could confess your sins to the priest, do some penance, pay and be forgiven. Without that escape clause, the ungodly sinner was doomed to Hell.

Those who wrote or spoke publicly in contradiction of the church's teachings were guilty of heresy and their books burned and banned, as well as the heretic themselves at times.

To speak disrespectfully of things holy was considered blasphemy, punishable as a serious crime, occasionally warranting death. This unfortunate situation still prevails in many Islamic nations, with a religion 600 years younger than Christianity.

The Catholic Church does not

have the power it once held over the minds of those in Western cultures. The credibility of the Church has not been helped in recent years by the paedophile scandals surrounding its priesthood.

Today we are witnessing a new 'religion' taking hold and while this one has nothing to do with spirituality, it has spread faster than any before. It has gripped the minds of billions across the world and is also powered by faith and fear, with an enemy as invisible as Hell and the Devil himself. Curiously, it has had its greatest success to date in the West, perhaps filling the fear vacuum that has been created by the recession of the Church in daily life.

Today's priesthood is embodied in the medical industry, staffed by highly-trained professionals with secure careers, for whom the public has high regard. Just as we once needed priests to act as intermediaries to God, we now need trained doctors as intermediaries to our bodies and guardians of our health.

Many people are sadly out of touch with their mortal frame and have unquestioning faith in doctors knowing best – the high priests of health

The medical establishment does not like competition for its services, doing whatever it can to ban or denigrate healing practices other than its own, whether herbs or naturopathy, prayer or acupuncture, homeopathy or reiki. Theirs is the only true path to health, and all other routes are portrayed as fraught with danger.

We do not know how well organised Christians were before the Romans assimilated them – before Christian belief was standardised and regulated at the Council of Nicaea.

We do know that before the healing profession was dominated by the World Health Organisation, The Centre for Disease Control, and the Global Alliance for Vaccines and Immunisation, there was full medical freedom of choice for the individual.

In 1880 there were more homeopaths in the USA than allopathic doctors, while mechanics earned more than either of them. It is no accident that the WHO, CDC, and GAVI are largely funded by the pharmaceutical industry, and headed by their chosen men and women. They have become today's equivalent of the Vatican during its 1,000 years of dominance. They claim a monopoly on truth and woe betide those who question or counter it.

Notable physicians, respected virologists, vaccine designers, even a Nobel Prize winner have countered the official narrative and lost their positions, been discredited, denounced and excommunicated; they are denied any further involvement in the hospitals, clinics and practices that are spread across the land as thickly as were early chapels, churches and cathedrals.

Popular speakers, performers and entertainers have had their bookings cancelled for refusing to be vaccinated, or for questioning the vaccine passports. We could view these outspoken characters as being 'excovidicated' from the medical and media establishments.

It takes a lot of faith to accept being injected with a partially-tested, new-concept mRNA injection. Taking the second jab could be seen as one's baptism into the Covidian Church. Like it or not, it is an affirmation and commitment, and unlike the splashing of holy water and utterance of sacred words, it may be difficult to decouple our immune system from the one implanted by Big Pharma.

This new system will need an upgrade every six months to keep your internal software up to date. Where have we heard this before? What will system crashes look like?

Just as going to church does

not prevent God-fearing folk from sinning, taking the injection does not prevent covid-fearing folk from getting the disease or from spreading it. But, we are told, if the case is bad enough to need hospitalisation, the sufferer will be less likely to die. Considering that the covid survival rate, before vaccination began, was over 99.9%, how much the vaccine increases it is, perhaps, a moot point.

In today's somewhat free society, it is okay to declare that the Queen is a shape-shifting lizard, okay to accuse the Bush family and their associates of taking down the three towers (the twins and WTC 7); okay to accuse Hillary Clinton of running a paedophile ring and drinking an extract of tortured children.

It is decidedly not okay to counter the narrative of 'Big Pharma' – to suggest that covid-19 is not an existential threat; to recommend tested known treatments for it; to disclose that natural immunity is widespread and better than jabs; or to publicise the hundreds of thousands of documented serious adverse reactions to the injection. Those who question or counter the narrative on any level are guilty of (forgive me) 'blaspharmy.' Thou shalt not speak against the trinity of the CDC, WHO and GAVI.

Instead of burning books today, they 'burn' the online platforms of those who question or challenge the narrative of Big Pharma. YouTube channels are shut down without warning, with all their content removed from view – troves of information that was approved and online for years. Twitter accounts are terminated.

Much like the bad old Soviets used to remove people from official photos when they fell out of favour, today Wikipedia entries of repeat blaspharmers can be erased, with Google searches relegating links to 20th pages.

This all may be more 'climate-friendly' than burning books, but it does immense harm to the free flow of ideas, the emergence of truth, and the connected feedback loops that power positive evolution.

The parallel has been made with the papal precedent. There is much of positive value to gain from Church teachings but they are not and never were the only source of spiritual and moral guidance. Neither is the medical establishment the only viable source of sound and effective advice on healing and health. Its biggest player, Big Pharma, does exceedingly well out of poor health.

Mind revolution not a natural evolution

AS a senior transactional analysis psychotherapist, I believe we are living through a 'mind revolution' in society; that is, our traditional ways of thinking are being replaced at speed by ideas that often appear extreme, dangerous and ill-thought-out.

Last year I wrote a short e-book. I wanted to shed some light on what is going on. Using corporate and social media, we are being psychologically manipulated through a mixture of lies,

guilt, fear, anxiety and righteousness; what once united us now divides us as we cannot find common ground.

In the book, I debunk the myth behind 'empathy' as a wise, sentimental good, and show it to be little more than narcissistic, 'projective self-involvement'.

I explain how brain-washing works, especially on intelligent, naive-yet-well-meaning-people. I also refer to a little understood phenomenon called 'reaction formation', where guilty people project their bad conscience onto innocent people, thereby casting a veil of moral goodness over themselves.

This psychological compensation is what Shakespeare captured so well in Hamlet: "The lady doth protest too much, methinks".

The following is an excerpt from the introduction to my book:

"There are few things more painful than a mind that has lost the plot.

Sitting down in 2020 as the UK is in lockdown, the thought 'have we all gone mad?' enters my mind. Yet, if this is a collective madness, then the sane person is like the one-eyed man in the land of the blind. Or is he the pariah, the one who doesn't really belong, the one whose existence threatens all the others?

If madness is defined as sticking out in a large crowd then I guess the sane person is called 'mad'. However, if sanity is about being able to hold one's own thoughts, feelings and actions together under an umbrella of consistency and reason then no, the person is not mad".

The book includes a section entitled 'About You: A Brief Guide to Transactional Analysis' that serves to give you, the reader, a primer on transactional analysis. It is a system by which to examine your individual psychological make-up and personality. It aims to help you make better sense of yourself, to find your own voice. In so doing, it may help

you understand others better too.

In part three, I reflect on what is going on around us in this world we all inhabit, how the way we think about ourselves and society is changing rapidly; how the concept of the 'individual' and that of 'individual freedom' is on the endangered species list

I call this 'The Mind Revolution'. We are so driven by our desperate need to belong, to give up our history, to ignore the wisdom of our elders, to 'stay safe', 'stay alert', to conform to diktats that so many of us remain sceptical of, while others scream at us to put on our face masks or take the knee. This once-proud society is at risk of breaking up and returning to medieval 'witch hunts' and mob violence. It is fast becoming deranged.

I have spent several years investigating this phenomenon and I do not believe we have arrived at this point organically; this is not a natural evolution of our society. Instead, it has been a socially

and psychologically-engineered phenomenon, an ideologically-driven push to introduce a new metaphysics, to replace the Christian faith that has been dismantled in the secular West.

It is one thing to remove a religion; it is quite another to replace it with something else. Yet this is what is being done, under the cover of a health emergency and by stealth through our naivete.

Many of us are asleep as a revolutionary fervour seeks to destroy the successful West from within. We are passively allowing an imposed, oppressive ideology to dictate our future. Christianity was far from perfect, yet its values kept the West together for 2,000 years. We need to rediscover our confidence if we are to stand up against such tyranny and liberticide.

This cycle of dishonesty has been turning now for over 200 years in America (and longer in Britain), and the resulting chaotic snowball of deceit has probably only been marginally slowed by President Trump's victory in November of 2016. Bill Gates and the uncertain prospects for food security

AS we approach a winter of discontent and food systems go from bad to worse, there is trouble in paradise.

At the root of these problems, government responses to covid have contributed to a six-fold increase in famine-like conditions as global supply chains collapse and field trials for gene-edited crops and farm animals restart in the UK.

Against the backdrop of this perfect storm, the UN's World Food System Summit convened last month, with member states joining the private sector, civil society groups and researchers to bring about "tangible, positive changes" to the world's food systems, and as the story goes, "drive recovery from covid-19"

But even if we could solve our problems using the same logic that created them, there are deeper institutional problems undermining the integrity of the Summit. Specifically, its corporate capture by one man, whose vision of the future of food security places the interests of civil society and farming communities in a different universe to the corporations he is beholden to.

A household name on the world stage of disaster capitalism, there is more to Bill Gates than doomsayer-general terrorising the world's population into a permanent state of suspended animation, and it typically involves the future of food security.

In less than a decade, Gates has become America's largest private farmland owner, acquiring more than 269,000 acres of prime farmland in the US, including the 100 Circles Farm where fast food giant McDonalds' potatoes are grown. Gates effectively owns McDonalds' fries, his commitment to public health aside.

On the one hand Mr Gates is the most influential player in global public health, following in the footsteps of his spiritual leader, John D. Rockefeller. On the other, he backs a confederacy of fast food brands that are killing more people than tobacco, and driving those who survive towards the very pharmaceuticals which he also wheels and deals to half of all Americans suffering from chronic health disorders.

When it comes to fast food, Gates owns 7.8% of Warren Buffet's investment vehicle, Berkshire Hathaway, which controls 39% of the largest Subway fast food

franchise and 9.3% of The Coca-Cola Company. That's in addition to the Gates Foundation's 16.8% stake in the largest Coca-Cola bottling franchise in the world, named for the fourth consecutive year as the world's biggest plastic polluter.

But Gates' environmental effrontery is only part of the problem. He also backs multiple ventures blurring the lines between food and tech, and if, indeed, Gates has his way, the food of the future will little resemble what grows out of the ground.

That's because his centre of gravity is GMOs. He owns 500,000 Monsanto shares worth a modest \$23 billion, making him, by implication, the sworn enemy of everything natural, organic and sustainable. There's the Gates-funded Impossible Burger, made from genetically engineered soy and yeast, with its manufacturer, Impossible Foods, owning 25 patents on artificially replicated cheese, beef and chicken.

Another Gates-backed start-up is Ginkgo Bioworks. According to their mission statement, Gingko will produce custom organisms using cell programming technology to genetically engineer flavours and create ingredients for ultra-processed foods. Their plan is to license more than 20,000 engineered cell programmes to the food industry.

If, indeed, the agrifoodtech ventures Gates is bringing to market continue to flourish, traditional diets will soon be replaced by lab-cultivated meat and other Frankenstein foods.

Like Rockefeller before him, Gates is transforming our relationship with food, only he's weaving climate change and the mantra of 'following the science' into his worldview.

This typically involves genetics, agrochemicals, and a shedload of automation, with his foundations industry partners operating Herculean monopolies over services and supply chains. What is of little importance to Gates are the social and environmental costs of his ventures. Or at least, he promotes one set of values, and invests in another.

For example, Gates accepts that agriculture accounts for 24% of 'greenhouse gas' emissions, but thanks to the 100 Circles transaction, Gates

is now the largest farming real estate holder in the U.S. This despite, as we are told by the likes of Gates, that agriculture makes up as much as 70% of fresh water usage globally, leads to greater soil erosion, deforestation, and, you guessed it, climate change.

Gates flouts the very values of low carbon and sustainability which he himself helped to popularise. From the carbon footprint of his farmland holding, to \$1.4 billion invested in the world's biggest oil companies, Gates backs all the largest corporate perpetrators on the list of the European Commission's top five causes of 'climate change'.

When it comes to unsustainable scientific interventions, however, nothing quite hits the mark like synthetic fertilisers, which Gates describes as the "magical innovation that's responsible for saving millions of lives from hunger and lifting millions more out of poverty".

What he fails to divulge is that synthetic fertilisers pollute the world's water sources, destroy the world's largest carbon sink - the soil - exhaust the soil's natural nitrogen deposits, deplete the soil's microbial biomass, and, according to the Intergovernmental Panel on Climate Change, are one of the key drivers of 'climate change'.

Taking no notice of these facts, synthetic fertilisers are central to Gates's master plan for the future of food security. He's under the spell of Europe's biggest fertiliser producer, Yara, which is not only causing climate catastrophe, but also had their top executives sent to prison in one of Norway's biggest corruption scandals. There's also the small matter of his 14.4% ownership of Canadian National Railways - one of the most important fertiliser supply chain operations in North America.

On the one hand Mr Gates uses his influence to transform public policy towards high input farming interventions; on the other, he directly profits from their deployment. What is of little importance is whether these interventions are fit for purpose.

Marking a broader takeover of the farming commons, fertilisers were once solely derived from natural and organic farming practices, including compost, animal manure and crop rotation – which have been shown to be more robust, sustainable, and profitable to farmers.

That was until the arrival of the



Rockefeller Foundations' 'Green Revolution' in the 1950's, which galvanised an industry-wide overhaul to chemical interventions, large scale, technology-driven monoculture and hybridised seeds. Modernisation that heralded the arrival of mega corporations into farming and the reliance of small-scale farmers on their products and services.

But that's only half the story.

A generation before the Green
Revolution, John D. Rockefeller (the
first) belonged to a group of prominent
industrialists at the turn of the century,
including the Carnegie and Harriman
families, who were committed to
facing off a threat presented to
America's Anglo-Saxon ruling elites
by inferior genes, such as they were
considered.

That culminated in the adoption of eugenics programmes across the U.S., which set out to eradicate the poor, feeble-minded and ethnic minorities from the gene pool through the forced sterilisation of 80,000 so-called defectives. That was until the Nazis' race purification programmes were revealed to be imported from America's flourishing eugenics movement, which, to say the least, proved to be a public relations disaster for eugenics.

The solution was to distance the pseudo-science from the holocaust by transmuting eugenics into the morally acceptable fields of 'birth control' and 'genetics' (with the reconstruction generously funded by the Rockefeller and Ford foundations), and with many of the original eugenics institutions

morphing into today's medical genetics organisations.

Fast forward a generation and many of the principles of eugenics were put to work in the Green Revolution of the 1950s when John D. Rockefeller Jr brought the gene revolution and its hybridised seeds to India. He was signalling man's conquest over nature and the principle that only the strong amongst plants and animals should thrive and survive.

Half a century later, Gates would come to inherit this legacy through his foundation's programmes in Africa. As is often noted, Gates's father was the head of Planned Parenthood, one of the birth control descendants of the original eugenics movement, founded by prominent American eugenicist, Margaret Sanger.

This explains why the Gates Foundation is today active across the barometers essential for life itself - birth, health and food, and why no other organisation is so deeply embedded in medical genetics, from GM seeds and farm animals to the mRNA gene-based vaccine to the myriad birth control organisations funded by Mr. Gates, these principles are central to his philosophical worldview, which like Rockefeller before him, involves the aberration of man meddling with natural laws to rein in a subordinate nature. If, indeed, Gates has a maxim, then it is science over nature, man above God.

Real concerns are dismissed by labels

The term 'conspiracy theory' is a getout-of-jail card for corporate media and government

WHENEVER the corporate media and government agree something is true, there can now be no possibility that their assertion is false. Any insistence to the contrary is automatically defined as a conspiracy theory.

Perhaps the best definition of conspiracy theory I have ever heard comes courtesy of Mark Crispin Miller, who describes it as something that "if true, you couldn't handle it".

The reason you cannot handle it is because it is too dispiriting for most of us to integrate. If true, it means that the government and the corporate press have been colluding together against the public interest on a number of issues for a very long time. This represents a heavy psychological burden.

As such, the spell words of conspiracy theory provide us with convenient encouragement to remain comfortably tucked into the version of reality constructed for us by the official narrative.

As with the spell words of antivaxxer and extremist, we are provided with instructions to isolate ourselves from anyone labelled as a conspiracy theorist and anything labelled as a conspiracy theory.

Consequently, the very concept of 'conspiracy theory' provides the government and the financial interests that control the corporate media free license to weave reality into any desired shape.

Prior to the promulgation of this spell, the proper description for what is now called 'conspiracy theory' would have been 'investigative journalism'.

Investigative journalism seeks to uncover hidden truths and official corruption in order to expose the powerful and inform the public.

The spell power of conspiracy theory ensures that investigative journalism into certain forbidden areas by **RAELLE KAIA**

will never be conducted by corporate or state actors. It will thus carry the stigma of illegitimacy or fringe 'extremism'. This is an incredible boon to the free-handed exercise of official power in ways the public would otherwise object to.

The first word, 'conspiracy', evokes a mood of paranoia. It summons the image of someone suffering from paranoid schizophrenia, erratic and isolated, prone to delusions and unhealthy behaviour.

Imagine instead that the word 'corruption' were substituted for conspiracy. The paranoia dissolves away. We are all aware that corruption

Imagine instead that the word 'theory' was replaced by the word 'investigation'. The connotation shifts immediately. A theory is something a cranky recluse concocts from his armchair at home, letting the imagination run wild. An investigation is a sober analysis of facts and evidence that seeks to uncover a hidden truth.

Now put them together, 'conspiracy theory' becomes 'corruption investigation'.

Imagine your public officials or media personalities deriding something as a corruption investigation. "There are wild and rampant corruption investigations going around. We need to put a stop to these reckless and dangerous corruption investigations".

is real and very present, and that the rich and powerful engage in it regularly. That is how most of them got there.

The second word, 'theory', carries the implicit assumption that the accusation is speculative and has not been proven. Since a conspiracy theory is defined by governmental and mass media agreement as untrue, a circular, self-reifying loop is created.

As long as both the government and the corporate press both agree that something is not true, it is automatically confined to the realm of speculation as a matter of definition.

No amount of evidence or reasoning can ever shift the accusation from the realm of theory to the realm of fact, regardless of how strong the evidence and reasoning may be. It is defined as non-factual by the spell word itself.

As with the previously mentioned spell words, the ability to apply the label 'conspiracy theory' is wielded by the media figures and public officials who hold societal power.

Or imagine replacing the predictable denouncements of someone as a conspiracy theorist with the term corruption investigator: "Don't talk to me about the JFK assassination or 9/11. You're just a corruption investigator". In the absence of the spell that adheres to the term 'conspiracy theorist', public perception would be very different.

We would have a plethora of corruption investigations on our hands, conducted by a growing number of corruption investigators.

Rather than nervously laughing and dismissing these investigations out of hand and saying things like, "I don't believe in corruption investigations", we would probably start demanding official inquiries, hearings, and prosecutions, and we would also insist that our corporate news outlets conduct honest investigations into these matters themselves. The power of spell words cannot be underestimated.

Where the real power and control lies

THE roots of the publicprivate partnership in health go back at least a century to the capture of medicine as described by E. Richard Brown in Rockefeller Medicine Men: Medicine and Capitalism in America.

The kerosene king had started out selling counterfeit snake oil, but once the technology of cracking petroleum arrived, the ingenuity of his fellow Germans led to petrochemical-based pharmaceuticals.

Rockefeller became the biggest name in U.S. pharmaceuticals by using the power of his endowments to gain control of medical schools. He promptly banned traditional medicine. Simultaneously he became a force in the media.

It is not just a curious parallel that today we see Big Pharma, the medical profession and the corporate media in cahoots - they are largely the same interests.

The vast profits to be made set off a rivalry between the U.S. and Britain on the one hand, and Germany on the other. That quest for wealth was to shape the 20th century.

Government, for all its big budgets and burden on taxpayers, cannot compete with private foundations. These are the playthings of families and wealthy individuals. Through think tanks, the big four auditors and their consultancies, and the banks and private equity, corporate forces make government policy.

Examples include George Soros's well documented and lavish funding of selected U.S. district attorneys, having realised how the political machine - and electoral process - can be controlled through the judicial system.

There is Bill Gates's development of Common Core and successful effort through the teachers' unions, academics and politicians to foist it upon the U.S.

The powerful influence of billionaire families like the Pritzkers set the gender debate, as explored by Jennifer Bilek.

It goes much deeper than the revolving door between government and the private sector. Catherine Austin-Fitts explains how defence

contractors control computing and IT systems, including information and payments. Private banks run the financial systems.

Democratically-elected governments are no longer sovereign: their information and payment systems are now run by banks and corporations and they restrict what they allow politicians to see.

When Austin-Fitts was number two in charge of the Department of Housing and Urban Development in the 1990s, contractors flat out denied her access to information. It is worth quoting her at length:

"Sovereign government no longer controls the information and payment systems. They are run by the defense contractors who report to a shadow government. The NY Federal Reserve and member banks operate as depositors. So they run the bank accounts and financial systems and the defence contractors run the information and payment systems. Between them they report to the shadow government or themselves...

If the middle class is going to reassert authority, that means control of the digital systems - the sovereign government, the president, the officials do not control them. They control the appropriations".

There is one deeper and more troubling feature of heist by organised crime. Unlike Lucky Luciano and Meyer Lansky, today's dons have absorbed the lessons of Freud and Bernays. They employ the skills of Marc Bernays Randolph, founder and CEO of Netflix. Whether Randolph knows it or not, he helps to sculpt the cranium that accepts the Great Lockdown

In summary, the degree of mind control that accompanies Event Covid, the Lockdown and the momentous transfer of wealth that is taking place in its shadow, makes the propaganda machine of the Third Reich look like playtime.

Unexplained excess deaths 'point to vaccines'

Official data shows worrying pattern as shots are given to ever younger people

A RETIRED professor from Edinburgh is pushing the Scottish government to explain more than 1,500 unattributed excess deaths north of the border this summer.

Professor Richard Ennos has also expressed his concerns with MSPs and health bosses that official data point to a "prima facie case" for the country's mass covid vaccination programme being "a contributing factor to the dramatic rise".

Information he gathered from the National Records for Scotland shows that deaths increased down through age groups almost simultaneously to the injections being rolled out to ever younger people.

Comparing the huge rise in excess deaths figures for summer 2021 compared to summer 2020, Professor Ennos tells Anita Morrison, Scotland's Head of Health and Social Care Analysis and Support, "What differs between the two years? The glaringly obvious answer is the rollout of covid-19 vaccination.

There was no covid-19 vaccination programme in 2020, but there was a sequential way to increasingly younger age groups in 2021, a pattern that we see in manifestation of excess deaths".

He also suggests that policy provides a "simple and compelling explanation for a three to sixfold increase in summer covid hospitalisations".

In a response to Ms Morrison on October 28, he added: "All of the covid-19 vaccines are novel and experimental with no long-term safety data. They are now associated with a wide range of serious side-effects (blood clotting, myocarditis, Guillain-Barre syndrome) whose likely frequency in the wider population was not assessed in the small-scale phase one and two trials that included only a subset of healthy volunteers.

"The Yellow Card adverse events reporting system, that captures only a fraction of events, has already recorded over 1,700 deaths in the UK population associated with the covid-19 vaccines. There is therefore a prima facie case for covid-19 vaccination being a contributing factor to the dramatic rise in summer excess deaths in Scotland in 2021".

The former professor of evolutionary biology at Edinburgh University collated detailed official data covering 21 weeks over this summer, in an effort to seek an explanation for 3,000 excess deaths.

Responding to an inquiry on the matter from Edinburgh MSP Boyack on October 25, Ms Morrison revealed that covid accounted for 45% of deaths and states that Public Health Scotland analysis from 2020 provided 'some possible reasons for non-covid excess deaths'.

She lists them as:

- 1. Artefact deaths directly due to covid-19 that were not certified as such in provisional data (although this is less likely now due to mass testing).
- 2. Unintended consequences (social determinants) deaths are due to unintended consequences of the non-clinical response to

- covid-19.
- 3. Service supply/access deaths due to problems with health and social care service access.
- 4. Service demand deaths of individuals not presenting to health and social care services as they would at other times.
- 5. Other other causes that have not vet been identified.

In an article for the Daily Sceptic on November 4, Professor Ennos states that he and others have written to MSPs about the 'dreadful situation' of more than 3,000 excess deaths in 21 weeks this summer asking 'for a thorough analysis of what is responsible'.

He adds: "Five possible explanations are given, none of which reflect favourably on the Scottish government's public health policy.

To paraphrase her (Ms Morrison) reply, 45% are due to covid-19 and the rest are accounted for by one or more of:

- Covid deaths that were not recognised.
- Unintended consequences of the Scottish government's nonclinical response to covid-19 (masks, social isolation etc.).

- Problems with access to the health and social care services (presumably due to the Scottish government policy of withdrawing these).
- Patients not accessing services that were available (presumably because they were too scared of catching covid-19 due to the Scottish government exaggeration of the risks).
- Some other causes that have not been identified".

Professor Ennos adds that Ms Morrison's response is "a damning indictment of Scottish government public health policy whose outcome should ultimately be measured by the metric of excess death".

By December 20, 2020 there were 6,298 deaths registered in Scotland where covid-19 was mentioned on the death certificate because of a positive PCR test within the prior 28 days.

A Freedom of Information request to the Scottish government in December 2020 revealed there had been fewer than 500 deaths directly attributed to covid since March 2020

Canadian police mount massive challenge to covid mandates

Officers defend people's right to bodily autonomy and accuse government of coercion

AROUND 30,000 officers in the Royal Canadian Mounted Police have signed an explosive letter opposing mandatory covid vaccinations and having to enforce them.

As well as accusing the Canadian Government of coercion and overstepping its authority, the officers have also called on investigators to collect statements from medical professionals and other reliable witnesses who allege they have been silenced – "thereby putting lives at risk".

In the powerful open letter, sent to RCMP commissioner Brenda Lucki on October 21, they expressed their "sincere concerns and resolute stand against the forced coercive medical intervention of Canadians, and against the undue discrimination experienced by those exercising their lawful right to bodily autonomy".

It added: "We are not against vaccinations, but as law enforcement officers, we cannot in good conscience willingly participate in enforcing mandates that we believe go against the best interests of the people we protect.

"As Canadians, our constitutionally-protected freedoms precede the government, and may only be temporarily limited if the majority of evidence justifies such infringements as reasonable, provable, and guided by law.

"If presented with all available evidence in a court, we firmly believe the government implemented mandates would not hold up under scrutiny.

"A complete investigation must include full disclosure of all the facts of the case, even contradictory evidence. Why, then, is there little to no tolerance for free and open debate on this matter? Many credible medical and scientific experts are being censored. "Accordingly, we rightly have concerns about 'the science' we are being coerced to 'follow'.

"As representatives of our

communities within the RCMP and representatives of the RCMP in our communities, we have never witnessed such division in our country.

"This sense of 'Us versus
Them' will be further fuelled by
having a police force consisting
only of 'vaccinated' people, while
serving communities consisting of
'unvaccinated' people, which goes
against the community policing model
the RCMP has strived to achieve.

"As law enforcement officers, we already face higher levels of stress and mental illnesses due to the nature of our work. These have been compounded – considerably – by mandates that we believe are deeply unethical, threatening our livelihood and dividing society.

"Moreover, what assurances are we given that the injections will not cause short- or long-term side effects? What steps will be taken to ensure members are compensated for adverse side effects?

"Police officers are expected to preserve the peace, uphold the law and defend the public interest. We strongly believe that forced and coerced medical treatments undermine all three and, thus, contradict our duties and responsibilities to Canadians.

"We remain loyal to the Charter and Bill of Rights and ask you to send investigators to collect statements from medical professionals (and other reliable witnesses) who allege they have been silenced – putting lives at risk.

"Allow us to make this information publicly available to all, so the public can scrutinise it and achieve informed consent."

The letter stated it was created from the collective thoughts, beliefs and opinions of actively serving police officers across many ranks and covering the whole spectrum of RCMP work from across the country, including the Prime Minister Protection Detail. "Together we are the Mounties for Freedom... united in the belief that citizens, including federal employees, should not be forced and coerced into taking a medical intervention."

The letter follows an announcement in August by Canadian Prime Minister Justin Trudeau that federal public servants need to be fully vaccinated and that for those without a medical exemption who choose

not to be vaccinated "there will be consequences".

Since Trudeau's statement, many federal employees have been told they will be sent home without pay for refusing to receive the contested medical treatment.

The letter added: "We stand united against the forced and coerced medical intervention of Canadians and against the discrimination faced by those who have exercised their right to bodily autonomy. We believe in democracy, the Canadian Charter of Rights and Freedoms, and the Bill of Rights.

"Our primary duty as peace officers in the RCMP is the preservation of peace. We have never witnessed the level of division in our country as we see from the covid-19 pandemic. It is our responsibility, now more than ever, to make all efforts at preserving the peace in our country.

"The Charter of Rights and Freedoms protects fundamental rights and freedoms essential to keeping Canada a free and democratic society.

"We believe our federal and provincial governments have failed to uphold the Charter, Bill of Rights and Constitution and we are witnessing the erosion of democracy in Canada.

"Requiring mandatory covid-19

treatment options is a slippery slope and allows the government to overstep its authority unchecked. It infringes on the fundamental belief in our society that the individual has the right and freedom to choose.

"The choice of whether to receive medical treatment has always been an individual's right in Canada. The Canadian National Report on Immunisation (1996) states 'Immunisation is not mandatory in Canada; it cannot be made mandatory because of the Canadian Constitution'.

"Though the Nuremberg Code is not a law, it is internationally accepted and falls in line with the spirit of our Charter and Bill of Rights.

"A key component of the Nuremberg Code is that participants in a medical experiment need to participate voluntarily without any form of force or coercion.

"We have obtained documentation from several Canadian doctors who have explained the current covid-19 treatment options in Canada, being referred to as 'vaccines', were recently authorised as new drugs despite the absence of long-term data.

"According to these accredited Canadian doctors, these treatment options did not meet the criteria of true vaccines until very recently when the definition of vaccine was changed.

"Without long-term data, these vaccines are still experimental. We believe the act of removing the rights and freedoms of citizens who refuse to participate in specific covid-19 treatment options is a form of coercion.

"The Criminal Code contains our country's Criminal Offences and explains that a person commits an assault by intentionally applying force to someone else without that person's consent. The Criminal Code further explains that consent is not obtained from a person who submits, or neglects to resist, on the grounds of authority being exercised over them.

"How then can someone give proper consent to a covid-19 treatment injection when doing so under the threat of losing their job, freedoms, or livelihood? Canadian courts have already ruled that medical treatment without proper informed consent is an account.

"As law enforcement officers, we cannot in good conscience willingly participate in enforcing mandates that violate the laws of our country and breach the rights and freedoms of the people we protect".

Freedom rallies across the world

MASSIVE demonstrations against tyrannical, nonsensical and unnecessary restrictions were observed at the end of November in Austria, Croatia, Italy, Northern Ireland, Britain, France, Germany and the Netherlands.

Outside of Europe, protesters were seen in several cities across Canada,

city of Rotterdam, clashes between protesters and police began Friday 19th November and continued through Saturday night.

About 30 minutes' drive away, protests also transformed into riots in The Hague. It has been reported that



Australia, Japan and even the U.S. Some marked Saturday as part of a "Worldwide Freedom Rally" to protest health passes and vaccine mandates.

Some of the most intense rallies turned into riots. In the Dutch port

'agent provocateurs', sent in by the authorities themselves to stir up trouble with the police, were responsible for much of the violence, to detract from the message of peaceful noncompliance with medical tyranny.

Protesters across many European cities shared commonalities as they marched to preserve their lives and liberty. Governments are attempting to plunder that via increased restrictions, mandatory health passports and forced vaccinations for more and more sectors of workers. They are in no doubt as to what the end goal is - full mandatory vaccinations for the entire population, ongoing for ever.

The worst restrictions in Europe - or rather the government's plundering of liberties - are in Austria, where full lockdowns began Monday 22nd November. Nationwide lockdowns are expected for at least ten days but can be extended to more than two weeks.

Then by February 1st, the government will make vaccinations mandatory (only 66% of Austria's 8.9 million people are fully vaccinated), with threats of fines and prison for noncompliance. Good luck with finding cells for 3 million people.

Saturday's march in Vienna's massive Heldenplatz Square had many chanting "My Body, My Choice", "We're Standing Up for Our Children!" and "Resistance!"

One of the biggest protests might have been in Zagreb, Croatia's northwestern capital, where Citizen Free Press reported as many as 100,000 people flooded streets to protest the government's health passports and new covid measures.

In Rome, thousands of demonstrators gathered in the capital's Circus Maximus to protest against "Green Pass" certificates now required at workplaces, restaurants, cinemas, theatres, sports venues and gyms, as well as for public transportation.

"People like us never give up," read a protester's sign.

The pushback against totalitarianism is spreading across Europe. Usually, "Europeans generally are more compliant than Americans when it comes to government orders. But even there, citizens are protesting governments seizing power in the name of public health," said American Thinker's Thomas Lifson.

People of the world are awakening to government tyranny plundering their life and liberties as the Davos Man, the world's elites and their political puppet officials are becoming more unfavourable than ever. Concerns grow over EV fire hazard



ELECTRIC vehicles are coming under increased scrutiny over alleged "unaddressed" fire risks.

Two months ago, a massive fire broke out at a German bus depot, destroying 20 electric buses. First responders were not prepared nor properly trained in extinguishing lithium-ion fires.

The fire prompted one German official to question the vehicles, stating the "spontaneous" combustion of the batteries "is completely unaddressed".

"The risk of these fires, including in other locations such as bicycle basements or large apartment blocks, is completely unaddressed", Heinrich Duepmann of Germany's Electricity Consumer Protection Association told RT News. "Also, insurance companies are not yet tackling the issue".

Duepmann said that fire barriers between electric buses and ones that run on diesel will be constructed to reduce risk

Europe and much of the West are experiencing a green transport boom. The transition from diesel and petrol to electricity has come with significant risks, such as when a lithium-ion-powered vehicle spontaneously combusts during operation or charging (over the years, we have seen plenty of Teslas catch fire). First responders are not prepared to tackle such fires.

This was clear in Baltimore, Maryland two months ago, when a Tesla crashed and its batteries exploded, taking firefighters more than two hours to extinguish the blaze.

Baltimore County Volunteer Firefighters Association was unhappy about the incident because its members are not equipped nor have the proper training to handle such fires.

The association tweeted, "Let's hope @elonmusk can work with the fire service, and together we can develop a better response".

It is not just Baltimore firefighters who are inadequately trained in battling lithium-ion fires, as more electric vehicles enter the roadways. Most fire stations across the country are not prepared.

The only weapons that firefighters have are water and to let the fire burn out, but that could take hours

A few months ago, 20 tons of water were used to extinguish a Tesla fire in Taiwan. For some context, it only takes three tons of water to put out a petrol car fire.

In a separate incident, a Texas fire chief told *The Independent* that a Tesla fire needed 40 times more water to control the blaze.

What becomes evident is that first responders are not prepared for the brave new world of 'green' transportation and the occasional battery fires that go with it.

Across the world, electric car companies including Tesla and VW, are being urged to brief local governments on how to tackle lithium-ion fires.

Covid shots precede 5,024 in-utero deaths

Vaccines' legacy on pregnant mums: 5,024 in-utero deaths (13.45%) hidden among 37,625 dead

Presently, 19,250 and 18,375 deaths can be counted from Adverse Reactions Reports filed to the U.S. VAERS and EU Eudra-Vigilance systems respectively (37,625 combined), following administration of various covidiabs.

Analysis conducted continuously over a six month period since mid-June 2021 uncovers 5,024 in-utero deaths hidden among two million reports, fewer than 4% of which are included in the official death count: 4,493 spontaneous abortions, 402 foetal deaths, 119 stillbirths and 10 neonatal deaths are all linked with mothers jabbed during pregnancy.

This combined U.S.+EU total (5,024) in eleven months of jabbing is still accelerating, as we head towards 5,500 for the full year, despite the fact that all adverse reactions are massively under-reported (and many are being deleted). Nevertheless we can compare this total with an average of only 16 (combined) in-utero deaths (annually) following DTaP (Diphtheria and Tetanus toxoids and acellular Pertussis "whooping cough") and 23 (combined) in-utero deaths (annually) following flu-shots, both of which are routinely recommended and administered to pregnant women.

Headlines about women's menstrual problems following covid jabs already started to circulate this summer. Up to now, there are a combined 58,185 cases of documented menstrual cycle mismanagement (discomfort, disorder, delayed and/or irregular) or 64,162 annualised. This compares with fewer than two cases per year with respect to DTaP jabs and/or flu shots.

The CDC insists that "mRNA covid-19 vaccines in pregnancy are not associated with – and there is no evidence of – an increase in spontaneous abortion rates and no evidence of any disproportionate negative infant birth outcomes". The

UK Government's 'Green Book' for public health professionals advises that "women who are pregnant should be offered primary and reinforcing immunisation at the same time as non-pregnant women, based on their age and clinical risk group. There is currently no evidence that any vaccines, including covid-19 vaccines, cause fertility problems".

The WHO redefined "pandemic" on 6th May 2009 to being "a worldwide epidemic of a disease" prior to announcing (five weeks later on 11th June 2009) "a global pandemic of novel influenza A (H1N1) was underway", which (like covid) never was.

Previously, the WHO defined a "pandemic" as occurring when a new virus appears against which the human population has no immunity, resulting in epidemics worldwide with "enormous numbers of deaths

and illness". A real pandemic with enormous numbers of actual deaths and illness (not asymptomatic "cases") would not need to be advertised 24/7 on television programming, radio broadcasts, newspaper propaganda, billboards and tannoy announcements in supermarkets and train stations.

A "pandemic" (declared, real or not) permits Emergency Use Authorisation (EUA) of experimental covid jabs (contrary to the Nuremberg Code on medical experimentation) on the basis of there being no other available treatments, such as WHO-listed generic "essential medicines" Ivermectin or Hydroxychloroquine (administered with zinc) or nebulised Budesonide, all of which are cheap, effective and counteract whatever "insult" was making some very few people sick, and undermines the entire "vaccine" narrative.

The EUA was granted from December 2020 to people 16 years and older; it was later (May 2021) modified to include adolescents of 12~15 years

and, as of 26th October 2021, the FDA voted 17-to-0 in favour of extending the EUA to children as young as 5 years of age.

According to CDC demographics, 173 U.S. children, in this now-targeted 5~11 age category, died with covid "mentioned or presumed" on their death certificate from a population of 8.7M, i.e., 0.002%. The CDC's modelled Infection Fatality Rate for children is (coincidentally) 0.002% and the "actual" IFR, based on a grand total of 805 "deaths" (0~17 years) from 5,661,826 "cases", is 0.014%. In England, six children (0~14 years) died with "covid mentioned on their death certificate" between February and July 2020 during the height of the "pandemic"

As for the "virus" (SARS-Cov2), no one anywhere has isolated it from an infected person; 138 health authorities, scientific institutions and government departments admit this; CDC scientists were unable to prove contagion in any of three human tissue cell lines. The

CDC's RT-PCR "Instructions for use" document admits they had no virus sample with which to validate their own test protocol. There are in fact no viruses nor any contagious diseases. This is known to us since scientists investigated the "Spanish flu" which was not from Spain, was not flu and occurred only in those then vaccinated. Science has in fact repeatedly disproven (and has never proven) the germ-based theory of contagion, yet an entire industry of dogma persists because it serves itself at our expense. All claims about viruses as pathogens are false (The Light, Issue 12, page 3).

As of mid November, ten months of U.S. VAERS covid jab deaths had already exceeded twice the totality of all other (non-covid) jab deaths in that 31 year-old database. Covid jab Adverse Events annual run-rate is 37 times higher than the annualised non-covid jab AE run rate, and the covid-jab annualised death run-rate is 73 times higher. There is no virus, no test, no contagion. It's in the jabs.

Australian army moves people to quarantine camps

THE Australian army has begun forcibly removing residents in the Northern Territories to the Howard Springs quarantine camp located in Darwin, after nine new covid-19 'cases' were identified in the community of Binjari. The move comes after hard lockdowns were instituted in the communities of both Binjari and nearby Rockhole on Saturday night.

"Residents of Binjari and Rockhole no longer have the five reasons to leave their homes", said Northern Territory chief minister, Michael Gunner, referring to the country's five allowable reasons to be out (buying food and supplies, exercising for up to two hours, care or care-giving, work or education if it can't be done from home, and to get vaccinated at the nearest possible location).

"They can only leave for medical treatment, in an emergency, or as required by law. It's highly likely that more residents will be transferred to Howard Springs today, either as positive cases or close contacts", he continued, adding, "We have already identified 38 close contacts from Binjari but that number will go up. Those 38 are being transferred now.

I contacted the Prime Minister last night. We are grateful for the support of about 20 ADF personnel, as well as army trucks to assist with the transfer by TYLER DURDEN

of positive cases and close contacts – and to support the communities.

We are doing an assessment today of what extra resources we might need from the Feds, and the Prime Minister is ready to help further – I thank him for that?

Police Commissioner Jamie Chalkner told NT News: "We're conscious of the fact that this can have some impact on people's mental health as well as their general well-being".

Of note, the Northern Territories are home to a large percentage of indigenous Australians. As the Epoch Times' Steve Milne notes:

"According to the Australian Institute of Health and Welfare, in 2018-19, almost one in five Indigenous Australians lived in overcrowded dwellings (18 percent), compared to 5 percent of non-indigenous Australians. Although this percentage had decreased from 27 percent in 2004, it still meant an estimated 145,340 Indigenous Australians were living in overcrowded dwellings in 2018-19".

In addition, the more remote an area, the higher the proportion of Indigenous Australians living in overcrowded dwellings (26 percent in remote areas and 51 percent in "very remote" areas), compared to 8 and 22 percent in non-remote areas.

Five days ago, NT Senator Malarndirri McCarthy told ABC that overcrowding in Indigenous communities was a "massive problem", pointing to the region's second cluster of new infections - which included nine members of McCarthy's direct family, including her sister who flew from Katherine to Robinson River while unknowingly bringing covid-19 with her, per the report.

"If we could get housing in there right now, I would be pushing that straight away to the federal government and the NT government to work on that, but we obviously need the resources to do so," she said.

Of the nine new cases in Binjari, four are women and five are men, including a 78 year-old woman who has been transported to Darwin Hospital.

There were zero new covid-19 cases reported on Sunday, however Minister Gunner said he was worried about 'mingling between households' in Binjari and Rockhole, whose populations are around 220 and 130 respectively.

Two days ago, Gunner said: "Yes, these are strong measures, but the threat to lives is extreme".

But it's all for their own safety, of



But we were not so stupid to accept this idea, not wanting our wings to be clipped.

So they created a chip called a SIM card and created the cellular phone.

They knew that the gadget-mad masses would demand one of these things as their own.

So be careful to understand your connection, as this phone is more connected to you.

We're becoming a nation of zombies, staring at screens whilst sat on the loo.

Step away for a while from your smartphone, reconnect with your loved ones for real.

And remember the things of importance, like clean air or fresh water with a hot meal.

Clues to Thyroid issues?

Many different symptoms can point to underlying health problems

Are you wondering if you have low thyroid function? One of the best ways to test for thyroid issues is using your temperature. A normal body temperature should not be lower than 98.6°F or 37c. It turns out that almost everybody's temperature is lower than that and doctors are now taught that a temperature of 97.8°F is normal. It's not. Try taking your temperature before you get out of bed in the morning. Throw off the covers so your body reaches its normal temperature and take your temperature with a thermometer. If your temperature is low, it is almost certainly a sign of hypothyroidism.

It is worthy of note that the 'standard body temperature' that was considered average 100 years ago was up to a degree higher than 98.6 F. That is the current standard, however the reality is that most people these days have a temperature almost 1°F lower than 98.6. This is clearly indicative of low iodine levels in almost everybody.

There are also several tests you can do. You can pinch the skin on your upper arm, and you should be able to grip the skin easily between your thumb and forefinger. If you're unable to do this because the skin feels too tight or you can pinch a very large amount of skin this could be myxoedema (a build-up of mucin), which could well be a sign of hypothyroidism.

The famous thyroid expert, Dr Barnes, shared that his patients being treated for hypothyroidism had way fewer heart attacks and less complications from diabetes than the general population. Dr Mark Starr suggests that all diabetics have hypothyroidism.

It seems very likely the children who suffer frequent infections are also hypothyroid. Anyone who has swelling around the neck or in the hands may well be hypothyroid. Unfortunately, the doctors' tests for hypothyroidism and hyperthyroidism are typically inaccurate.

Dr Barnes found that his thyroid treatment cured 90% of his patients with acne. Most skin issues are thyroid related, something that is massively overlooked by medical "professionals". He also found that every alcoholic that he treated turned out to be hypothyroid. It should be noted that alcohol can lower blood sugar levels, particularly in hypothyroid cases. Low blood sugar can result in tiredness, poor decisionmaking and impair driving skills. I believe that many road accidents are caused by drivers falling asleep due to a lack of glucose in the brain. Hypothyroidism also seems to lead

to substance abuse. Tobacco and alcohol can reduce the symptoms of hypothyroidism, hence why people are subconsciously choosing them. Correcting the hypothyroidism can reduce addiction problems, making it easier to quit.

People are clearly much heavier than they used to be and obviously a lot of this is to do with diet. However, with more and more people becoming hypothyroid, this too may be an explanation.

Cold weather increases the demand on thyroid, so the symptoms can increase at this time.


The link between hypothyroidism and chronic heart failure has been known since 1925. One could ask why the doctors haven't been told this? It can take just days of remedying hyperthyroidism to reverse chronic heart failure. The average heart specialist is unaware of the connection. If you've been told you have an enlarged heart, the chances are that the cause is low iodine and thyroid issues. Tiredness, angina, pneumonia, blood pressure issues, kidney problems, anaemia, circulatory problems may also have a root cause in hypothyroidism. If you are hypothyroid, you may find you are unable to process vitamin B12 correctly.

For those with kidney issues, it is vital to understand that the decreased output of urine may well again be hypothyroidism. Liver problems, hypoglycaemia, bladder issues, digestive tract issues, eating disorders, inflammatory bowel disease (IBD / IBS), and poor appetite may also be linked to hyperthyroidism.

It could be seen that almost every problem could have a link to iodine deficiency and hyperthyroidism such as fertility problems, miscarriages, premature babies, candida, libido problems, erectile dysfunction and most problems in women's reproductive organs and breast cancer.

Chronic fatigue syndrome and fibromyalgia can often be reversed by treating the thyroid. For those suffering chronic fatigue, it is vital to look at the other factors such as dental issues, nutrient deficiencies, heavy metal poisoning and the usual list of suspects.

Do you bleed and/or bruise easily? Do you suffer from lupus atherosclerosis, autoimmune issues, headaches, migraines, or fluid retention? Do your feet swell up? Do you have difficulty taking rings off?



You can guess the answer!

So, what should you do if you feel you have hypothyroidism? Doctors' tests will be next to useless. It may be wise to assume that if your temperature is low and you have a number of the symptoms mentioned, that it might be worth experimenting with iodine, selenium and natural desiccated thyroid from an animal.

Desiccated thyroid must be taken into the stomach at least 20 minutes before a meal. I'm not going to give specific instructions on treatment guidelines here, however if your basal temperature rises above 98.2°F, this would indicate that an immediate reduction in the dose of thyroid would be in order. Usually, a half grain is the starting dose and some people go up to 3 grains. Can I suggest that you seek out expert advice or at the very least, read Mark Starr's book, "Hypothyroidism Type Two" for precise and detailed instructions.

If you have been given thyroid medication by a doctor and did not tolerate it well, it may be that you have an issue with mold.

Correcting this may initially be a nutritional program including iodine (preferably as Lugols Iodine), Magnesium, Celtic salt, Selenium and B vitamins, particularly B2 and B3, along with vitamin C.

Finally on another front, has the doctor told you that you have high cholesterol? You may have been told erroneously to cut down on natural fats such as animal fats and eggs. During World War II there was a shortage of these foods and atherosclerosis skyrocketed, only to fall again when these foods were reintroduced at the end of the war, running contrary to what most doctors believe today.

Here are some signs and symptoms of low thyroid function which are almost always associated with low iodine or excessive exposure to chlorine, fluoride, bromine, and perchlorates:

Health suffering from corporate hijacking

'ALTERNATIVE' means different, something that you have instead of. 'Complementary' means two things that go together. Words convey subliminal meaning and it is such linguistic subtleties that unconsciously manipulate our thoughts and beliefs.

In using comparative nomenclature, natural treatments are defined in relation to allopathy. It implies inferiority against a perceived 'gold standard' of 'orthodoxy'. Drugs and surgery are referred to as orthodox, but 'orthodoxy' actually means 'the way things have always been done'.

The corporate hijacking of health only occurred early in the 20th century when pharmaceuticals usurped traditional healing methods taught in medical schools.

But synthetic drugs are foreign molecules that move the body away from normalcy and require detoxification, making them a less attractive and less-effective option.

Allopathic medicine has fraudulently positioned itself to be grounded in science, deeming natural medicine unscientific and untested. This, combined with state-endorsed medical systems, insurance policies and legislation, ensure allopathy maintains its monopoly.

Symptoms are an adaptation to a problem and a signpost to what is wrong, not an aberration that needs fixing. Despite the fact that Hippocrates understood the progression from disease to health and the importance of healing crises, modern medicine lacks recognition that such a dynamic exists.

Hering's 'Law of Cure' is a way of evaluating whether symptom progression is curative or pathological. Allopathy does not acknowledge an innate governing intelligence that dynamically adapts to challenges.

In focusing on symptomatic relief, allopathy can have a progressive, detrimental effect on health. This is evidenced by a correlated increase in disease seen in medicalised countries

Allopathic medicine targets the 'disease that has the patient', rather than the 'patient who has the disease', resulting in standardised treatments regardless of biochemical individuality or causation. Its emphasis on the diagnosis ignores the compromised functionality that led to the diagnosis, which assumes less relevance when reversing the disease process naturally.

The pharmaceutical industry has incrementally eroded our belief in the body's ability to heal and has fostered the myth that health can only be acquired via medical intervention. This paternalistic model is prescriptive and disempowering. The mindset shift from trusting 'experts' towards regaining health sovereignty can be challenging for anyone conditioned to be a passive recipient of medical treatments.

The product of reductionism, allopathy was developed at a time when, supported by an empire mentality, Christianity and Darwinism, dominion over Nature was being promoted. Although science is now recognising our symbiotic relationship with nature, the petrochemical industry has not moved on. The same industry that poisons us with environmental, household and agrichemicals and which has massively contributed to the decline in health over the past 100 years, offers us a chemical 'solution' to our ailments.

The discovery of germs was integrated into a militaristic model, which has resulted in the development of treatments such as anti-inflammatories and antibiotics (which suppress our immune systems), in the misguided belief that microbes are our enemy and are primed to attack indiscriminately. Vaccination is based on the myth that microbes are so dangerous, protection is needed from birth.

The two paradigms are polarised. Natural medicines are not complementary to allopathy (although they can support one another when treating injuries). However, with chronic disease they would be working against each other. Since chronic disease accounts for more than 70% of modern health problems, our medical system is not adapted to the diseases presenting today.

Once the stranglehold of the pharmaceutical industry has collapsed, it is likely that future generations will wonder how we had been hoodwinked into enduring chemical poisoning and invasive surgical procedures in pursuit of health.

Even when confronted by 'side effects' and lack



of cure, indoctrination into the allopathic paradigm triggers cognitive dissonance, ensuring the sickness system is self-perpetuating. We have surrendered our bodies to pseudoscience because it promises, but does not deliver, salvation from disease.

That is why the inappropriate use of

terminology such as 'alternative' and 'complementary' devalues the status and scientific credentials of natural healing modalities and unwittingly endorses the implicit authority of the pharmaceutical industry.
