Covid shots alter DNA

While they may try to deny it, another study shows covid mRNA can permanently alter human genome

They manipulated billions into receiving one or more experimental genetic injections, and may have now altered the human genome permanently, according to scientists

WHEN a Swedish study came out this year, it found that the messenger ribonucleic acid (mRNA) in Pfizer's shot was able to be alter DNA in liver cells.

This alteration, known as reverse transcription, is when mRNA writes to DNA, the opposite of the normal transcription process. Normally, it is a portion of the DNA that is transcribed into an mRNA molecule, which then forms the specified protein.

News agencies and fact-checkers played down the significance of the University of Lund research published last February, so as not to derail the mass injection programmes still under way across the world.

But in May, a team of scientists, including noted MIT biologist Rudolf Jaenisch, published a paper titled, *Reverse-Transcribed SARS-CoV-2 RNA Can Integrate Into The*

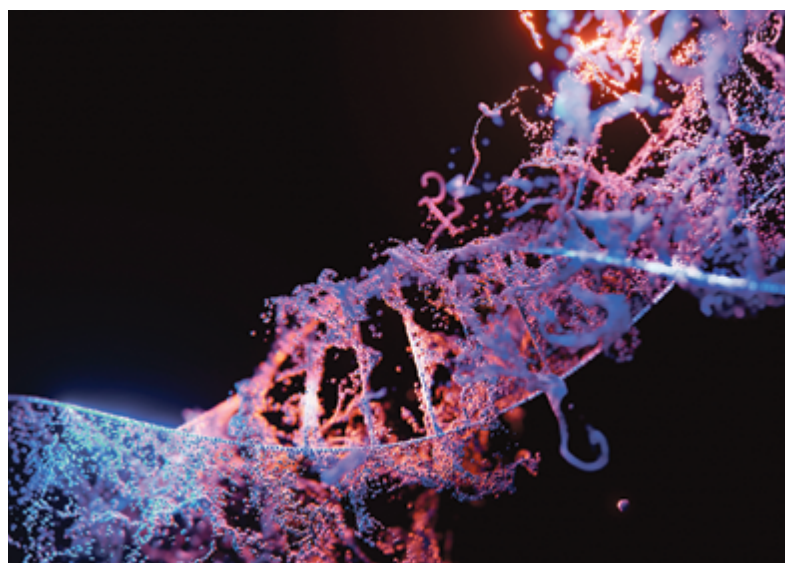

Genome Of Cultured Human Cells And Can Be Expressed In Patient-Derived Tissues.

They wrote: "We investigated the possibility that SARS-CoV-2 RNAs can be reverse-transcribed and integrated into the DNA of human cells in culture, and that transcription of the integrated sequences might account for some of the positive PCR tests seen in patients.

"In support of this hypothesis, we found that DNA copies of SARS-CoV-2 sequences can be integrated into the genome of infected human cells.

"We show here that SARS-CoV-2 RNA can be reverse-transcribed and integrated into the genome of the infected cell, and be expressed as chimeric transcripts fusing viral with cellular sequences. Importantly, such

chimeric transcripts are detected in patient-derived tissues. Our data suggest that, in some patient tissues, the majority of all viral transcripts are derived from integrated sequences."

If researchers have found that RNA from the supposed virus can alter DNA, then what is there to prevent RNA from the supposed vaccine doing the same? Scientists steer clear of asking this question, for obvious reasons.

It can perhaps be argued there is little about these experimental products that Big Pharma has been honest about. If these covid injection makers let people know the shots can change their DNA and that of their offspring, potentially permanently, no one would go near them again..

One needs to ask the question

- as it would be naive to assume ignorance or incompetence on the part of the world's biggest drug companies - why are they doing something so shocking, and getting away with it?

We have already seen tens of thousands of reported deaths after the covid shots, with millions of injuries worldwide. It is also clear the authorities and Big Media want to cover up the size and scope of the adverse reactions to the 'vaccines', with the notable exception of GB News and perhaps a handful of MPs in the UK.

There is already a plethora of evidence to suggest the covid shots are interfering with reproductive systems, with miscarriages, menstrual problems and heart problems in newborns all reported

from mothers who have received one or more mRNA injections.

The scandal of this keeps growing, as does the deafening silence on the issue from the 'pro-vaxxers'. Why is there no live televised debate with those who stand by this experimental medical procedure?

It is perhaps even more worrying that those trying to warn people about the injections are often ignored, banned, censored, ridiculed, refuted without chance of reply and/or are accused of peddling 'misinformation'.

And the favourite tactic for those trying to silence those urging caution about the covid injections? It is to brand them as conspiracy theorists.

Renowned American heart specialist Dr Peter McCullough is a 'conspiracy theorist' for asking questions and reporting studies that show serious problems after the covid shots. As are those who themselves have suffered serious injury, or the permanent loss of loved ones after the covid shots.

Such is the degeneration of public discourse today, there is just one message coming from nearly every orifice of the media machine. And, as the tech giants have a stranglehold on what information we see, everyone is either talking in an echo chamber or blissfully unaware of what is really going on.

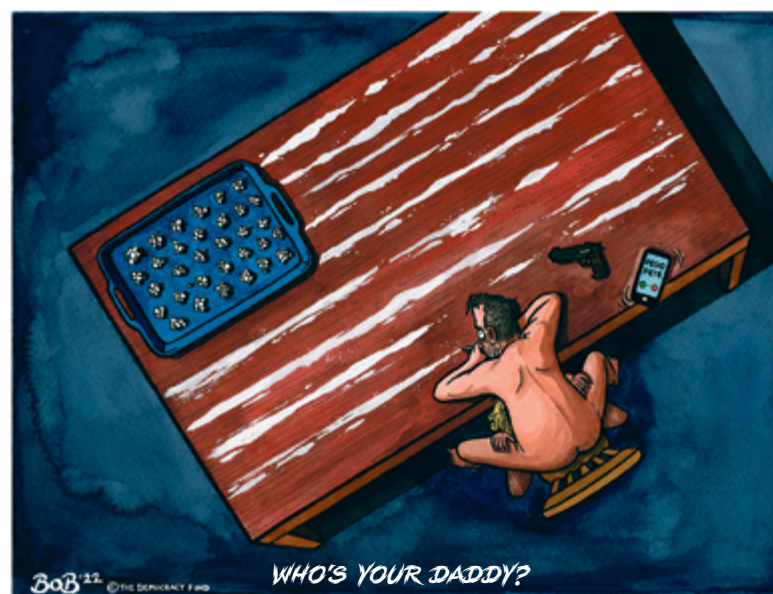
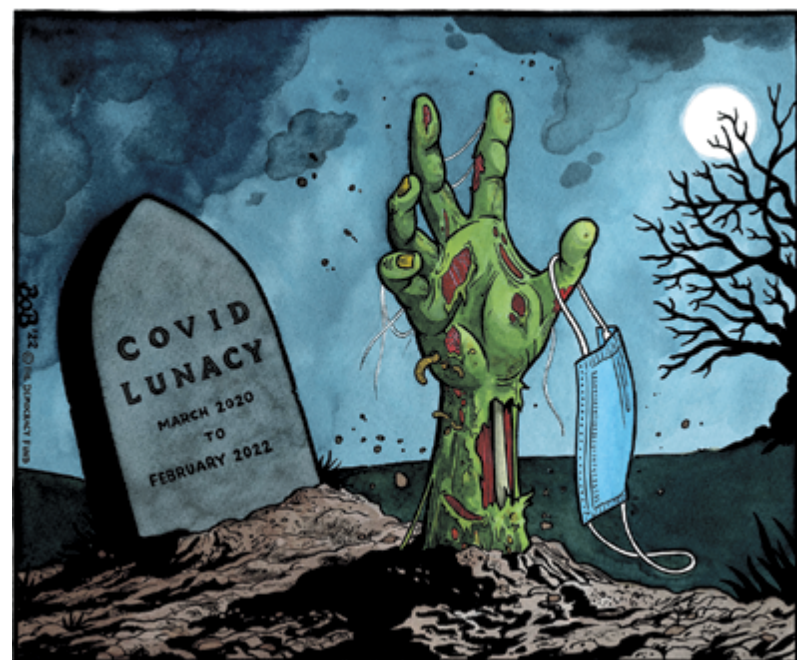

Latest Pfizer documents: even more adverse events

Why were so many participants with ‘minor’ issues withdrawn from the trial?

JULY’S release of documents covering the Emergency Use Authorization granted to the Pfizer covid-19 vaccine included reports of a significant number of people who withdrew from the trials - and the reasons for these withdrawals.

In some instances, participants withdrew or were withdrawn from the trial due to serious adverse events, which, again, were usually determined to be ‘not related’ to the vaccination, the U.S. Food and Drug Administration (FDA) data dump reveals.

In other instances, participants ended their participation in the trial over seemingly minor adverse events, such as injection site pain, without any further explanation provided in the documentation about other factors that may have been at play in the decision to withdraw.

A greater proportion of these minor adverse events were determined to be ‘related’ to the vaccination, as compared to the instances of serious adverse events, which usually were deemed ‘not related’ to the vaccine.

The document cache also reveals a large number of trial participants who contracted covid-19 during the trial period, and a notable revelation regarding the covid-19 vaccine and pregnant women.

The documents were released on July 1 as part of a court-ordered disclosure schedule stemming from an expedited Freedom of Information Act (FOIA) request filed in August 2021.

Public Health and Medical Professionals for Transparency, a group of doctors and public health professionals, submitted the initial FOIA request.

In several instances, the participation of subjects in the vaccine trial ceased following the onset of new medical conditions that did not correspond with anything in their medical history. Nevertheless, study investigators determined these adverse events were not related to the vaccine



The next 80,000-page cache of FDA documents pertaining to the FDA’s authorization of the vaccine is set to be released on August 1.

A total of 34 withdrawals are detailed in a massive 3,611-page ‘confidential’ document with no title — only the file name ‘fa_interim_narrative_sensitive.’

All participants listed in the document received the 30 µg dose of the BNT162b2 candidate vaccine, which was the one ultimately issued an Emergency Use Authorisation by the FDA.

Of these 34 withdrawals, four can be identified as being the result of seemingly serious adverse events that were also classified as “related” to the vaccination.

They include:

- A 56-year-old white female in the U.S. who was vaccinated with her first dose on August 11, 2020, and discontinued from the study the following day due to generalised pruritus (nerve disorder) and tachycardia (heart-rate issue). She

had no ongoing health conditions listed, nor any medical history involving heart conditions. According to the study investigator, “there was a reasonable possibility that the pruritus and tachycardia were related to the study intervention.”

- A 61-year-old Hispanic/Latino female from the U.S. received her first dose of the vaccine on September 25, 2020, but subsequently experienced unilateral deafness on October 14, 2020, and was withdrawn from the trial the following day. Her condition lasted until October 23, 2020. Again, there was a ‘reasonable possibility’ the problem was related to the study.
- A 71-year-old white male from the U.S. who was vaccinated on October 28, 2020, but withdrawn from the trial the following day “because of worsening of the depression that was ongoing at the time of the last available report”.
- A 36-year-old white female from

the U.S. who was vaccinated on August 26, 2020, and in the days immediately following, experienced adverse events such as chest tightness, worsening headache, pain at the injection site and left arm pain, leading to her discontinuation from the trial on August 30.

Notably, all four of these instances came from participants based in the U.S., even though the 3,611-page document also contains participant data from trials in Argentina, Brazil and South Africa - with Argentina being home to the largest Pfizer vaccine trials in 2020.

In several instances, the participation of subjects in the vaccine trial ceased following the onset of new medical conditions that did not correspond with anything in their medical history. But study investigators determined these adverse events were ‘not related’ to the vaccine.

A separate document providing a broader picture of trial withdrawals

is 16.2.1.1 Listing of Subjects Discontinued From Vaccination and/or From the Study – All Subjects ≥16 Years of Age, which contains a 232-page list that was part of July’s document dump, and which appears to list all patients who withdrew from the trial, as well as the date and reason of their discontinuation.

On average, approximately ten to eleven patients per page are listed in this document as having withdrawn from the trial.

Pages 1,059 to 3,611 of the ‘fa_interim_narrative_sensitive’ document list a long series of trial participants who were diagnosed with covid-19 during the trial period, with the records for each patient averaging eight to nine pages in total length.

The list includes participants in the placebo group.

In one example, a 51-year-old white female from the U.S. received her two doses of the vaccine on July 29 and August 19, 2020. On October 17, 2020, she reported a “loss of taste or smell” and “new or increased sore throat”. She tested positive for covid-19 following a nasal swab test.

This high number of covid-19 cases among trial participants is further confirmed by a separate 430-page document listing trial participants who tested positive for covid-19 following either the first or second dose of the vaccine.

Overall, an average of three to nine patients per page is listed in this particular document, and although a majority of the listed covid-19 cases are in the placebo group, there are approximately 215 trial participants who received the candidate vaccine and who later tested positive for covid-19.

Questions therefore arise as to whether the study was conducted in such a way that placebo recipients were more likely to be tested for covid-19 at the first sign of relevant symptoms, as compared to participants in the vaccine group, for whom similar symptoms may have been attributed to other causes.

When your bank fails, don't walk... run!

Financial sleight of hand puts savers in firing line

AS a new recession spirals into an economic depression, central banks have a Hobson's choice: stop rapidly rising core consumer inflation, or stop national economic production deflation.

The Bank of England cannot do both, and, like the U.S. Federal Reserve, it lacks the economic tools to deal effectively with either.

The British bank depositor is very much at risk.

The UK pound hit historic lows in value this month, and all major banks are suddenly predicting doom. Bank depositors would do well to comprehend several inconvenient truths, the first being that depositors, when demanding their money, are not first in line. Nor second.

Since you are tertiary in this vital financial relationship, when your bank fails... don't walk, run!

Since 2008, too-big-to-fail banks have consolidated to become much greater in size and power than ever. They are financial and political powerhouses controlling world economies to their advantage.

Normally in any managed court-ordered business liquidation, such as before the bankruptcy of Lehman Bros in 2008, or Spain's Bankia in 2013, a bank's secured creditors - such as its depositors - are paid off first because theirs are hard assets when first deposited, not investments or speculation.

These secured creditors normally had legal priority during liquidation. However, under the new 'bail-in' definition, your cash deposit is now unsecured, with derivatives and other similar high-risk banking adventures to be paid

before the depositor's savings, if any.

Today, worldwide exposure in derivatives by banks and financial houses has dramatically ballooned to more than a quadrillion dollars distributed over virtually all other financial sectors. In 2008, it was only the housing sector.

UK banks are currently required to hold a reserve of 18 per cent of cash deposits. But this reserve is not applied to derivatives. Currently, UK banks hold trillions in derivative exposure. What this means for cash depositors is that all of these derivatives will be paid off first, using your savings, and your savings are now legally last in the minds of the banks.

With U.S. and UK banks holding \$7 trillion and \$1.4 trillion respectively in personal cash savings deposits, the U.S. Federal Deposit Insurance Corporation's (FDIC) total war chest of \$25bn will not be quite enough.

The latest Bank of England (BoE) data shows total gross derivatives assets and liabilities at £5.17 trillion - a one per cent jump this year. In the U.S., it's \$200 trillion plus. The Prudential Regulatory Authority (PRA) in the UK is underwritten by the Bank of England (which is similarly cash-strapped), well below this legal necessity to aid this newly defined bail-in.

The creators of the Dodd-Frank Wall Street Reform and Consumer Protection Act knew they were shifting this burden to the depositors before the Act was signed in 2010.

As John Butler points out in an April 4, 2012 review in Financial Sense: "do you see the sleight-of-hand at work here? Under the guise of protecting taxpayers, depositors... are to be arbitrary, subordinated... when in fact they are legally senior to those claims."

Millions across the world who had lost their homes, pension funds, retirement plans - and dreams - watched helplessly as the bail-outs did not trickle down from the "too-big-to-fail" (TBTF) banks to their dinner tables or petrol tanks. Regarding new bail-ins, however, in 2010, the previously bailed-out TBTF banks were also provided with a new, more hopeful definition: Globally Active, Systemically Important, Financial Institutions (G-SIFI).

By redefining bail-outs to bail-ins, Dodd-Frank gives new powers to the FDIC, and by extension, the PRA, that allows for an even more draconian resolution: any deposited funds in a bank can, in lieu of a cash payback, be returned to the depositor in the form of bank stock.

An April 24, 2012, International Monetary Fund report also supported the conversion of bank deposits to stock using bail-ins.

Such was the case post-2008 in Cyprus, Greece and Spain. For affected depositors, to retrieve the remaining cash value of what was formerly their cash account balance, the stock provided to them had to eventually be sold.

When Lehman Brothers failed, unsecured depositors eventually received only eight cents on the dollar. Over a million Bankia customers in Spain, who were forced by decree to become stockholders, were paid just five per cent when finally selling their stock.

Like Britain, America and most of the western EU nations, China now suffers from the conclusion of an economy based only on debt. On April 18, over 400,000 depositors of five regional banks in China's Henan province were prohibited from making withdrawals. Despite the massive outrage the Chinese authorities did little except to promise a

maximum paltry bail-out of 50,000 Yuan (US \$ 7,445).

However, this week, China mobilised its military to protect these same banks from public outrage, after the CCP suddenly announced that the depositors' remaining funds will now be repaid... with stock!

As the pound collapses, lay-offs begin anew, fuel reaches historic highs and with winter on the way, the bank depositor would do well to heed two other vital financial truths that the Chinese now consider self-evident. Never trust a banker, and...

when your bank fails, don't walk... run!

Earth is cooling, not warming

As most of you will have heard, 97% of scientists believe global warming is real and that humans have played a part.

Furthermore, the UN's special panel of scientists believes most of the warming since 1950 is man-made. All the world's science institutions have gone along with this UN opinion.

And nearly all governments worldwide have made significant investments in carbon emission reductions and renewable energy supplies - so contrary to Greta Thunberg's uninformed opinion, much has been done.

In fact, vast sums of money are moving around in carbon credits, offsets, wind turbines, hydro-schemes, biofuel plantations, solar farms and the scary carbon story has rejuvenated the nuclear industry.

Here are some facts:

1. Global warming of Earth's surface effectively stopped twenty years ago. Two big El Nino (ENSO) events, where warmth is released from the ocean, bumped up the surface figures for 2016 and 2020 – by as much as 0.6° C of the 'record' 1.2° C – otherwise, the 21st century saw no increasing surface trend.

2. It is argued that internally, the oceans continued to warm as excess heat was drawn down, hence global warming did not stop – but this is exactly what natural cycles do – they bury heat at depth and release it later.

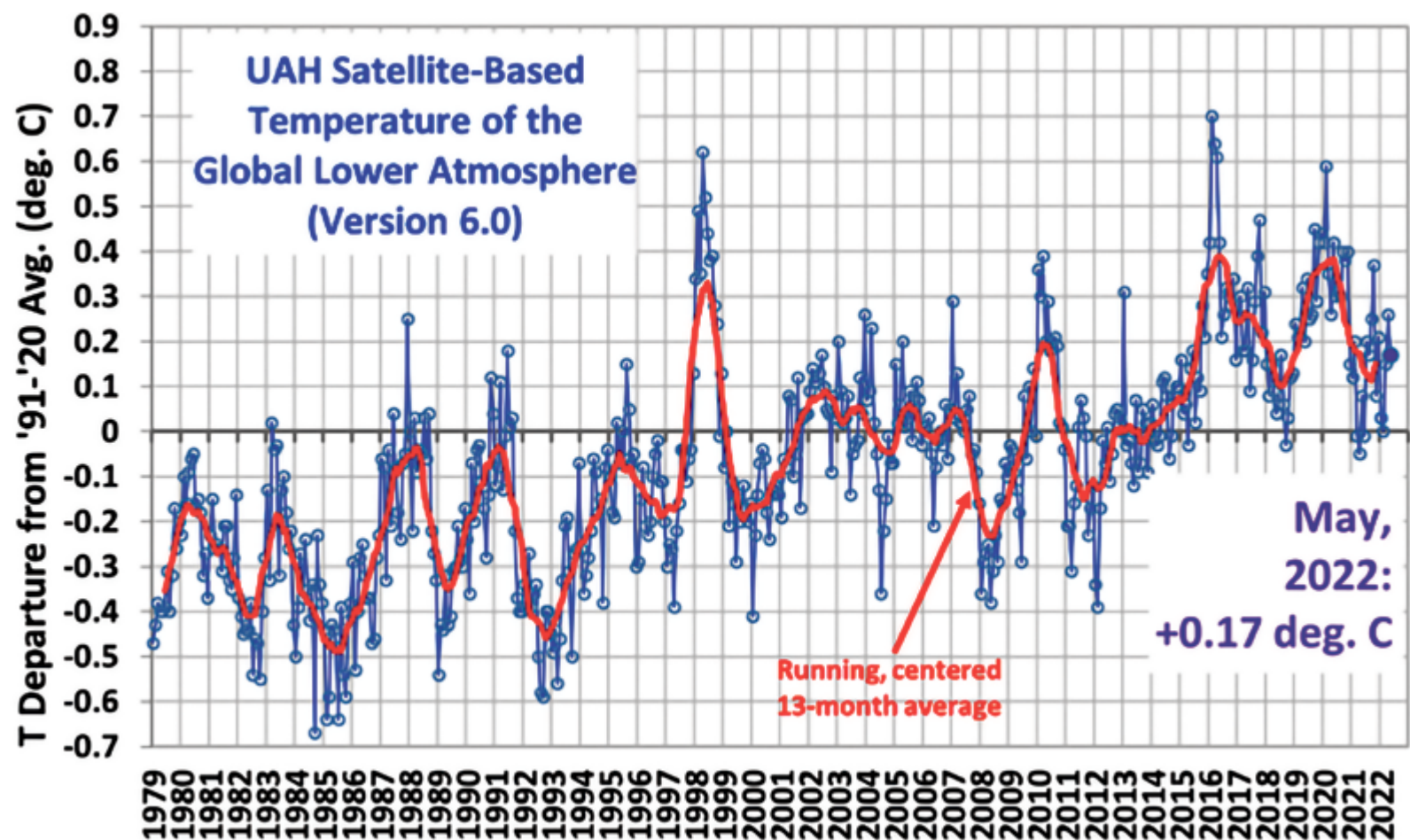
3. The globe has cooled since 2016 peak – see the graphic derived from atmospheric measurements by satellite - the only data set I trust not to have been 'adjusted'.

4. Prior to 1950, even the Intergovernmental Panel on Climate Change's models show insignificant contributions to warming from carbon dioxide – the main increase of which was post-1950.

5. If one compares a major warming from 1920-1945 with 1975-2000, there is no difference in the rate and magnitude of the warming during both periods (and there was no warming from 1945-1975 – in fact a slight cooling to 1962, despite the rise in carbon dioxide).

6. If we look at proxies for temperature in the heat content of the oceans or the retreat of glaciers, then global warming started in 1850, and the current magnitude lies between 0.8° and 1° C, up since pre-industrial times (the 2016 ENSO event caused a brief excursion to 1.2° C, and this

figure is often quoted despite its mostly natural causation).

7. The current magnitude and rate of warming is not unprecedented (as often claimed by the MSM) – it is normal territory for the interplay of the two cycles of 60 years and 1,000 years, and the latter has been consistent for the past 6,000 years. Around 8,000 years ago, the northern hemisphere was 2° C warmer than present, the Arctic Ocean was ice-free in summer, and pelicans nested on the Somerset Levels. The last high point in the cycle saw white storks nest on Edinburgh cathedral, and the Vikings farming in Greenland.

Lay people and even some scientists with their limited specialism will argue: "but surely CO₂ is a greenhouse gas – it must be the main cause?" Of course, CO₂ is a greenhouse gas – but increasing concentration (by 50 per cent since the end of the ice-age) is not the relevant metric, as the power to heat diminishes above 300 parts

per million (the level in 1900) and tails off above 400 (the level now). This power is measured in watts per square metre of the Earth's surface. The whole of global warming has added about two watts to the natural surface flux of 240 watts – that is about 1% and not as scary as a 50% figure, and so small it can hardly be measured above natural variability.

So – what is happening with scientists? They have been misled by a few fanatical 'warmists' who furthered their careers with flawed models with unproven feedbacks that predicted two to three degrees of warming. They were abetted by the mainstream media and the funding influence of organisations (headed by Bill Gates and Al Gore) driving a well-oiled media propaganda machine.

However, it does not help matters, in my opinion, to call this a hoax or a 'scam'. For two reasons: first and foremost, there are dozens of conscientious climate scientists

working to reform the system against great odds, and whose voices are shut out; and second, we need to understand the nature of the corruption – in particular, the abuse of power in institutions, the suppression of dissent, and the influence of vested interests and funding streams.

But a little more on future cooling. The 1,000-year cycle is at its peak and will turn downward – indeed, there are indications it has already begun to do so. This is not a quick nor easily predictable process. Many scientists think that solar magnetism and UV radiation are the key variables that drive the long cycle.

The sun's energy is now declining, with each 11-year sunspot peak being lower than the preceding one. This may indicate cooling, but normally the system drops in steps, and the next low point will take about 300 years, when a new 'Little Ice Age' will prevail.

However, it is not temperature that is the most concerning change – rather it is wind direction, and with that, rainfall patterns. All major empires crashed in the low parts of the cycle – the 'dark ages' marked by famine and mass migrations. During such low periods, human society deteriorated in all its cultural aspects, with invasive vandalism often destroying the previous glories of an empire.

I estimate CO₂ may be responsible for, at most, 25% of observed warming. Ironically, if carbon dioxide has the heating role ascribed to it by the politically constructed false consensus, it could not only save us from a Little Ice Age – we are likely facing descent into a full ice age (which would take 3,000 years) – CO₂ could prevent that.

Artificial intelligence to bring about dystopia

Build unconnected devices to avoid losing our free will

THE term AI, being the short form for Artificial Intelligence, was first coined in 1956 by John McCarthy, a computer scientist at Stanford University. The concept has been widely popularised by many movies ever since, including *The Matrix* and Steven Spielberg's *AI*.

Artificial intelligence represents the vision that machines will one day become intelligent and be capable of thinking for themselves. Moreover, it is the foundation on which the latest craze for technological utopia is to rest.

I was about twelve years old when I became enthralled by the idea of a 'thinking machine', and it was a fascination which drew me into computers and programming. You see, the portrayal of AI in the science fiction of my youth was generally a positive one. As the years went by, however, my enthusiasm for it waned. In its place, despite some apparent technological advances, there grew a feeling of vague disappointment - as if my heart could sense there was something wrong, but my mind could not quite put a finger on what it was.

Today, I think I know what it is - the modern realisation of AI bears no resemblance to the dreams I once held for it on so many levels.

For one, the AI with which we are familiar today is nothing of the sort - it does not represent intelligence or any meaningful form of artificial thinking or consciousness. It is merely clever programming, or let's call it algorithmic engineering. In itself, there is nothing wrong with clever programming. In fact, it could be a fascinating area, provided we are clear on what we are dealing with and its limitations.

For another, the fictional depictions of AI which so captivated me in childhood generally had one thing in common that is absent today — virtually every sci-fi robot (such as R2D2 from *Star Wars*) or spaceship computer (such as HAL 9000 from the movie *2001: A Space Odyssey*) was a unique, independent and autonomous agent which made

its own decisions. In other words, these were depictions of machines which arguably had minds of their own. Indeed, that was what I once understood to be the very point of artificial intelligence, but now regard the terms 'mind' and 'machine' to be mutually exclusive.

Today's so-called AI, however, appears to be overwhelmingly centralised in its implementation. When you speak to Alexa, for example, it has no uniqueness or anything which can be described as personality. It doesn't even process what you say to it. It is nothing more than a dumb terminal which transmits your words to a centralised mainframe (or more precisely a corporate 'cloud' of computers) controlled by Amazon. The same goes for Apple's Siri.

Above all else, however, I find that I can no longer endorse or condone how AI is being applied against people. This is not even AI after all! It is merely the automation and leveraging of information for purposes of wealth extraction, centralisation and control.

The reason I claim that AI does not represent any kind of true intelligence is rather profound, and involves such things as uncertainty, information and free will. These were not things I understood years back, at least beyond the everyday usage of the words. However, I now feel they are important, as they represent the seeds of destruction for the dreams of technological utopia, or, more accurately, a dystopia.

The very definition of a machine is that which transforms energy from one form to another - but it does not generate it out of nowhere. Likewise, computers transform information from one form to another, but they do not generate it. They merely reflect back information they get from elsewhere in a different form.

Minds are things which possess free will, whereas deterministic, rules-based machines do not. Human minds, like others in the animal kingdom, are not fundamentally deterministic or algorithmic in nature, but tap into uncertainty at the nano level.

In an entirely digital world, however, you lose something which hardly seems to matter at first, but it really does - the ability to bring into existence new information.

Living things, among which I would include human societies, as they form out of our interactions with each other, cannot grow in isolation, but must interact with and exchange information with other autonomous members in order to thrive. If you place human beings in solitary confinement, for example, they degenerate both mentally and physically over time. Likewise, without the ability to generate new information, a so-called utopian society will not be able to sustain itself, but will become hollowed out and brittle. Unable to innovate and adapt to change, things will simply fall apart, as entropy increases in what is essentially a closed system of strict determinism.

In short, I do not believe that either surveillance capitalism or the technological utopia of the World Economic Forum have any sustainable future, but will collapse in an implosion of nothingness. This gives cause for hope, at least in the long-term, as new shoots will then be able to emerge.

I believe that we should build a free-market business case for independent and unconnected devices, along with private computer networks with well-defined boundaries to the outside world.

Excess deaths continue to rise in Scotland: government ignores covid shots as cause

Professor claims data shows clear link and calls for public inquiry

A DRAMATIC and unexplained resurgence in excess deaths in Scotland points to the covid-19 injections, it is being claimed.

Retired Edinburgh professor Richard Ennos says official data for 2021 and 2022 “provide very strong evidence for a causal relationship” between the vaccinations and a large number of excess deaths in the country.

Prof. Ennos has written to Siobhian Brown MSP, convener of the Scottish government’s covid-19 recovery committee, calling on her to reopen a public inquiry into the deaths, which can only be partially explained by the virus.

Earlier this year, the committee investigated the cause of an unprecedented level of excess death recorded in Scotland from week 21 to week 52 of 2021.

Numbering 4,819, it was 12% above the average - the worst ever recorded.

Recorded deaths so far in 2022 are heading in the same direction, and Prof. Ennos suggests they are now a consequence of the booster jab.

In a recent letter to Ms Brown, on July 12, he also expressed his concern that the public inquiry earlier this year into the 2021 excess death figures failed to make any mention of the injections as a potential cause.

He states that of 103 public submissions to the inquiry, more than a third pointed to the jabs as a possible reason for the inflated loss of lives.

He tells Ms Brown, “in your report to Humza Yousaf, Cabinet Secretary for Health and Social Care, there was not a single mention of adverse reactions to covid-19 vaccines as a possible cause of the excess deaths seen in Scotland in 2021.

“This was despite the fact that a number of respondents provided detailed information from peer-reviewed scientific papers, showing that death is a known

adverse reaction to the covid-19 shots, and that a variety of mechanisms of action have been established (induction of blood clots, myocarditis etc.).

“Post mortems have also confirmed that covid-19 injections can cause the death of recipients, and this is acknowledged by the UK government who have already paid compensation to multiple families of those who have died as a consequence of covid-19

vaccination.

“Your lack of any reference to covid-19 vaccine adverse reactions as a contributor to excess death in Scotland in 2021 is even more concerning because recent detailed analysis of National Records of Scotland data now suggests a causal relationship between excess death in Scotland and covid-19 vaccinations.”

Prof. Ennos states that the argument leading to this conclusion begins with the observation that in the last 32 weeks of 2021, excess death began in different age classes of the Scottish population in a staggered manner, approximately 12 weeks after peak vaccination of that age class.

Beginning with the oldest, this pattern was repeated as the jabs rollout continued down through ever-younger age groups.

He suggests there can only be two reasons put forward for the extra deaths: it was the injections, or it was a lack of medical care caused either by withdrawal of NHS services, or by patients’ failure to access these services, with both being “consequences of the Scottish government response to covid-19”.

However, he says, there was no consistent rise in excess deaths to point to delayed medical care as a result of long waiting lists.

Instead, what National Records of Scotland data reveal, says Prof. Ennos, is a second staggering of excess deaths following the booster (third dose) jab – with 2022 mirroring the pattern of 2021 whereby age group deaths occurred approximately 12 weeks after peak administration of the vaccine.

He states that the sequential manner “predicted by the adverse reaction hypothesis... provides very strong evidence for a causal relationship between covid-19 vaccination and excess death”.

At the time of writing his letter, the cumulative excess deaths in Scotland in 2022 were

1,669.

Prof. Ennos’s letter concludes: “The National Records of Scotland data do not support the statement you made to Humza Yousaf on April 28, 2022, that ‘the excess deaths have decreased and, at the date of this letter, are below average for the time of year’.

“On the contrary, the excess death situation in Scotland in 2022 is turning out to be as serious as it was in 2021.

“Given this body of evidence, I would like you to explain to me why, in your report to Humza Yousaf, you made absolutely no mention of the possibility that adverse reactions to the covid-19 vaccine were responsible for at least a portion of the excess deaths seen in Scotland in 2021.

“I also call upon you to reopen the inquiry into excess deaths in Scotland, given the resurgence of excess deaths in 2022 (552 in the past four weeks alone), but this time taking into consideration that adverse reactions to the covid-19 vaccine may be a significant contributor to these excess deaths.”

In response to the questions raised by Prof. Ennos’s letter, a Scottish parliament spokesman stated: “The committee’s inquiry into excess deaths in Scotland since the start of the pandemic has now concluded. All the evidence it considered, including the Scottish Government’s response to the committee’s findings is available on the parliament’s website.”

Prof. Ennos said: ‘I am dismayed at this totally inadequate and evasive response from the Scottish government. It is not good enough. Lives are at stake, yet pertinent questions arising from official data are simply being dismissed. Where is the much-vaunted concern for public health we have had hammered at us for the past two and a half years?’

Hypocrite Hancock

CAMPAIGNER and former model Tony Stowell was stunned when he managed to get a face-to-face meeting with Matt Hancock in October 2020.

Family man Tony, 54, says: "I'd been campaigning to get CCTV cameras into care homes since 2016, and when my mother Antonia died that May after being horribly neglected in a care home, I stepped it up a notch and wrote to Matt Hancock to discuss the possibility of getting Antonia's Law legislated."

At that time, Hancock was appearing on TV almost daily, encouraging people to wear masks, socially distance and scrub their hands. Tony, from East Yorkshire, knew that when he visited Hancock's office in Suffolk, he'd have to comply with these measures. "I didn't mind," he says. "If sticking to the rules was all I had to do to see Hancock one-on-one, I was more than happy to comply."

On the day of the meeting, Tony - whose work has included modelling as a Tom Cruise lookalike - brought his lawyer Fadi Farhat (from the Gulbenkian Andonian firm of solicitors) with him to answer any of Hancock's questions about legalities.

They both donned black cotton face masks. "I wasn't feeling that great - I was still recovering from a stroke I'd suffered in July, brought about by the stress and upset over what had happened to my mum," says Tony, who's since discovered he had a hole in his heart and underwent major heart surgery in September last year.

"But I put on the mask nonetheless. I knew Matt would be wearing one, so I didn't want to get off on the wrong foot by going in with my face on full display. I didn't want him to think I was the type who'd flout the rules."

When the pair arrived at Hancock's office, they were told by his PA to go back and wait in the car. "I noticed she wasn't wearing a mask, but I didn't think to question it. I just presumed she was exempt," says Tony.

When they eventually entered the building, the PA made sure they used hand sanitiser, maintained social distancing and that their face masks were firmly in place.

When she opened the office door and ushered them in, following closely behind, they were met with an unexpected sight. "As we entered the office, I couldn't believe what I saw," exclaims dad-of-two Tony. "I was expecting Hancock to be sitting on the far side of the room, behind a desk, in full PPE - or wearing a mask or visor at the least - but he wasn't."

Hancock walked over to Tony and guided him to one of three chairs that had been positioned to the side of his desk. "He greeted me like an old school friend," Tony claims. "We sat down and Matt pulled his chair right up close to mine. Then he looked me straight in the eyes and said, 'Take the mask off, Tony.' I was gobsmacked. There he was, maskless himself - this man who'd been instructing the whole country on a daily basis to keep their faces covered, pretty much at all times, ordering me to take mine off. He clearly wasn't worried about catching or spreading anything."

Tony says he looked at his lawyer, then back at Hancock. "I asked him was he sure and he nodded. So Fadi and I took off our masks. I put mine around my wrist. Hancock then said, 'That's better. I can see you now.' It was all very strange."

Throughout the meeting, Hancock continued to sit close. "At one point, he was so close, I could almost feel his breath on my face," Tony recounts. "It was odd but the way he behaved actually made me feel very comfortable, like I was talking to a friend. When I was telling him about my mum, I got a bit choked up, and Matt actually got a tear in his eye. He's a good actor."

The meeting appeared to go well. Hancock said he would back Tony 100 per cent and that he was certain he'd be able to help getting

Antonia's Law passed.

When the meeting was over, Hancock suggested taking some photos. "The PA got up and I handed her my phone," Tony remembers. "Matt went to shake my hand for the photo, then suddenly said. 'Ooh, we'd better not do that if we're being photographed!' Then he laughed and went in for an elbow bump."

Three photos were taken. In one, Tony's mask is clearly visible pushed up around his right elbow.

Tony and the lawyer left in a state of confusion. "We were pleased we'd had the meeting, but alarmed by the utter hypocrisy of Hancock. He wasn't worried about the rules - or the virus - in the slightest, and made me realise there was actually nothing to worry about. His behaviour told me loud and clear that either the virus wasn't as bad as the government was making out or - God forbid - that there wasn't a virus at all."

Despite Hancock's promise of support, shortly after the meeting he was 'let go' from his position as Health Secretary after he was found canoodling with his alleged lover. Tony hasn't heard from him since.

Schoolchildren in Wales to eat insect-based protein in workshops

INNOCENT children from Wales are taking part in an experiment to highlight the benefits of an insect-based diet and of climate sustainability. This pilot study evidently aligns with the aims of Agenda 2030. How to keep Britain's lights on

Energy policy should pull away from renewables

IT was on April 7 that the government gave a road map for future energy policy.

This announcement recognised the inadequacy of past direction and the need to avoid dependence on foreign sources of oil and gas.

It was also recognised that electricity supplies are dependent on gas and future investment should not just exploit our indigenous resources, but use them more efficiently.

However, the detail of future direction exposes other questions such as how this would be paid for, especially with the sudden steep rise of fuel bills and the inflation it brings. Although certain measures were announced, these are insufficient for the scale of commitment for what lies ahead.

More questions arise such as why is there a focus on concentrating all household services upon electrical supply. This is no idle question, as for more than two decades, the focus has been on intermittent renewables. This has enfeebled traditional utilities and conventional manufacturing capacity across Europe. Another, more critical issue has seen increasing fragility within our confined grid system - lack of investment has made us reliant at peak periods on the continental grid system.

The rapidly increasing costs of grid accommodation, around £2bn annually, are a powerful indication of this problem, not helped by

Shortfalls in generation from renewable sources have always been backed up, mainly from gas turbines. Connecting a car or heat pump would, for most of the time, have this extra power demand supplied by gas

uncertainty with the role of National Grid. Only recently has intent been clarified, with a new Electricity System Operator (ESO) being formed for both balancing the grid system and system planning, and having operational independence from government.

These measures would not satisfy everyone, given the short timescale forced by the new realities. The commitment for nuclear power has become essential within the new geo-political conditions. What may be questioned is the wisdom to pursue more renewable investment, especially for onshore wind and solar, given the precarious state of the GB grid system. It would take several

years to produce this power, by which time other sources of indigenous gas would have become available. Meanwhile, committed projects would have been completed.

Producing more from renewable sources only increases the risk for constraint payments having to be made. Either that or forced selling of surplus power at knockdown prices via continental interconnections. Until a hydrogen economy can be established, forging ahead with further renewables would be unwise.

An immediate announcement to curtail future renewable investment would allow significant cost savings to be made, providing relief for consumers. This would enable a more

studied direction of future investment to be made by the newly formed ESO. It should be noted that costs of supply in the renewable sector have risen by almost 30% over the past year.

Past decisions were made by politicians setting targets, the new arrangements would allow time for more technical issues to be addressed. Due caution should always accompany longer term investment as market conditions can vary widely over time. Recent supply constraints, notably with wind resource, are having a decisive effect on generation technologies, stimulated by bullish intent from the net zero programme. The existing portfolio of gas turbines would benefit significantly from improved efficiency were they to be replaced.

A radical alternative recently promoted by the Global Warming Policy Forum (GWPF) with a paper entitled 'Taking Back Control' outlines clear proposals that provide a new direction. It would only take a serious grid incident to introduce a further new reality above one we have just experienced. Essentially, the paper suggests a return to conventional practice as continued renewable direction would only feed more insecurity onto the GB grid system. Diversification is emphasised, as is efficiency and reliability, enabling security to reassert its dominant aim as a basis for lowering costs. These are technical issues, having been lost in the decisions made by civil servants

and accountants.

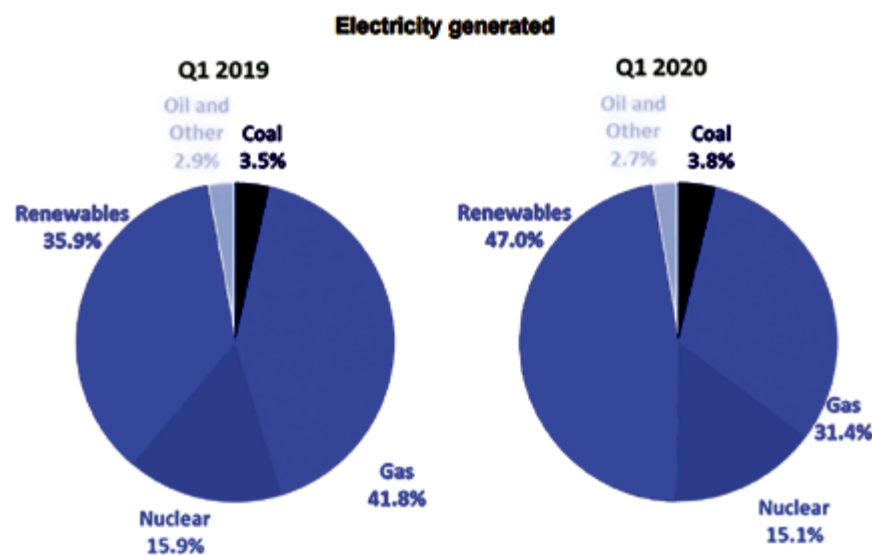
Further reforms would provide efficiencies by eliminating subsidies and requiring renewable sources to meet their own balancing costs. This would constrain their output towards being dispatchable, thereby avoiding constraint payments. Subsidies are a state-imposed charge that should properly be funded through general taxation to allow parliamentary scrutiny. Avoiding further onshore projects would also curtail transmission infrastructure. These measures provide significant savings for the consumer that could be implemented on an early timescale, the savings also being reflected upon all the products and services throughout the economy.

At the end of 2021, the government announced a further £285 million of subsidies for renewable energy sources. £200 million is for offshore wind farms, £10 million is for onshore wind and solar projects, and the remaining £75 million will be spent on more inefficient and expensive 'emerging technologies' which are never likely to add much to the energy mix, but will certainly add to everyone's energy bills.

Subsidy inevitably breeds inefficiency, especially over time, and twenty years have now passed to see bills treble in cost, and that is before the recent electricity price increases. Decisive reform is long overdue, and it should have happened on leaving the EU.

Patriotic own goal over Jubilee book

Deadline missed and £12m contracts sent abroad

The Department for Education (DfE) spent £12m on producing books celebrating the Queen's platinum jubilee, yet failed to source a British printing company or even distribute them on time.

While 4.3 million children live in poverty in the UK, it was pledged that vast amounts of public funds would be spent on producing the books. At almost a hundred pages in length and retailing for £9.99, it is pitched at an average reading level of nine to ten years. Despite this, it is being given to all state-educated primary school children in England as young as four.

Around 38% of children in London live in poverty and free meals for those living beneath the breadline are debated in Parliament. While parents are being asked to pay for exercise books and children are unable to attend school trips due to the rising cost of coach travel, the DfE has squandered £12m on the promotion of the monarchy. Furthermore, the DfE failed to ride the wave of public interest and provide the 4.5 million books to children in time for the national celebrations.

Though the tender was put out in September last year, the books were delivered late to most schools, and some still await them. The public holiday for the Jubilee passed several weeks ago on June 3, however, many state schools finished for the long summer break in the week commencing July 18. Whether or not all eligible children received the book in time is unconfirmed.

After the Welsh government complained it was too Anglocentric, the decision was made that children in Scotland and Wales would be given the book based on their school opting in. Initially touted to be sent to schools in May, the



project has failed to deliver on schedule, with new announcements made in June and July advising that the books may arrive in multiple deliveries.

Ironically, the patriotic books were mostly printed abroad. The British publisher, DK, was unable to find a printing house to fulfil the vast quantity required. Three of the sub-contractors were based in Italy, with the fourth being in Glasgow. This echoes the 2018 fiasco when a French company won the bid to print Britain's new blue post-Brexit passports.

The same amount that the books cost to produce was spent by the government on a scheme to help protect vulnerable children at risk of neglect, violence, and exploitation during the alleged pandemic.

As children are left behind by the huge gaps in their education due to the problems created by lockdowns and covid rules, the government continues to misspend budgets instead of rectifying these wrongs amidst a cost-of-living crisis.

The diversity of characters within the book doesn't make up for the glossing over of our nation's history or even current-day events. An entire chapter is devoted to charity and care, with the protagonist of the story, Isabella, mentioning how seeing the work of doctors and nurses during the pandemic has made her want to help others too. This

blurring of charity with the work of the NHS - paid for by the public through taxation - is dangerous and misleading. Even the glossary includes a description of a pandemic as well as covid-19, and claims it is ongoing.

Accounts for the Sovereign Grant show the monarchy cost the British taxpayer £102.4m in 2021-22, which is a 17% increase on the previous year. Even the most ardent royalist has been suspicious of the use of public funds since Prince Andrew paid off his accuser, Virginia Giuffrè, a reported £12m and avoided legal scrutiny over his alleged sexual abuse of underage girls. However, a report from the BBC on March 8 this year claimed that a statement from the Treasury, in response to a Freedom of Information request, ruled out any public funding being used to pay legal or settlement fees.

Despite their unelected status, the Queen and Prince Charles have vetted more than a thousand bills since the beginning of her reign. It was revealed by *The Guardian* last year that the Queen and Prince Charles have prevented numerous bills from being debated in Parliament if they are deemed to affect her personally.

This includes a transparency law which enabled her to conceal her private wealth. Other proposed laws covered subjects such as pensions and race relations. None of these royal privileges are covered within the pages of the royal book.

Schools in Southampton give out 'goody bags' encouraging children to get covid shots

According to the GAVI website:

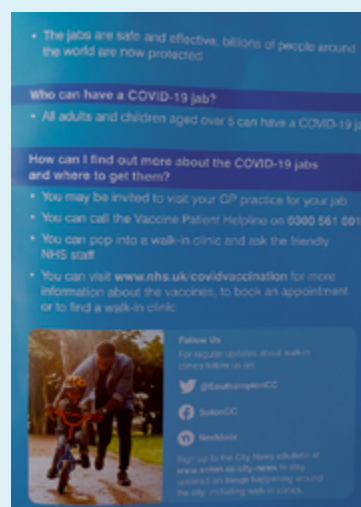

Should we own nothing and be happy? Schwab thinks so!

Technocracy
- trusting big government to make the big decisions

TO quote Klaus Schwab in the final paragraph of his book, COVID-19: The Great Reset: "We are now at a crossroads. One path will take us to a better world: more inclusive, more equitable and more respectful of mother nature. The other will take us to a world that resembles the one we left behind - but worse."

In my previous article, I gave an overview of what economics is and the fundamental economic problem of infinite wants and needs, but limited resources. This dilemma causes us to make choices with the resources we have. These choices are what to produce, how to produce and whom to produce for.

The resources that we have at our disposal are categorised as the factors of production; these are natural, human and man-made resources. When managing an economy, the first decision we need to make is: who should own these factors of production?

In this article, we will investigate the idea of a technocracy, which is a way of managing the economy that the World Economic Forum is so keen to push and is described, but not named, in Klaus Swab's book. So, what is a technocracy? And why do they think we need it so badly?

The majority of the population agrees that there are some deeply concerning problems with our current economic system. These include the increasing inequality, destruction of the environment, biodiversity loss and rising inflation across the world.

To understand how to fix these problems we must first discuss what the causes of these problems are. This brings us to the idea of the economic agents; the households, businesses and governments within the economy.

To model the economy, we need

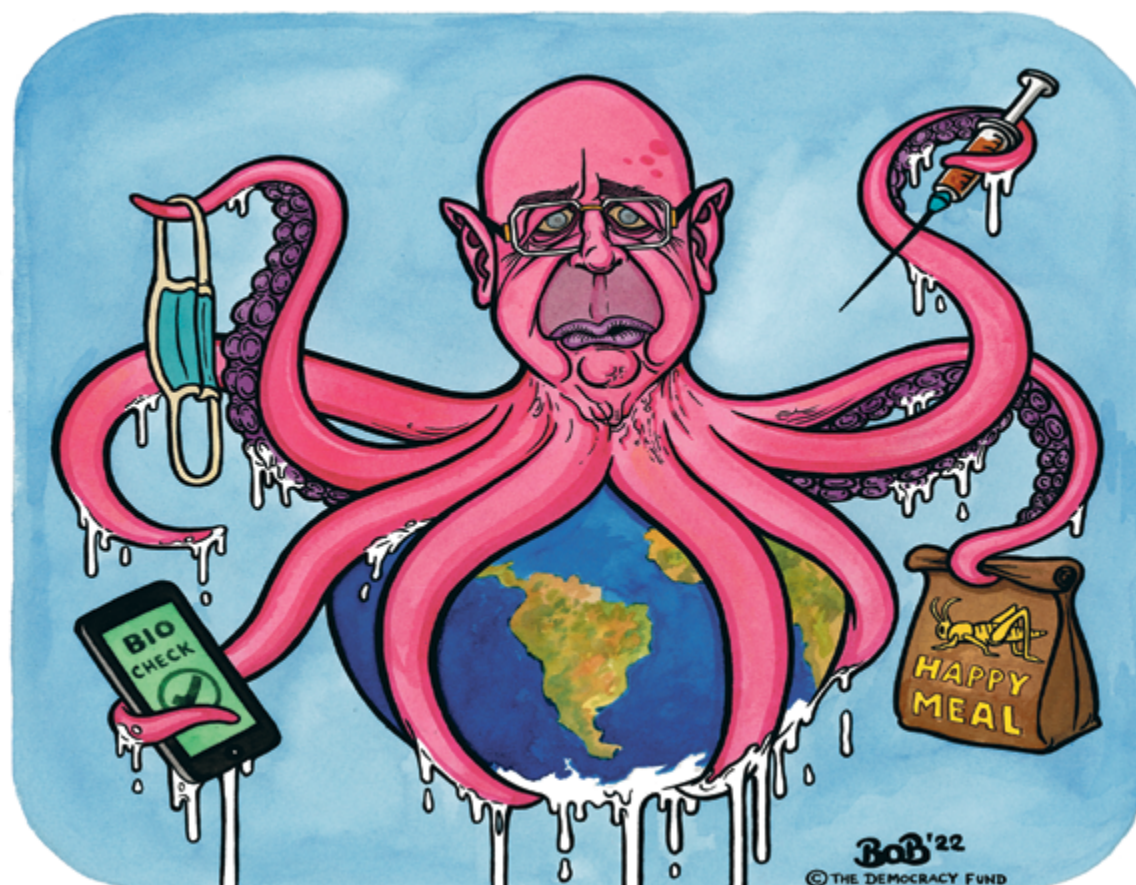
to make some assumptions on how they act. We assume that households will maximise their benefits, businesses will maximise their profit and governments will maximise the welfare of their citizens. This is how the neo-classical mixed economy is supposed to play out, with the households and businesses playing nicely together under the watchful eye of the government, who ensures that no one is being exploited and the environment is protected.

One of the biggest changes in economics in recent years is the idea of irrational behaviour. When Adam Smith first modelled the economy, he assumed that consumers were perfectly rational. They would always make choices that would be the best for themselves and society. They would not be influenced by others, would have perfect information about the products they buy and their impact on the environment. Businesses were also assumed to behave ethically; if they didn't then consumers would find out and stop buying their products which means that they would lose profit.

Behavioural economists predictably found out that consumers were not as rational as hoped and continuous scandals involving big businesses shows that we keep buying products from companies despite their unethical behaviour.

With these assumptions, it is the irrational behaviour of households and the unethical behaviour of businesses that have created the problems of the world. The destruction of the environment is caused by our irrational behaviour and we are to blame for the inequality as households like to buy the cheapest products from larger businesses.

This brings us to how a technocracy is supposed to solve this problem. You will notice that governments got a good deal as an economic agent, as they are assumed to benevolently maximise the welfare of their citizens. Logically with this assumption, a bigger government would be better to allocate resources and solve the problem of irrational consumers and unethical businesses. Businesses have grown much bigger than when



Adam Smith first invented the term capitalism and a bigger government is needed to keep the bigger businesses in check. Competition within markets has decreased as there are now fewer firms that dominate almost all of the major industries.

Businesses are also now worldwide, so a world government would also logically be needed. This ever-increasing business size and bigger government is also coupled with an ever-increasing concentration of ownership of companies by investment firms. This means that under corporate governance, many business decisions will be influenced by their shareholders, and the same shareholders own most of the large firms.

A technocracy is formed by the natural progression of the factors of production to be owned by the governments, the large multinational businesses and the large investment companies. This progression occurs as large businesses and investment companies gain more money as their profits rise in comparison to small businesses and households, giving them an advantage when buying

assets. Therefore, eventually we will own nothing and be happy.

The large businesses and investment firms are considered best at deciding how and what to produce in a technocracy due to their economies of scale.

Economies of scale are the advantages that large businesses gain, such as the ability to lower the costs of production as they are able to include more technology; they have better management and can gather more information about their customers than small businesses, so arguably they can offer better products.

Large investment firms gather big data - such as Aladdin created by Blackrock - and keep the large businesses efficient through the threat of selling shares if efficiency falls. This creates a system where big data and economies of scale mean that we no longer need the information from free markets to decide the allocation of resources, because they would already have all the information they need.

The problem of environmental damage can be solved by world government agreements or a world governing system. The idea is

that with so much technology and regulation, the average person will work less and make fewer irrational decisions. We will have more time for relaxation and leisure. We will be kept controlled, safe and entertained by the experts.

As Schwab suggests, we are at a crossroads. On one hand, a technocracy can offer us an easy way out of the problems that we have. We can pass on the responsibility for our economic choices and allow the government and technical specialists to decide what goods and services we use. The problems of inequality, climate change and inflation are solved, as governments and large businesses can closely monitor what, how and who we produce for. According to those at Davos, this increase in efficiency and safety is worth the loss of freedom and individual choice.

On the other hand, is there an alternative system that could work without our losing our freedoms and choices? It will be more work, but the result could be much, much better. To do this, we will next month explore the opposing system suggested by the Austrian school of economics.

How and why reporters have failed to hold authority to account

How has this come to pass when so many of my colleagues are bright, intelligent people who are hard working and wish to serve their communities?

As a message to any mainstream journalist reading this, please, please, do not be afraid of asking difficult questions, and make it your business to seek out information that is being censored and then to decide for yourself if that information has any validity.

It has been a shocking experience, and disheartening. The propaganda pumped out by the government and regurgitated by the national newspapers and

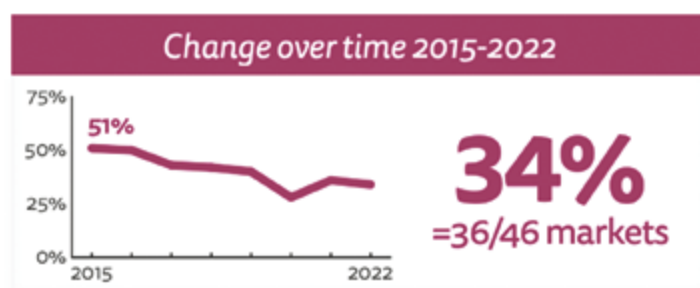
television news networks has done a good job of scaring them to such an extent that some have suffered genuine psychological trauma.

illegality of denying my right to informed consent. Even the NHS guidance highlights that there are many reasons people cannot wear a mask and that these should be respected.

They did not deny their behaviour, nor apologise for it. They simply de-registered me. They cared not a jot about my existing medical condition and offered no advice on what I should do without access to medication. How many others avoid their GPs now altogether, regardless of the health implications? A GP recently blogged anonymously about medical ethics as he feared his profession had forsaken them. I find the words powerful and relay some of them below. How many doctors reading this could truthfully say they have honoured their oaths over the past two years?

The health and wellbeing of my patient will be my first consideration;

I will not use my medical knowledge to violate human rights and civil liberties even under threat.

A physician will:

- Respect a competent patient’s right to accept or refuse treatment.
- Not allow his/her judgment to be influenced by personal profit or unfair discrimination.
- Certify only that which he/she has personally verified.
- Act in the patient’s best interest when providing medical care.

Any (all) preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information.

We should be cowed into submission yet, every day, more question how we allowed ourselves to:

- be muzzled
- accept non-diagnostic test results equal a pandemic
- allow loved ones to die alone
- deny natural immunity
- accept a covid-only ‘health’ service
- reject the benefits of early treatment
- become guinea pigs in a dangerous experiment
- allow our economy to be destroyed

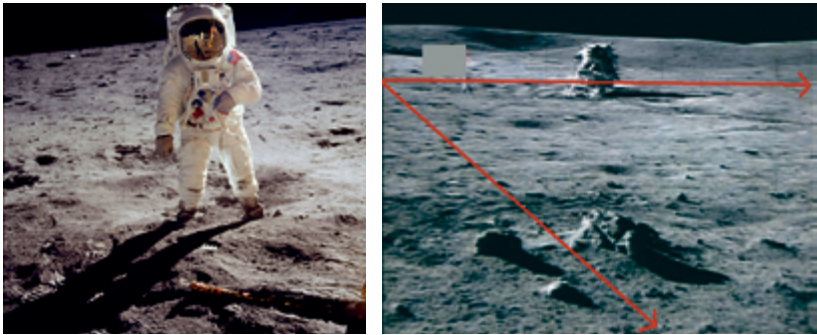

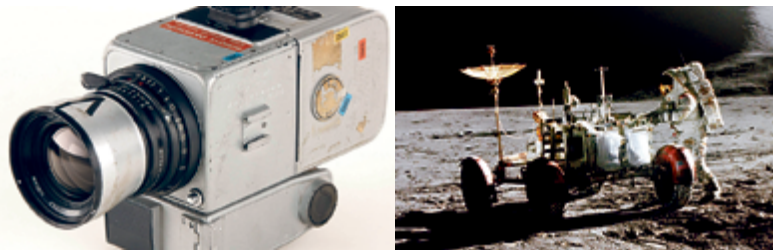

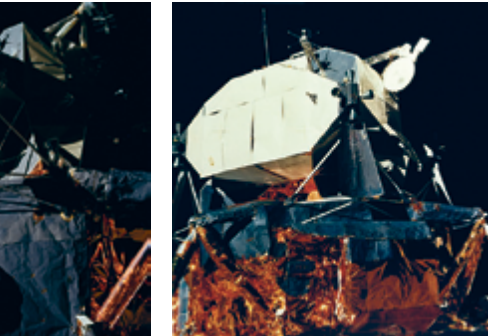

Worldwide farmers protest while mass media remain silent

Thousands of farmers across Europe now rising up against government overreach and the green agenda

FARMERS in the Netherlands are leading the resistance against The Great Reset by strongly opposing draconian plans by the Dutch government to destroy the agricultural sector under the guise of reducing nitrogen emissions.

On June 10, the Dutch government announced a €25 billion national and region-specific environmental programme for a 50% reduction of nitrogen emissions by 2030.

The Netherlands House of Representatives released a stark statement in relation to the plans: "The honest message is that not all farmers will continue in business. Those who do will have to farm differently."

The origins of the severe climate measures go back to 2019, when a court order from the highest administrative court in the Netherlands pledged to reduce the number of livestock in the country as the only way to considerably cut greenhouse gas emissions. The ruling was in response to a lawsuit from environmental organisations.

In some regions mapped out in the plans, farmers are facing 70% reduction targets. To add insult to injury, 500 million Euros have been set aside to buy out farmers by regional government. The Dutch government have shamefully called the environmental plans an 'unavoidable situation'.

The emissions targets align with the 2015 Paris Agreement, the UN Agenda 2030 Sustainable Development Goals and the EU's Natura 2000 network of vulnerable and endangered plant and animal habitats.

The Dutch farming union, LTO, which represents over 30,000 farms, estimates that the proposed measures

could force 30% of farms out of business by 2030, and described the nitrogen reduction targets as 'simply unfeasible' and a 'knee-jerk' reaction to EU policy. The large union group says the government are fixated on buying up land and reducing livestock, and should instead be focusing on innovation and sustainable farming practices.

Farmers argue that they are being used as scapegoats and unjustly accused as polluters. Marcel Crok, a Dutch science writer and co-founder of the Climate intelligence Foundation, told Fox News Digital: "I really understand their anger. The farmers are also angry because they say, 'we are the only sector who get all the blame. What about industry? What about all the traffic? Maybe we should just ban all the cars in the Netherlands because they also emit [nitrogen]'."

Radical environmentalists in the Netherlands have offered an expected compliant view to the plans. Andy Palman, director of Greenpeace Netherlands coldly said: "You rip a plaster off a wound in one go. Painful choices are now necessary."

The Dutch government appear motivated to acquire high-priced and high-quality farmland cheaply and many believe the real goal may be a landgrab. Dutch social and political commentator Eva Vlaardingebroek didn't mince her words when talking about the crisis with Tucker Carlson.

She said: "This is literally communism. If the state says, 'we are going to take your private property away for the sake of a greater good,' then the state has the prerogative to create crises to strip you of your rights. That's what's happening here. This will definitely affect ordinary citizens; it's part of a global agenda, so everyone across the world, especially Western countries, should be aware that this is something that is not just about the Dutch government, this is part of Agenda 2030; this is part of the great reset."

Since the Dutch government announced their ambitious targets in June, thousands of farmers across the Netherlands have mobilised together to protest. Farmers have protested by blockading food distribution centres, roads, and politicians' driveways. They have taken their protests to busy motorways, some have dumped hay bales on roads and large gatherings have been seen all over villages, towns and cities in the country.

Farmers also sprayed manure over a town hall and dumped a truckload of manure in front of the home of Dutch Minister of Nature and Nitrogen Policy. Some Dutch farmers have brilliantly replaced road signs with signs of 'boerenlanden' (farmer land) in some rural villages. Even cows have been seen protesting outside the Dutch parliament.

Dutch fisherman also showed solidarity with the farmers by blocking the port of Harlingen with trawlers. Fishing crews were seen holding placards that read, 'Eenrucht maakt Kracht': Unity Creates Strength.

The Dutch freedom-loving farmers have inspired thousands of farmers across Europe and beyond to revolt against rising 'agflation'. Farmers worldwide rightfully feel threatened that their agricultural way of life has been slowly eroded to suit the narrative of 'the greater good'. The farmers have a very clear message: "No farmers, no food."

Since the beginning of the

protests, German farmers have staged huge blockades with their Dutch counterparts on the Netherlands-Germany border in solidarity. On July 6, farmers from both countries held a blockade near the border city of Heerenburg.

In Italy, farmers copied the Dutch by driving tractors through towns and cities in the country. The farmers chanted "We are not slaves, we are farmers," as they drove through the northern powerhouse city of Milan. EuroWeekly News reported: "In Spain, farmers in Bdajoz, Granada and Albacete paraded their tractors down the streets in solidarity with the foreign farmers, as well as staging national protests at home over a lack of food and gasoline." Polish farmers also got in the solidarity spirit by

driving their tractors through the capital, Warsaw, to protest against rising inflation, interest rates, and accusing the political classes of destabilising production.

In South America, thousands of Argentine farmers and farming associations protested in Buenos Aires against government policies, high tax rates, currency controls, and shortage of diesel.

According to the Epoch Times, Canadian farmers organised convoy protests across the country on July 23 in solidarity with Dutch farmers. Protests also took place in several provinces across the country. In British Columbia, activists held a rally outside the Netherlands consulate in Vancouver.

The Dutch farmers are naturally horrified by the extreme green agenda regulations proposed, and feel that they will be forced out of farming. The Netherlands is a world agricultural powerhouse with a lucrative agriculture sector.

The Netherlands, despite its small geographical size, is one of the world's top ten food exporters, Europe's biggest meat exporter, and one of the top three countries in the world for fruit and vegetable exports. It has the highest density of livestock in Europe, with more than four times the food and animal population of the UK. Farming union LTO estimated in 2019, that nearly 54,000 Dutch agricultural businesses' exports totalled 94.5 billion Euros.

It comes as no surprise that the Dutch government have pursued climate change and Agenda 2030 principles over food and job security. Prime Minister of the Netherlands, Mark Rutte, is one of the World Economic Forum's (WEF) 'Young Global Leaders', and a regular

speaker at WEF meetings.

Rutte reacted to the farmers protests by saying: "You can demonstrate, but in a civilised way. So don't block highways, don't set off fireworks outside a minister's house and spread manure and... scare two children and endanger families." Some feel that Mr. Rutte is guilty of double standards here, as he made these comments while attending a NATO summit in Madrid.

Dutch farmers have responded to Mr Rutte by reminding him they will continue the protests and have the support of millions in the country and across the world. National pride in the farmers is evident across the country as the Dutch national flag is seen hanging on bridges and alongside roads in support for the farmers.

There are many similarities between the farmers protests and the Canadian trucker's freedom convoy in Ottawa back in February. Both have become vanguards for freedom. The mainstream media have blatantly ignored them and in both cases, protesters have been subjected to the brute force of the police.

Rowan Dean from Sky News Australia observed by saying: "The similarities between Canada and Holland are as startling as they are disturbing." Dean called Canadian Prime Minister, Justin Trudeau, and Dutch Prime Minister, Mark Rutte, the 'golden pin-up-boys' for Klaus Schwab and the globalist fantasists of the WEF.

Irish president links massacre of Christians in Nigeria to climate change

Outrage from bishop over 'misleading' comments

In early June, at least 50 Christians in Nigeria were callously murdered during a ceremony at St. Francis Catholic Church in Owo, in south-western Nigeria.

Authorities in Nigeria have linked the attack to Islamic extremists.

Nina Shea, a human rights lawyer, advocate, and expert in international religious freedom at the Hudson Institute in Washington D.C., told the Catholic News Agency (CWA) that "it was clear that large scale, war-like attacks on Catholics and other Christians are spreading in a system of impunity."

In response to the cowardly terrorist attack, the President of Ireland, Michael D. Higgins, issued a bizarre statement regarding the evil massacre by saying, "that such an attack was made in a place of worship is a source of particular condemnation, as is any attempt to scapegoat pastoral peoples who are among the foremost victims of the consequences of climate change".

He added: "The neglect of food security issues in Africa, for so long has brought us to a point of crisis that is now having internal and regional effects based on struggles, ways of life themselves."

Higgins finished his statement with: "The solidarity of us all, as peoples of the world, is owed to all those impacted not only by this horrible event but in the struggle by the most vulnerable on whom the consequences of climate change have been inflicted."

Higgins' statement mentioning the consequences of climate change, drew criticism from many, including a leading bishop in Nigeria. Bishop Jude Ayodeji Arogundade issued a response on his Facebook page: "To suggest or make a connection between victims of terror and consequences of climate change is not only

misleading but also exactly rubbing salt into the injuries of those who have suffered terrorism in Nigeria. Alluding to some form of politics of climate change in our situation is completely inappropriate."

The bishop added: "Such comments associating banditry, kidnapping and gruesome attacks on innocent and harmless citizens of Nigeria with issues concerning climate change and food securities are deflections from the truth."

President Higgins brazenly tried to sidestep his disgraceful remarks when rightfully criticised. A spokesman for the president told The Irish Times: "The President's comments with regard to climate change related to the plight of pastoral peoples in the region and the president made no link in his statement between climate change and the attack itself."

It is no surprise to see such a casual attitude from European leaders about the persecution of Christians across the world. Recently, the European Parliament voted against debating the plight of all Christians who are persecuted and in danger anywhere in the world. French MEP, Jean-Paul Garraud, said the European Commission "does not want to designate a coordinator for the fight against Christianophobia, when a coordinator of this type was created for anti-Semitism and Islamophobia."

It is quite incredulous that a president of any nation would try to associate any atrocity with climate change. The obsessional religion and cult of climate change is laid bare with Mr Higgins' ill-judged and distasteful comments.



Ukrainian court permanently bans opposition party and takes its assets

Poking the Russian bear may have grim consequences

FAUX humanitarian President of Ukraine, Volodymyr Zelensky, recently signed an undemocratic bill in the Ukrainian Parliament outlawing the activities of popular pro-Russian political parties in the country.

This resulted in a court ruling in favour of the Ministry of Justice in the western city of Lviv on June 20th by the Eight Administrative Court of Appeal permanently banning the activities of 10 political parties with pro-Russian stances.

A statement issued on the official Ukrainian Justice Ministry Facebook page read: "The court satisfied the claims of the Ministry of Justice of Ukraine: the activities of the political party Opposition-For Life were banned; the funds and other assets of the party, its regional city, district organisations, primary organisations and other structural entities were transferred to the ownership of the state."

The Opposition Platform - For Life party - received the 2nd highest number of votes in 2019 during the Ukrainian parliamentary election and held 44 seats in the Ukrainian Parliament prior to the outbreak of the war.

Chesno, a Ukrainian election integrity civil movement group set up in 2011, said: "Due to the fact that the court did not allow journalists into the courtroom, the arguments of the parties to the trial aren't known, and will become available only after the full court decision is made public."

The Ukrainian government have also disturbingly voted through two laws placing restrictions

Minister, Oleksandr Tkaachenko, said he was "glad to welcome" the draconian legislation. He added: "The laws are designed to help Ukrainian authors share quality content with the widest possible audience. After the Russian Invasion, [we will not] accept any Russian creative product on a physical level."

The anti-democratic attack and clear censorship on political opposition and on Russian culture

Sri Lanka introduces fuel rationing scheme by QR code



THE Sri Lankan Energy Ministry along with the Information and Communication Technology Agency (ICTA) launched a National Fuel Pass system last month, to manage the limited fuel supplies and ease queues in the country.

Minister Kanchana Wijesekara introduced the system to the public on Saturday 16 July in a live press briefing and revealed more details:

- Guaranteed weekly quota for all types of private vehicles
- Applicable for All CPC and LIOC fuel stations Islandwide

- Not applicable/No limitation of fuel for public transport (Buses/Trains)
 - Registration open for next few days. NIC/Passport No./Business Registration No., Vehicle number & Chassis number mandatory
 - Users will be informed once the fuel quota is ready
 - 1 NIC/Passport/BRN - 1 Vehicle only
 - Once fuel quota received, QR code to be produced at Fuel Pump. Either image or printed hard copy
 - System will show utilised/available fuel quota and expiry date
 - An SMS will be received to registered mobile number once fuel pumped.
 - Week's fuel quota cannot be carried forward
 - Days are allocated to pump fuel based on last digit of vehicle number
 - LIOC current system will continue until Fuel Pass method is implemented
- While on the surface this seems to be helpful, this is the 'solution' they really want to offer: rationing with everything allocated by Digital ID. This would appear to be another test case for what the rulers want the whole world to be like in the very near future.

Huge protests in Panama over skyrocketing inflation

PANAMA is the latest country in crisis as citizens rise up against the government over high inflation following the covid plandemic.

Macron loses vote for vaccine passports

ON July 12, the French National Assembly voted down a proposal that would have given the government the power to demand that visitors to France show proof of covid-19 vaccination or a negative test for the disease upon entering the nation. The French Parliament also voted down a measure to mandate that children carry such a passport.

Macron was re-elected as President in April, but his ruling party, 'La République En Marche!' lost the majority in the National Assembly in the June parliamentary elections.

The vote on the proposal to demand French visitors show proof of a vaccine or a negative covid-19 test was 195-219.

The defeat of the mandate 'was met with wild cheering and a standing ovation from opposition lawmakers,' reported the Telegraph.

All of the major opposition parties in France - including the right-wing National Rally (RN), the left-wing La France Insoumise (LFI), and the center-right Republican Party (LR) - united to defeat the mandate.

It was the first true test of Macron's power since winning another five-year-term - a test Macron and his new minority government failed.

"The article of #PJLCovid reinstating the health pass at the borders but also between Corsica/Overseas and France has been rejected. We will fight tirelessly to protect the freedoms of the French people," tweeted Assembly member Thomas Ménagé of National Rally.

Macron no longer has the power to issue edicts and expect the National Assembly to simply rubber-stamp his wishes.

"The circumstances oblige the government to listen to opposition parties which at the moment it has a few difficulties in doing," said Republican Olivier Marleix.

Prime Minister Elisabeth Borne blasted the outcome and blamed what she called 'extremes' on the Left and the Right for the mandate's defeat.

"The situation is serious. By joining together to vote against the measures to protect the French against covid, LFI, LR and RN



prevent any border control against the virus. After the disbelief on this vote, I will fight so that the spirit of responsibility wins in the Senate," Borne tweeted.

Ménagé suspected that Borne was simply lamenting the loss of the ability to track people in France.

"@Elisabeth_Borne is very embarrassed: this text gave it all the power to attack the freedom of movement of French people even within the national territory. They gave us a clear mandate to oppose these types of draconian measures: we respect it," Ménagé tweeted.

The new government also failed in its bid to keep in place vaccine passports for children. Marine Le Pen, the leader of the National Rally, who lost to Macron in the presidential election, tweeted: "First victory of the Deputies @ RN_official! The health pass will no longer concern minors. We won't fail to defend you," Le Pen tweeted.

Despite the defeat on vaccine passports for visitors and children, a wider covid-19 package intended to guard against a 'seventh wave' of infections did pass the assembly.

The Macron government first initiated the vaccine passport system in late 2020, after saying that vaccination "will not be compulsory," French Minister of Health Olivier Véran later revealed that the passport "is a disguised form of vaccination obligation, but it's more effective."

France ended most vaccine passports in March of this year, but Macron's government was attempting to reinstate some covid-19 protocols so that France was more in line with the rest of the European Union.

Macron may have won a second term as the President of France, but the defeat of his continuing draconian covid-19 measures signals that his second-term agenda may face tougher opposition than during his first term.

Vatican issues coins and medals commemorating vaccines and Ukraine

THE Vatican has recently issued a commemorative series of coins and medals highlighting the Ukrainian war and promoting the importance of vaccines.

Epistemology of Ethical Choice in Times of Pandemics reacted to the issuing of the coins by saying: "A Vatican commemorative coin dedicated to the 'need to be vaccinated' against covid-19 is something serious scholars and people of goodwill would have gladly done without."

The eminent Italian scholar Di Blasi further added: "I receive this news with a mixture of deep pain and concern for a Church that is increasingly in a crisis of identity and truth. These drugs

are not technically vaccines; they statistically kill a number of people, and, according to the latest studies, they even have negative efficacy. While judicial rulings against them multiply more and more, the Vatican increases fanatical support for them, which is not scientific at all, and which is foreign to revealed truth."

The virtue signalling continued in the Vatican with an official silver medal to peace in Ukraine. The Philatelic and Numismatic Office in the Vatican said: "One side of the medal depicts a family



fleeing from a city destroyed by bombs with their entire lives in a suitcase; a child carries a soft toy as the family is guided by a young mother who is walking towards us, reminding us of our duty to welcome and show solidarity."

The cost of the medal is 50 euros.

It comes as no surprise that a powerful institution such as the Vatican is shilling hard for its globalist friends. In May 2021, the Pope hosted an online Vatican health conference that was attended by many important

Pharma boss caught falsifying jab status

Investigation uncovers fake vaccine certificates scam

A POLICE investigation in Spain, code-named 'Operation Jenner', has discovered that at least 2,200 prominent people paid a nurse for fake vaccine passports - people seeking to have their names added to a covid vaccine database despite not getting the trial jab.

According to the Spanish newspaper El Mundo: 'A vast network of celebrities and elites paid money to have their names fraudulently entered on the National Immunisation Register, despite refusing to be vaccinated.'

Euro Weekly News reported: 'The leader of the network was

a nursing assistant at the La Paz University Hospital, where he is accused of charging more than 200,000 euros for fraudulently registering 2,200 people as vaccinated in the Spanish National Registry against covid-19. He has been arrested and is currently in custody.'

Prominent people from the world of music, film, business, sport, and medicine were caught fabricating their jab status. One of the most interesting and high-profile names listed was Jose Maria Fernandez Sousa-Faro, the Spanish boss and founder of the large pharmaceutical company PharmaMar.

PharmaMar is one of the largest pharmaceutical companies in Spain, and specialises in researching drug treatment for Alzheimer's, cancer and ironically covid.

According to ABC News in

Spain, the 76-year-old businessman and pharma boss used the illegal scheme to make it appear that he had had the third dose in the official Spanish database, while other relatives also used the same service, according to police sources.

ABC News reported that the Pharma boss paid an organisation a 'VIP fee' of between 1,000 and 2,000 euros to be added to the Spanish vaccine register. It is alleged that Sousa-Faro was injected with a saline solution, instead of the covid jab.

Acclaimed Dr. Sousa-Faro has worked in the pharmaceutical industry for over 35 years, and has more than 90 scientific publications and patents in the fields of biochemistry, antibiotics, and molecular biology to his name.

When a powerful and wealthy CEO of a large Pharma company goes to such extreme lengths not to take the experimental jab, one really needs to take serious note.



No such thing as a sexually transmitted disease

Negative thoughts can harm your health

THE medical establishment claims that sexually transmitted diseases are a significant worldwide problem.

This is indicated by the first ‘fact’ on the November 2021 World Health Organisation fact sheet entitled Sexually transmitted infections (STIs) that states: “More than one million STIs are acquired every day worldwide.”

The reference to these diseases as ‘infections’ is based on the idea that they are caused by ‘germs’ of one kind or another.

As the fact sheet claims: “More than 30 different bacteria, viruses and parasites are known to be transmitted through sexual contact. Eight of these pathogens are linked to the greatest incidence of sexually transmitted disease. Of these, four are currently curable: syphilis, gonorrhoea, chlamydia and trichomoniasis. The other four are viral infections which are incurable: hepatitis B, herpes simplex virus (HSV or herpes), HIV, and human papillomavirus (HPV).”

It is claimed that monkeypox is not an STI, yet paradoxically, it is also claimed that monkeypox can spread through sex.

The most important points to emphasise are that there is no evidence that any ‘germ’ is the cause of any disease; and that this includes the ‘diseases’ claimed to be transmitted sexually.

In our book, *What Really Makes You Ill? Why Everything You Thought You Knew About Disease Is Wrong*, we refer to the work of many physicians and scientists who have recognised this fact. In his book *The Hygienic System: Vol VI Orthopathy*, Herbert Shelton cites the words of Dr Beddow Bayly MD MRCS LRCP, who wrote in the June 1928 edition of *London Medical World*: “I am prepared to maintain with scientifically established facts, that in no single instance has it been conclusively

proved that any microorganism is the specific cause of a disease.”

And there is no evidence that this situation has changed since 1928.

Interestingly, the WHO fact sheet states: “A person can have an STI without showing symptoms of disease.”

This statement is highly anomalous, not to say an outright contradiction of the idea that a person has been ‘infected’ with a ‘pathogen’, the definition of which is a ‘disease-causing organism’.

The presence of the pathogen in the absence of disease or the absence of the pathogen in the presence of disease are situations that violate the first of Koch’s Postulates and therefore demonstrate a complete failure to establish a causal relationship.

The WHO states that STIs are ‘known to be transmitted through sexual contact’, which suggests that this is a proven fact; but this is not the case. No test is ever conducted to determine whether any germ ‘found’ in one person had actually been transferred to them by another person during sex.

The only tests that are used are ones that claim to find an ‘infectious agent’ or an antibody to an ‘infectious agent’. But merely finding a ‘germ’ or an ‘antibody’ does not prove that they cause the disease a person is claimed to be suffering from. Nor does finding the same ‘germ’ or antibody in the bodies of two people prove that anything has been transferred between them.

However, the failure of the ‘germ theory’ to explain symptoms attributed to an STI does not mean that they cannot be explained.

The body produces symptoms for a purpose, which is to eliminate toxins, as clearly explained by TC Fry in his co-authored 1983 book *The Cruel Hoax Called Herpes Genitalis*: “The diseases that we attribute to viruses are actually body created eliminative crises to eject forcibly toxic matters that have accumulated. Uneliminated wastes are life-sapping



and deadly.”

Although he refers to ‘viruses’, the same applies to all so-called ‘infectious agents’, whether ‘viruses’, bacteria or parasites.

The medical establishment’s methods for treating these conditions usually involve antibiotics and antiviral medications, which are toxic. But TC Fry states that these conditions do not need to be treated in this way. He said: “Herpes and other acute diseases can be quickly overcome (in days) by simple detoxification measures.”

The toxins the body is attempting to eliminate will be different for each person, but they could include chemicals commonly used as ingredients of personal care products that are applied to the body on a daily basis. These chemicals may include phthalates and synthetic ‘fragrances’, both of which have been proven to be harmful to the body. It should be noted that, with a few exceptions, cosmetic products and ingredients are not subject to FDA approval before they can be released onto the market.

It is important to emphasise that the body does not choose the

genital area to eliminate toxins as the result of sexual activity. Instead, as TC Fry states: “The body selected the site because it was the easiest vicarious outlet, not because of sex relations.”

There are other reasons that symptoms may occur in the genital area. The claim that pathogens can be transmitted through sex may, for some people, reinforce their belief that sex is ‘bad’ and that ‘disease’ is the just punishment for sexual intercourse. This idea can, and often does, inculcate a feeling of guilt about sex that can have a very real detrimental effect on a person’s physical health.

There is an abundance of evidence that our thoughts, ideas and beliefs play a significant role in our health as demonstrated by the well-known phenomenon of the placebo effect.

There is also a lesser-known phenomenon called the nocebo effect, which is not solely the result of experiencing ‘side effects’ from an inert substance taken during a drug trial. It can have a far more detrimental impact on a person’s health and well-being.

An August 2013 article entitled *The Nocebo Effect: Negative*

Thoughts Can Harm Your Health, refers to the power of the nocebo effect and states: “The literature shows that patients believed to be terminal who are mistakenly informed that they have only a few months to live have died within their given time frame... even when autopsy findings reveal no physiological explanation for the early death.”

The article explains that doctors are instilling in the minds of their patients a ‘belief’ about their condition, which, if accepted, will often become a self-fulfilling prophecy.

In contrast, there are other people who completely reject the prognosis and defy their doctor’s belief by not succumbing to the ‘disease’ and instead live a long and healthy life.

A belief in sexually-transmitted diseases can be dismissed in a similar manner on the basis that, as discussed above and in our book, there is no evidence to support the idea that infectious agents cause any disease, or that any disease can be transmitted sexually.

Looking behind the curtain of virology

Pandemics will be declared with no evidence

IN the 1800s, the emerging medical industry proposed that diseases were caused by invisible, infectious particles attacking the body.

Some of these diseases turned out to be vitamin deficiencies such as scurvy, beriberi and pellagra. Others turned out to be caused by poor sanitation and toxins. For example, by the time the vaccine to fight the so-called measles particles was introduced, improvements in hygiene had already lowered the death rate to nearly zero.

The vaccine for smallpox was also useless and many were killed by it. The method until 1895 was to take scabs and pus (expelled dead cells, bacteria and toxins), add them to water and rub the mixture into cuts made in the arms of babies and children. Alfred Wallace wrote in 1898, how incredulous it was that so many educated specialists could be deceived into accepting that vaccines were effective, when there was no proof. The same could be said today.

The electron microscope was not in use until the 1930s so no one had actually seen any microscopic 'viral' particles. However, even today, SARS-CoV-2 has not been observed in a sample, as there is apparently never enough.

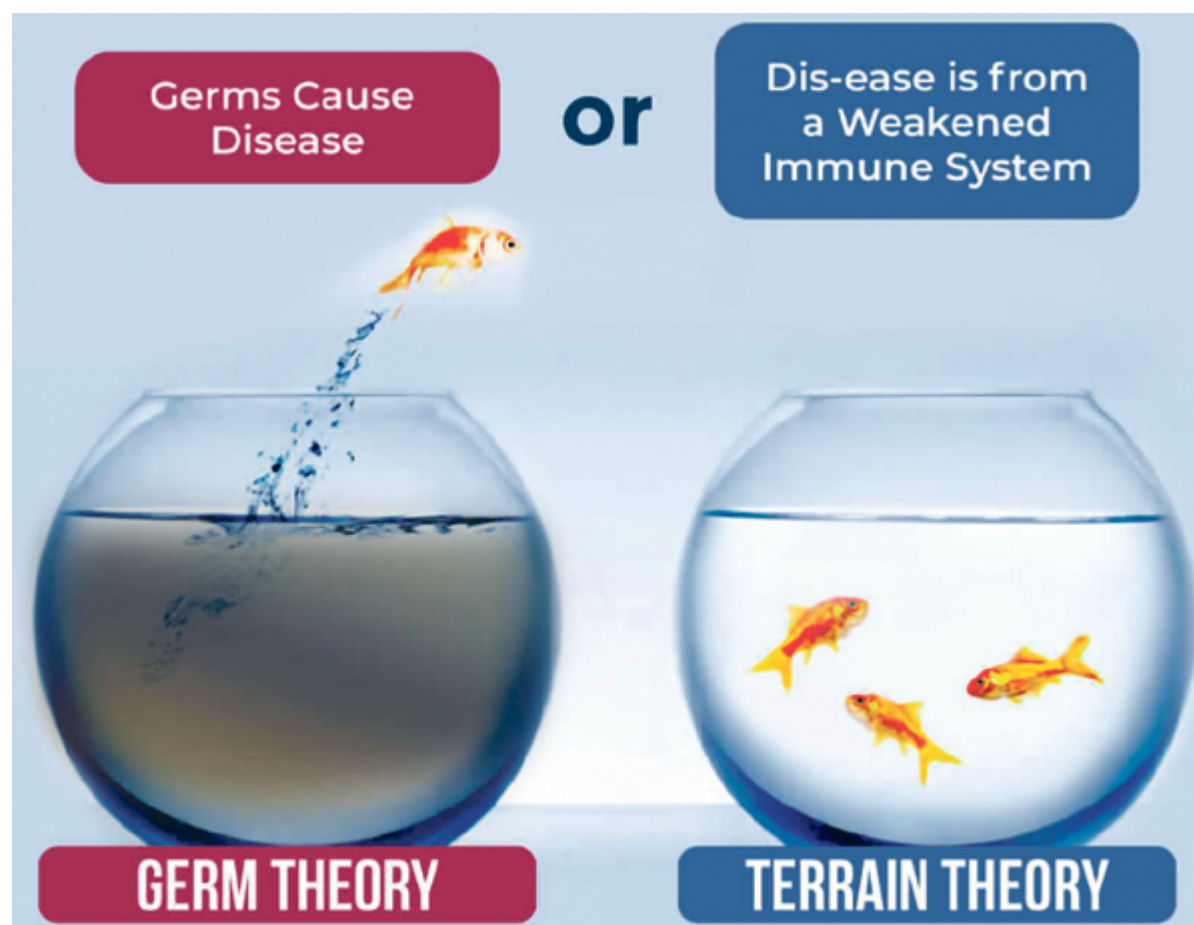
Has SARS-CoV-2 been observed by the indirect method of isolation? If isolation means separation, then no, it hasn't.

Virologists merely take crude samples of genetic material from sick patients, add these to petri dishes containing abnormal monkey kidney cells. Antibiotics are then added, and the cells are then starved.

Toxic effects seen in the cells are called 'isolation' and the effects of adding proteases (enzymes), are called 'viral activity'.

However, as control studies using cultures prepared in the same way are never undertaken by virologists, these claims must be totally disregarded.

How can the genome of a 'virus' be mapped out, if the 'virus' has never been separated from other genetic material, i.e., properly isolated, and thus never actually



observed?

A patient who lived and worked in Wuhan, one of the most heavily polluted cities in the world, presented with symptoms of fever, chest tightness, unproductive cough, pain and weakness. This collection of symptoms, commonly used by the body to expel toxins, was inexplicably declared to be a new and distinct disease.

Fan Wu, et al, analysed an unpurified lung sample from the patient, which contained his stressed, dead and dying cells (we know that stressing cells can produce novel genetic sequences and novel proteins), as well as mucus and bacteria, and detected 56,565,928 short fragments of RNA.

These nucleotides were fed into a computer which made 384,096 overlapping sequences, from which one was agreed upon. This was further rearranged to make 30,474 nucleotides that resembled a previously guessed-at sequence from bat droppings.

There was no evidence that the computer nucleotide sequence represented a genome coding for an actual external entity, a 'virus', and not merely part of the genetic material taken from the patient.

No attempt was made to show a correlation between the presence of this nucleotide sequence and the presentation of the same symptoms

in any other patients. Nor was there any evidence provided to show that the sequence could cause the exact same symptoms in others.

It was simply declared to be the genome of a virus that was the cause of common symptoms, and which was able to replicate and infect others, with no proof.

Researchers failed to prove contagion in the case of the the so-called 'Spanish flu' epidemic in 1918. This disease-state occurred after millions were bombed, shot at, separated from families, malnourished and terrified.

62 healthy volunteers were placed in close proximity to very sick patients, who repeatedly coughed in the healthy subjects' faces. Much to the surprise of the researchers, not one of the healthy test subjects developed an influenza-like illness.

Many lessons could have been learned from AIDS; a collection of symptoms caused by oxidation, poppers, drugs, malnutrition and poverty, and not by 'HIV'. AIDS cannot be sexually transmitted by 'HIV', as it is only correlated with frequency of receptive anal sex; semen is highly oxidising and the anus is very thin.

The AIDS test detects proteins present in many conditions, including pregnancy and good health, so a diagnosis is given on patient history: blood transfusions,

or being a Black African or a gay male - seeing positive results only where one expects to see them. This is so far beyond the scientific method as to beggar belief. Many who tested positive took their own lives, and many more were killed by the toxic drug, AZT.

What about bacteria and fungi? These proliferate in disease states, though they seem to help by breaking down and clearing toxins and dead cells. We cannot survive without the microbiome which protects the lining of our skin, gut, kidneys and brain and which nourishes cells, among many other things.

What really makes us sick? Malnutrition, poor sanitation, poverty, junk food, toxins and medications; emptying the oceans of fish, cutting down forests, depleting soils, factory farming, suppressing our emotions, poor sleep, EMFs, stress, fear, trauma, negative thinking, isolation and loneliness are all high contributory factors.

The Global Pandemic Preparedness Treaty is on track for May 2024, when pandemics will be declared without any real evidence, and even more draconian lockdowns will be imposed by laws to allegedly protect our health.

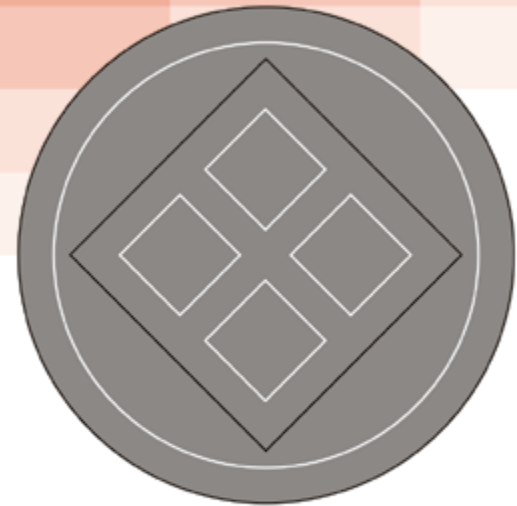

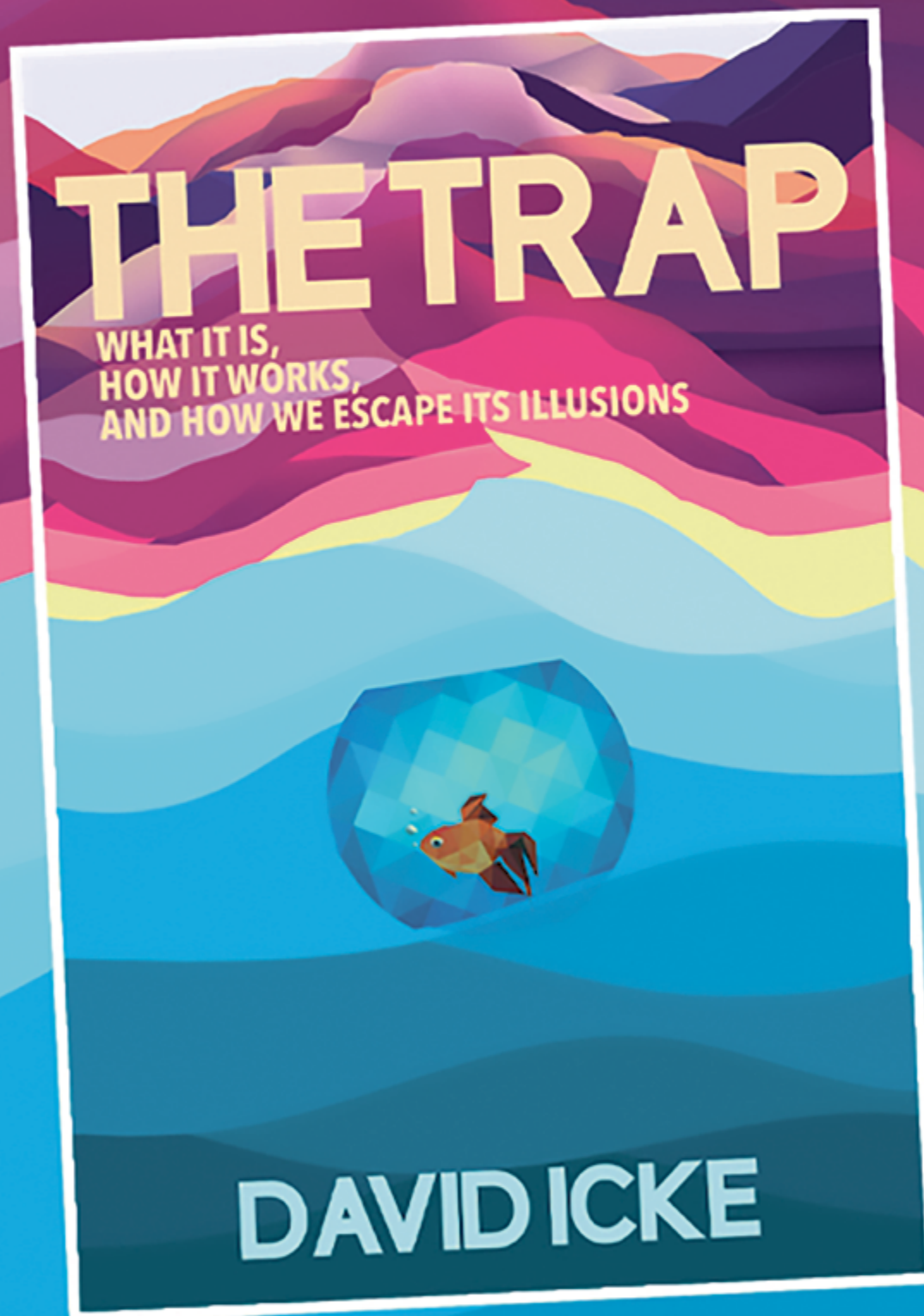
