DNA contamination found in mRNA shots

Shocking discovery could explain rise in ‘turbo cancers’

LAST April, a claim was made about the presence of DNA plasmids in vials of covid-19 ‘vaccines’ manufactured by Pfizer and Moderna.

In response to Dr Kevin McKernan’s claim, the World Council for Health (WCH) last month hosted an emergency hearing involving leading experts to discuss the issue.

The intense four-hour session was hosted by WCH Steering Committee members Christoph Ploth and Mark Trozzi.

Appropriately, the first presentation was by Dr McKernan who explained he had sequenced nucleic acid in Moderna and Pfizer vials and found that as much as 35% was DNA from bacterial plasmids.

This finding has since been confirmed by various other laboratories, including in the USA, Japan, France, and Germany, with a recent study finding DNA in all 24 vials tested.

Despite far fewer people now receiving the covid shots, the number of reports of adverse events continues to rise. Dr Peter McCullough identified four domains of adverse events, namely cardiovascular, neurological, immunologic, and – the one that may be most directly influenced by DNA contamination – oncogenesis (the process through which healthy cells become transformed into cancer cells).

Indeed, the Vaccine Adverse Events Reporting System (VAERS) is now reporting large numbers of cancer cases, including rapidly developing ‘turbo cancers’.

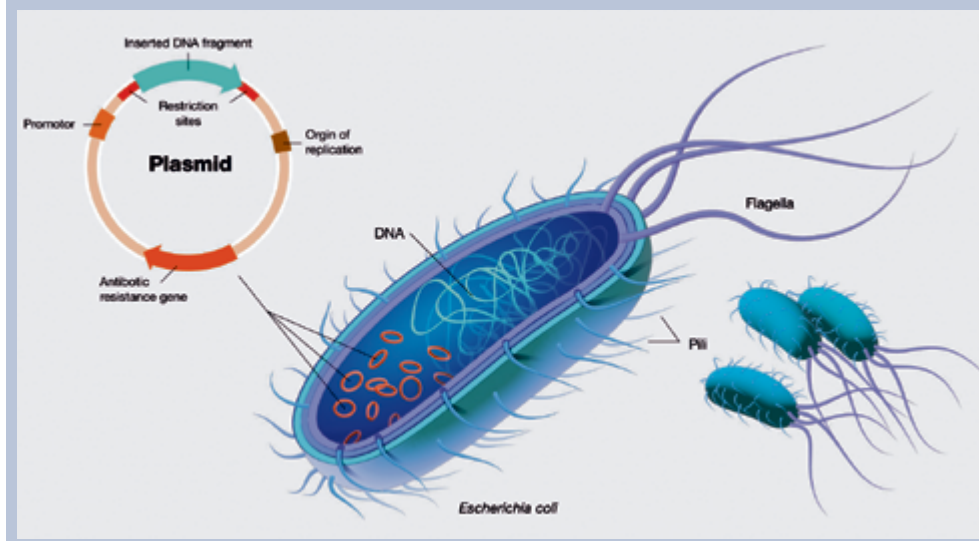
Dr Jessica Rose explained during her presentation that, while the clinical trials of the covid shots had used a PCR-based process to manufacture the mRNA, this method was not suitable for mass production.

A completely different approach was needed to produce the billions of mRNA shots that were rolled out to the public. In this case, the process used the bacterium *E. coli* to produce DNA plasmids (circular, double-stranded DNA), which in turn produced the mRNA.

Unfortunately, the DNA was not satisfactorily removed after manufacture, resulting in high levels of contamination.

What is a plasmid?

- **Plasmids are self-replicating, extrachromosomal units of double-stranded bacterial DNA**
- **They often contain genes not related to basic life functions, such as antibiotic-resistant genes**
- **Scientists can cut open plasmids, attach a desired gene, then reinsert the plasmid into the bacteria**
- **When complete, the bacteria will contain a new gene (instructions) to create a desired protein**



It was heard that the manufacturers did not disclose to the public the fact that different production methods (associated with different risks) had been used and, consequently, there could be no possibility of informed consent.

The presence of plasmid DNA in the covid shots introduces risks, such as the possible presence of bacterial endotoxin, which may cause anaphylaxis. Ironically, this effect is exacerbated by the spike protein that the shot was developed to produce.

Furthermore, if plasmid DNA is able to enter the nucleus, there is a risk that it may be incorporated into the recipient’s DNA. As noted by Prof Alexandra Henrion-Caude, DNA can enter nuclei during cell division when the nuclear membrane disassembles. But worryingly, there are at least five ways

in which contaminant DNA can enter the intact nucleus. The most obvious mechanism is the lipid nanoparticle (LNP) which encapsulates the nucleic acid in the shots. It acts as a Trojan horse protecting the mRNA and DNA from destruction by enzymes in the cell.

While the discovery of the contamination of the mRNA shots with DNA has been an enormous shock, it is also proving to be a new focus for research, collaboration, and action.

It may also represent a tipping-point, as people injured by the mRNA products come to realise the extent of contamination. This meeting of minds was an opportunity not only to consolidate what we have learned in the few short months since the publication of Dr McKernan’s findings, but also to

appreciate the team that is coalescing in response to the challenge.

Already, this gathering has served as an opportunity to share initiatives and resources. Dr McKernan has made his primer sequences available so that other labs can replicate the work. He is currently manufacturing kits to enable pathologists to test tissues, and these will be available in late November.

Prof Brigitte König is developing samples that are available to the research community for analysis of spike protein, vaccine-derived mRNA, and plasmids.

Dr Rose is planning to build up the dataset of sequenced vials and correlate these with what is being observed in pharmacovigilance databases. She also plans to investigate the integration of plasmid components into stem cells or germline cells using Kevin’s protocols.

Mark Trozzi and Christoph Ploth concluded the meeting with a statement of intent:

- There should be an immediate stop to the injections.
- The relevant regulatory bodies should undertake public investigations into the covid-19 countermeasures; if they do not undertake this, they themselves should be investigated.
- Tests should be available to the public to detect circulating spike proteins and genomic integration.
- Treatment (spike detox) and compensation of victims must be made available. The WCH provides various treatments on its website.
- The level of criminality relating to the covid-19 event cannot be ignored. Investigation, prosecution, reconciliation, and compensation must follow.
- Education of health care workers and the public is needed.
- Censored experts should be restored to their positions. They can lead the way to a better future.

Shock for ‘settled’ science

Temperatures rising *ahead* of CO2 emissions

NEW evidence points to temperatures on Earth rising before an increase in atmospheric carbon dioxide.

The findings are causing considerable concern in the ‘settled’ world of climate science where a political narrative promoting Net Zero demands that it is undeniable that temperatures rise after humans burn fossil fuels.

The controversy has been building for about a year since initial findings were first published by the UK Royal Society.

The latest work from four scientists uses sophisticated techniques to examine data from numerous temperature and CO2 data sets over the last 60 years. As with the initial findings published by the Royal Society, they found the causality link – placing a CO2 rise ahead of temperature – cannot be scientifically supported, since it is clearly shown that temperature precedes CO2 by six or more months.

The collectivist Net Zero project relies on the assumption that humans operate a climate thermostat by burning fossil fuel. The UN-backed Intergovernmental Panel on Climate Change

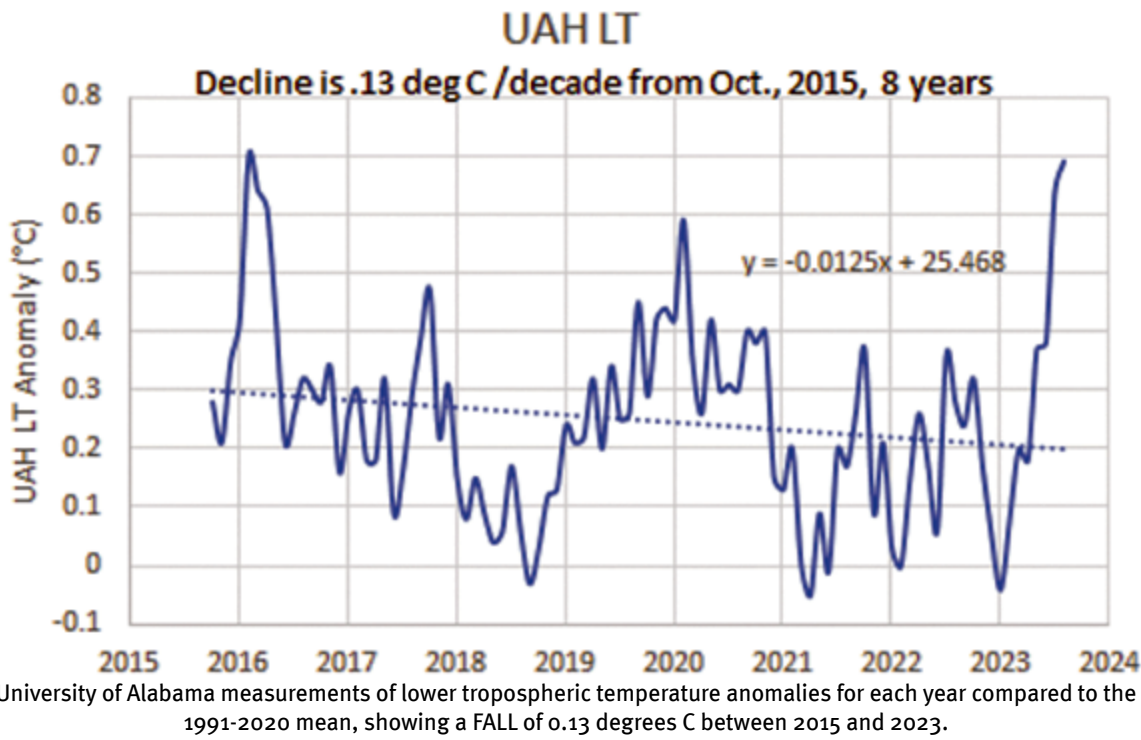
promotes the suggestion that all variation in the climate since 1900 has been caused by humans.

But the hypothesis of anthropogenic climate change was always shaky, since no scientist can prove the actual amount of warming to be expected, while scientific observations going back 600 million years offer little proof of a conclusive link.

The scientists have noted that their current and more detailed work was developed after critical review in the Royal Society journal. They said: ‘Some concerns expressed by critics are dealt with in this new paper. No-one has, however, developed any critique of the methodology.’

The lead author is Professor Demetris Koutsoyiannis from the University of Athens, and there are three other contributors from Athens, London (Imperial) and Poznan. The paper is titled, *On Hens, Eggs, Temperature and CO2: Causal Links in Earth’s Atmosphere*. The reference to hens and eggs highlights a basic, age-old concept in the scientific process: what is the sequence of cause and effect – what came first, the hen or the egg?

This paper may well hasten the breakdown of the always shaky hypothesis that humans hold the climate thermostat, and can



control it by regulating their own CO2 production.

If human-caused CO2 was causing the climate to warm, it would only be detectable over a longer period. But the longer period does not offer much evidence of a direct link, with the last 150 years showing rises, falls and pauses in the global temperature record. Instead, alarmists have had to fall back on anomalies that show one-off departures from the norm.

It is impossible to link human-caused CO2, or indeed any CO2,

to an outlier over a month or so. Of course, this has not stopped pseudoscientists using computer models to claim they can link an individual weather event to the long-term trend.

The authors go on to provide other reasons for climate change, including oceanic heat exchange, and both solar and geological activity. They conclude on a note of realism, seemingly lost in the mainstream rush to attribute all climate change to humans: ‘Causal links in complex systems

may form endless sequences... it is naive to expect complete answers to problems related to complex systems, or to assume that a complex system is in permanent equilibrium, and that an external agent is needed to kick it out of the equilibrium and produce change.’

The importance of trial by jury

Twelve peers better than one judge in court of law

WHEN faced with a court appearance, many people would instinctively prepare to take on the services of a solicitor and, certainly in the case of criminal proceedings, a barrister.

And, therefore, they are settling in for an expensive and quite often disempowering experience.

Certainly this was my initial reaction having been summoned to appear at my local magistrates' court to answer a charge in relation to a fire safety regulatory offence with reference to my firm's property management work.

Having been quoted thousands of pounds in fees, and being exposed to a rather negative tone from my assembled legal team, I felt in my bones that there was a better way.

Being A Stand in the Park member, attending my local park most Sundays since the pandemic lockdown era, when I was particularly concerned about loss of freedom and mask mandates, I eventually became very aware of the issue of personal sovereignty and the potential protections of Common Law in this regard.

Initially, I found the whole subject difficult to grasp, and wondered how it could possibly be put into practice, but nevertheless, began to research the subject.

It was on Telegram that I spotted Common Law posts from a 'Stand in the Park' group in the Peak District, which increasingly drew my interest as 'Trial by Jury' was mentioned.

The allure of a 'Trial by Jury' grew stronger and more urgent as my court date approached, and so I made a trip up to the Peak District and met someone who a few years previously had purposely put himself through the courts to test the system.

He became my perfect Common Law coach as he had front-line experience as to how to withstand the legal jargon and psychological machinations unleashed by a court more interested in a quick verdict,

presided over by a judge, than a 'Trial by Jury'.

This approach can be borne out across the land, as currently under five per cent of court cases are heard in front of a jury.

I must admit that my first magistrates' court appearance defending myself was indeed a daunting one, but keeping to my coach's script which kept me out of the jurisdiction of a bench-led court, I was able to survive the encounter and move one step closer to a 'Trial by Jury'.

My next hearing was at a Crown Court, where I was exposed to more legalese and a psychological grilling, which it seems was designed to spread fear in a self-representing defendant: I was arraigned, faced with various indictments and finally given unconditional bail, while at the same time being threatened with a psychiatric examination (are you fit to plead?) and an instruction not to abscond before my next hearing for fear of a period in custody.

After five Crown Court appearances, I have now been promised a 'Trial by Jury' where I can access the Common Law (law of the land) proper, which has been excellently described in a book by Lysander Spooner, *An*

Essay on Trial by Jury.

The importance of a 'Trial by Jury' is that you will be judged by twelve men and women randomly selected from the electoral roll. The members of the jury are not employed by a local authority, and are therefore free to exercise their consciences in pursuit of a fair trial and a just verdict; whereas a trial in front of a judge is weighed down by legal baggage in the form of an oath to uphold the law, and a potential bias in judges to be consistent in their sentencing, as well as, consciously or not, a career-saving requirement to keep the legal executive – government ministers and civil servants – on side.

In other words it is very difficult, even for the fairest of judges, to exercise their consciences, as they are hemmed in with the responsibilities and expectations of office.

A 'Trial by Jury' is a liberating experience for all its participants. The defendant is offered a fair trial in front of twelve peers, who are given the opportunity to examine their consciences and, by their own innate understanding of natural law, decide whether harm has been caused.

If one member of the jury, based on this form of impartial justice and the merits of a given case, finds the defendant innocent according to their conscience, then a not guilty verdict is returned.

For a defendant to be found guilty, a unanimous verdict must be returned by the jury. In order for a jury to examine their consciences, they must have full access to the facts of the case, the law surrounding it, and all the evidence. Essentially, the jury are the judges of the case.

It is the jury who will return the verdict; the judge has an opportunity to be free of the burdens of executive office, and without forfeit, preside over a legitimate Common Law trial.

The overturning of government legislation at a 'Trial by Jury', also referred to as jury nullification or from some judges' perspectives, a perverse verdict, is an essential prerequisite for the proper functioning of our democracy, and is enshrined in our constitution through the Magna Carta 1215.

Without a 'Trial by Jury', Parliament and its guiding executive is given carte blanche to enact legislation, which based on current events, will lead to

increasingly authoritarian laws undermining the welfare of the population and exerting more and more control – legislative enslavement.

The nullification of such laws by a jury of twelve peers sends an unequivocal message to government that the country will not countenance the passing of bad laws. Also, politicians will eventually heed this popular sounding board, and judges will be emboldened to separate the sheep from the goats of legislation.

Despite their seemingly love-hate relationship with 'Trial by Jury', the highest ranks of the judiciary themselves are very keen to retain 'Trial by Jury' for the very reason that it is an essential instrument in the operation and preservation of our democracy.

During the pandemic, an idea was espoused to temporarily halt 'Trial by Jury' in the interests of quick judge-led verdicts, but this was never acted upon, and the press was full of supportive arguments from the legal establishment to stymie the idea.

Coining in on future currency

CBDCs, cash and Bitcoin vying for position in our wallets

IN an era where the mainstream narrative often dictates public opinion and actions, I have chosen a less-travelled path: doing the opposite of what is generally advised.

This approach has been surprisingly effective. From questioning untested pharmaceutical treatments, doubting the traditional food pyramid, and navigating the complex world of higher education and its associated financial burdens, I’ve embraced a path of scepticism and self-reliance.

Within traditional finance, this philosophy extends to the use of cash. Contrary to mainstream advice, which favours digital transactions for convenience, cash offers distinct advantages.

It offers control, privacy, and immunity from censorship.

These values might seem insignificant until they become crucial, as vividly illustrated by the plight of Canadian truckers. Yet, there’s a growing sense that the era of cash might be nearing its end. As cash is issued by central banks, its existence could come to an end if they choose to discontinue its issuance.

Most people don’t realise that their money is essentially just numbers on a screen and doesn’t really exist in a tangible form. The funds displayed in your online banking app are, in a technical sense, not entirely under your ownership either, as banks have the authority to lend out and use your deposits.

Holding onto cash as a long-term strategy also poses challenges. The diminishing purchasing power of cash, a result of government overspending and increasing debt, is a harsh reality. A depressing amount of our tax money goes on war and interest debt. We are forced to pay our hard-earned money on mismanaged finances and forever wars.

The historical example of Weimar Germany, where hyperinflation rendered cash worthless, is a cautionary tale. The

financial crisis of 2008 and the economic disruptions during the covid-19 pandemic further illustrate how government policies can favour large corporations over small businesses, leading to what some describe as crony capitalism.

Gold has traditionally been a refuge against currency devaluation, but it is with limitations, especially regarding mobility and ease of transaction. Enter Central Bank Digital Currencies (CBDCs), a modern solution that leverages blockchain technology.

However, the efficacy of CBDCs is still a matter of debate, as evidenced by the failed projects in countries like Nigeria and China.

They also offer programmability into our money, a feature that has not existed before in money. This will allow the government to close the loop on our growing surveillance state.

Looking ahead, it appears increasingly likely that cash will become obsolete in the UK, to be replaced by CBDCs. CBDCs will be pitched as a solution to inflation and the cost-of-living crisis. However, this will be another government mistruth designed to confuse and distract.

A CBDC is essentially a digital version of our current, weakening currency, but with the added feature of programmability – controlling where and what you can spend on, and even setting expiry dates.

This represents a fundamental change to the nature of money, which is being introduced by stealth to avoid public uproar.

In this context, the mainstream media’s stance on Bitcoin is noteworthy. Often portrayed negatively, Bitcoin is dismissed as a tool for illegal activities or an environmental threat. However, these criticisms are not true and overlook the fundamental attributes of Bitcoin as a decentralised, peer-to-peer electronic cash system. Money that has a connection to real work and energy, like gold, and is not created from thin air.

What, then, would constitute ideal money? Consider a currency with a capped supply to prevent debasement, like Bitcoin, which is limited to 21 million coins, yet highly divisible by 100,000,000 ‘Satoshis’. Bitcoin’s design makes it censorship-resistant, enabling transactions without intermediaries.

It’s also permissionless, allowing free access to anyone in the world, further democratised by innovations like sending Bitcoin via SMS, a boon for those without smartphones.

Bitcoin banks the unbanked, and provides a solution for those distrusting their governments, or who have been debanked for having non-mainstream views.

Bitcoin’s open-source nature ensures transparency and ongoing improvements in transaction costs, speed, and privacy. This represents a new form of money that aligns with the principles of freedom and autonomy. It challenges us to rethink our approach to currency and financial sovereignty. It is a global money outside of governmental control.

Alongside traditional assets like gold and

cash, Bitcoin offers an alternative worth considering. Its resistance to debasement and growing acceptance makes it an appealing option for transactions and savings.

However, it is important to differentiate Bitcoin from the broader category of cryptocurrencies, as this article specifically advocates for Bitcoin. Bitcoin and crypto are not the same.

The best thing about Bitcoin is you don’t need to ask permission. Transactions are confirmed, not approved.

The truth is we are all equal

It's just that some of us are more so than others

Or are we? This 'equality' that has suppressed uprisings for millennia is malleable, and can be shaped for the convenience of those who 'have' in this world.

In theory, the 'haves' are not above the law, but in practice, history books show us, they have done as they please.

But, like with all official history books that most of us have been subjected to, they stop short of shining a light on more recent and equally grotesque misdemeanours committed by those in power.

To do so would illustrate that we have not

learned from our precious history, and that would not do if the masses are to be suppressed by a sense of equality for all.

One such group of 'haves' - the British Royal Family - don't come across particularly well in history books covering times of old.

But in the last century or so, they have gotten quite a good show. Collectively, they are a jolly good thing for one and all.

Like with all families, they have the naughty and nice members, and within reason, the naughty ones can be flogged in public via the corporate press. And so Prince Andrew has been flogged.

He said: 'The delays in release create a vacuum for speculation and fantasists; their release would go some way to restoring trust in institutions, not least the monarchy.'

Lownie need not worry, the masses still believe we are all equal, it's just that some are more equal than others.

Power's democratic mask

Analysis of conspiracy deniers

Copy-and-paste arguments attempt to shut down debate

DISTRIBUTING *The Light* newspaper in my town centre, I met a well-spoken, middle-class woman who asked what free material I was offering.

Before I could answer, she saw the title and visibly flinched.

She said: “I’ve heard all about that paper on the BBC, it’s full of conspiracy theories.”

As I suspected, she had heard Marianna Spring’s *Conspiracyland* missives on Radio 4.

I tried to explain that Spring’s role is not objective journalism, but to smear truth-seekers whose government appears to be following a globalist agenda.

“I don’t know who to believe,” she replied. That would be a fair position, but she was unwilling to hear the other side of the story.

While mainstream media ignore or denounce any legitimate discussion about the Great Reset and a looming technocracy of totalitarian surveillance and rationing, the latest edition of the *Hastings Independent* has a remarkably balanced approach.

After a feature in the previous edition suggesting that conspiracy theories should be taken on merit, the newspaper was criticised for giving oxygen to dangerous disinformation. In response, the editor invited two writers to argue for and against such thinking.

Presenting the case for defence, Jonathan Andrews, under the title of ‘Tin Foil Hatter’ (a self-deprecatory trait absent in censorial puritans), argued that conspiracy theorists have so often been proved right that they have higher predictive value than those representing the official narrative. For example, their warning that the authorities would impose a cashless society and digital currency is rapidly becoming reality.

‘A threat to all’ was the case for the prosecution, by Neil O’Warne. ‘It’s very disappointing that you gave a whole page to Kent Barker’s attempt to minimise the damage done by conspiracy theories and turn them instead into a free speech debate,’ O’Warne began. He focused on Barker’s ‘wrong-think’ and its deleterious impact on society.

He said: ‘In a town like Hastings, where you can hardly lift a pebble on the beach without stumbling over some fictitious conspiracy or other, I think that it is highly irresponsible to encourage these fantasists.

‘It’s important that the people who try to sell “alternative facts” are challenged at every turn. In reality, it’s not the powerful,

but the rest of us that are threatened. Conspiracy theories are toxic to people, communities and civil society as a whole.

‘The vast majority of conspiracy theories are deliberately created to promote right-wing talking points and ideas. They don’t just spontaneously appear from people doing their own research.

‘These conspiracy theories are then pushed into the mainstream through right-wing media companies like Fox News or GB News.’

Does O’Warne watch GB News? Apart from the eloquent sage Neil Oliver, this channel is justifiably deemed ‘controlled opposition’ for its limited airing of contrary opinion.

Then O’Warne suggests an underlying motive: ‘The idea of Cultural Marxism, which has literally never existed except as an anti-Semitic conspiracy theory, has even travelled so far through the political mainstream that it was used by the Home Secretary Suella Braverman in a speech

earlier this year.

‘Anti-Semitism runs through most conspiracy theories like letters in a stick of rock.’

O’Warne is parroting the line that any mention of a ‘New World Order’ is definitively anti-Semitic. Cultural Marxism is the ideology of radically changing society by undermining and reshaping the culture, as propagated by the Frankfurt School and Antonio Gramsci, and encapsulated by the phrase ‘long march through the institutions’.

If O’Warne doesn’t believe it exists, how would he describe the form of Marxism that stirs up a cultural rather than economic revolution – Marxism that is cultural? Perhaps having heard too much of Marianna Spring, O’Warne regards conspiracy theory as a real and present danger.

He said: ‘Secondly, and most measurable and obvious, is the physical harm that conspiracy theories cause. Public health

issues, like the large rise in cases of measles in the UK recently, were caused by anxiety over non-existent links between MMR vaccines and autism.

‘This can be directly related to proven false information spread by anti-vaxxers. In the USA, covid deaths amongst Republican voters were 43 per cent higher than Democrat voters purely because Republican voters refused vaccines due to ludicrous conspiracy theories pushed by right-wing politicians.

‘A quarter of mass shootings in the USA between 2016-2020 were carried out by people directly inspired by right-wing conspiracy theories. Attacks and harassment triggered by conspiracy theories are also common in the UK.’

Readers will immediately see the problem here – O’Warne gets all his information from approved sources. Unwittingly, he is immersed in the conspiracy that only sceptics see.

‘Thirdly, and most important of all, is the damage caused to civil society and political discussion by the poison of conspiracy theories. By promoting cynicism, the “they’re all the same” attitude and anti-democratic assumptions, conspiracy theories fragment communities and alienate people, telling us everything is lost, whilst at the same time destroying the solidarity we need to change things.

‘Many people are rightly disenchanted with a political establishment that has largely abandoned them, but conspiracy theories are being weaponised by the right to attack our means of changing anything. Politics has become a dirty word. But we need politics to get ourselves out of the mess we are in. We need community and solidarity to defend ourselves and build a better world.’

The whole package of conspiracy denial is here. Critical thinkers, who realise that their government is acting against the interests of the ordinary people, must be vilified, if not criminalised. They are nasty, right-wing, anti-science, regressive xenophobes, now revealing themselves as anti-Semitic.

O’Warne could be copying and pasting from the Anti-Defamation League, a body that claims to represent Jewish interests, but instead protects a globalist cabal that wants to continue its dystopian programme unhindered by too much public awareness. The likes of O’Warne are useful for the super rich, who steal our belongings, liberties and future.

Traveller's adventure of a lifetime

3 Seconds in Bogota

Mark Playne

HAVE you ever wondered what it would be like to be tested? No, not tested like a driving test, but rather a life test of capability, of what YOU are capable of.

Mark Playne's novel *3 Seconds in Bogota* places the reader at the heart of the 1990s, during the peak of the South American drug cartels, and North America's War on Drugs.

Kurt Cobain was dead, the Red Hot Chili Peppers had just released *Under The Bridge*, and U.S. President Bill Clinton was definitely not having sexual relations with a particular intern at the White House.

We are thrown into life, and love, on the roads of Argentina, winding through Playne's first-person true story. The situations and experiences that the reader is drawn into are peppered with Playne's enthusiasm and natural ability to weave a narrative, infusing his characters with archetypal qualities and intricate idiosyncrasies with ease.

There's an allegorical and parable-like quality to each chapter, which seems designed to prepare the reader for the next, like a moral breadcrumb to store up for later. Seeing this time in history through Playne's eyes, he provides helpful reminders of the events of the day scattered through the adventure in South America.

This is a tale of life on the road. The life of the vagabond, the wayfarer travelling on the steam of his ingenuity and wit. It is also a tale of reflection, of the sum of our parts and what conspires to make us human (in some cases inhuman), and who is to judge.

Characters are developed from within the narrative, emerging slowly from the deep, rather than being hastily thrown in, as with so

many of the genre.

Mark's steadfast companion and muse on what feels more like a quest than a collection of travel stories, Luciana, is developed almost on her own. She appears in the reader's consciousness over the first few chapters, subtly drawing us in like a Siren on the rocks. It's when Mark and Luciana's paths cross that we set sail on our adventure through South America.

If you've ever had the good fortune to travel – really travel, like months-at-a-time travel, full-immersion travel – you'll be familiar with Playne's easy dialogue, never straying into predictable or rehearsed territory. Life is breathed into the pages by Playne's real-life experiences. One can imagine being part of the scenes, a participant in the tale.

Confronting and ultimately shocking, Playne captures the imagination of those who have never travelled to this part of the world, the memories of those who have, and weaves an intoxicating cocktail of humour, deprivation, relief, and, in many ways, introspection. I'm left wondering



if there's some catharsis for the author in the writing.

The book builds to fever pitch as we progress through the latter chapters, gathering pace. This is when it's hardest to put down. Mark has utilised a very clever approach to keeping the reader aware of the passage of time, or as Mark might say, *real-time*.

Three seconds of *real-time* to be precise.

Turn the tables on corporations

Dave Molden talks to Richard House on seriously inconveniencing big business

It's time to turn the tables and stand our ground against faceless corporations

Richard House [RH]: People can often feel pretty much helpless in the face of the sheer scale of bureaucratic corporate power. But you have other ideas! Introduce us briefly to what you've been up to.

Dave Molden [DM]: Yes, you're right – it can seem like a hopeless case fronting up to the corporates. But if large numbers of us do it, we can send them a strong message that corporations themselves need to be pushing back too.

RH: So what did you do?

DM: I cancelled my direct debit (DD) with Octopus about a year ago, and told them I refuse to accept an increase in my energy bill for doing so. They replied, saying that DD payment will save me £80 per year, so I do not pay all my bill, only a portion, until they refund the amounts added for non-DD payments. This is an ongoing private dispute.

Then I found Greg Jackson, CEO of Octopus,

on Twitter and I sent him a direct message regarding the truth about how the UK colluded with Norway and the US to destroy Nordstream. I sent him a link to Seymour Hersch's blog about this and told him he needs to be pushing back on the energy giants who are making huge profits. I then sent another message saying that I'm waiting for the government to pay my energy bill; since they can find money for a fake pandemic and constant wars, they can find money to pay my bill.

Because I keep a negative balance on my energy account, I received a letter threatening to install a pre-payment smart meter, give me a bad credit rating, and engage debt collection. So I sent a strong letter to Octopus telling them to stop the threats, to stop promoting smart meters on their website, and included links to information about EMF radiation, and that our house is wifi free due to its occupants being EMF radiation-sensitive. I added that I will not use their website to make payments until they remove the smart meter promotion.

RH: What did they say to that?

DM: They replied saying that analogue meters are no longer manufactured, so I told them to push back on this. Then I received an email saying I could pay by calling their payment hotline. I tried this, but hung up after a minute of awful on-hold music. So I emailed them, saying that I am too busy to waste time holding for an

agent, so you can call me, or give me your bank details and I will make a payment by bank transfer.

RH: You could almost make a soap opera out of this!

DM: Indeed! Next I received an email from a company called Orphelo, or something like that, with my Octopus account details, saying they are collecting debts on behalf of Octopus via their app. So I emailed Orphelo and Octopus, stating that they have breached the Data Protection Act by passing on my account details, and I included an FOI request for information on how my personal details were handed to Orphelo, and instructed them to delete it.

RH: It all sounds a bit onerous?

DM: Well, you might say that I'm making hard work for myself; but from my perspective, I've had enough of these big suppliers treating me like a commodity – so I'm standing strong against them, letting them know I'm not just going to accept the way they do business. They're going to have to do it the way I want; and if enough of us do it, they'll have a big problem, as they rely on computer systems to do all their work.

RH: How is this one going to play out?

DM: If and when Octopus do call me for a payment, I'll ask the caller to prove that they are from Octopus by emailing them a security password which they will need

to give me before I engage on the call. It's what they do to us under the term 'Know Your Customer'. My version of this is 'Know Your Supplier'. It's time to turn the tables and stand our ground.

RH: Giving corporations the run-around is a new sport that might just catch on! There's something about self-empowerment and sovereignty in all this, and even transcending victimhood – would you agree?

DM: Definitely! I like the idea of it being a sport. It's no good being awake to the widespread corruption and doing nothing about it. Action is needed. Stand in your power, be strong, and refuse to accept the way things are done. We can change things for the better if we all push back.

Let them know it's time to listen to the people and push back on the greed of government and global corporations. Those in charge of our utilities and services that are toeing the government line need to feel the pressure of public disdain. We can best do this by disrupting their business models that run on computers. As individuals, we have our sovereign power, and when we all come together we can have a real impact. Stand tall, be strong, believe in yourself and let all fear turn to dust.

The Prisoner - a libertarian classic

Insight into our current dystopia from 50 years ago

THE iconic television series makes for a richly entertaining and endlessly thought-provoking entry-point into the globalist zeitgeist.

In the dim-distant 1970s, I shared a rented house in Norwich with five or six other students. The TV series that totally captivated us at the time, guaranteeing that each week we'd be huddled around the box eagerly waiting for the next episode, was *The Prisoner*.

Even then, we all seemed to know intuitively that there was something hugely important about the message of this series for our freedom. It literally mesmerised the nation when first televised on ITV in 1967.

At least some truthers and freedom activists might know little about this iconic series - so I'll try to persuade you in a few hundred words why *The Prisoner* is essential viewing for any reader not acquainted with it.

Filmed in Portmeirion, Wales, where (I'm imagining) no-one owned anything, and everyone seemed to be happy most of the time, *The Prisoner* is about an unnamed British intelligence agent, played by Patrick McGoochan, who is abducted and imprisoned in a mysterious coastal village. He is held captive, isolated from the mainland, with his captors designating him as 'Number Six' as they try to find out why he abruptly resigned from his post.

The Village is little more than a glorified prison camp, populated with numerous high-tech monitoring systems and security forces. The island's inhabitants are assigned numbers which largely give no clue to any person's status, whether prisoner or guard. With Kafkaesque and panopticon resonances, potential escapees thus have no idea whom they can and can't trust.

Civic life in the Village consists of the robotic repetition of cheery slogans masquerading as meaningful communication, with celebrations being superficially cheerful, but with an underlying cheerlessness, reminiscent of the 'celebrations' that typify totalitarian regimes.

The Village's inhabitants incessantly parade the streets waving rainbow flags, mindlessly clapping and whooping. Yet they live in a constant, menacing dread of saying the wrong thing, of being seen not to be celebrating sufficiently, of being seen as individuals (heaven forbid!).

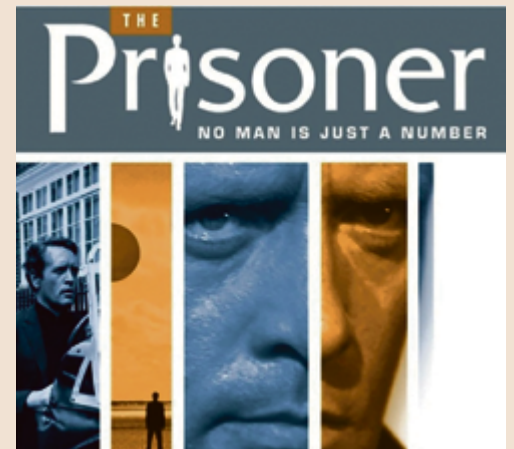
McGoohan himself once said: "The Village is a place that is trying to destroy the individual by every means possible; trying to break his spirit, so that he... will live there happily as Number Six for ever after."

The Village's inhabitants do seemingly live a materially comfortable existence - as long as they conform. Prescient themes that recur in the 17 episodes are those of privacy, individualism and mind control. The depiction of a village election in episode two is a wonderful and prophetic allegory of the

information to do so, was a dramatic device deployed many years ahead of its time.

A major theme of the series is individualism (as represented by Number Six) versus collectivism, as represented by Number Two and the other villagers - with Number Six's indomitable will refusing to be broken, and his famously declaring: "I am not a number; I am a free man."

The storyline certainly contains many warnings about the way society was

vacuous, duplicitous nature of so-called representative democratic systems.

The Prisoner's highly unusual combining of 1960s counter-cultural themes with a quasi-surreal setting has had a far-reaching influence on science fiction, and on popular culture more generally. It has developed a huge cult following - which comes as no surprise to me, remembering how, as doctoral students, we were utterly enthralled by it nearly 50 years ago.

The series also engages with not-knowing, mystery and ambiguity, leaving so many questions unresolved - post-modern, well before that term was even coined.

The Prisoner resists easy answers at every turn, with very little being certain - identities, motivations, goals. The way in which viewers are left to make sense of it all, without anything like sufficient

heading. McGoochan always maintained that the march of technology and progress was too rapid, saying that we should slow down and let technology be our servant, rather than our ruler.

The Prisoner resonates on many levels with books like Orwell's *Nineteen-Eighty-Four*, Huxley's *Brave New World*, Samuel Beckett's *Waiting for Godot* and, most tellingly, Franz Kafka's paranoid, mad-making world so brilliantly depicted in *The Trial*.

There's also a crucial connection between *The Prisoner* and the so-called 'audit culture', about which I've written at length in the academic literature.

Yet Number Six was there some three decades earlier, with his legendary assertion: "I will not be pushed, filed, stamped, indexed, briefed, debriefed, or numbered. My life is my own."

The Prisoner is highly entertaining, unnerving, dramatic, and at many points, hilarious, as well as being a profound allegory for - and warning about - our times. A claustrophobic, surreal post-modern masterpiece, with a plot that, even by today's standards, can be described as avant-garde. It somehow manages to achieve both light relief from, and yet full engagement with, the globalist zeitgeist - a quite stunning creative achievement.

To those seeking a different entry point into thinking about what's unfolding at this juncture in human history, I can't recommend it highly enough.

We perhaps underestimate the extent to which out-of-the-box drama and fiction can illuminate what is going on in these momentous times.

Illusion of democracy created with pantomime politics

THE constitution of North Korea proclaims it a democratic republic.

In reality, their single-candidate elections are merely for show, and those who wish to reject the sole candidate must do so in a specially monitored booth - an act which risks persecution, incarceration or death.

Who are they trying to fool with this pantomime? Perhaps no one. Instead of a mechanism for government to (allegedly) derive authority from a democratic mandate, their voting is instead a ritual of humiliation and subjugation.

In the Western world we are told how fortunate we are to live in true democracies. Systems of government so well-perfected that our leaders yearn to export them to less fortunate nations - often at gunpoint. Doubtless it is coincidence that many of these democratically unfortunate nations are highly fortunate in other ways - such as in the possession of abundant oil, gas or mineral resources.

What makes a Western democracy different to the North Korean model? Well, instead of a single party, there are typically two, or sometimes three, main parties on offer.

Cynics may suggest that in practice, these opposing parties often represent a single establishment 'uniparty' - yet others say nay! They debate approved divisive political issues with furious passion! They wear different colour ties! Thus the electorate are presented with an illusion of choice.

Noam Chomsky once wrote: 'The smart way to keep people passive and obedient is to strictly limit the spectrum of acceptable opinion, but allow very lively debate within that spectrum.'

This spectrum is known as the 'Overton window'. You may read *The Guardian*, etc. and support the Labour Party. You may read *The Telegraph*, etc. and support the Tory Party.

Political opinion outside these

bounds is banished to the outer darkness by the word 'far' (merely denoting populist), and by a variety of other insults and smears. Far Left. Far Right. Extremist. Fanatic. Loon. Mob. Terror sympathiser. Woke. Conspiracy theorist. Communist. Fascist. Antisemitic. Racist. Something-aphobe, and a host of similar playground jeers.

The establishment media of both Left and Right comprise in their totality a finely tuned propaganda machine designed to divide us and ensure that any populist resistance remains mired in infighting, and thus may never hinder the elite.

Sometimes the establishment's 'current thing' may require them to coddle one side to help subdue the other. Leftist sentiment was manipulated to label covid dissenters as 'scary far right' and rightist sentiment is being similarly manipulated today to

label anti-war or pro-Palestinian dissenters as 'scary far left'.

Could there be any better demonstration of how the Left-Right perspective has become weaponised?

Many who admit that Western democracy isn't perfect may still mock comparisons with North Korea. Indeed, we are more comfortable under this slightly more elaborate fake democracy.

Yet though the velvet glove is rather thicker in the West - better concealing the state's iron fist - this is still a carefully crafted illusion.

As Frank Zappa once said: "The illusion of freedom will continue as long as it's profitable to continue the illusion. At the point where the illusion becomes too expensive to maintain, they will just take down the scenery, they will pull back the curtains, they will move the tables and chairs

out of the way and you will see the brick wall at the back of the theatre."

The occasional rotation of tie-colours lulls the unwary into false hope that a change of superficial government may bring real change, and is thus a handy safety valve for public discontent - until the hopium hit wears off and another election is required to renew it.

I still remember the heady excitement and optimism I felt as a naive student when Tony Blair's Labour won power in 1997, and D-Ream's Things Can Only Get Better was blasting out through the student union bar.

The Iraq War betrayal dashed my foolish illusions for ever, and it is interesting to compare the 'dodgy dossier' of Iraq's supposed weapons of mass destruction with the more recent dodgy dossiers of absurd computer modelling used

to terrify parliamentarians into toeing the climate and covid lies.

Where faked evidence and panic-mongering are not sufficient to bring the elected useful idiots into line, then flattery, bribery and blackmail (e.g. Epstein's notorious island) will usually do the trick.

The mysterious death of WMD expert Dr David Kelly after the Iraq War hints at the shady world of deep politics where the true power lies.

Douglas Adams once wrote: 'The President in particular is very much a figurehead - he wields no real power whatsoever. He is apparently chosen by the government, but the qualities he is required to display are not those of leadership, but of finely judged outrage.'

'For this reason, the President is always a controversial choice, always an infuriating but fascinating character. His job is not to wield power, but to draw attention away from it.'

Power becomes ever more distant and centralised, and, just as local government has mostly been relegated to the unglamorous task of emptying bins, national governments are fast becoming mere rubber stamps for unelected globalist institutions - snapping to attention and saluting smartly when the globalist elites declare a war, a pandemic or a climate emergency.

'Global problems require global solutions', they cry - not realising that the tendency to centralise power and wealth in the hands of ever-more distant, unaccountable and hubris-ridden elites is at the root of most of our problems, and should be reversed.

We can't wait for other people to save us

Hi, I'm Catherine, leader of the Freedom Alliance party, but I'm not your typical leader. I rock up at council meetings in dirty work clothes, stand on roundabouts holding yellow boards in the rain. I've sung 'People Got The Power' on a rock album. I am proud of what I have become.

Early in 2020, I was an ordinary person, working hard in a low-paid job, raising three children alone. I grumbled at the news, moaned about the situation, and always switched off the radio propaganda. I still am that person. The difference is now I don't put up with it any more – I do stuff!

As events unfolded in China, I thought: "Will it come here? Will we die?" I don't watch TV. However, I took great interest in the statistics and listened to the media.

I am glad I did, because it raised more questions than there were answers available. Toilet roll-mageddon arrived. I guiltily bought an extra pack, a freezer and a shed-load of food. I'd seen enough zombie films to conclude it was either 'run for the hills' or sit it out as the bodies pile up.

All the while, this wasn't making any sense. This was unnatural, unreasonable, fear-driven behaviour. Not my bag. A strong nagging feeling that all was not right grew. Was I going mad? Everyone else was full throttle. I wasn't remotely afraid.

Witnessing the government's pandemic strategy roll-out, the future for my children's freedoms, rights and prospects looked bleak. Their education, social

relationships and mental health suffered.

I felt alone, segregated, discriminated against. The worst feeling was helplessness. Not my bag, either. I am a strong believer that there is no fate but what we make for ourselves. By chance, my daughter spotted a White Rose sticker on a bus stop. So started the Butterfly Effect. Thrilled with the hope of finding like-minded people, I forced myself onto social media.

Finding someone to connect with was a huge relief. A stranger tentatively met in the park turned to two strangers in the park - A Stand in the Park, Birkenhead was born.

We turned our efforts to public outreach in town centres, handing out *The Light* and leaflets, engaging with the public, running petitions, marches, rallies, door-to-door leafleting campaigns; you name it, we've done it.

The smallest action to resist, defy and not comply, or supporting others to do the same, can be exhilarating. It's an intensely good feeling knowing you are doing something positive to counter the



tyranny upon us.

Driven by both determination and desperation, when the mRNA shots were being offered to under-18s, I was hungry for more groups to get involved with; I would protect my children's bodily autonomy at all costs.

The more I did, the more my confidence grew. From Against Vaccine Passports, to the Together Declaration, Save Our Rights, Debbie Hicks, local groups and more, I've met and learned from so many people committed to the cause, but utilising different strategies. Even if we don't see eye to eye, or agree on matters outside of the freedom movement, it's important that we work together respectfully.

Passionate people keep me going. Together, we've delivered over 50,000 *Light* papers, more than 150,000 leaflets, and had hundreds of conversations with the public. We're currently fighting the almost blanket zomph roll-out on the Wirral, all part of the plans to reduce the number of cars on the roads, making it harder and more expensive

for us to travel.

This anti-20 campaign, including doing yellow boards on roundabouts, leafleting and lobbying councillors is a collaborative effort from the Freedom Alliance party, our SITP (Skeptics in the Pub), the local Together Wirral branch, Reform UK candidate Ken Ferguson, other local groups and individuals not from the freedom movement.

I discovered the Freedom Alliance party last year. Being politically homeless, it seemed the most credible political arm of the freedom movement. It had realistic solutions to bring us through the pandemic, and goals I believe in, e.g. decentralisation, localism, proportional representation.

The party went through changes of leadership, and I felt it was too important a part of the movement to lose. It took real courage to put myself forward, but the membership voted me in! We can't wait for other people to save us. We must act in whatever capacity we can. It is an honour to fight tyranny now as Leader, too. It's not whether we get our party into power, but that we get the party in power to listen to the will of the people. If we can break the system and build a new one, even better.

The strength of our party is your support and your action. Our movement has the power to resist, to not comply. But we need to work harder to get the message out to the masses, to protect our freedoms and regain the rights taken from us. We have at best a year to use the General Election to our movement's advantage.

Online Safety Act 2023

Described by the international human rights organisation *Article 19* as an '*extremely complex and incoherent piece of legislation*'.

This act poses a threat to the privacy, human rights and civil liberties of every UK citizen by curtailing fundamental freedoms such as that of free speech and free press.

Public Order Act 2023

This Act limits the freedom to protest in certain places such as power stations or near hospitals and abortion centres. Despite claims that its implementation is for the protection of patients and workers, its powers have proven to be far overreaching and easily abused.

Abortion (Amendment) Regulation 2022

Amends the Abortion Act 1967 to provide for at-home abortions to mothers whose babies are at under 10 weeks gestation. A doctor can certify 'on good faith' that the baby is below the 10 week threshold before sending abortion medication, meaning no scan or evidence is necessary, thereby broadening the ability to murder babies without due process.

Contempt of Court Act 1981

Severely restricts the ability to comment on court cases publicly or using social media, even where the individual is unaware of any censorship by the judiciary. Those found to be in breach of this Act can be sentenced to up to two years in prison as well as facing a fine.

Elections Act 2022

Being the most significant change to the voting process in around 150 years, this Act makes it a legal requirement to present identification upon voting in general elections. This could be considered to alienate young and marginalised voters by hindering their involvement in the voting process.

Judicial Review and Courts Act 2022

The Act introduces suspended quashing orders (SQO) and prospective quashing orders (PQO), in addition to the regular quashing orders, meaning unlawful Acts can remain valid, even if just for an extended period of time. Broadens the remedies used by the courts to grant and limit the use of judicial review as a route of appeal from the tribunals.

Police, Crime, Sentencing and Courts Act 2022

Far-reaching new powers for police; usurps constitutional right to protest and criminalises marginalised communities. Despite over 700 academics and 350 charities in direct opposition to the Bill, it was given Royal Assent in April of 2022.

Genetic Technology (precision breeding) Act 2023

Precision Breeding - described by Birmingham University as 'gene editing technology to make targeted changes to the genetic code of organisms' - is not required to be clearly labelled, therefore potentially undermining consumer protection and free choice to not consume genetically modified foods or the products of genetically modified animals.

Terrorism Act 2000 (places of detention) Designation 2022

While seeming to be a piece of legislation which protects the national security of the country, it allows for any police station to be considered a place of detention at which persons can be detained under the Terrorism Act 2000. Misused to unlawfully detain protesters and dissidents.

Health and Care Act (water fluoridation) 2022

This Act amended the Water Industry Act 1991 to transfer the responsibility and power to the Secretary of State for Health to implement and terminate water fluoridation schemes. This power was previously with the Local Authority, whom this Act relieves of that duty, in yet more centralisation of power.

EU Digital Services Act

EU will impose huge sanctions on companies if they fail to remove illegal content, including 'hate speech', from their large digital platforms. In summary, users of these platforms can be banned for sharing content which the EU concludes to be criminal, including 'misinformation' and hurt feelings.

Climate Change Act 2008

Committing the UK to reduce its emissions of greenhouse gases by up to 80 per cent by the year 2050. This Act legislates a responsibility to tackle and respond to the Trojan Horse climate change agenda, used to restrict our freedoms incrementally, in the name of lower carbon dioxide, which has zero effect on temperatures.

Banking Act 2009

Allows banks to legally confiscate our money. Any money stored in a banking institution is now an unsecured loan to the bank, and account holders will share in bank losses with no recourse. Disguised as a stabilisation tool, similar legislation was used in the 2013 Cyprus financial crisis to seize people's hard-earned savings.

National Security Act 2022

Supposedly to strengthen the national security of the UK against espionage, interference in the political system, sabotage and assassination. Another Act that, while being introduced under the pretence of being for the hard to imagine being used against law-abiding citizens.

Covert Human Intelligence Sources (criminal conduct) Act 2021

Legalises criminal conduct of covert human intelligence sources - so long as the conduct is thought to be proportionate to what is sought to be achieved by that conduct. Those employed by the state and paid by the people to obstruct and investigate crimes, can be authorised to commit crimes in the course of their duty.

Energy Act 2023

Described by Energy Security Secretary Claire Coutinho as "the largest piece of energy legislation in a generation" this Act aims to boost the roll-out of smart meters. This includes a five-year extension of the secretary of state's power to modify energy license conditions and industry codes for the sole purpose of pushing smart meters.

Zero Emissions Vehicle Mandate

In an attempt to switch to a nation of electric vehicles, this mandate requires 80 per cent of new cars and 70 per cent of new vans sold in Britain to be zero emission by the year 2030 and increasing to 100% over the subsequent 5 years. Further pushing the green agenda as laid out by the United Nations/World Economic Forum's Sustainable Development Goals.

Digital Protection and Digital information Bill

This Bill will establish a framework to facilitate digital verification services, enabling the replacement of paper documentation with digital identities. It will be used for birth and death registration, law enforcement and national security, and for the processing of data by political parties and elected representatives.

Covid sceptics back in political trap

If we want freedom why not afford it to Palestine too?

ON October 7, a large number of Hamas militia somehow crossed the most heavily secured border in the world to kill and kidnap Israeli citizens.

According to the authorities in Tel Aviv, about 1,400 died in the attack, and over a hundred were taken hostage. Benjamin Netanyahu’s government immediately declared war, and began an aerial bombardment of Gaza city, destroying swaths of apartment blocks. Water and electricity supply to the enclave was cut, and Israel ordered the full evacuation of the northern half of Gaza, prior to its tanks going in.

This latest eruption of the deadly conflict raises important questions. First, did the Israeli state know of the Hamas operation, why were watchtowers and other security posts unmanned, and why did it take several hours before the army arrived? Secondly, why was the blitz of Gaza justified rather than condemned by Western leaders? Prime Minister Rishi Sunak stated that Israel has a right to defend itself.

But this was not defence: it was a massacre of inhabitants of a densely-packed urban area, and soon the death toll was a multiple of that killed by the initial terrorism.

Much of the mainstream media took Israel’s side, as did many independent outlets and commentators from the right of the political spectrum.

Simon Elmer was a trenchant critic of the covid-19 regime, whose essays were compiled in *The Road to Fascism: For a Critique of the Global Biosecurity State*.

He tweeted: ‘Many of those who for three years denounced government lies about covid, opposed censorship and were called anti-Semitic for doing so, now believe everything the government says about Gaza, want to censor protest against the genocide, and denounce anyone calling for a free Palestine as anti-Semitic.

‘The stupidity with which the Left unthinkingly aligned itself with lockdown, gene-therapy mandates and environmental fundamentalism has been matched by the stupidity with which the Right has unthinkingly aligned itself with Zionism, collective punishment and genocide in Gaza.’

The strategy of divide and rule seems to work for the powers-that-be every time, despite the great awakening in the

pseudo-pandemic.

War in Ukraine also fractured the so-called freedom movement, albeit fleetingly as people realised the ulterior motives, but this time the split is more damaging.

Many conservatives and right-wingers fell hook, line and sinker for the story told by the BBC and Daily Mail, because it fits their world view of a religious clash of civilisations. They called for mass marches in support of the Palestinians to be banned and participants arrested for glorifying terrorism.

Covid-19 sceptics, Allison Pearson, Laura Dodsworth and Toby Young launched the ‘October Declaration’ in support of British Jews.

Of course, all communities should be free from abuse, but the petitioners ignored the persecution of Palestinians in their homeland. Are the victims of Israeli missiles of a lesser god? I submitted a mild corrective to the pro-Israel barrage on Daily Sceptic but this was rejected for failing to support military intervention.

Influential figures who saw through the covid scam uncritically accepted Israeli propaganda. When hundreds died in a strike on the main hospital, the story of a misfired rocket from Gaza was taken as fact. But according to military experts, the damage could not have been caused by the crude arsenal of the militia (little more than pipe bombs).

The horrified commentariat did not consider if the Hamas attack was allowed to happen (it has been claimed the Egyptian Government informed Tel Aviv of the mission three days before).

Furthermore, Western voices reinforced the Zionist message that the Palestinians are collectively guilty for electing Hamas.

But it has been claimed Hamas was actually a creation of Mossad to undermine the peaceful Palestinian Liberation Organisation and its charismatic leader, Yasser Arafat.

It is difficult to believe that the event on October 7 was not facilitated to some degree by the Israeli authorities. Cui bono (to whom is it a benefit?) – the land grab continues without opposition from the USA, UK and EU.

The Israeli Defence Minister, who claimed they were fighting ‘animals’ in Gaza, said that his country had experienced its 9/11.

And yet, arguably, the Twin Towers event over twenty years ago was the most dramatic false-flag event ever committed. It led to war in Iraq and Afghanistan, and heightened surveillance on citizens’

Mossad faces false flag allegations

‘ Hamas funded into existence to disrupt peace ’

Is Hamas (Islamic Resistance Movement) an Israeli intelligence ‘asset’?

AND as such, is it covertly used against both the Israeli and Palestinian populations? It could be argued that some of the evidence points in that direction.

Prof Michel Chossudovsky, editor of Global Research, claimed Hamas was founded in 1987 by Sheik Ahmed Yassin. It was supported from the outset by Israeli intelligence as a means through which to weaken the Palestinian Authority, he alleged.

According to Prof Chossudovsky, Israeli intelligence services promoted and facilitated Hamas’ rise as a counterweight to the secular nationalists of the Palestinian Liberation Organisation (PLO) under Yasser Arafat.

It is also claimed that Zeev Sternell, historian at the Hebrew University of Jerusalem, said: “Israel thought it was a smart play to push the Islamists against the PLO.”

Other allegations include the Israeli Cabinet, in 2003, ordering the assassination of Yasser Arafat. It was allegedly approved by the U.S., which vetoed a UN Security Resolution condemning the Israeli Cabinet decision. Arafat died the following year after a short period of illness, aged 75.

The cause of his death has since been debated, and several different theories concerning it have been suggested. However, official investigations by French and Russian teams did not find evidence of foul play, it has been claimed.

The death helped ensure Hamas gained power in the Palestinian Authority elections of 2006. The stratagem served to sabotage prospects for peace.

These alleged manoeuvres are also described in detail in former U.S. president Jimmy Carter’s book, *Palestine: Peace Not Apartheid*, published in 2006.

In a speech to the U.S. House of Representatives in 2009, Republican Ron Paul said that Israel “encouraged and started Hamas”.

Prof. Chossudovsky wrote: ‘Thanks to Mossad (Israel’s ‘Institute for Intelligence and Special Tasks’) Hamas was allowed to reinforce its presence in the occupied

territories. Meanwhile, Arafat’s Fatah Movement for National Liberation, as well as the Palestinian Left, were subjected to the most brutal form of repression and intimidation.’

He alleged that Mossad has a mandate to create divisions within the Palestinian Resistance Movement, while sustaining fear and routine terrorist ‘false flag’ events against its own Israeli civilians, which sustain the ‘Justified Vengeance’ narrative.

As Machiavellian as it sounds, false flag events are contrived by intelligence services to misdirect public perceptions

and elicit a response of ‘useful outrage’, at whatever cost.

Prof Chossudovsky added: ‘The doctrine of ‘Justified Vengeance’, initiated in 2001, is the cornerstone of Israel’s intelligence narrative. It provides a justification to carry out acts of genocide with the support of the International Community, first in Gaza, then in the West Bank.’

He claimed the Hamas attack on October 7 this year was a false flag operation ‘carried out by a faction within Hamas, in liaison with Mossad and U.S. Intelligence.’

The Guardian newspaper reported in October this year that Israeli PM Benjamin Netanyahu is on record, declaring to his Likud party: “Anyone who wants to thwart the establishment of a Palestinian State has to support bolstering Hamas and transferring money to Hamas... This is part of our strategy – to isolate the Palestinians in Gaza from the Palestinians in the West Bank.”

In *Palestine: Peace Not Apartheid*, Jimmy Carter writes that ‘Israel put confiscation of Palestinian land ahead of peace.’

Israel leads the world in surveillance and IT technology, and in a merger with the U.S. military complex, has the potential to unleash death and destruction in the Middle East, with all the consequences that implies – twenty years after the UK joined the U.S. in invading Iraq under the manifest lie of weapons of mass destruction.

Prof. Chossudovsky further claims that Mossad, combined with Shin Bet (Israeli Domestic National Security) and Aman (Israeli Military Intelligence) had extensive covert capabilities.

He alleges that over the years it has infiltrated both Hamas and the Palestinian National Authority. In liaison with U.S. Intelligence, it also exerts control over Al Qaeda operatives, ISIS and Daesh throughout the Middle East.

The question is, are the populations of the world ready to see through their governments’ lies and divide-and-conquer stratagems?

Macron bans anti-zionist protests

Declaration fights back to protect free speech

THE autocratic, anti-free speech Macron government has recently made protests against Israel and Zionism an illegal offence.

The concepts of liberty and freedom that once were the cornerstone for the proud French Republic are now undermined with constant attacks on free speech and freedom of expression.

French President, Emmanuel Macron, said: “Let us not bring ideological adventures here to France by imitation or by projection. Let us not add national fracture... to international fractures.”

Pro-Israeli Macron recently justified Israel’s unrelenting and bloody attack on Palestine by saying that the country had a right to defend itself but “has to preserve civilian lives” because it is the duty of democracies to only respond to terrorism in terms that are strong but fair.

The United Nations (UN) has reported that children in Gaza are paying the heaviest price with thousands of deaths reported.

In a Telegram post quoted by news agency, AFP, Interior Minister, Gerald Darmanin, said: ‘Pro-Palestinian demonstrations must

be banned because they are likely to cause public disorder.’

The Minister added that foreign nationals partaking in these protests ‘must have their residence permits systemically withdrawn, and deportation implemented without delay.’

The shutdown of any protests critical of Zionism has been justified under the guise of ‘public order’ offences. Free speech advocates in France have called the shutdown an attack on free speech and civil liberties.

Charlotte Vautier, who attended one of the large rallies in France, told Reuters News Agency: “We live in a country of civil law, a country where we have the right to take a stand and to demonstrate, it is unfair to forbid one side and to authorise the other, and that does not reflect the reality of Palestine.”

Reuters News reported that since October 7, France has banned over ten protests and issued hundreds of fines to protestors. France’s top administrative court ruled that the French Government cannot ban protests outright, but instead said that banning protests should be based on a case-by-case basis.

Freedom of speech is clearly under attack in

France, and also across Europe, with the EU leading the way for more censorship laws across the continent.

Since August, the EU’s Digital Services Act (DSA) has set out a series of legal obligations on various topics that large online platforms must comply with to avoid being penalised. EU Digital Service Coordinators will now target so-called ‘disinformation’ on social networks, and require greater transparency in algorithms and more responsibility on data collection.

However, on October 18, a large diverse international coalition of prominent journalists, intellectuals and public figures from across the political landscape signed a public declaration in defiance of growing international censorship and anti-free speech laws.

Signatories of the ‘Westminster Declaration’ included Jordan Peterson, Tim Robbins, John Cleese, Edward Snowden, Matt Taibbi, Richard Dawkins, Jonathan Haidt, Julian Assange, Bret Weinstein, Glenn Loury, Oliver Stone and Slavoj Žižek.

The nearly 140 signatories of the Westminster Declaration believe ‘the attack on free speech is a crisis of humanity itself’ and declared in their opening statement:

‘We write as journalists, artists, authors, activists, technologists, and academics to warn of increasing international censorship that threatens to erode centuries-old democratic norms.

‘Coming from the left, right, and centre, we are united by our commitment to universal human rights and freedom of speech, and we are all deeply concerned about attempts to label protected speech as “misinformation”, “disinformation”, and other ill-defined terms.’

The Westminster Declaration takes issue with the large-scale coordinated global censorship efforts, otherwise known as the ‘Censorship-Industrial Complex’, in NGOs, universities, online companies and in government policies, who regularly ‘monitor citizens and rob them of their voices.’ The Declaration also highlighted the nefarious ‘subtle methods’ that the ‘Censorship-Industrial Complex’ uses to silence dissenting voices.

Freedom of speech may be at a perilous and fragile stage presently, but many defenders and advocates of free speech will continue to highlight and fight the public and hidden entities that are trying to shut dissenters down.

‘Human origin’ substances for sale

THE European Union (EU) in Strasbourg, France has recently approved a disturbing regulation outlining new rules concerning the use and sale of Substances of Human Origin (SoHO). The plenary session voted overwhelmingly by 483 votes to 52 votes on September 12 to authorise the sale of human embryos.

Under the draft directive, it states: ‘This Regulation aims at setting high quality and safety standards by ensuring, amongst others, the protection of SoHO donors, taking into consideration their fundamental role in the provision of SoHOs and for recipients, as well as measures to monitor and support the sufficiency of the supply of SoHOs that are critical for the health of patients.’

Nathalie Colin-Oesterlé MEP, Rapporteur Group of the European People’s Party (Christian Democrats), said before the vote: “Dear colleagues, 25 million blood transfusions, 35,000 stem cell transplants,

1 million cycles of medically assisted reproduction are carried out each year within the European Union. These figures show how important this regulation on which we are about to vote is. Donations of substances of human origin are essential to the survival and recovery of many patients in the European Union, as well as to the birth of many European citizens, with real public health issues: [The draft regulation aims to improve] protection for donors and recipients throughout Europe, aid better harmonisation in our national systems, and build European autonomy. I sincerely thank my fellow shadow rapporteurs for their work on this report which, I believe, allows us to answer all these questions by recalling the fundamental principle of voluntary and unpaid donation, and the non-commodification of the human body.”

In a joint statement with the German Church’s Catholic Office in Berlin, the Commission of the Bishops Conferences of the European Union (COMECE) outlined their opposition to the proposed regulations. The COMECE believe the draft is a direct attack on the unborn and the wording

within the regulation clearly dehumanises and degrades human life. It stated, ‘The SoHO regulation degrades unborn human life to a mere “substance of human origin” or - depending on its origin - to a “SoHO preparation” equating it (in the regulation) on the same level as skin cells or blood plasma without any sort of differentiation. Human subjects are thus subdued to be mere objects in disregard of their inherent dignity.’

The COMECE took issue with the cold-hearted clinical term substances of human origin. ‘Substance of Human Origin’ (herein: SoHO) is defined very broadly. Due to the broad wording, it is to be feared that even naturally conceived children who are not yet independently viable in the prenatal stages of development may be subsumed under the term SoHO. It is also foreseeable that human life created by medical or laboratory assistance, not intended for the purpose of gestation, will be covered by the new EU regulation in the future.

‘Human life does not receive its value through purpose. Furthermore, it cannot matter for the protection of human life

whether it has been created inside a laboratory or through medical intervention. Human life has value on its own.’

The COMECE condemned the planned framework and feel it will cause constitutional and legal problems for EU Member States. They said: ‘The regulation should not interfere with ethical decisions made by Member States concerning the use or restriction of the use of certain types of SoHO. Each Member State must be able to adopt stricter and more differentiated rules in the areas covered by the SoHO regulation. It cannot be ruled out that - in conformity with Union law - the interpretation of such terms (such as “tissue” or “tissue preparation”) in national law, particularly in Member States’ legal systems which attach great importance to the protection of unborn human life, will be overridden by the degradation of human life enshrined in Union law.’

The framework will now be sent to the European Council, with additional discussions planned for next year.

Hawaii - escape plan for the richest

Billionaires move to Maui as world nears meltdown

ENDLESS words have been written about the fires on Maui, but this perspective takes a different look at the Hawaiian island.

Between 2011 and 2016, there was a project called JUMPSmartMaui involving a number of investors that included several Hawaiian and Japanese stakeholders, a company called SWARCO, as well as that of Hawaiian Electric which provides 95% of all the power in the Hawaiian islands.

The project itself was led by Hitachi and included the Mizuho Bank, Ltd., both World Economic Forum members, as well as a company called Cyber Defense Institute, Inc.

There is little explanation why a cyber security specialist would be interested in a high-tech renewable energy grid on a small island. That is unless there is a hidden agenda. The WEF was not just represented by Hitachi and the Mizuho Bank, but hiding in the detail was none other than global investment giant BlackRock.

In January 2023, BlackRock disclosed it had a 9.3% share in Hawaiian Electric and had increased this significantly since 2022.

Why would both BlackRock and the Cyber Defense Institute be interested in Maui and by extension, Hawaii? There is far more to Hawaii than might be politically expected. Hawaii is not just a State of the United States, but a captive one, illegally incorporated into the union, it has been claimed. Hawaii has the potential to become an independent nation. This is not just a dream or a hypothesis, but a reality already set in motion.

In 1993, President Clinton signed an 'Apology Bill', acknowledging that Hawaii had been illegally incorporated into the United States. This was a reference to the military takeover and coup of 1893, and the removal of the legitimate government by the U.S. military. Following this, in 2009, President Obama supported a move to re-establish a Hawaiian government.

This seems innocent enough at first, but delving beneath the surface reveals an innermost working. The U.S. Government rarely, if ever, apologises for its behaviour. The body does not make mistakes

Medicines to blame for autoimmune disease?

THE concept of an autoimmune disease is based on the existence of the ‘immune system’.

The National Institute of Arthritis and Musculoskeletal and Skin Diseases (NIAMS) explains: ‘Your immune system is the network of cells and tissues in your body that work together to defend you from viruses, bacteria, and infection. It tries to identify and destroy the invaders that might hurt you.

‘In autoimmune diseases, proteins known as autoantibodies target the body’s own healthy tissues by mistake, signalling the body to attack them.’

It would seem, therefore, that, according to the medical establishment, the human body is not only a passive receptacle that is attacked by disease, but it also makes mistakes and is capable of self-destruction.

However, despite the apparent confidence displayed by their statements about the body making mistakes and attacking itself, the medical establishment admits to not knowing the causes of these conditions.

Under the heading, *Autoimmune Disease Risk Factors* on the Johns Hopkins Medicine web page entitled: *What Are Common Symptoms of Autoimmune Disease?* is the statement that ‘researchers don’t know what causes autoimmune disease.’

This statement continues: ‘But several theories point to an overactive immune system attacking the body after an infection or injury.’

This does not provide a convincing argument that the immune system actually attacks the body if there are only theories that point to this idea.

More importantly, the concept of the immune system itself is flawed because it is based on the idea that viruses and bacteria attack and infect the body to cause disease, which, as we have shown in many of our previous articles, remains an unproven theory.

The National Institute of Allergy and Infectious Diseases (NIAID) web page about autoimmune diseases states that there are more than 80 such conditions.

In addition to admitting that the causes of many of these conditions remain unknown, it adds that ‘a person’s genes in combination with infections and other environmental exposures are likely to play a significant role in disease development. Treatments are available for many autoimmune diseases, but cures have yet to be discovered.’

There are many people who still suggest that the ‘no virus’ position is not really important. But we would disagree with this suggestion for many reasons that include the implications for conditions that are considered to be autoimmune diseases. The main implication for people diagnosed with one of these conditions is that the treatment they receive will be based on an incorrect understanding of how the body actually works; so cures will never be discovered.

Addressing the underlying cause of any health problem requires medical researchers to understand how the body actually works. But they are not taught

this and so they do not have the relevant understanding; they do not recognise that the body is a self-regulating, self-healing, living organism that needs to be recognised as an intimately interconnected living entity.

On the contrary, medical practitioners and researchers are taught that the body is little more than a bag of chemicals separated into various organs that can be treated in isolation from the rest of the body.

No wonder they don’t know what causes autoimmune diseases!

This, of course, raises the inevitable question: so what does cause an autoimmune condition? The answer to this is the same as the answer to questions about the causes of all other conditions, which is: it will be due to a combination of factors that will be different for each person because we are all unique.

One of the symptoms associated with a number of autoimmune conditions is inflammation, which is recognised to be the body’s response to damage and injury; it is also an important aspect of the healing processes.

Unfortunately, some researchers in the 1980s made the suggestion

that inflammation was a driver of disease and this view has largely prevailed. However, according to Herbert Shelton in his book, *Natural Hygiene: Man’s Pristine Way of Life*: ‘Inflammation in any part of the body arises out of the same cause – toxemia.’

The claim that toxins cause inflammation and can induce symptoms associated with autoimmune diseases is corroborated by the authors of the book, *Uninformed Consent*, who discuss certain toxic substances that are specifically used for autoimmune disease animal research studies. One such substance is mercury.

Another chemical used in autoimmune disease research is called TMPD (tetramethylpentadecane), which is described by the chemical industry as ‘a hydrocarbon oil adjuvant’ and promoted for its ability to act as an ‘autoimmune disorder induction reagent’.

As a March 2010 article entitled, *Toxicology of Autoimmune Diseases* states: ‘The adjuvant properties of certain hydrocarbons can precipitate inflammatory or autoimmune disease in humans and animals.’ Of even more significance is that

certain pharmaceuticals are also known to induce an autoimmune response, as the article also explains: ‘The chemicals most often associated with development of autoimmunity in humans are medications.’

The article refers to many drugs that have been shown to induce certain ‘SLE-like’ conditions (SLE is systemic lupus erythematosus). Most significantly, the article concludes that ‘there is ample evidence that exposure to a variety of drugs and chemicals can lead to autoimmunity.’

A December 2002 article entitled: *Environmental chemicals and autoimmune disease: cause and effect* not only supports this association but also shows that there is a direct causative relationship. The article states: ‘These are temporary conditions that resolve when the medication is removed.’

It is clear that pharmaceutical products called medicines can induce the very conditions they are being claimed to treat. These conditions are not the result of the body attacking itself.

The body is not stupid; it always seeks to restore itself to homeostasis and health.

5G and the awakening

Richard House [RH]: There've been a number of big events held recently on 5G (see Resources section); do you sense a turning of the tide in relation to the 5G issue?

Tanja Rebel [TR]: I do. In fact, I believe we are nearing a boiling-point where the pot will soon boil over. There are more and more scientists daring to speak up and, as you point out, more and more events across the world highlighting the harm caused by electrosmog to humans, wildlife and the Earth at large – not to mention the threat to our privacy and human rights.

It will be harder and harder for the mainstream media to ignore the facts being put forward by these scientists, which are based upon tens of thousands of peer-reviewed studies. Once we've reached a critical mass in the general population, who until now have not been informed of the facts, the tide will turn. Until then, we must keep on pushing! Of course, most importantly of all, we must walk our talk and relinquish all wireless gadgets for wired connections. Anything else would not be serious.

RH: What was it that first drew your attention to there being a problem with 5G?

TR: I got into this via the LED route, being an early campaigner against the (totally un-green) roll-out of LED street lights across the country – and the world – when it was obvious that these lights were not at all beneficial from a public-health perspective. However, I was met with such a level of resistance by the powers-that-be, even when confronted with the clear facts that these lights are not green at all, that I wondered what was going on. It took me a while to realise that the roll-out of LED street lights is merely the precursor of Smart Cities and The Internet of Everything, for which 5G is essential.

The dangers of 5G (and electrosmog in

general) were pointed out to me by my Polish chiropractor. Polish (and Russian) scientists have long had an in-depth understanding of the harms caused by Electro-Magnetic Radiation, and the rest of the world needs to catch up before it rolls out ever-higher frequencies.

In the lower stratosphere, tens of thousands (100,000 approved) satellites are being launched to enable ‘Broadband For All’, harming the the ionosphere, the magnetosphere (i.e., the electric circuit essential for all life), blanketing the Earth in electrosmog, disturbing astronomical and meteorological observations – and destroying the view of our night sky.

RH: Tell us about your amazing campaigning work on 5G, and some of the challenges you've come up against in the process.

TR: A lot of people think that I'm beating a dead horse. However, I was taught early on that if you want to reach a certain goal, you need to retain focus and keep at it; I've done this with Global 5G Protest.

It started on January 25, 2020, when a Croatian woman and I got together to encourage people to rise up against the worldwide 5G roll-out, foisted upon us without any independent Health or Environmental Impact Assessments, public consultations, or free and informed consent – a right enshrined in UN Law. The first protest was big, with events in 38 countries and big crowds in Copenhagen, Amsterdam and Munich. People also came out in significant numbers in the U.S., Australia, India and South Africa. So we set another protest for March that year.

Then covid happened. The pandemic covered people into their homes, and when they eventually emerged, many had either become too frightened or too distracted by everything going on to retain focus on stopping 5G. People rose up against lockdowns and vaccines, with huge freedom marches worldwide. Unfortunately, these marches commonly omitted to mention the very thing being rolled out during lockdowns, threatening to take away freedom for ever. It's becoming ever more apparent that, apart from being a health and environmental threat, 5G is a surveillance grid-in-the-making, and protecting freedom necessitates stopping it. If not, we'll find ourselves locked into an electronic prison.

So we've called subsequent protests (there've been many) 'Global 5G Protest for Freedom'. Since 2020, we've organised a protest every season to coincide with equinoxes and solstices.

Numbers haven't been as large as for our first protest, but there have been thousands of brilliant events worldwide, with amazing pictures which we've made into collages and distributed in press releases across social and mainstream media. However, apart from once in January 2020, they have been ignored, and even the alternative media hasn't been particularly receptive. Maybe this interview will mark a turning point?

RH: Let's hope so! Very briefly – what would victory look like for the 5G movement?

TR: An immediate halt to the 5G roll-out and the dismantling of all masts. But this is only the beginning. We need the total dismantling of *all* wireless radiation equipment in favour of wired connections, which are more safe, effective and secure.

Moreover, we need a complete re-evaluation of electromagnetic radiation and its effect on humans and wildlife,

with far lower exposure levels – International Commission on Non-Ionising Radiation Protection (ICNIRP) ‘safe’ levels are ridiculously high, but what authorities invariably refer to when dismissing the serious potential health problems of 5G.

The only safe level is the Earth's natural background radiation. Humans don't need ever more connectivity; we urgently need to reconnect to the Earth and each other.

So we should celebrate the fact that we have the capacity to do wrong. It is the most beautiful divine privilege. To deny it by externalising evil is the vain work

Indeed, the outer battle is the inner battle, and it is only through endless struggle with the ego that we can claim the right to engage in the parallel endless campaign against the evil around us.

Genesis tells the story of how Adam and Eve ate from 'the tree of the knowledge of good and evil'. Now the traditional evangelical message tells how their disobedience cursed the human race forever with the false arrogance that they could assume the place of the

Almighty and be the judge of what is right and wrong, thereby condemning all of mankind to a lifetime of suffering.

But I would like to offer an alternative interpretation. Perhaps the allegorical apple was in fact a blessing, the original red pill. Could it be that 'the knowledge of good and evil' is actually the very thing that makes us unique in all of creation, and uniquely powerful? Is this awareness the very thing that links us to the divine?

The Quaker guidebook, *Advices & Queries*, opens with this passage:

'Take heed, dear Friends, to the promptings of love and truth in your heart, and respond to them; they are the leadings of all that is good and pure. In each of us, there is a light to show us our condition and to renew us.'

So I must fight my inner fight to uphold the right of everyone to follow their truth, their path, their light, whether I happen

to agree with it or not. I am called to set aside my ego and remember the quote attributed to Voltaire: 'I disapprove of what you say, but I will defend to the death your right to say it.'

As we wage our own personal, internal wars on the side of liberty and justice, we are likewise called to confront the greater evil in the world. I would argue that we are surrounded by a perverting culture, where declaring natural truths is outlawed, while soft falsehoods are allowed to flourish.

But does it really matter? Is it not a just expression of true, liberal human rights to acknowledge the truth of everyone's individual identity?

No. It is essential to push back against any abuse against life, whether it be physical, emotional, or spiritual.

I would argue that imposing an absurd belief on others is absolutely a form of spiritual abuse if it seeks to diminish our innate spirit, our connection to the divine, which denies our true and proper place in creation.




