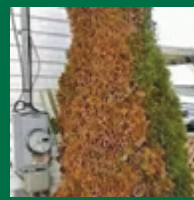

How they control you

Fourth-Generation devastation: The West has been targeted in a decades-long psychological war

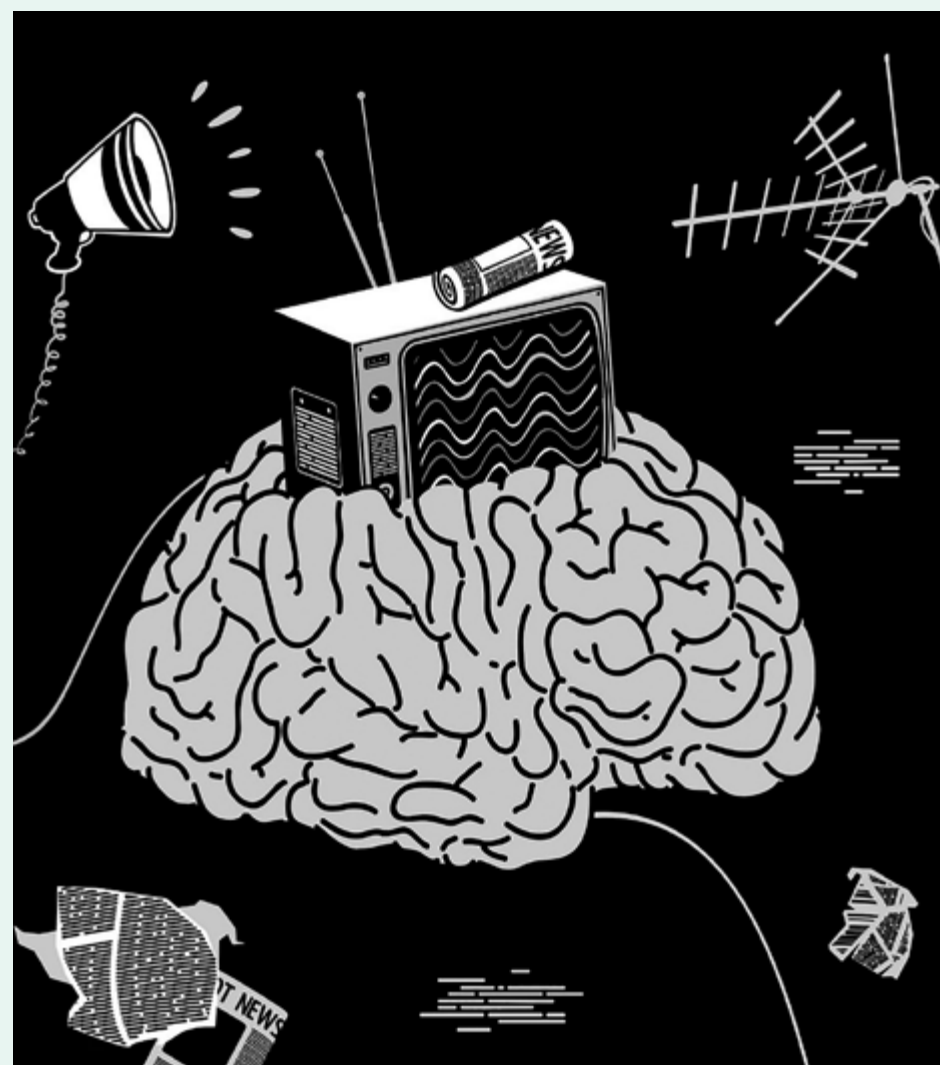
WHEN I first encountered the concept of fourth-generation warfare around 20 years ago, I was studying the basics of propaganda and how it works.

to change the very nature of money through central bank digital currencies (CBDCs). By extension, they are also influencing public behavior by attaching social justice ideology to economic participation through ESG (environment, social and governance).

In other words, if you want to have access to credit or money, and have the ability to compete in the new 'inclusive' marketplace, you will have to bow to the woke religion. If you refuse, your access to trade could be shut down completely and you and your family could starve.

A greater factor in the mind war, though, is the pole-shift of the Overton Window by turning cultural pillars into cultural villains. This is being accomplished through the creation of the deconstruction religion, or what we sometimes call the cult of woke.

Name any cultural value or principle that defines the western world, such as meritocracy, independence, self reliance, mental toughness, liberty (with responsibility), legacy through

hard work and family, the protection of children from perversions, discipline over hedonism, logic and reason over fanaticism, conservation of heritage and history and, for many people, the tenets of Christian duty – these are all pillars of our society which the woke cult seeks to destroy. In every way I can imagine, it is a psychological war on the West, funded through billions of dollars in grants from globalist think tanks like the Ford Foundation, Rockefeller Foundation and the Soros's Open Society Foundation.

The globalists view public manipulation and social engineering as their birthright. They think it is their manifest destiny, and they suggest often that humanity would somehow decay and self-destruct without their guidance.

As the famed propagandist, Edward Bernays, once stated:

'The conscious and intelligent manipulation of the organised habits and opinions of the masses is an important element in democratic society. Those who manipulate this unseen mechanism of

society constitute an invisible government which is the true ruling power of our country. We are governed, our minds are molded, our tastes formed, our ideas suggested, largely by men we have never heard of.

In almost every act of our daily lives, whether in the sphere of politics or business, in our social conduct or our ethical thinking, we are dominated by the relatively small number of persons... who understand the mental processes and social patterns of the masses. It is they who pull the wires which control the public mind.'

For men like Bernays, the purpose of psychological operations was more about maintaining a certain status quo, with the establishment power brokers firmly in charge but shielded from public view (and anger) as much as possible. The methodology of 'shadow government' was constructed in the era of Bernays. However, what started as a tactic for keeping the populace in the dark has now become a strategy for waging war on us. Fourth-generation warfare was born from the mire of public perception management.

You might ask, though, how we are being attacked without soldiers, guns, bombs, tanks or drones? Doesn't this sound a little paranoid?

In an internal U.S. Army document titled, *From Psyop To Mindwar*, the military value of sabotage through fourth-generation methods is described in detail. The treatise outlines the idea of causing

a target population to self-enslave by undermining its core structures through psychological warfare. The paper was written in 1980 by Lt. Colonel Michael Aquino, a devout satanist, and Colonel Paul Vallely, who would later become a general.

Aquino's theory was essentially that the U.S. Army was under-utilising psychological operations as a background to kinetic operations. He argued that psyops could be used as the frontline weapon to destroy an enemy nation (or control a domestic population) without the exploitation of standard munitions. As Aquino suggests in a 2003 preface to *Mindwar*:

'Essentially you overwhelm your enemy with argument. You seize control of all of the means by which his government and populace process information to make up their minds, and you adjust it so that those minds are made up as you desire. Everyone is happy, no one gets hurt or killed, and nothing is destroyed.'

The faux benevolence behind this idea is disturbing. Believe it or not, this was Aquino's attempt to soften the public's perception of the document. He lamented the exposure of *Mindwar* among 'conspiracy circles' and spent decades trying to downplay the role of occultism in the upper echelons of the military and the government. It was all a 'big misunderstanding', according to the satanist.

From Psyop To Mindwar attempts to disconnect itself from the dark and dirty

reputation of propaganda efforts among the Nazis or the communists because it is commonly, and rightfully, associated with lying. Aquino admits that the new psyops will be used against Americans, not just foreign enemies, but this time, he claims they will use 'the truth' to manipulate the masses. But who gets to dictate what the truth is? Well, satanist fanatics like Aquino, of course.

The hypocrisy of *Mindwar* is evident in its underlying premise – that the establishment will always propagandise using the truth, because that which is a lie today can be made into the truth tomorrow. As Aquino notes:

'Unlike PSYOP, *MindWar* has nothing to do with deception or even with "selected" – and therefore misleading – truth. Rather it states a whole truth that, if it does not now exist, will be forced into existence by the will of the United States.'

Mindwar as a document is itself a piece of propaganda that can't help but twist reality to justify the vision of men who seek power above all else. I invite you to read the paper; nearly every concept described in it is being used against the American people and the western public today. The crooked arguments made in it are the same exact arguments used by current governments to justify state propaganda and mass censorship of opposing views as essential to national security and the greater good.

Not to mention, the woke movement is disturbingly similar in its ideals and goals to the narcissistic religions of satanism

and luciferianism that Aquino adores. I'm sure that's purely coincidence.

The reason that conservatives and liberty proponents have been at such a disadvantage in the midst of this mind war until recently is because we have an OLD way of viewing warfare that assumes a stand-up fight. They point their guns at us and try to control us, we point our guns at them and say 'no thanks'. But not all war is designed to destroy people directly, and some wars are fought in a cowardly fashion in order to avoid direct confrontation.

Mind war proponents would argue that the tactics are similar to guerrilla methods. I would argue they are much more closely related to terrorist methods, and yes, there is a difference.

Midazolam questions remain

Unintended ‘serious harm’ fears over protocol

NG163 was a covid protocol used to treat those presenting with respiratory issues.

But evidence from more than 100 families could show this protocol has resulted in the untimely and unnecessary death of loved ones - and is reminiscent of the abolished Liverpool Care Pathway.

And when the National Institute for Health and Care Excellence (NICE) guideline NG163 was reviewed in early 2020 by a panel of nine doctors and two professors, they did raise concerns.

Yet, the protocol - which recommended the combined use of midazolam and morphine that both suppress the respiratory system - was approved.

After studying the guideline, the medics familiar with palliative medicine said they were ‘concerned that uncritical use of NG163 may create unintended risks for people with suspected or actual covid-19 infection’ and suggested that the flawed guideline should not be implemented.

The new guideline was rebranded NG191 in March 2021, and on November 30, 2023,

the recommendation to use midazolam on covid patients was dropped completely.

In a letter published on April 20, 2020, the eminent experts, led by Professor Emeritus, Sam H Ahmedzai, said that, ‘while NG163 states, “Note that symptoms can change and patients can deteriorate rapidly in a few hours or less,” there is no counterpoint that most patients without the preconditions above will eventually recover.’

They also stated that, while there was plenty of detail on dosing covid patients with powerful medications, there was no advice on monitoring the

patients, nor on weaning them off the drugs.

Another major concern of the panel about NG163 was that the protocol stated: ‘Sedation and opioid use should not be withheld because of a fear of causing respiratory depression.’ Further into the letter, the professors and doctors say that if covid-19 was uniformly fatal, the instruction to doctors and nurses to ignore any concerns in administering these drugs would be acceptable. But by then, many experts were seeing covid as no more dangerous than the flu.

This is explained in the letter as follows: ‘For people not

previously known to be at the end of life, there is potential risk of unintended serious harm if these medications are used incorrectly and without the benefit of specialist palliative care advice.’

In conclusion, the nine doctors and two professors clearly stated in the letter that the covid protocol NG163 had the potential to cause serious harm and all 11 agreed that it needed reviewing.

The Light approached former Health Secretary Matt Hancock’s office for comment on November 28, and again on December 1, but at the time of publication was yet to receive an

official response.

The Light has also approached the Department for Health and Social Care for comment and is yet to receive a response.

An NG163 case study

Linda Keen, a psychotherapist from East Sussex, claims her mother was, effectively, euthanised by health staff allegedly following NICE guideline NG163 in 2021.

She said: “After the government psyop scare tactics in March 2020, I wondered if my 92-year old mother Kathryn Davis would survive in her care home.

Over the following months, I barely saw her as the lockdowns turned the home into a prison, and contact was mostly via window visits and FaceTime calls. As she had dementia, she really didn’t

understand why we couldn’t go inside to see her. We got through 2020 and into 2021 when another lockdown was imposed.

“In early January, we got a phone call saying she’d tested positive for covid and my heart sank. I knew about Matt Hancock’s stockpile of midazolam and how it was being used with morphine to ‘treat’ covid, and that worried me. A week later, we – her husband Neville and I – got the call we’d been dreading; she’d apparently ‘deteriorated’, and the clinical nurse lead was starting her on end-of-life drugs, despite her telling us earlier that she was ‘alert and responsive’.

“My stepfather, Neville, was ill so I was the only one who could be with my mother as they euthanised her - not that I knew that’s what they’d be doing when they let me in to see her late on January 14. She was deeply agitated and was fighting them as they injected her periodically to ‘make her comfortable’. It was distressing to watch.

“I spent the following day with her and watched as this horrendous process continued.

“On January 16, I returned to visit. I was taken into a side room by a nurse, who told me that the lead nurse was ‘seeing to her’. Finally, the lead nurse calmly walked into the room to

“The lead nurse told me I could go and see my mum. My mum was dead in her bed and a young carer, who had witnessed her last moments, was sobbing and shaking next to her. The whole scenario was horrendous and I’m now taking legal action against the care home.”

combination of morphine and midazolam should be given.

However, both these drugs suppress the respiratory system, and concerns have been voiced by medical experts that delivered together, their effects can be magnified.

Also, patients whose bodies are unfamiliar (naïve) to these drugs might experience stronger effects than might otherwise be expected. These effects have been witnessed by families seeing their loved ones deteriorate rapidly, and it is understood that the average time between the protocol being actioned and death was 29 hours.

Killing in the name of health

Dramatic rise in illnesses after jab rollout

NEIL Shaw, a reputable and highly respected naturopath and homeopath who runs a thriving health store in Northern Ireland, has witnessed a dramatic rise in a variety of illnesses among his customers since the covid vaccine rollout, a trend which is of great concern.

During the pandemic, Neil reports that he had minimal awareness of people experiencing any major complications, life-changing issues, or even ultimately dying, with the exception of those who were already ill, or within the elderly age bracket.

Yet since the mRNA shot rollout of 2021, he is seeing a huge shift in the demographics of people who were previously unaffected by covid.

These individuals, who presented as healthy and without underlying conditions, are now experiencing life-changing health issues. Neil believes this to be “very telling”.

He continues: “A strange phenomenon was the media pumping out death rates and horror stories during covid, yet that was not what we were seeing on the ground, and I include a nurse whom I know well. Yet now we are seeing myocarditis in 30-40 year olds, stroke issues at the same age, and people dying suddenly that shouldn’t be dying at all – healthy, fit athletes and the like. Nobody is asking the question ‘why?’ anymore. If a plane crashes, it will be (excuse the pun) investigated to death for years, so why – this being the case – do we have such a lack of critical analysis at the minute? Where is the media concern to ask questions and probe for answers?”

I ask Neil if people are connecting the dots between ‘vaccines’ and illness.

He replies: “Part of the protocol to try and help sick people is to build a timeline to see when things started to go wrong, as you do in any scenario. The vast majority themselves would say it has been after their vaccine or booster.”

I enquire if, having connected the dots, we are aware of these individuals reporting their side effects to the relevant agencies? Neil tells me, “This is the frightening bit, because if you mention the Yellow Card reporting system to people, they do not even

know what it is; they have not even heard of it!”

The Yellow Card scheme to which he refers is the government’s dirty secret, because it should have been publicised at every vaccine clinic and at every opportunity on the media, and yet it was not.

This is the early warning recording system, so that side effects and serious medical issues could be collated and analysed to look for patterns of illness and warn of dangers, in order to take appropriate action. It would be akin to a radar system in World War 2 where you have advance warning of attack, and do nothing whatsoever about it. However, the Yellow Card system was unknown to his clients.

He notes that he has seen a sizeable increase in younger people, in their 20s, 30s and 40’s, who are presenting with problems more often associated with the older generation – the likes of shingles, increases in inflammatory issues, and post-viral fatigue. This may also mean a spike in stress, anxiety and sleep disorders, because these

conditions can be very debilitating.

These may also be, in part, caused by lifestyle changes since 2021, such as less travelling, working from home, more isolation, and greater fear from the TV and legacy media.

But how can we know whether the vaccine is safe when the early warning system is ignored making the Yellow Card scheme unfit for purpose?

I ask Neil for an anecdotal story and he tells me the astonishing account of a lady well known to him. She had informed him that she had been ill and hospitalised swiftly after each vaccination, but thankfully had been getting her health back on track.

She continued that she was very concerned because they were now calling her for her booster, but considering her previous two experiences, she was extremely reluctant. Neil offered honest advice, and finished the conversation. A couple of weeks later, he learned that she had passed away, having been found dead by the side of her bed. He also learned that against his advice, she had indeed

elected to go for her booster just a few days prior to her death.

Questions MUST be asked about why these boosters are still being pushed by medical staff, without due regard to previous reactions and hospitalisations. Is it misinformation to say that they are safe? This lady was stressed, anxious and afraid to take the booster, yet also afraid NOT to!

Surely safe should mean you don’t die within a few days of taking it? If this is such a rare exception, then automatic and urgent investigation is essential. The obvious question has to be: just how rare is this?

There is a website and Facebook page called Real Not Rare which allows the vaccine-injured to post their stories, and I strongly encourage you to take a few minutes to read some of their posts.

Here are some of the quotes, telling the impact on their lives and their suffering, in their own words:

- I have to use a cane to walk and I can’t drive.
- My life changed forever and work has been hard. I’m afraid of losing my job due to all the chronic pain, absences and medical issues.
- I have a large blood clot that I’m not able to get rid of as of yet, due to its size. I’ve put up with the pain and discomfort for a very long time.
- Loss of fine motor skills in left hand, left calf muscle spasms and some weakness on left side.
- I had the left side of my body absolutely paralysed.
- I was voiceless and powerless, with low energy, I couldn’t even send a text message for several weeks. I had no money and mostly no help, I was on my own.
- Looking back now and what I know, and what happened, I would’ve never put my job over my health, and now I have neither.
- I just hope and pray the pain leaves my body, and I get better, because I don’t know how much more I can take.

Epidemic of sickness and sadness

It’s time to end narrative of safe and effective

I HAD the opportunity to interview a local hairdresser who, for the purposes of this article, we shall refer to as Mrs R.

Mrs R. reported concern at the astounding number of regular clients she had recently discovered to have been suffering a sudden onset of illness.

Fortuitously, while we were chatting, she was with a client, whom we shall refer to as Lee. Lee often interjected with her thoughts on the subject matter, as she too was deeply affected.

I will start with the story Lee kindly shared about her mother, who was recently discharged from hospital following a stroke. Lee revealed that her mum was diagnosed with a brain tumour about 14 years ago, but it had fortunately remained stable for years, and follow-up scans were clear. How distressing for her to have made such progress over these years, only to have had her covid shot and then suffer a stroke. Although she did not have any reaction to either vaccine at the time, she started suffering mini strokes shortly after receiving the jabs, requiring an anxiety-ridden seven-week hospitalisation.

Lee states that at the time of the covid vaccine rollout, her mum didn’t even allow access to her home to those unvaccinated. That is how much faith she had placed in the system.

But oh how things have changed since then. Her health went downhill rapidly, and subsequently, she started to become aware of conflicting reports online. While educating herself, she began to join the dots, so much so that now they (the entire household) have refused to allow the vaccine and boosters near them ever again.

What I personally find upsetting is that I had heard exactly the same thing about two years ago, from an online doctor whose genuine observations about cancer patients in his charge were that cancers previously in remission for years were aggressively returning following the covid injection.

At that stage, he did not say it was causal, but that this was a red flag that urgently needed addressing.

I asked Mrs R how typical this report

of Lee and her mother was among the stories she heard.

She said that she had heard dozens, and that she could write a book about it.

She continued: “I would say that I have, with no exaggeration, about six customers with skin cancer, and all since they got the covid jabs.

“One is a friend I went to school with, and she suddenly developed mole after mole, having to have three surgically removed. The last client came in with a mark or patch on her face, which I knew instantly

was skin cancer. The doctors confirmed it, and then she had to wait a year before the NHS removed it.”

So I asked Mrs R whether they were linking the cancer to the covid jabs, but she said that she was often told: “Ach, just wise up.”

She continued: “My own uncle passed away after having the vaccine; he had kidney and liver failure. My other uncle’s brother also died after getting jabbed, and he also suffered organ failure.”

While I am not a medical expert, I

consider there to be two principles.

First, the burden of proof should be the opposite way around when a new technology is rolled out. Can the doctors investigate all these suspicious deaths and prove it WASN’T the ‘vaccine’, which remember, is a new and unproven mRNA gene-therapy?

Second, there is an urgent requirement for investigation into the timing of the illnesses, with regard to the vaccines given, and the sheer number or increase of such illnesses. As if proving the point, Mrs R said: “I know several clients in their early 60s who died after having organ failure, and each of these people were fine up until the covid vaccine.

“Did I ever tell you about one of my son’s classmates? He wanted to go away on a school trip, but to do so, he was required to take the covid vaccine, and unfortunately he got covid when he returned.

“His mum rang me one day and asked if I could come to his house to cut his hair because he was very ill and unable to walk. He was so bad that his dad had to carry him up to bed.

“His mum thought it was caused by covid. That was in his third year in school, and he is now in fifth year, walking on crutches, and still can’t play football or rugby.

“My cousin’s mother has recently been diagnosed with dementia at just 62 years of age. I now frequent a nursing home, cutting and styling hair weekly, and you would be astonished at how many of them are in their 50s with dementia, an illness that usually affects people over 70.”

In conclusion, each of us on our individual path experiences a journey of revelation when we come to a realisation that things are not as they seem. Devastatingly, for some previously trusting individuals, it takes a vaccine injury to reach the point of questioning the men in white coats and the whole narrative on the TV.

It is my hope that people reading this will not need to suffer such things in the future, and it will serve as a warning lesson to many. By courageously telling their stories, many more will come to a greater knowledge of the truth, and will find the confidence to critically evaluate everything they watch and read.

The sooner this ‘safe and effective’ narrative falls, the better for everyone. It’s time to end this epidemic of sickness and sadness.

Complicity with genocide a crime

Letter to MPs focuses on Israel's actions in Palestine

DEAR Members of the British Parliament,

Do you acknowledge the rule of international law, or do you just pay lip-service to the idea?

The question is relevant, because members of the British public may well ask why they should obey the laws that you as legislators enact, when you yourselves fail to adhere to the principles of law, which is what you are doing in supporting Israel's continuing war on the Palestinian people.

In order to understand how little claim to legitimacy Israel has, both as a state and in its actions, let us examine the legal landscape.

The much vaunted United Nations resolution 181 of November 29, 1947 merely recommended the partition of Palestine, but this recommendation was never confirmed by the UN Security Council and, therefore, does not have the force of law.

By contrast, a cornerstone of the United Nations Charter since 1945 has been that annexation is profoundly illegal under international law. This is because annexation was the cause of many wars in Europe before WW1 and in the lead-up to WW2, and the drafters of the UN Charter considered that the way to end the scourge of warcraft as a central part of a state's foreign policy, was to make borders inviolable under international law.

Consequently, since the Arab-Israeli war of 1967, the UN Security Council has adopted no fewer than eight different resolutions declaring the inadmissibility of the acquisition of territory by war or by force, specifically with respect to Israel's acquisition of Palestinian territory.

The settlements are also in breach of the IV Geneva

Convention, which prohibits an occupying power from moving its civilian population into the occupied territory, because it does this for one reason alone: to be able to establish a flag of sovereignty upon that occupied territory, which leads to annexation and conflict.

In the 1970s, both the UN General Assembly and the Security Council made it very clear that Israeli settlements were illegal, that all settlement activity had to cease, and the existing settlements dismantled. Again, as recently as December 2016, the UNSC referred to the settlements as 'a flagrant violation of international law'.

The EU, the International Committee of the Red Cross and the UNGA Human Rights Council have all declared the Israeli settlements profoundly illegal. Then in 2019, the U.S. stepped outside the international consensus and started to undermine over half a century of finely-woven international law, when Secretary of State Pompeo said the U.S. position had changed and they no longer recognised the Israeli settlements as illegal.

Since then, although the international community has continued to be forthright and vocal on the issue of the illegality of the annexation of settlements, of the separation wall, of collective punishment of the Palestinian people, and on the human rights violations in the occupied territories, they have failed to convert their condemnation into enforcement.

At the heart of any legal system is the issue of accountability. Under domestic law, citizens who break the law are liable to be charged, prosecuted and, if found guilty, face the penalty. International law equally has detailed formulae for accountability.

Article 25 of the UN Charter states that all member states are to uphold and apply the decisions of the Security Council.

Article 1 of the IV Geneva Convention provides that all High Contracting Parties are to respect, and to ensure respect for, all the rights and guarantees in the Geneva Convention in all circumstances, including no settlements.

Under the UN Articles of State Responsibility adopted in 2001, where an outlier state breaches its membership status in the UN, in defiance of international law, the rest of the international community is under an obligation to take action to bring the recalcitrant state into compliance with international law.

The UNSC has repeatedly told Israel the settlements are illegal, as is the location of the separation wall, and that it must recognise Palestinian self-determination and end the illegal annexation of the Syrian Golan Heights and East Jerusalem. Israel continues to defy the UN resolutions, thus it becomes an outlier state.

We are now three months into a well-documented genocide of the Palestinian people by Israel, supported by its western sponsors.

Prior to the war, the Gaza Strip had already been under a 17-year air, sea and land blockade by Israel, which controlled everything and everybody that went into and came out of what is described as the largest open-air prison in the world.

The economy was already on its knees because of limited hours of electricity. There was already 45-50 per cent unemployment, which in the under thirty-year-olds that make up the majority of the population, was between 65-70 per cent, despite this being a well-educated population.

According to Prof. Michael Lynk, the UN's special rapporteur from 2016-2022 for the situation of human rights in the Palestinian Territory occupied since 1967, the only drinking water supply in Gaza by 2019 was 97 per cent contaminated either with seawater or sewage, because inadequate supplies of power made it impossible for the sewage treatment plants to operate properly. This resulted in millions of litres of raw sewage flowing daily into the Mediterranean Sea, befouling the coastal waters and returning to the drinking water. Healthcare facilities lacked medicines and basic necessities and suffered power outages.

All this against a backdrop of a huge natural gas field in the Eastern Mediterranean Lavantine Basin, off the coasts of Palestine, Lebanon and Syria. So the Palestinians have their own unexplored natural gas field in the Gazan waters which, if the Israel-US-UK partners have their

way, will never be enjoyed by the Palestinians, who are being daily slaughtered and frightened into becoming refugees.

South Africa has rightly invoked the 1948 Convention on the Prevention and Punishment of the Crime of Genocide, bringing charges against Israel before the International Court of Justice. As of the time of writing, Turkey has officially backed South Africa's case before the ICJ.

International law is unambiguous when it comes to genocide. Under its provisions, any politicians, not just government ministers, who vote for measures in support of, or express support in any form for, the actions of the perpetrators of the genocide, are complicit in the crime.

Therefore, complicity with genocide is also a crime.

In the last two years, members of the British Parliament have waved through a tidal surge of legislation at odds with democratic principles; tyrannical impositions disguised as protective laws.

Article 1 of the International Law Commission states that 'an internationally wrongful act of a state may consist in one or more actions or omissions, or a combination of both'.

Article 16 of the International Law Commission's Articles on State Responsibility provides that 'a state that aids or assists another state in the commission of an internationally wrongful act is internationally responsible, where certain conditions are fulfilled'.

That parliament is in disharmony with the people it represents is evident, but the ignition point may well be Britain's complicity in genocide.

In the words of UN Secretary-General António Guterres, in the speech he gave on December 8, 2023 at the UN General Assembly: 'The eyes of the world and the eyes of history are watching'.

What evidence do you have of a secret

Mightier than the sword

Deploying the press letter for truth and freedom

IT'S all too easy to feel helpless in the face of unfolding global(ist) events and power plays.

Yet there exists a multitude of different ways in which we can push back to help the world wake up to the truth of what is happening. Here, I want to highlight just one modest approach, that if enough of us were to pursue it, could have a significant impact. I'm referring to press letters, submitted to local, regional and national newspaper letters pages.

I'm certainly not suggesting that truthers waste time and energy writing to captured corporate nationals (although I have recently managed to get several counter-narrative letters into the *Metro*), which rarely if ever print anything challenging the mainstream lockstep narrative. But local and regional newspapers are often a different matter; they are often far more prepared to publish counter-narrative letters from readers – no doubt in part because it suits them to publish controversy-generating material that gets local readers fired up and eyeballs for advertisers.

Here in Stroud, Gloucestershire, we have several local and regional papers which have consistently been prepared to print letters that robustly challenge the mainstream narrative about the covid 'pandemic' and the jab. Appended to this article are some excerpts from several examples that I've had published in our *Stroud News and Journal* (circulation around 25,000).



I had my first press letter published in the *Western Gazette* in 1975, and I've had many hundreds published since, including open letters. I organised with Sue Palmer on 'toxic childhood' that went viral in 2006, 2007 and 2011; and also scores of letters in the national and local press supporting Jeremy Corbyn's leadership between 2016 and 2019.

Some years ago, I wrote a long book chapter on the art and practice of writing press letters for a book on 'The Press Letter' that ultimately never got published. The 8,000-word chapter goes into great detail about how to write a successful letter – drawing on over four decades of experience.

The chapter can be found online – it sets

out the key preconditions for a successful press letter. I hope readers of *The Light* will feel inspired to find out the details of their local press letters pages, and start submitting letters that challenge mainstream globalist narratives and champion truth and freedom.

Local newspapers also often have press letters published online which then offer a forum for online comments. Our *Stroud News and Journal* has such a forum, and local truthers here are fully engaged in these debates. An excellent recent example can be found here, under the letter titled, *Why alarming increase in average excess deaths?* The letter generated an extraordinary 302 comments – most of them from very

articulate local truthers.

Of the many letters my truther friends and I have had published in the local press in recent years, below I reproduce some excerpts from just two. One was published in October 2020, when the national media wouldn't go anywhere near anything that was challenging mass vaccination; and the other is perhaps my most telling published letter from the covid era, dismantling the mainstream narrative about covid deaths, and published in January 2022.

When good people do bad things

Are we up to task of forgiving the indoctrinated?

RECENTLY I had a conversation with a local lady about *The Light* newspaper. I had just delivered a batch of papers to a shopkeeper who displays them on her counter for customers to take.

While I was chatting to 'Janet', an elderly lady came into the shop. No sooner had she caught sight of the papers than she erupted in an explosion of sheer fury.

She asked: "What on earth are you doing promoting that awful paper?"

"It's nothing but conspiracy theories. It says that the vaccine is killing people. It is dangerous in the extreme. It's evil and vile and makes out that governments are bad and are knowingly harming people."

She uttered much else besides and with each exhortation she worked herself up into a sorry state. "I'll never set foot in this shop again," were her parting words as she stomped out.

Janet was somewhat shell-shocked at this outpouring and didn't say a word. She had previously told me that one or two customers had said they didn't like the paper (to which she had replied: "Well you don't need to read it then"), but it didn't take long for her monthly batch to be taken by enthusiastic readers.

She had never seen this customer before and had never encountered this level of hostility.

I made an instant decision to go out of the shop and catch up with this lady, as I could see she was distressed.

I caught up with her, and in my most sympathetic and concerned demeanour (genuinely felt), I asked if she was alright because she seemed so upset.

Clearly, she didn't connect me with the paper (why should she?) and began to regale me with the same vitriolic invective she had been using in the shop. Over the years, I've learned that the only

way to deal with people who are so hyped up is to let them vent out their feelings, be patient and not be in any way argumentative or confrontational. Letting people talk themselves out is the only way they will calm down, and then, perhaps, you can converse with them on an even keel.

After some minutes, she was beginning to settle somewhat, and she then asked me if I had read *The Light*, and if I had, what did I think of it. I've been in similar positions before and have gradually realised that rather than an absolute defence of the paper and presenting a counter-argument, a more subtle and thoughtful response is always more productive.

"I have seen this paper before,"

I gently replied, "and, yes, it definitely does present alternative views to the mainstream. My own opinion is that 'truth' is a slippery business in the modern world, and I don't know whether we can expect the truth from any source. Do you think we get the truth from the mainstream media?"

Her reply to this was interesting: "There's no doubt the media exaggerate and mislead us to some extent." She told me about her position as a senior local politician, her involvement in the decisions made over the last four years and how it hadn't been easy. I then realised why she had been so upset.

Now we were getting onto common ground. Job losses, businesses closing, the choices

between heat or eat, constant wars and fearmongering, the insecurity and anxiety of modern life, particularly for the young, NHS waiting lists, technology leaving millions behind, and much else besides.

I gently suggested that, in view of the aforementioned, it might not be a surprise that more people were prepared to consider 'conspiracy theories' as their lives had been so seriously impacted, while those who were super wealthy seemed to benefit more and more. She certainly didn't disagree with this. I must have chatted to her for 15 minutes and we were certainly on the same page regarding most things.

I brought the conversation to a conclusion and we parted with

a handshake. My softly, softly approach may have planted a seed, who knows? But it is, in my opinion, the only way of dealing with people who are so psychologically damaged that they cannot comprehend an alternative to that which they have been indoctrinated by.

On December 4, Andrew Bridgen MP co-ordinated and chaired a presentation at Portcullis House, 'An address by doctors and scientists regarding the Covid pandemic and its consequences'.

And 16 Members of Parliament attended, with most seeming to be genuinely startled to hear the facts as presented. How, Ian Paisley asked, would MPs such as he manage public fear once his constituents were made aware of the truth imparted to them?

How indeed? And is it now the case that most MPs are simply too afraid to contemplate the truth, fearing the repercussions that will be forthcoming when the public finally find out the extent of the harms they have been subjected to?

The senior local politician who I spoke to had been instrumental in the enforcement of covid policies. However, she impressed me with her decency and her sincere belief that what she was doing was right. This is what I mean when I say 'good people do bad things'. They do it out of ignorance and a lack of basic research, possibly because they have been systematised for so long.

Perhaps this goes some way to explain the anger shown by this lady when seeing the newspaper. Maybe deep down, her conscience was pricked, and the revelation of what might be true was too much for her.

When the truth is established, there will be an awful lot of soul searching, and I do believe there will be very many people who will find it extremely difficult, if not impossible, to come to terms with their actions over the covid years.

Many of us will need to be compassionate, understanding and forgiving, but considering the harms done, particularly if we have been directly affected, will we be up to the task?

Name-calling over debate

ALDOUS Huxley wrote that ‘the purpose of propaganda is to make one set of people forget that another set of people are human.’

This dehumanisation is a prerequisite to oppression and atrocity. If a people’s humanity is upheld in its fullness then we will cherish them as equals of like kind to ourselves, and permit no harm to them.

The Oxford English Dictionary defines an antisemite as one ‘characterised by prejudice, hostility, or discrimination towards Jewish people on religious, cultural, or ethnic grounds; anti-Jewish’.

I am fortunate to have met very few truly characterised by prejudice, hostility, or discrimination towards anyone on such grounds – those with persistent malice towards other races or faiths have a distinct, unpleasant vibe.

Our experiences of other’s vibes are real and important, yet being subjective, they are hard to objectify. Yet, even before his hatred manifested in persecution and mass murder, it was obvious that Hitler was a rabid antisemite. Such hatred rightly evokes

disgust in good people whose hearts are attuned to love and wisdom.

Evoking disgust is the most potent tool in the propagandist’s armoury (with fear a close second), so smearing opponents as antisemites is a potent ploy.

I witnessed this technique used against Jeremy Corbyn. As a gentle soul, few would naturally regard him as characterised by prejudice, hostility, or discrimination, so the smears focused on inferring guilt by association. Propagandists shrieked that he once called Hamas delegates “my friends” (in context, an unremarkable courtesy) and he was once pictured near an arguably antisemitic mural. A flimsy case - yet endless repetition (aka the ‘Big Lie’ technique,) ensured that enough odium clung to cost him election victory.

More recently, Andrew Bridgen was summarily declared an antisemite for the ‘code infraction’ of stating (correctly) that the mRNA covid ‘vaccine’ experiment was “the biggest crime against humanity since the holocaust.”

Neil Oliver received similar treatment, as did musician-activist Roger Waters of Pink

Floyd fame. Even Greta Thunberg – stuffed mascot of the rulers’ energy austerity programme in the guise of environmentalism, the net-zero project – recently got a warning-shot antisemitism accusation for the code infraction of possessing a stuffed octopus toy, after expressing sympathy for the plight of Gaza. Get back in your box and do as you’re told, Greta!

John Bercow (former Commons speaker, himself Jewish) was once asked if he thought Jeremy Corbyn was an antisemite. “I do not believe Jeremy Corbyn is antisemitic,” he replied. “He’s been very supportive of me, and I’ve never detected so much as a whiff of antisemitism.” It is interesting that he paid no heed to ‘guilt by association’ or ‘code infractions’ – as a man of discernment, he trusted his nose for Corbyn’s vibes.

Few would honestly judge Corbyn, Bridgen, Waters, Oliver, Thunberg or the vast majority of the millions appalled by the slaughter in Gaza to be antisemites, by the dictionary definition. Yet they have all been labelled as such by the legacy media propagandists of corporate totalitarianism.

How may we distinguish between actual antisemites and

these dissenters targeted by propaganda today?

As targets of Nazi propaganda, Jews were often smeared as ‘VERMIN!’ or ‘LICE!’. Targets of today’s propaganda are smeared as ‘ANTY-SEA-MITE!’. The aim in both cases is the same – to provoke disgust.

Like father, like son

ACCORDING to the chorus of *Running in the Family* by 1980s band, Level 42: 'We all have our daddy's eyes'.

But when applied to corporate oligarchs, royal families and political dynasties, this is not such a nice idea. Like father, like son has a darker meaning when considering that our nepotistic ruling class does not have our best interests at heart.

On the contrary, it is working towards our impoverishment, enslavement and even eradication.

A good example is the Trudeau succession in Canada. Pierre Trudeau, who was Prime Minister from 1968 to 1979, was an enthusiast of cybernetics and population control.

While 1968 is popularly remembered as the year of emancipatory revolution, behind the scenes it was the anno domini of the new religion of ecological doom.

In the same year came Paul Ehrlich's treatise, *The Population Bomb*, which warned that the world could not sustain a growing population and that humanity was heading for disaster.

Trudeau worked closely with Alexander King and Aurelio Peccei, leaders of the Club of Rome, which was launched in 1968 at the Rockefeller estate near Rome. The mission of the Club of Rome was to bring together business leaders and academic experts to work on matters of global concern (in truth, this meant overriding the sovereignty of democratic nations in pursuit of one world governance).

As Matthew Ehret describes in his new book, *Science Unshackled* (2023):

'Trudeau was a devout supporter of this new organisation, which soon became a centre of neo-Malthusian revivalism during the early years of the 1970s.

'Trudeau even presided over the Canadian branch of the Club of Rome and allocated money to fund the MIT Club of Rome study, *Limits to Growth*, which became a holy book of sorts.'

King's computer modelling indicated that human progress was irreversibly destroying the equilibrium of nature. This justified a strategy of depopulation, although always masked by ecological virtue.

Trudeau's son, Justin, the current Prime Minister, has placed his vast and relatively unpopulated country at the vanguard of the globalist regime to mitigate the purported climate 'emergency'. Canadian citizens might freeze due to the enforced replacement

of gas by ineffectual heat pumps, but he doesn't care.

The British royal family has been deeply involved in the climate scam and its underlying motive in pseudoscientific eugenics. We owe to the late Prince Philip a rare insight into this thinking.

His inappropriate remarks were often not the 'gaffes' as reported by the media, but were unbridled expressions of elitist disdain. In one notorious comment, he revealed his misanthropic desire: "In the event that I am reincarnated, I would like to return as a deadly virus, to contribute something to solving overpopulation."

His eldest son Charles, elevated to the throne in 2023, would never utter such a callous wish to eradicate the minions.

Yet Charles's attitude is not fundamentally different to that of the former Duke of Edinburgh. When Charles criticises humankind for its despoiling consumption, he is really targeting humankind: there are too many of us, Charles believes.

Recently, King Charles III was in Dubai for the COP28 international conference, where he made the headlines with his concluding remark that, "Earth does not belong to us; we belong to Earth."

Charles's environmentalism was presented as his love of nature and of traditional harmony between people and the land. But for decades, he has been active in developing globalist organisations with the goal of total control of population and resources. The Great Reset is not a new idea, but a master plan conceived long ago.

In 1971, Klaus Schwab, a German financier at the University of Geneva, founded the European Management Forum. Supported by Prince Charles, this body would rise from obscurity to become the most influential globalist organisation. In 1973, at its third annual conference in Davos, Schwab introduced the thousands of attendees to Peccei, who propagated the messages from *Limits to Growth*.

That meeting was sponsored by Prince Bernhard of the Netherlands, a one-time Nazi collaborator who founded the eugenicist Bilderberg Group in 1954. A secretive organisation, the Bilderbergers comprise prominent political and corporate leaders in transcending nation states to create a new world order.

Schwab's organisation, renamed the World Economic Forum in 1987, works like an executive arm of the United Nations to transform society, typically on the rationale of anthropogenic climate change.

Schwab's son, Olivier, is Managing Director and his daughter, Nicole, who is on the executive committee, sounded just like her father when she proclaimed covid-19 as leverage for the Great Reset. Mega-financier, George Soros, at the age of 92, handed his \$25bn portfolio to his son, Alex, who became chairman of the Open Society Foundations in December 2022. Interviewed by the *Wall Street Journal*, Alex Soros declared himself as 'more political' than his father, and thus even more motivated to attack the remnants of traditional society and its conservative defenders.

Computer salesman, Bill Gates, whose father, William H Gates, was head of Planned Parenthood, exerts his wealth through supposedly philanthropic funding of international health projects. Initially focusing on reproductive health (contraception and abortion), he moved into vaccination. In a TED talk in 2010, Gates junior said: "The world today has 6.8 billion people. That's headed up to about nine billion. If we do a really good job on new vaccines, health care, reproductive health services, we could lower that by perhaps 10 or 15 per cent."

Having captured universities, regulators and media by predatory funding, the Bill And Melinda Gates' Foundation was at the forefront of the covid-19 pseudopandemic. As a key player in the World Health Organisation, Gates promotes universal vaccination by novel mRNA technology, which has intended use far beyond alleged immunology, to hormonal control and body surveillance.

One more father-and-son duo deserves mention: Boris Johnson's father, Stanley, who worked for the World Bank and EU, suggested in a *Guardian* interview in 2012 an ideal UK population of 10 to 15 million. Is his son, who successfully disguises himself as a buffoon, really unaware of the depopulation mission of the UN and WEF? He spent three years carrying out the same orders as fulfilled by every government. Again I must conclude: like father, like son. But these men would gladly extinguish the legacy of your fathers, and the future of your sons.

Smart meters causing serious harm

Worldwide testimony shines spotlight on devices

SMART meters are being imposed on more and more customers by energy companies whose staff assure us that there is nothing to worry about in terms of impacts on health.

Despite this, The White Rose UK has gathered first-hand testimony from across the world, begging to differ...

Jennifer Andree is a New Mexico resident who was severely injured by a smart meter that has completely devastated her life.

She is a nurse and a veteran who knew nothing about smart meters until she was injured by one. This occurred on Kirtland Air Force Base in New Mexico.

She claimed that for three-and-a-half months, she slept with her head approximately one foot away on the other side of a wall from an electrical panel containing two electric smart meters.

Anything that carries an electric current or emits any radiation now causes her headaches, brain fog, and internal burning.

She writes: "I can no longer tolerate living in an urban environment so I have moved to South Dakota, to a cleaner environment in the country. Because of the harms I was exposed to, I am separated from my family, which has contributed to my suffering. I have a nursing licence, but can no longer work in my profession."

Maryann McCabe writes from the UK: "From the time the smart meter was turned on, I could not walk around in my flat; I could not write an email; I could not think and I could not sleep. It was an absolute nightmare until it was switched off."

Harriet Greene, formerly of New Mexico, writes: "I was able to opt out and keep my old meter. Everybody I talk to who was forced to accept smart meters has complained of numerous effects."



The effect smart meters have on nature

Lauren Bond writes: "Smart meters were installed in my building, and the radiation they emit inside apartments causes a constant burning pain on my skin."

Jeanne Thompson writes from California: "My mother died of a massive brain tumour caused by a row of six smart meters outside her condo, on the wall where the head of her bed was. We discovered this after she had already passed. You can imagine my shock and horror at that realisation."

Alvita Armanavičienė, from Latvia, submitted the startling photograph (above) of a bush standing just inches away from a smart meter.

Dr Linda Thomas writes, "I have seen hideous debility in adults and children after smart meters were installed in my area." These include seizures in a two-year-old boy and chronic fatigue and fibromyalgia in his mother.

Mario Desira writes from Malta: "Back in 2017, my electrical meter caught fire and nearly caused a house fire. Luckily I was at home and intervened before anything worse happened."

Persephone Maywald writes from California that she was diagnosed with suspected Parkinson's disease a few

months after a smart meter was installed, and that she later had the meter replaced and within a few weeks all her symptoms disappeared.

Simone St Clare writes from California that since a smart meter was installed, there have been almost no hummingbirds at her feeders and a decrease in caterpillars in her garden.

Deirdre Novella writes from New York that her hair started falling out within a few months of a smart meter being installed at her place of work, that she was diagnosed with leukaemia, and that she developed a lifelong allergy to electricity.

Sheila Reavill, who works as an electromagnetic radiation specialist (EMRS) in Georgia, writes that after smart meters were installed, the smart meter signature she logged (on her radio frequency meter) in her bedroom was at the precise times she woke up at night.

She added that her next-door neighbour and her neighbour's daughter woke at the exact same time she did every night.

Rebeca Randle writes from California that while she had a smart meter she could not sleep and there were no birds, and that when the smart meter was removed, the birds came back.

Robert Workman, an EMRS in Missouri, writes: "I have confirmed injuries from wireless radiation and the smart meter seems to be the most damaging to me and my clients. Once the ITRON electronic meter is removed, many of my clients have an immediate response of improved health. This meter has been torture to myself and others in St Louis; it is my professional opinion this meter kills all biological life."

‘Far right’ messaging blamed over riots

THE Irish government has blamed the recent riots on the phantom ‘far-right’ and vowed to fast-track draconian ‘hate speech’ laws.

This was after the barbaric knife attack on three children and a creche employee in Dublin by a 50-year-old Algerian immigrant on November 23, which then sparked riots.

As a result of a coordinated government response to tackle ‘hate speech’, the Republic of Ireland’s new Online Safety Media Commission has urged the Irish public to report any ‘hate speech’ to the Gardai (Irish police) in the aftermath of the stabbings and riots in Dublin.

The newly established Irish online media regulator approved by the European Commission, Coimisiún na Meán, is currently overseeing what is being billed as online safety in Europe in a move to tackle hate speech and disinformation.

Immediately after the riot, Irish online regulators became the first EU member state to activate an alert under new Digital Services Act (DSA) rules. The activation alerted the European Commission to contact large social media companies within hours of the riot in Dublin to remind them of their legal obligations regarding dissemination of illegal online content, threats, hate speech, and ‘disinformation’.

On November 28, Minister for Tourism, Culture, Arts, Sport and Media, Catherine Martin, told the Irish Parliament that online regulators are “calling for those who see hate speech or other illegal content online to report it to platforms or to the Gardai.”

In the wake of growing tension and concern about mass immigration, housing, and violent crime in communities across the country, the Irish government is instead planning to pass legislation to curb freedom of speech and silence anyone who criticises the regime that currently exists



in Irish politics. The new and unpopular Hate Speech Bill is considered one of the strictest draconian hate-speech regulations in the world.

The Criminal Justice (Incitement to Violence or Hatred and Hate Offences) Bill 2022 (the Hate Speech Bill) will criminalise any speech that is ‘likely to incite hatred, or violence’ against protected groups or groups of persons on account of certain characteristics.

After the stabbings, an Irish Senator named Sean Kyne vented his anger not towards the Algerian terrorist who stabbed defenceless children, but towards the rioters who were mostly a concoction of opportunistic teenagers and looters. He told Minister of Justice, Helen McEntee, that the rioters needed “a good, honest, decent beating”.

A Limerick City Councillor of Bangladeshi roots named Abul Kalam Azad Talukder told a council meeting in the city that the rioters should be “shot in the head” and beaten by the public “until they die”.

Under pressure, McEntee, who is strongly pushing to get Hate Speech legislation passed, was unable to define what ‘far-right’ is when asked during a Oireachtas Joint Committee on Justice recently.

In a waffling response she said: “We have seen people to be anti-government, anti-state, anti-immigration, anti-women’s rights, amongst other things – that would be my own particular view of those who claim to be far-right.”

The legislation vaguely defines hatred as ‘hatred against a person or a group of persons in the state or elsewhere on account of their protected characteristics’. The protected characteristics include race, nationality, gender, sexual orientation and religion.

The radical bill outlines how merely possessing ‘hateful’ content on your devices or on signs, posters and banners that ‘could’ incite hatred can lead to criminal charges and up to five years imprisonment.

Authorities will be allowed to seize all electronic devices including phones, laptops and tablets, and force individuals to hand over passwords, even if no crime has been committed, according to the Orwellian bill.

Independent Irish Senator, Sharon Keogan, who called for a national vigil for the victims of the stabbings in central Dublin, said what happened “has been lost in all of this noise” around legislation. She believes the main objective of the hate speech bill is “partly designed to keep political dissenters quiet.”

In a viral video that got international attention, a Green Party Senator, Pauline O’Reilly, unironically said: “When you think about it, all law, all legislation is about the restriction of freedom. That’s exactly what we are doing here. We are restricting freedom, but we are doing it for the common good.”

Eisenhower's dirty secret

History's hidden genocide of German soldiers

A VAST field is filled as far as the eye can see with miserable and gaunt men in remnants of military uniform.

It's May 1945 and the war in Europe has ended. By rights, these surrendered soldiers will be allowed to return to their families, but many will not leave this muddy ground alive.

There is no food, no shelter, and no medicine. The Rheinwiesenlager (Rhine meadow camps) were the killing fields of one of the worst war crimes in modern history, committed by General Dwight Eisenhower and the U.S. Army.

The cull of German troops was a closely guarded secret until four decades after the war, when a Canadian researcher was writing a book on a French resistance hero. James Bacque found that his subject, Raou Laporterie, had been saved by a German soldier, Hans Goertz. In gratitude, in 1946, Laporterie got Goertz out of a French prison camp to work in his chain of drapery stores. Goertz told of mass deaths of inmates through lack of sustenance.

After pursuing leads in the French records, Bacque came to realise that Allied military leaders had 'committed an appalling crime against humanity'.

Bacque's investigation culminated in his harrowing book, *Other Losses* (1989). The foreword to this exposé was written by Ernest Fisher, a retired colonel of the U.S. Army, and war historian noted for his book, *Cassino to the Alps*.

Fisher set the scene: 'Over most of the western front in April 1945, the thunder of artillery had been replaced by the shuffling of millions of pairs of boots as columns of disarmed German soldiers marched wearily towards Allied barbed wire enclosures.

'Scattered enemy detachments fired a few volleys before fading into the countryside and were eventually captured by Allied soldiers.'

As Fisher explained, German soldiers did everything they could to evade capture by the Russians, who raped and pillaged as they advanced over eastern Germany.

He wrote: 'The mass surrenders in the west contrasted markedly with the final weeks on the eastern front where surviving Wehrmacht units still fought the advancing Red Army to enable as

many of their comrades as possible to evade capture by the Russians.

'This was the final strategy of the German High Command then under Grand Admiral Doenitz, who had been designated Commander-in-Chief by Adolf Hitler.'

But crossing to the Allied side was not the sanctuary that the defeated Germans expected, due to the visceral hatred of Eisenhower. The supreme military commander, of Swedish-Jewish background, had written in a letter to his wife: 'God, I hate the Germans.'

In September 1944, in the presence of the British ambassador to Washington, Eisenhower proposed that the entire German general staff, all officers of the Gestapo and all leaders of the Nazi party from mayor upwards should be exterminated (around a hundred thousand men).

Fisher had met Bacque in Washington in 1987, where they uncovered evidence, deeply buried in national archives, of a systematic slaughter.

Bacque wrote: 'More than five million German soldiers in the American and

French zones were crowded into barbed wire cages, many of them literally shoulder to shoulder. The ground beneath them became a quagmire of filth and disease. Open to the weather, lacking even primitive sanitary facilities, underfed, the prisoners soon began dying of starvation.'

Shockingly, more German soldiers died in the camps from April 1945 onwards than died in combat.

In the archives, Bacque studied each edition of the Weekly Prisoner of War and Disarmed Enemy Forces Report, which showed a high number in the category of 'other losses'. As escape was almost impossible, these men must have died in the camps.

According to Bacque: 'The victims undoubtedly number over 800,000 and quite likely over a million. Their deaths were knowingly caused by army officers who had sufficient resources to keep the prisoners alive.'

'Relief organisations that attempted to help the prisoners in the American camps were refused permission by the army. All of this was hidden at the time,

then lied about when the Red Cross, *Le Monde* and *Le Figaro* attempted to tell the truth publicly.'

Ominously, on April 26, 1945, the combined chiefs-of-staff at Reims decided to create the status of 'disarmed enemy forces'.

This category would apply to 'prisoners-of-war in American hands only'. No public declaration was made of this bypassing of the Geneva Convention. Mortality data was censored by the American military authorities, who exploited their control of media to push propaganda about their 'humane' treatment of prisoners.

With German soldiers failing to come home in the months after the war ended, the myth of a 'world food shortage' was used, a contrived crisis blamed on the Germans. Yet despite the war, there was ample supply of wheat and corn.

The Swiss Red Cross had 13.5 million food parcels intended for prisoners, which would have prevented any death from starvation, but this provision was blocked. Indeed, the Red Cross was prevented from entering the camps.

Bacque explains: 'Granting permission for the welfare agencies to visit the camps would have led to a storm of public protest against the atrocious conditions, while at the same time producing the workers and political will needed to alleviate them. It can hardly be doubted that this was why permission was not given.'

There is another part to this dark episode. General George Patton, a magnanimous victor who respected the Germans as a people, was disgusted by Eisenhower, accusing him of Gestapo practices.

As described in a Daily Mail article (December 21, 2019), Patton's death at the end of 1945 was later suspected as an assassination.

Was Patton killed because he knew too much about the death camps, and was too much of a maverick to risk the dirty secret coming out?

A hidden consequence of the ‘pandemic’

THE issue of mental health is a topic that has been receiving an increased level of attention in the legacy media over recent months.

However, because we know we cannot take what the media report at face value, this topic requires some further investigation to be able to appreciate what may be behind these reports.

One BBC article, dated August 2022 and entitled, *Covid: Brain fog more common two years on study suggests*, states:

‘Two years after having covid-19, diagnoses of brain fog, dementia and epilepsy are more common than after other respiratory infections, a study by the University of Oxford suggests.’

A more recent BBC article, *Brain power dropped among over-50s during covid-19 pandemic*, refers to a different study and reports that: ‘The covid pandemic may have impacted brain health in people in the UK aged 50 and over, according to a new study.’

This study, called PROTECT, was designed, ‘...to help understand how healthy brains age and why some people develop dementia.’

Although, as we’ve discussed in previous articles, there was no new disease outbreak nor was there ever a ‘pandemic’, this does raise the question: Why are studies reporting that there is a link between brain health and the alleged ‘covid pandemic’?

It could be viewed as simply a business model to encourage people to visit their doctor so that their symptoms can be diagnosed and treated with a pharmaceutical; although it should be noted that the medical establishment admits there is no ‘cure’ for dementia.

However, there seems to be a deeper purpose to this.

The WHO web page entitled *Mental Health*, under the heading, *Overview*, states:

‘In recent years, there has been increasing acknowledgement of the important role mental health plays in achieving global development goals, as illustrated by the inclusion of mental health in the Sustainable

Development Goals.’

In other words, the purpose is to support the implementation of Agenda 2030, as can be seen on another WHO web page:

‘Mental health is critically important to everyone, everywhere. All over the world, mental health needs are high but responses are insufficient and inadequate. The World mental health report: transforming mental health for all is designed to inspire and inform better mental health for everyone everywhere.’

But what exactly does the WHO mean by ‘mental health’? According to their June 2022 *Mental health fact sheet*,

‘Mental health is a state of mental well-being that enables people to cope with the stresses of life, realise their abilities, learn well and work well, and contribute to their community.’

Although acknowledging that ‘mental health’ is more than just the absence of mental illness, the fact sheet also lists various mental disorders, which the WHO’s *Mental disorders fact sheet* defines as involving ‘significant disturbances in thinking, emotional

regulation, or behaviour’.

In other words, they are making judgments about our thinking, emotions and behaviours! This is highlighted by the disorder called ‘Disruptive behaviour and dissocial disorders’, about which the fact sheet states:

‘40 million people, including children and adolescents, were living with conduct-dissocial disorder in 2019. This disorder, also known as conduct disorder, is one of two disruptive behaviour and dissocial disorders, the other is oppositional defiant disorder. Disruptive behaviour and dissocial disorders are characterised by persistent behaviour problems such as persistently defiant or disobedient to behaviours that persistently violate the basic rights of others or major age-appropriate societal norms, rules, or laws.’

This approach empowers certain members of society, namely, the medical establishment – or to be more accurate, those who create the rules for the medical establishment - to determine what is ‘normal’ and make us abide by the rules they create.

This is highly problematic for many reasons.

There may be genuine reasons that children exhibit certain behaviours, in a school setting for example, that are perceived to be disruptive. These reasons can include sheer boredom because what they are being taught is not stimulating either intellectually or creatively, an increasingly common situation. There could also be genuine emotional issues or even traumas that cause them to behave in a disruptive manner, but these will not be resolved by labelling these children as ‘abnormal’ in some way.

One of the insidious aspects of this move towards labelling children and adolescents with one of these conditions is that it could be extended to apply to children who are homeschooled, an option that increasing numbers of parents are choosing. The reason this needs to be considered is because homeschooled children are more likely to ask questions of anyone who tries to tell them what to do. This could give rise to the belief that these children are behaving in a way that can be described as ‘disruptive’ or ‘defiant’, purely as the result of learning how to think for themselves and not merely take orders from an adult.

We would add that this approach is almost certainly intended to be used against adults as well, especially those of us who challenge the mainstream narratives!

There are reasons that people may experience diminished brain power – prolonged stress being one of them. However, there is also the placebo, or rather nocebo effect that cannot be dismissed because it is incredibly powerful.

It has been shown in clinical trials that people who believed they were receiving a genuine chemotherapy drug, but in fact received a placebo, nevertheless experienced some of the known chemotherapy ‘side effects’, including vomiting and hair loss.

It is therefore entirely possible that some people who read media reports that refer to brain fog, diminished brain power, and dementia all in the same article, may start to believe that they have this condition, a belief that may then go on to become a self-fulfilling prophecy through the nocebo effect.

We do acknowledge that some people experience genuine cognitive decline and other symptoms that are diagnosed as a form of dementia. The point we are making in this article is that the medical establishment not only does not know the real cause(s), and cannot therefore truly help these people with the treatments they offer, but, with respect to the past four years, it is largely the medical establishment and the media that can be held responsible for some of the increase in cognitive problems through the perpetuation of the unproven idea that there was a ‘pandemic’ caused by a ‘virus’ that could be transmitted between people.

It is always a combination of different factors that will influence our health, and this combination will differ for each of us. However, whilst these factors do not include ‘germs’, they most definitely do include fear and stress, especially when prolonged.

Do viruses actually exist?

Exposure to synthetic chemicals could be causing disease

IF you cast your mind back to 2020, governments across the world declared a covid pandemic based on scant evidence, at best.

People got sick and died in Wuhan, China – a city known for massive industrial pollution and cases of pneumonia. It is unpleasant to say, but people have been dying since the dawn of time and so this in itself is no evidence at all.

Wuhan scientists had sequenced many short fragments of genetic material from a patient's lung fluid.

They asked a computer programme to arrange them in every single possible combination and when joined up it ended up similar to a pre-existing virus sequence contained in a database, which may or may not have been found in the same recursive way.

Scientists saying they have found the genetic sequence of a virus sounds impressive. It sounds like good proof. Except of course some or all of the individual DNA sequences, which were joined up on a computer to make this novel virus, could possibly have come from human DNA.

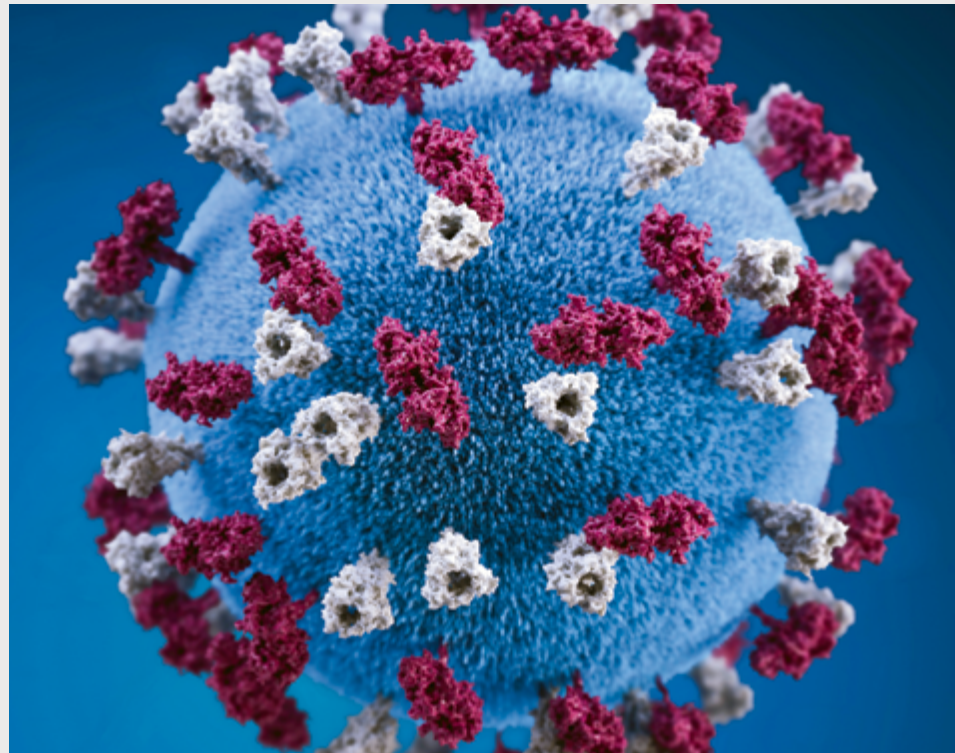
The scientists sequenced from an impure soup, instead of from purified and isolated virus particles. Furthermore, the scientists were only concerned with obtaining a genetic sequence. There were no studies to see if this virus was actually contagious or causing disease.

Virologists never obtain pure samples of their viruses. Instead, the viruses are contained in a medium of host animal cells, antibiotics and fetal calf serum. So it is difficult to know what they are sequencing or what exactly is causing a problem.

In the past three years, the internet has been awash with articles and videos from doctors and scientists stating that viruses do not exist. Is this an overreaction to the covid pandemic lockdowns?

The same scientists cite terrain and germ theory. Terrain theory states that ill-health is caused by a polluted environment and poor nutrition. All disease is either caused by not eating the right foods or the ingestion or inhalation of toxic, synthetic chemicals.

Germ theory states that disease is caused by dangerous bacteria and viruses.

If we look at the Wikipedia entry for tuberculosis, the epidemiology section (using a World Health Organisation reference) states: 'Roughly one-quarter of the world's population has been infected with *M. tuberculosis*, with new infections occurring in about 1% of the population each year. However, most infections with *M. tuberculosis* do not cause disease, and 90–95% of infections remain asymptomatic.'

We can see that large numbers of people carry the bacteria held responsible for the disease, but only 1% of them actually progress to suffer from the disease. This suggests other causes for the disease such as malnutrition or drug abuse. So even from the mainstream science, we can see the terrain theory is not so outlandish.

Bacteria definitely exist. Their colonies can be seen with the naked eye when they are grown in large numbers on scientists' agar plates. They can be stained and seen under light microscopes. Viruses, on the other hand, can only be seen under considerably more powerful electron microscopes and it is difficult to distinguish whether the viruses have a real existence as anything other than debris of the host animal cells that they are presumed to grow in, or are artefacts of. Harsh staining is needed to visualise the material.

Medical doctors see people with dangerous bacterial infections and see that antibiotics cure them. So germ theory must be true and, by extension, terrain theory is false.

It could be that both terrain and germ

theory are both partially correct.

Bacteria exist, but animal viruses may be misunderstood. Bacteria exist to clear up dead and decaying matter. Viruses exist to clear up overgrowths of bacteria. Bacteria may only cause a disease if there is something else causing the initial problem.

If viruses do not exist, then what causes childhood diseases such as chickenpox, measles and mumps? Why, when one child gets sick with chickenpox, do other members of the school get the disease at the same time?

There are many explanations for this. It could be that chickenpox is a reaction to childhood vaccinations and members of the same class get vaccinated at similar times. Alternatively, it could be that growth spurts deplete the body of the building blocks needed to make collagen (a protein used to construct blood vessels and skin). Without sufficient collagen, small blood vessels leak fluid which form pustules under the skin (known as poxes).

The liver disease, hepatitis, could be caused by drug abuse or eating seafood grown in polluted waters as opposed to a virus. The liver is the detoxification centre of the body and so it makes sense dangerous chemicals will be sent there for processing.

The real cause of so-called viral diseases may really be cumulative exposure to the many synthetic chemicals we encounter in our everyday lives.

Is medical intervention the leading cause of death?

THE term iatrogenesis is derived from the Greek word for doctor, although the origin of the word ‘doctor’ derives from the Latin for ‘teacher’. It is widely recognised that there are problems within the medical systems an understatement of immense proportions.

Nevertheless, the existence of problems is recognised, albeit in a limited way, by the medical establishment itself, as can be seen by a May 2005 article published in the BMJ that is worthy of note. The article refers to a Johns Hopkins study that analysed medical death rate data, and discovered that the number of deaths per year due to medical error was far in excess of the number of deaths due to respiratory disease, which the CDC was claiming at the time to be the third leading cause of death. This discovery moved ‘medical error’ into third place.

The article, appropriately titled Medical error: the third leading cause of death in the US, explains that most data about causes of death are based on the ICD (International Classification of Diseases) codes and states that: “...causes of death not associated with an ICD code, such as human and system factors, are not captured.”

This clearly raises serious concerns about the true scale of the problem, if certain information is not even captured. However, iatrogenesis does not equate to medical error alone.

The Merriam-Webster dictionary defines iatrogenesis as: ‘the unintentional causation of an unfavorable health condition (such as disease, injury, infection,

to the use of untested medicines and syringes, but does not include reference to the side effects of these allegedly safe injections.

The idea that medicines are harmful is definitely an unscientific topic for the medical establishment, but the scale of the problem is too large and too significant for them to completely ignore. However much they would like to do so. Therefore, any reference to the problem will be the result of improper practices of some description, rather than the actual medicines and practices that are being prescribed. This attitude can be seen on a WHO web page entitled Medication without harm, which states that: “Unsafe medication practices and medication errors are a leading cause of injury and avoidable harm in health care systems across the world.”

There is a clearer deeper purpose to this WHO initiative, which is to create an emphasis on

description, many of which are known to cause harm and even death.

One of the reasons that the situation in the U.S. is so alarming is because pharmaceutical use there is one of the highest in the world. If modern medicine truly was the miracle it is claimed to be, then Americans ought to be amongst the healthiest people in the world. But this is far from a true representation of the state of health of the vast majority, many of whom take multiple medicines each day, a phenomenon known as poly-pharmacy.

The above cited BMJ article reveals, under the heading State of iatrogenesis, that ‘iatrogenesis is the fifth leading cause of death in the world. There are about 5%–8% of deaths due to ADRs. In many countries, ADRs are a leading cause of death.’

ADR are not the only component of iatrogenesis. If all aspects are taken into account, it is almost certain that iatrogenesis would be recognised as the leading cause of death in all countries where modern medicine is practised as the main system. Yet modern medicine is supposed to heal not harm, and certainly not be one of the leading causes of death!

Dr Carolyn Dean summarises the situation in her aptly named book, Death by Modern Medicine: ‘How modern medicine has come to be the number one killer in North America is as incredible as it is horrifying. Doctors certainly don’t think of themselves as killers, but as long as they prescribe toxic drugs and don’t ban non-toxic options, they are pulling the trigger on helpless patients.’

Toxic drugs are not the only culprits; as the past two years have shown, toxic injections must also

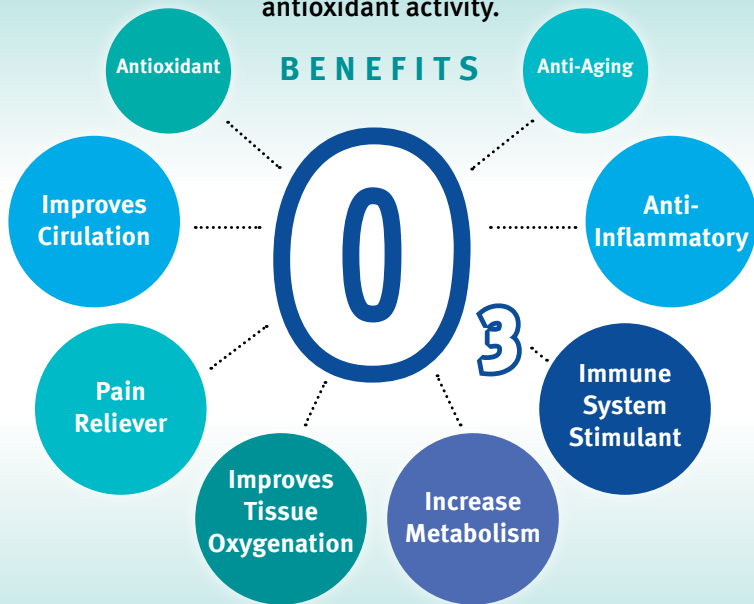

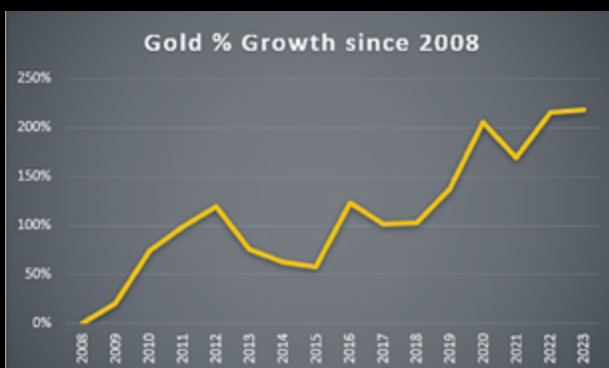
