The money issue

MONEY makes the world go round.
Love of money is the root of all evil.

We all know what money is – or do we really?

How much are we actually taught in school about banking, currency, credit and the entire financial system?

The answer is actually very little – even in terms of personal finances, saving and investing for ourselves somehow requires specialist knowledge, while governments rack up huge debts that rise every year.

The reason for this is very simple, and famous industrialist Henry Ford summed it up best when he said: “It is well enough that people do not understand our banking and monetary system, for if they did, I believe there would be a revolution before tomorrow morning.”

While we are not seeking to cause a revolution in the broad sense of the word, a revolution in your approach to finances, banking and borrowing may well see your world improve significantly in the coming months and years, and therefore the world of the people around you.

Here's another quote by a famous banker that is not well-known, and for a reason: “Gold is money, everything else is credit” – J.P. Morgan

So what are the pounds, dollars or euros in your wallet or electronic device really?

While they used to denote something of actual value – a pound of silver, for example – nowadays they represent the

assumed future productivity of a nation, but are based on nothing of intrinsic worth, and nor would they burn for very long to keep you warm. They are issued by central and commercial banks when governments, businesses or individuals borrow money. They are literally loaned into existence.

Of course, you can take those fiat tokens and exchange them for the goods and services you need today – food, fuel and energy, clothes, tools and so on. But tomorrow they will be worth slightly less, and the next even less, because that's the way the currency system is designed – with a hidden tax called inflation.

Inflation is not just prices rising – it's not companies being greedy, despite this being told to us repeatedly by the clueless media

– it's the constant creation of more and more debt as governments, businesses and individuals borrow more and more, which logically reduces the value of the units of currency already in existence.

No new goods or services are created by the creation of more currency credits – so the same available goods and services are now being chased by even more currency, meaning their prices go up. It is not the only reason of course, but this basic truth about money is missing from most people's understanding, by design.

Then you have what is known as the Cantillon effect, where those closest to the money creation source benefit the most, as they get the new units first and can buy the real things of the world before their prices

rise – land, property, businesses, resources and so on – leaving the rest of us with ever higher prices and a ‘cost of living crisis’.

Make no mistake, it is a money creation crisis, and for most of human history, usury, or the charging of interest on borrowed money, was completely outlawed for this very reason. So really, usury is the root of all evil.

The Bank of England does not work for the people of England. The Federal Reserve is neither federal nor does it have any reserves. They have the licence to create money from nothing and loan it to governments with interest, which we the taxpayers are then saddled with for generations.

Central banks are private, for-profit corporations and their power was evident in 2022 with the downfall of Liz Truss's administration – she wanted to be fiscally responsible and reduce spending and taxes, but the bankers weren't having that. Too late did she realise that the Prime Minister is not the most powerful person in the country by a long chalk, again, as our schooling claims is the case.

Parasitic banks run the world

WHEN you investigate the operations of world power structures and begin to understand the enormous influence they wield over our lives, the question that pops up continuously is: who controls the world?

Grappling with that question can turn into an exploration of a Russian doll power hierarchy. Who or what is the giant doll housing all the smaller ones nestled inside it?

To that end, we could seek out institutions that are unaccountable to nation-states

and yet indisputably control the economic fabric of the lives of all those living within those states.

A syndicate of international central banks finances wars and, through their banking cartel members, they control the allocation of economic resources within societies.

This all happens behind a curtain of financial wizardry, and it will continue unhindered unless more of us become aware of the fact that all nation-states are not sovereign.

The world is controlled by a huge financial parasite, and the Bank for International Settlements (BIS) is its head.

The BIS was set up to administer Germany's reparation payments following the end of World War One, the war supposedly 'to end all wars'.

But war is a highly profitable enterprise for the parasitic banking class who are highly skilled in playing both sides of any conflict. Their loyalty is only to themselves, and their ability to play both sides guarantees that the financial ruling class always emerges stronger after major conflicts.

Once we grasp this, we can begin to understand why wars happen. It is futile to try to make sense of them by listening to the propaganda peddled by the politicians, and corporate and state-owned media.

The political class in nearly all Western nations is beholden to the international banking cartel through debt, including war debt.

Sweeping and rapid shifts in the direction of humanity across cultural and geographical divides are manifestations of the banking cartel's total control.

A key objective of international financial institutions like the International Monetary Fund (IMF) and the World Bank is to ensure that countries are drowning in debt which is then used as a lever of social and economic control.

He talks about the creation of a global empire that has emerged without the need for any military, and how it uses a nation's debt to take control of its decision-making.

He described how economic hitmen like himself would be sent into third-world countries that had resources that corporations coveted.

The hitmen would then loan money to

corruptible political leaders, and that money would go to the corporations to build infrastructure for mining those resources, which it would then take as payment for the country's recently incurred crippling debt.

Wars are another key element of control as they have to be financed, creating further profit and control for the financiers.

The global banking cartel, headed by the BIS, decides which wars happen, how long they will last, and who will win.

Sweeping changes also require financing and are enacted by the banking cartel's opening and closing of its purse strings.

The BIS and its vast central bank network is a parasite seeking to ensure continuing control of its host – all of humanity. For all our sakes, we need to cast it off.

What next for the parasite?

While the BIS is the coordinating brain of the world's central banks, the U.S. Federal Reserve is the titan of central banks. In May 2024, the Biden administration issued a memo that gives a clue to the direction of intended central bank influence, not just in the U.S., but across the world.

It reveals a final major push to openly replace rule by democratic governments with rule by privately-owned central banks that will control every aspect of humanity, with programmable digital currency being a key pillar of that control.

The White House memo promotes a move to sever the remaining control that Congress has over the Fed and

argues: 'Nearly all advanced economies and many developing countries are now governed by independent central banks whose governing bodies decide monetary policy without political input, approval, or fear of reprisal.'

The West's so-called leading democracy admits that nearly all advanced economies are governed by banks. And it wants that control to be normalised in the U.S. as well.

The Western world is straining under an ever-increasing mountain of debt owed to the banking parasites. This is an important clue to understanding who really controls the world.

Exposing zero carbon fantasists

Nearly 7,000 years of lithium mining needed for green goals

IN 1958, Leonard E. Read wrote the book *I, Pencil*.

As the book's title suggests, this is the story of a pencil, told from the pencil's perspective.

The pencil traces his beginnings – from the cedar forests of Northern California and Oregon – to the mill in San Leandro, California, where specialised equipment cuts the logs into pencil-length slats.

Next, the newly cut slats move to the pencil factory, where machinery cuts eight grooves into each slat and inserts graphite.

Read goes on to further describe each part of the pencil manufacturing process.

His point: even something as simple as manufacturing a pencil is a highly complex process. Yet left to the free market, profit incentives allow individuals and companies to efficiently combine raw materials and produce any in-demand product.

No committee of central planners is required any time during the manufacturing process.

So, if central planning cannot produce something as simple as a pencil, how can governments expect to coordinate and control a product as critical and vital as energy, whose production is exponentially more complex than a pencil?

They can't. But they'll still try.

To be fair, although the current administration in Washington has enacted plenty of anti-energy policies, they aren't solely responsible for the world's dire energy predicament. In fact there's plenty of blame to go around.

In recent years, 'woke capitalism' has gained a serious foothold in western financial markets.

Led by the movement's high priests, like Larry Fink (who manages \$10trillion at Blackrock), and Klaus Schwab of the World Economic Forum, one of their key tenets is replacing fossil fuels with green energy solutions.



The devastation caused by lithium mining, all to 'save the environment'?

Sadly, many of the world's largest energy companies have bent the knee to the Holy Climate Warriors. Now, most of us like a clean and pristine environment, and we have a strong desire to leave a better world for our children.

But inefficient green energy solutions like solar and wind simply aren't the way forward, and here's why:

Let's suspend reality for a moment and pretend that Klaus Schwab and Greta Thunberg are right, and that the world's energy should be 100 per cent renewable.

What would it actually take to do this? Remember, solar panels, wind turbines, and batteries require lots of raw materials.

According to estimates by Professor Simon Michaux of the

Geological Survey of Finland, achieving the Schwab-Thunberg-Fink dream world require: 218 million tons of cobalt; 899 million tons of lithium; 4.3 billion tons of copper.

Let's tackle copper first.

In 2019, the world produced 22 million tons of copper. So, a full transition to renewable energy would require 100 per cent of the world's annual copper production for the next 195 years.

That means that for the next two centuries, there would be zero copper left over for anything else. Only renewable energy. Also bear in mind that solar panels wear out after a few decades. So, after 195 years, the world will have had to replace all of its panels at least five times.

Now, if you think that's a

daunting challenge, lithium and cobalt are even more interesting.

Global lithium and cobalt production in 2022 were approximately 130,000 tonnes each. Therefore, based on Prof Michaux's estimates, the transition to renewable energy requires 1,676 years of annual cobalt production, and a whopping 6,915 years of lithium production.

No, those are not misprints.

In short, the climate fanatics don't realise that their renewable energy dream requires so many raw materials that it would take nearly 7,000 years to mine all the necessary resources.

But reality has never been their area of expertise. Instead, they fly around on their private jets to luxurious climate conferences to complain about fossil fuel

companies. They pass legislation and resolutions. They put out hit jobs in the media.

But just like the humble pencil at the beginning of this article, the fanatics and central planners don't contribute a single thing. They don't mine an ounce of lithium, manufacture any solar panels, nor produce even one kilowatt-hour of electricity.

Does this sound a bit ridiculous? This is why, no matter how fanatical the climate cult becomes, natural fuels aren't going anywhere for a long, long time; not without most of the world's population sitting in the dark. And we don't think people will stand for that.

Welcome to the nerd reich

Perfect revolution being sold as inevitable technological progress

Trump and Musk moving towards *Brave New World* endgame

THE tech elite already have more wealth than they could spend in multiple lifetimes.

What they are pursuing is something far more ambitious – total control over society’s future development.

What appears as chaos is actually a precisely choreographed sequence of events. What looks like resistance is often part of the plan. What began with subtle changes in society’s foundation has revealed itself as something far more calculated. The growing polarisation, the accelerating technological revolution, the institutional breakdowns – none of these were random events. They formed the opening moves in a transformation so ambitious that even describing it risks sounding implausible.

Three elements converged to create the perfect conditions for change.

- **First:** a strategic erosion of trust. Government agencies making decisions that seemed designed to undermine their own credibility. Media organisations abandoning even the pretence of objectivity in ways that destroyed their authority. Political processes long ago devolved into such obvious theatre that they undermine the entire system’s legitimacy.
- **Second:** a precise channelling of public frustration. Rather than focusing on specific targets, anger fragmented and turned inward against the society itself. Left and right polarised beyond dialogue. Different social groups found themselves in perpetual conflict. Each attempt at reconciliation or compromise failed in ways that deepened divisions.
- **Third:** the emergence of technology sophisticated enough to enable total control. For the first time in history, the technical capability exists to implement governance through algorithms, monitor populations comprehensively, and automate resource allocation across entire societies.

This transformation follows a classic pattern: problem-reaction-solution.

1. **Problem:** create or amplify problems severe enough that the population demands change.
2. **Reaction:** wait for the reaction – frustration, anger, calls for reform.
3. **Solution:** present solutions that would never be accepted under normal circumstances.

The execution of this formula shows remarkable sophistication. Each crisis connects to the next. Every institutional failure creates specific vulnerabilities. Each scandal opens the door for predetermined ‘solutions’.

Consider the perfect synchronisation of events to achieve their goals:

- Digital platforms replace traditional information sources while trust in media collapses.
- AI systems emerge as alternatives to human judgement while faith in institutions falters.
- Private infrastructure displaces public services precisely when government credibility hits historic lows.
- This is not coincidental. Like a master chess player’s strategy, the true pattern only becomes clear when the position is already won.

A chess master wins not through individual moves, but by creating positions where every opponent’s move strengthens their strategy. This perfectly describes the Trump phenomenon: each attempt to stop him made him stronger, every attack increased his immunity, all resistance cemented his position.

The pattern was too perfect to be coincidental.

- Media attacked him relentlessly, but always in ways that confirmed his ‘fake news’ narrative.
- Federal investigations launched with great fanfare, only to end in anticlimaxes that strengthened his position.

- ‘Leaks’ emerged with peculiar timing, always maximising their effect – not against Trump, but for his agenda.

It was like watching a boxing match where every punch from the opponent somehow builds the champion’s strength rather than depleting it.

But beneath this obvious theatre lay something far more strategic.

Court decisions about presidential immunity during office, presented as efforts to ensure Trump could face justice, instead built the perfect legal shield for future action. Before these cases, a president’s immunity was unclear – afterward, it became nearly absolute.

Most crucial were the specific precedents established. The courts granted extraordinary powers to sitting presidents while appearing to close in on Trump. What the public saw as the justice system pursuing Trump was actually the systematic creation of legal immunity for the coming transformation. Both sides of the establishment – those appearing to prosecute and those appearing to defend – played their roles in constructing this framework. The true game operated at a level above these apparent conflicts.

The culmination of the fanfare came with the alleged assassination attempt – an event so perfectly timed, so dramatically staged – that it transformed Trump from a political figure into something almost messianic.

Behind the money and influence flowing into the Trump campaign lies a set of radical beliefs and a dark agenda. The tech elite of Silicon Valley believes the American empire stands on the verge of collapse. Rather than prevent this collapse, they aim to accelerate it while creating safe landing zones for themselves and their assets – territories where they can run their own governments. Elon Musk and his growing empire represented the visible spearhead of this movement. Through his control over everything from space travel to social communication, he was systematically building the infrastructure required for the new order.

Under the pseudonym Mencius Moldbug,

a San Francisco programmer named Curtis Yarvin wrote a series of essays that would transform Silicon Valley’s worldview. His concept, which he calls Patchwork, envisions a world where the failed democratic system is replaced by thousands of corporate-run territories, each governed by its own joint-stock company without regard for residents’ opinions.

In Yarvin’s vision, nations dissolve into corporate-run territories; democracy yields to CEO-dictators; citizens become customers; rights become services; and governance becomes algorithmic.

What makes this transformation so effective is how it appeals to different groups:

- Progressives see potential for post-national organisation.
- Libertarians embrace promises of freedom from state control.
- Conservatives welcome a return to traditional values in modern form.
- Tech enthusiasts celebrate disruption of old systems (not to mention the transhumanist agenda).

Each group projects their hopes onto the concept while missing the underlying agenda of total corporate control.

Artificial intelligence isn’t just another technology in this vision – it’s the key enabler. AI provides the means to replace human judgment; tools for total surveillance; systems for resource allocation; and justification for eliminating democratic input.

When tech leaders discuss AI safety and control, they are laying groundwork for a new form of social organisation.

The Department of Government Efficiency (DOGE) serves as the vehicle for this transformation. Under Musk’s direction, what’s presented as modernisation reveals itself as:

- Mass layoffs labelled as ‘efficiency measures’.
- Elimination of oversight described as ‘streamlining’.
- Transfer of state functions to tech companies called ‘modernisation’.
- Replacement of human judgment with AI being branded as ‘optimisation’.

To install a new operating system, you must first shut down the old one. And DOGE is perhaps a ctrl-alt-delete for the state.

Are court ‘orders’ violating law?

Council tax legal battles exposing flaws in the system

IN April, I sat in the county court at Norwich as a McKenzie friend to a lovely doctor who challenged her council tax ‘bills’.

She found herself the recipient of a statutory demand for over £8,000, served by South Norfolk Council.

Most people above the age of majority and living in England and Wales receive a council tax bill each year. But how many of us realise, though, that no council has the authority to send us bills?

There are many references to ‘tax bills’ on the government website, but there is no legal definition of that term in existence. It stands to reason, then, that it was never parliament’s intention to authorise any public body to send you a bill. And just because councils have been doing it for a few decades does not make it right. At the hearing last week, however, a judge waved if all off as a ‘labelling issue’.

There are two pieces of legislation that councils use with respect to levying and enforcing council tax: the Local Government Finance Act (LGFA) 1992, and the Council Tax (Administration and Enforcement) Regulations (CTAER) 1992. Regulation 18 of CTAER 1992 says that the ‘billing authority’ (i.e. the council) is required to send the liable person a ‘demand notice’. Not a bill.

Local councils claim that their power to levy council tax originates in the LGFA 1992 and their powers to enforce it ensue from the CTAER 1992. Local authorities, also referred to as ‘billing authorities’ in the CTAER, must first send a demand notice, and then a reminder and final reminder. Only when this sequence is exhausted can they begin the process for obtaining a liability order.

The process for obtaining a liability order is prescribed in detail in the CTAER 1992, and it starts with the council submitting a complaint to a justice of the peace, on the basis of which the magistrates’ court then sends a summons to the liable person so they can come to court and defend themselves.

These are all set out in Regulations 34 and 35 of CTAER 1992. The complaint and the summons are vital here – without them, no liability order can be made by the magistrates’ court.

The Magistrates’ Court Rules set out the requirements for the form and content of summonses in magistrates’ courts as that the summons: (i) must be sealed by the court; (ii) must contain the name

of the magistrate authorising it; and (iii) must contain clear specification of the information or complaint to which the summons relates. The summons can be seen in the top image above.

None of the three requirements are met here and, unsurprisingly, my friend was suspicious. The five-digit ‘case number’ is not from Norwich Magistrates’ Court, because we know that their case numbers have both letters and digits. So if not the court’s, whose summons is it?

My good doctor friend made a special effort to call and email the court to ask if they had indeed made any summons or orders in her name in the relevant periods, and the answer was no, they had not. So now she had confirmation and evidence from Norwich Magistrates’ Court that they had not sent the summons and they had not made a liability order against her. Straight from the horse’s mouth. If only that would have impressed the judge. The next surprise was when she received the liability order. What must any court-

made order contain, you ask? At minimum, it must be sealed by the court and contain the name of the magistrate under whose authority it is made.

The requirements for the content and form of court orders in the UK are governed by the Civil Procedure Rules (CPR) Part 40. In short, says CPR 40.2, every court order or judgment should be sealed by the court and state the name and judicial title of the person who made it.

Understanding that, we can conclude that what you see in image 2 cannot be a liability order.

What happened to my friend is not an isolated event. It is a massive problem throughout the country that liability orders, which are not fit for purpose, are being used to enforce council tax with the blessing of the lower courts.

Recently, during the rule of law inquiry, Lady Hale and Lord Sumption of the Supreme Court declared to the world that people were ‘distressingly ignorant’ in the simple concepts underpinning the rule of law, which can be explained to children at all levels. It is a mystery, indeed, why schools wouldn’t include this important subject in their curriculum and teach children of all ages the substance and principles of the rule of law and, particularly, the constitutional rule of law. However, it is far more distressing, in my opinion, that respectable members of the legal profession, including judges, demonstrate blatant and unforgivable ignorance of those same simple concepts that can be explained to children.

Isn’t the independent judiciary supposed to uphold the rule of law by applying the laws fairly and impartially? If the judges do not know and understand the law, how can they uphold its rule?

Breaking free from the system

Time is ultimate measure of personal wealth

WE wake up to an alarm clock that dictates our schedule. We work for a paycheck that barely covers rising costs.

We scroll endlessly through distractions designed to keep us numb. And at the end of the day, we collapse into bed – only to do it all over again tomorrow.

Can we genuinely escape this system?

This question is one I've thought about for a while, and I'm pleased to see that the answer is quite simple, but it does involve a series of steps.

The first step involves identifying our most incredible resource – time.

Time is our greatest resource. With time, we can do anything. Time is the ultimate measure of wealth. Yet most people feel like they never have enough of it.

The truth is, there is a system that takes time away from us. This system is designed as an invisible prison where every hour of your day is accounted for, leaving just enough space for us to believe we're free.

But what exactly is this system? To understand it, we must see it for what it is – a multi-headed beast designed to control every aspect of our existence.

The image of a multi-headed dragon comes into play here: one head of the dragon breathes fire onto your finances – mortgages, loans, inflation, debt, decreasing wages, and taxes burning away every pound you earn.

Another head whispers distractions into your eyes and ears – entertainment, social media apps, political theatre, and more that hijack your attention.

A third head devises illusions, creating the perception that you are free when, in reality, you are trapped in a maze of obligations.

Between financial enslavement, entrapping the mind, and the illusions of this world, this dragon of a system ensures that it captures all of the available time we have.

Freedom is the representation of breaking free from the dragon.

When we have it, we are free to do what we please with our time without consequences.

If there are consequences for diverting from the dragon, this is further evidence of our enslavement by the system.

To be genuinely free, our spiritual and physical bodies must have the freedom to do as we please without repercussion from the system.

Freedom isn't just about having choices – it's about having control.

So, how do we measure true freedom? It comes in levels – each one bringing us closer to complete autonomy:

- Basic freedom (mental autonomy) – someone in this stage still works a 9-to-5 but questions the system. They read, reflect, and mentally detach from mainstream narratives.
- Advanced freedom – at this level, someone has eliminated debt to the system, has multiple income streams, and can move without money stress.
- Complete freedom – this is the final stage: complete ownership of land, resources and wealth, combined with full mental and money sovereignty. The system holds no power over your time, movement or autonomy at this stage.

Ownership, money and internal dominions are the ultimate physical representation of freedom.

When someone can own their time, think as they like, and move from place to place, with no obligation to the system, one is living their ultimate ideal of self-actualisation.

This freedom is the goal that we all need to strive to achieve.

The physical manifestation will look different for everyone, but if, as a society, we can accomplish these three, we are breaking free from the system.

Breaking free starts with understanding the full scope of the system's control – and how this multi-faceted spiritual and physical enslavement system was built. Then we can learn how to dismantle it in our own lives.

Many recognise the system, but few escape it. Not because they can't – but because they don't know how.

If you're serious about freedom, now is the time to take action in your own life.

Takeover of society by stealth

Totalitarian tiptoe is edging us towards slavery

IMAGINE an old ship where every plank, nail, and sail is slowly replaced. It looks the same, but is it still the original?

This ancient puzzle – the Ship of Theseus – helps explain how societies can be secretly reshaped.

Society does not function to serve the public, but rather the people that design and implement the systems that the public uses to go about its daily life.

A major overhaul and decentralisation is likely needed if people are to have autonomy over their lives and futures, but I will put that debate to one side for now.

What I have personally witnessed over the last forty or so years since I was able to think critically is a complete shift in society. This article will use a powerful metaphor to address this.

If unethical groups swapped parts of our schools, laws, or media with nearly identical versions that serve hidden agendas, would anyone notice?

If the change moved power from the public to a small group of people, acting as puppet masters, would it still look the same on the surface, but function to serve those people rather than the public?

How it works: slow, sneaky swaps.

This trick relies on three rules

1. Small changes over time: like replacing a pub's beer taps one by one until it's become a coffee shop, unethical shifts happen bit by bit. A tweak to school history lessons, a subtle law change – each seems harmless by itself.
2. Copycat design: new parts mimic the old. For example, a school might still have uniforms and exams, but lessons quietly push ideology over facts. Think of a fake £10 note that looks real but spends differently.
3. The new normal: just as London's Crossrail became the Elizabeth Line without most noticing, people accept transformed systems as 'how things are'.

Schools: when learning becomes brainwashing

Take British education. The National Curriculum's 2014 rewrite sparked debates about 'British values'. Imagine if, over years, lessons shifted:

- History: instead of balanced debates about the history of Britain, pupils

only hear about its evils.

- Citizenship classes: teachers present activism as the only moral path, sidelining critical discussion.
- Ofsted: inspections reward schools promoting specific ideologies, not genuine learning.

In 1986, the UK made it illegal for schools to push political views. But if replacements happen slowly – a textbook here, a teacher training seminar there – then the system looks intact while its purpose changes.

Why we miss the warning signs

Our brains are wired to overlook slow changes. Behavioural expert Rory Sutherland calls this 'psychological substitution' – like a chocolate bar shrinking gram by gram. Many only notice when it's too late.

Here are just a few examples

- Organic food, prior to one hundred years ago, we referred to as just food. Now spraying crops with chemicals is referred to as 'conventional'.
- Money used to be backed by solid objects. Now banks can literally print money out of thin air.
- Healing wasn't just pumping a person

full of drugs.

- Media used to serve the public (the degree is always debatable) rather than purely serving corporate interests with news articles resembling product placements rather than actual news.

How to fight back

- Question updates: if a new school policy claims to promote equity, ask: Does this encourage debate or silence it?
- Compare old vs new: keep old textbooks. Notice if health guidelines now shame certain lifestyles.
- Value friction: systems that never face criticism – like an NHS policy no one's allowed to question – are red flags.
- Open dialogue: we must be able to discuss these subjects without the emotional manipulation of the things we can and cannot ask or talk about.

One of most problematic planks being replaced

The term 'semantic drift' refers to a word's meaning altering. This is one of the most problematic issues, as dialogue and thinking are affected in more subtle

and stealthy ways.

We only have to refer to 'pandemic', 'vaccine' and even the term 'woman' to know something is afoot. I invite readers to think about how many other words have lost or changed their meanings.

The bottom line

The Ship of Theseus teaches that what matters isn't how something looks, but what it does. A society's true ship isn't its institutions' facades, but whether they still serve people – not power. The most effective manipulation feels invisible. Vigilance isn't paranoia – it's the price of keeping as much of society as honest as we can.

We have to look deeper and ask the questions to see how things function and if they fulfil what they intended to fulfil. If not, change must occur before the ship hits a large iceberg.

We are entering an age where more and more people are becoming aware that something is not quite right with our societies, and we are long overdue a genuine change of power from centralised institutions and power brokers, back to the people.

How the covid scamdemic worked

Deep dive into the deep state

UK Column conference exposes hidden control network

A JOYOUS gathering of conscious souls flocked to Cheltenham on Saturday 5 April to be part of UK Column's 'On Location' tour de force.

Over a sun-drenched weekend that defied even the chemtrails, many checked into the hotel venue in the Golden Valley on the lazy, hazy Friday afternoon before the conference, and as people drifted in and out of the garden carrying cups of tea and drinks, the atmosphere was already electric.

Total strangers walked up to one another with broad smiles and offers of joining them at their table. 'Are you here for UK Column?' they would ask. One probably radiated an inner glow of expectation and sheer contentment at the prospect of being surrounded by so many kinsmen in spirit. Plus, wandering around with a copy of *The Light* under one's arm was a bit of a give-away!

The theme of the event was to examine the machinations of the deep state in its various guises, how it has assumed the power it has, and how we can build our lives to put ourselves, as far as possible, beyond its reach. With the government surveillance centre, GCHQ, just minutes down the road, it could not have felt more

appropriate. And while the high-octane presentations of the speakers were 'for our eyes only', we may assume they were not necessarily for our ears only.

Indeed, Charles Malet who, as master of ceremonies, opened the day's proceedings to a packed audience of 350, also extended a warm welcome "to those in the security services who have given up their weekend to tune in by other means."

An invitation to attend in person had been issued to Anne Keast-Butler, director of GCHQ, but unsurprisingly, had been declined.

The day's line-up of speakers began with Raja Miah MBE, who gave a rousing account of the state-facilitated, industrial-scale grooming and gang-rape of children in Oldham, and his personal six-year long campaign to expose it, while enduring relentless police hounding.

UKC co-founder and editor Brian Gerrish gave a graphic presentation of the invisible deep state, unpacking its spider's web of multiple layers and networks, starting with the state takeover of the British press and media.

Not one phone went off during the conference, nor did they appear to be much in use during the breaks, as people were busy talking to one another. New acquaintances felt like long-established friendships, contact details were exchanged, stories were traded and laughter rang out.

There was a couple from Melbourne, Australia, who had suffered under the extreme tyranny that prevailed there from early 2020. Another couple had come from Switzerland. Such was the appetite to be present at an event like this.

Drinks merged seamlessly into the evening dinner as I asked people for their impressions.

One lady said: "I'm going to have to process this over weeks, because it's not just the content delivered by the speakers, but what I've learnt from the various conversations I've had."

Another said the experience was extraordinary, and his only regret was that there was not another day in which to talk to more people.

If I had to sum up the atmosphere in one word I would say it was intimate. Despite the weighty and sinister nature of the information we were hearing, it was such a relief to witness sanity alive and kicking!

The real purpose of *Adolescence*

TV show priming public for military conscription

EVERYONE was talking about the Netflix drama *Adolescence* in April, including an impressive collection of experts and the Prime Minister – and that was the intent.

My daughter's high school has been sending emails to parents about the importance of this show, and how teachers and parents should take the warnings very seriously.

Such sudden institutional reaction to a slice of televised fiction should leave you in no doubt: *Adolescence* is a government psy-op.

But what is the real purpose of terrifying teenagers, parents and the general public about adolescent volatility? An obvious theme is demonising and demoralising males.

The notion of toxic masculinity is pushed in schools and universities, with the controversial figure of Andrew Tate as pantomime villain. This is how the establishment controls the masses – any resistance to unpopular policies is smeared by associating critics with extreme views and a vilified character.

Thus, *Adolescence* reinforces the idea that men and boys need discipline, as they are prone to aggressive and abusive behaviour. This links to a second and more serious implication of *Adolescence*: censorship.

Arguably, the show is a scripted facilitator of the Online Safety Act. The official reason for heightened concern about young males is the influence of social media, allegedly luring impressionable youth to dangerous disinformation and 'hate'. Actually, I suspect that the powers-that-be are threatened by too much truth getting out, and too much bonding and networking of truth-tellers.

Sir Keir Starmer invited the creators of *Adolescence* to 10 Downing Street to discuss the impact of 'toxic material online' and the 'serious change' needed by government. After the meeting, Starmer's office deemed the film

required viewing for high school pupils, as it would 'help students better understand the impact of misogyny, dangers of online radicalisation and the importance of healthy relationships'.

Then Netflix helpfully made it free to British schools. Starmer found time to write an article on *Adolescence* in *Metro* newspaper (free propaganda rag for commuters) on the problems of boys and men, concluding: 'There isn't a simple solution, or a single policy lever to pull that will tackle this complicated problem. We'll need everyone to get involved across society.'

This is not an over-reaction or opportunism by Starmer. As Kit Knightly of *Off-Guardian* suggested: 'We're not getting laws passed because of TV shows, we're getting TV shows made so they can pass laws.'

He added: 'The studio behind *Adolescence* gets government funding, as does Tender, the charity that was also invited to that absurd meeting. Netflix's finances have been a source of speculation for years, but its political associations, alongside a track record of producing content that perfectly fits the mainstream agenda, really speaks for itself. Government, charities, corporate media. It's all one organism.'

Readers will remember the Nudge Unit launched by the Cameron-Clegg administration in 2010. It sounded benign – rather than beating people with a stick, making desirable choices more attractive by nudging through marketing and education (as well as taxes).

Adolescence is the culmination of fifteen years of such behavioural psychology. Apart from emphasising that

boys are bad and restricting their social media use, I believe that the nudging objective of the show is more sinister.

Note that Starmer said that there is no 'easy answer' to this manipulated moral panic. That's because he cannot tell you the real purpose of *Adolescence* – not yet. The major policy development for which the show is priming society is military conscription.

Germany is now pushing to enlist younger people to the armed services. Some sceptics say that conscription wouldn't work, because most people would refuse. But this is naive: by definition, conscripts are not given a choice.

Adolescence is sufficiently real-world to get its audience thinking what to do with all that testosterone-fuelled energy – can't it be channelled into something useful? Well, there isn't the manual labour nowadays, and rather than playing sport, most of the younger generations are glued to their mobile devices.

In a column in the *Independent*, defence expert Francis Tusa explained how the government could build the armed forces by nudging younger people into national service. But this will not be the three years of parade ground and overseas posting experienced in the 1950s, because the goal today is not peace. Just as Germany is projecting an armed manpower of millions, Whitehall is planning for action.

War is coming, and the pampered young of Britain and Europe are about to be harnessed. The calling will not be 'for King and country' as in the First World War, but defence of modern, progressive values, for democracy, for freedom and for equality.

Brave fighters will emerge, but most conscripts will be cannon fodder. The outcome of war with Russia is already visible in Ukraine, whose male population has been decimated.

For all the scaremongering of *Adolescence*, the solution is much worse than the problem. I fear another doomed youth.

Academics for academic freedom

Professor Dennis Hayes interviewed by *The Light*

RICHARD HOUSE [RH]: I got out of academia ten years ago – perhaps just in time! Can you briefly describe your academic career, and when you first realised that academic freedom was in jeopardy?

Dennis Hayes [DH]: When I taught in further education, and later at Canterbury Christ Church University, I was involved in two studies of the social and political ideas of skilled workers, of ‘Basildon Man’. An influential account of the research was published by Demos as *Basildon: The Mood of the Nation* (2001). This work involved interviews with hundreds of skilled workers and their families.

Talking to ordinary working people for hours, it became obvious that what they thought was not reflected in academic literature about them. That literature was ideologically biased and often contemptuous of the views of the aspirational workers we met in their homes and on the streets of Basildon.

There were things it was just unacceptable to say. Basildonians loved their cars and their families, and had little time for local and national politicians who told them what they should think, like and do. (No surprise, then, that Basildon and Essex became a Brexit stronghold in 2016).

This independent aspirational spirit should be reflected in universities, but it was being suppressed by groupthink and bureaucratic management. The title of one of the first pieces I wrote for *The Times* Higher magazine reflected this – ‘Happy to let someone tell you what to think?’.

The unspoken answer from academics was, ‘yes’. The importance of getting academics to publicly defend the freedom that should define their role motivated Roy Harris (Emeritus Professor of General Linguistics at the University of Oxford) and me to write the Academics For Academic Freedom (AFAF) statement of academic freedom, which we launched in December 2006.

RH: What hopes did you have for AFAF, and to what extent have they been realised? And what has been its reception within mainstream academia?

DH: Since the launch of that statement, alongside research and writing, AFAF has undertaken almost two decades of case work – unique among academic free-speech groups.

We work closely with the Free Speech Union

on this. We have defended, and continue to defend, many academics and students whose free speech – and their employment – have been threatened. We do not take sides, and we defend the free speech of all, even those we profoundly disagree with.

Throughout AFAF’s existence, we have maintained a banned list of speakers who have been cancelled or threatened with cancellation. This list has had huge impact, and is a source of reference for journalists and others. It shows that there is a free speech crisis in universities, and what defenders of free speech are up against.

A major development came in 2022 when the first AFAF branches arose spontaneously from informal discussions at the University of Edinburgh due to various issues, not least of which the silencing of gender-critical academics and students.

The University of Derby branch came next, and we now have branches covering more than 35 universities in the UK and Ireland, and one in the USA – and more are in the process of being formed. This is an exciting grass-roots development that could transform the university sector into a beacon of freedom.

Another unplanned development was the formation of Student Academics For

Academic Freedom (SAFAF) formed in 2024 and convened by Glasgow student Heather McKee, who has been described as a ‘flame-haired force of nature’.

SAFAF has dozens of active student members, and aims to have a representative in every university in the UK and Ireland. The uniqueness of AFAF and SAFAF is that academics and students are working together to defend free speech and academic freedom.

AFAF is now established in academia. There has been little hostility, except from some University and College Union (UCU) branches and censorious activists. Many of our branches are recognised but are independent from their universities. They have often been consulted about issues such as whether a university’s policies meet the requirements of the Higher Education (Freedom of Speech) Act 2023.

RH: This is a tremendous achievement, Dennis – retired academics like me are cheering from the sidelines! Are there ways in which sympathetic readers can support and enhance the work and development of AFAF and SAFAF?

DH: Being unafraid to make a public statement of your commitment to free

speech and academic freedom is the best way to support and enhance the work of AFAF and SAFAF. Just sign, and ask others to sign, the AFAF Statement of Academic Freedom and join our membership network.

If academics or students have a few friends who are happy to sign, then that is the basis of another AFAF or SAFAF branch – the more the merrier. We hope to have several thousand more signatures by the end of 2025.

We are also organising many events, not least a major debate in London to mark International Academic Freedom Day (IAFD) on May 20, 2025.

We launched IAFD at our annual conference in November 2023, and we chose May 20 as it is the birthdate of John Stuart Mill, the author of *On Liberty*, the classic work in defence of free speech.

Do put the date in your diaries and come along to one of the events being organised nationally and internationally on that day in celebration of free speech and academic freedom.

The four friends have all lived colourful lives, have been involved in several social justice movements and have dabbled in a wide range of different faiths. Between them, they have experienced their share of heartache, addiction and rejection in this crazy fallen world and their former passions, coping mechanisms and spiritual outlooks ultimately didn't satisfy them.

Caz said: "God made us all individuals with different talents, gifts and abilities – you don't have to lose your identity when you become a follower of Jesus. There's so much brokenness in the world and people mask their problems with everything from alcohol and drugs to gambling and sex addictions. He can heal all of that and take it from you."

"It's our prayer that people will find our music and testimonies of overcoming adversity accessible and relatable – that we can plant some seeds to bring people to faith. A faith that strengthens you, empowers you, and offers you both hope and purpose in these wicked, rapidly shifting times."

Simon adds: "It delights us to see such a reaction and we pray that the Holy Spirit is penetrating their hearts. We also seem to be annoying the enemy which is an added bonus: we were banned from a pub on our first gig; we have had drum kits collapse mid-performance and during a festival – as soon as Caz started to talk about Jesus – a nearby car alarm suddenly went off!"

"We're so passionate about this project. It really feels like God has brought us together and directed our path so far."

Deuteranarchy have already enjoyed performing at several truther festivals including Jam for Freedom and Hope Sussex, as well as many local venues. Currently recording an album, they are lined up for more gigs and festivals later this year, including Stand in the Light this May 23-26.

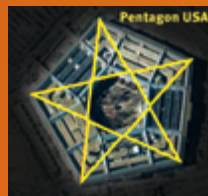

Your digital identity wallet

Personal data in hands of government and corporations

THE rulers are already running large-scale pilot schemes for the future they want and we don't. They are not being subtle about this. They are not hiding it.

The plan is a single government-issued app that holds your medical records, employment records, travel records, education records, vaccination records, tax records, financial records, as well as (potentially) copies of your signature, fingerprints, facial scans, voice samples and DNA.

All stored handily on your phone and shared with the governments of nineteen countries (plus Ukraine) and over 140 other public and private partners. Everyone from Deutsche Bank to the Ukrainian Ministry of Digital Progress to Samsung Europe.

You will use this app to make payments, apply for loans, pay your taxes, pick up your prescriptions, cross international borders, start businesses, book doctor's appointments, apply for jobs and even sign digital contracts online.

Businesses and government agencies

would access this data from the back-end to conduct 'automated background checks'.

The German Federation of Consumer Organisations (Verbraucherzentrale Bundesverband, VZBZ) has raised concerns that such an app would 'pose privacy and data risks', to which the only response is 'duh, that's what it's for!'.

None of this is hypothetical, by the way. It's potential.

There isn't just one of these pilot schemes 'building prototypes' for the digital ID, there are three others at least.

This is the latest development in a roll-out dating back to the birth of covid and beyond, with the EUID wallet being touted since 2021.

It was freshly brought to my attention when I stumbled on the article – *Why Would You Need An 'EU Wallet'?* – by Anton Chashchin.

Chashchin is apparently chair of the Fintech (financial technology) Investment Group N7, and his article is a fairly good example of the kind of thing you can expect to see more widely in bigger mainstream outlets as we get closer to EUID's full-scale implementation.

It talks up the costs of fraud and how digital

ID schemes will make everything so much safer and more efficient, but bemoans the 'lack of harmonisation' across borders and systems. It's standard stuff.

Interestingly, he also flags up that national-level digital ID schemes received a massive boost from the covid 'pandemic': 'In Belgium, the rapid adoption of *itsme*, the online identification system in 2021–2022, was fuelled by a government mandate requiring a covid-19 pass for restaurant visits. *Itsme*'s digital identity offered the most convenient way for consumers to obtain the pass, doubling the user base from three million to six million within a year. This demonstrates that consumer adoption follows when a service is needed and backed by government trust.'

He's right. Covid started the digital ID/vaccine pass ball rolling, and it has lost momentum since then. So maybe what we really need to be on the lookout for is the next big reason: a 'catastrophic catalysing event' – to borrow a phrase.

What do you think they have planned to make people suddenly need a digital ID wallet?

I guess we'll find out soon enough.

In other digital ID-related news, Jordan

has announced that digital ID will be implemented and will be required for voting in their next election.

Cameroon launched their new national ID system just recently, which could potentially go fully digital in the near future.

And Tony Blair has been back on his favourite hobby horse, claiming British people will gladly exchange privacy for efficiency.

It goes on and on and on.

I really hope no U.S. readers are thinking Donald and Elon are going to spare you this mess. The Department of Government Efficiency is going to be all over digital identity.

After all, what could be more 'efficient' than a single app used for everything? Hasn't Elon already said he wants X to be the 'everything app'?

The only difference is that the U.S. version might be rather more private than public, but is there any real difference any more?

Standing up to warmongers

Ex-GCHQ worker recalls her bid to prevent Iraq war

WHISTLEBLOWERS don't wake up one morning and decide to cause a furore. In the main, they are ordinary people going about their lives and business, when suddenly something lands square in their lap that they know they have to act upon.

The decision catapults them into a frightening world of unknowns and imponderables. Their lives are forever changed, but they rarely regret their decision.

Katharine Gun was a Mandarin Chinese translator employed by the Government Communications Headquarters (GCHQ), the surveillance centre of UK intelligence, based in Cheltenham.

In January 2003, in the lead-up to the invasion of Iraq, she and another 100 employees were sent a top secret memorandum by U.S. National Security Agency (NSA) requesting British assistance to spy on the office and private communications of the delegates of six non-permanent members of the United Nations Security Council (UNSC).

America and Britain were trying to force through a UNSC resolution to justify their invasion, essential to its legality under international law, as the weapons of mass destruction narrative had been known by investigative journalists since October 2002 to be a fabrication by a faction within the CIA. The votes of the six non-permanent UNSC member countries were crucial to securing the resolution. Therefore, the spying operation was intended to gather leverage with which to bribe, threaten or blackmail them into voting accordingly.

At the tender age of 28, Katharine made the decision to take a copy of the memo out of GCHQ and, through intermediary contacts, leaked it to *Observer* journalist, Martin Bright.

Bright, who had no idea who the original source of the leak was, set about attempting to verify its authenticity, and enlisted the help of the *Observer's* U.S. correspondent Ed Vulliamy. The memo had allegedly been sent from NSA by a man called Frank Koza, head of 'regional targets'. So the first task was to establish the existence of Frank Koza at NSA.

The *Observer* was editorially pro-war, what Ed Vulliamy described as 'accountable to the Tony Blair enforcement machine'. So tensions were high within a divided newsroom. But the paper eventually broke the story on March 2, 2003 on its front page with the memo. Whereupon the

countries, whose UN ambassadors had been spied on, were so incensed, that they refused even to participate in the process of voting for a resolution to give 'legal cover' to an illegal war, and the resolution was withdrawn.

On March 17, former Foreign Secretary, Robin Cook, at that time leader of the House of Commons, resigned in protest. Tony Blair remained undeterred, and on March 20, a US/UK coalition invaded Iraq.

Following publication by the *Observer* of the incriminating memo, Katharine's department at GCHQ was immediately investigated to identify the source of the leak, which she confessed to, and she was arrested on suspicion of breaching the Official Secrets Act. She was bailed for eight months, then charged, and the case came to court in 2004.

She was urged to plead guilty, and rely on her untarnished record as a conscientious employee to be given a reduced sentence. But she refused to plead guilty when, in her own words, she did not feel guilty, although she had 'broken the law'. As the defence of 'public interest' in cases of breaches of the Official Secrets Act was removed in 1989, her legal team came up with a novel defence of 'necessity to prevent a war'.

The Crown Prosecution Service has a degree of discretion as to whether to prosecute cases, but in the case of a breach of the Official Secrets Act,

permission is required from the Attorney General, Lord Peter Goldsmith at the time. The moral courage Katharine exhibited by risking a full trial – to 'put the invasion itself on trial' – was sadly not matched by Lord Goldsmith himself. It later emerged he had consistently advised the government that, without a UN resolution, invading Iraq would be illegal, but at the very last minute, despite the absence of a resolution, he suddenly decided the invasion was legal after all.

Katharine's resolve was pushed to the limits on the first day in court before the charges were dropped just half an hour in, when the prosecution declined to give evidence. Arguably, this was to prevent embarrassment to the government and its Attorney-General, as the defence had demanded disclosure of his legal advice to the government – that they suspected was compromising – to establish the legality, or otherwise, of the invasion. Plus, the prosecution knew it was highly unlikely a jury would convict Katharine.

It was not until 2010 that Lord Goldsmith's legal advice to Tony Blair was made public. When I sat down with Katharine, I asked her where her sense of values came from, and she said she thought it was innate; she had always had a keen sense of justice.

I also asked her if she felt relief when the charges were dropped at the beginning of the trial. She said she had mixed feelings,

because a trial would have released much more into the public domain. She had been aware of a cosy meeting between Bush and Blair in April 2002 in which they discussed how they were going to take over Iraqi oil.

I asked her if she felt she had achieved anything for all she went through. She said it angered her that MPs, who had clearly all read the *Observer* exposé on Sunday, March 2, didn't storm up to Tony Blair and demand that he explain himself to parliament. She also thought that if other press and media had picked up the story, the invasion might never have happened. And Tony Blair would not have been re-elected in 2005.

Ultimately, however, Katharine said the one thing she succeeded in doing was to prevent UNSC endorsement of the invasion, which means it remains a matter of public record that the war was illegal under international law.

Following her formal dismissal from GCHQ, Katharine found it difficult to get work in the UK and now lives in Turkey with her husband and daughter.

In 2019, a film was released of her story made by Gavin Hood and entitled *Official Secrets*. Keira Knightley played Katharine and Ralph Fiennes her barrister, Ben Emmerson.

The bloody carnage and destruction of Iraq caused an estimated 600,000 Iraqi deaths, with hundreds of thousands more injured.

Manipulation won't cost a snip

Training up hairdressers to influence customers about climate change

AN Irish university is planning to train hairdressers and barbers how to converse with customers about the climate change agenda.

It appears that one of the purposes of the course at University College Cork (UCC) is for hairdressers and barbers to lecture and indoctrinate customers with climate propaganda while chatting casually, and to create more gullible climate activists and climate alarmism in the community.

The project has received government funds of 63,000 Euros to 'empower the public' about climate. The plan is for four Irish towns to be chosen in a pilot scheme with training materials given to participating hairdressers and barbers about the 'pervasive and complex ways in which the need for climate action is downplayed'.

Dr. Maria Kirrane, from the Office of Suitability and Climate Action at UCC, said the purpose of the scheme is to "tap into places where chat flowed naturally."

Kirrane said: "Hairdressers and barbers not only provide a service for people; they are a real hub for conversation and social spaces within a community. Their reach is broad and gives the possibility of reaching a cohort of people that may not be involved in local environmental groups and the usual pathways of climate conversation and action. The relationship between client and hairdresser is a deeply personal and trusting one."

John McGuirk, editor for the online news site, Gript, commented on the hidden intentions of the bizarre government-funded initiative.

He said: "There's something very insidious about this. It is, after all, government deliberately trying to recruit hairdressers as ideological agents of the state. One wonders, for example, if it will not be the duty of hairdressers to 'report back' to their handlers about what the general sentiment of the public is, when asked about their views on agricultural methane emissions."

It comes as no surprise that the idea took inspiration from another woke country seeking to destroy their valuable agricultural sector under the guise of

reducing nitrogen emissions for the 'greater good': in 2023, an initiative in Sydney, Australia, called 'A Brush with Climate' was established to teach hair stylists how to talk to customers about climate change. Over 400 hair stylists attended workshops led by social and climate scientists.

The Irish government, in collusion with influential NGOs, is hellbent on destroying the farming sector. This year, the Environmental Protection Agency announced funding of €14.5 million for new research projects to address climate and environmental challenges. Funded as always by the taxpayer, the projects aim to raise awareness in Irish communities by spreading 'the message of community-led climate action'.

It is not the first time in Ireland that climate activists and woke government state agencies have tried to brainwash the public

about climate.

In 2024, the National Council for Curriculum and Assessment (NCCA) released a draft document called 'Climate Action and Sustainable Development' for secondary school students. The proposed document aimed to help 'students become effective organisers of collective change' and to teach the students 'how to effectively organise themselves to take action'.

Michael Fitzmaurice, an Irish politician with the newly formed Independent Ireland Party, responded to the draft document by saying: "Reading the document, the intention is not to teach young people to look at the world analytically and think critically, as is claimed throughout the draft specification. No – it is a very carefully constructed tool which is designed to indoctrinate young people with radical and unhelpful ideas about climate change."

He added that the radicalisation of young people is to "set up the demonisation, and destruction, of Irish farming in a very cynical way."

Irish farmers continue to be gaslit by state agencies about their role in 'fighting climate change'. A report carried out by a climate nudge unit at the Economic and Social Research Institute (ESRI) noted that two-thirds of farmers they interviewed said they would change their farming behaviours to tackle climate change.

Farmers across Europe are constantly being used as scapegoats and are unjustly accused as polluters by the radical 'green agenda' brigade.

The sinister pilot scheme at UCC is a slap in the face to hardworking, struggling farmers in Ireland who are being penalised daily. It is understood that many farmers are horrified by the green agenda and feel that unscientific regulations imposed on them are so extreme that they will be forced out of farming.

The Irish Nunti, an online news site, spoke to farmers in the Irish Midlands about the situation they are currently facing. They reported: 'Such a decline in the indigenous beef industry would suit the climate alarmism cult perfectly and the powers that be would probably celebrate this shift away from livestock beef farming.'

'The rural depopulation and the further erosion of rural communities that would undoubtedly occur, if this were to happen, would also suit their agenda ideally. While a complete collapse of the beef industry is unlikely, the long-term impacts of any sort of a major blow could decimate a significant part of local economies in Ireland and completely reshape the Irish agricultural and rural landscape, potentially making way for other markets to become established such as lab-grown meats and artificial foods.'

Thousands of farmers across Europe have revolted against emissions targets aligned with the UN Agenda 2030 Sustainable Development Goals as part of the 'Great Reset' plans. Farmers rightfully feel threatened that their agricultural way of life has been slowly eroded. Farmers continue to have a very clear message: 'No farmers, no food'.

What next for customers just wanting a quiet life when getting their haircut? Will they be lectured about the benefits of mass immigration, and that a man can actually be a woman? Or will they be encouraged to take the covid experimental jabs? The mind boggles at what the zealots will do to push their insidious agendas.

BBC bows to pro-Israeli lobbyists

Gaza documentary withdrawn amid slurs over Hamas

THE BBC, an organisation funded by the public yet controlled by the government and influential lobby groups, finds itself at the centre of yet another storm.

This time though, it is not about presenting biased news, or half-lies that feed the narrative of their most favoured influential lobby groups, but is about airing a documentary that simply presents a view of life through the eyes of children in Gaza.

The documentary, at the centre of the storm, is *Warzone*. The Campaign Against Antisemitism (CAA) took out full-page advertisements in The Sunday Times, Sunday Telegraph and the Mail on Sunday, calling for the suspension of licence fees for the BBC.

The claims made against BBC centre around Abdullah, a thirteen-year-old Gazan boy, fluent in English, who was hired by the BBC as a narrator to introduce children who were finding ways to survive the Israeli war in Gaza.

Abdullah, who worked for nine months during the making of the documentary, was allocated \$1,000 for personal expenses. The money was paid into his sister's account. The claim made is that in paying out these expenses, the BBC

were funding Hamas.

Like most of these claims, there is no evidence to suggest that any of the money paid out in expenses was used in an actual war crime against any Israelis. For a British group that has been set up to challenge incidents of antisemitism, their disregard for the life-threatening danger they have placed this child in is alarming to say the least.

CAA may just as well have painted a huge red target sign on Abdullah's back.

Courageous and industrious as these Palestinian children are, Israel does not regard their lives as worthy of concern. This has been well documented by evidence presented to the International Court of Justice.

Foreign doctors working in Gaza have spoken out about children being targeted by Israeli snipers, as they struggle to flee the aftermath of a bombing raid.

Israel has accused Palestinian staff at UNWRA (United Nations Relief and Works Agency for Palestine Refugees in the Near East) of working for Hamas. As a consequence, several of Israel's close allies instantly withheld funding to UNWRA, exacerbating the existing crisis and leaving many Gazans to starve, with babies and children being the most vulnerable.

Doctors, journalists and aid workers

have all been targeted along with deadly attacks on Gaza's hospitals, schools and residential buildings. These attacks are all based on the claim that they were legitimate military targets because they harboured Hamas fighters or were in some way connected with them.

Hamas is the elected government in Gaza. It won the Palestinian legislative elections overwhelmingly in 2006, hence anyone working for it in a civil capacity, works for Hamas. However, Israel makes no distinction between someone working for Hamas in a civil capacity and someone who is actively engaged in armed resistance against them.

In the UK, British journalists have been arrested under terrorism legislation for presenting factual evidence of Israel's war crimes.

British activists have likewise been arrested for trying to prevent Israeli companies based in the UK from shipping parts for arms to Israel during Israel's genocide of the Gazan people.

Under international law, any kind of resistance is considered not only legitimate, but obligatory for those who are aware and who are in a position to prevent further genocide.

For Israel, labelling those who oppose their occupation and military objectives as 'terrorist', is strategically

advantageous. Getting your closest allies to do the same to objectors is doubly advantageous.

The BBC is trapped. When serious journalists working within the BBC attempt to present facts favourable to the Palestinian cause, they are likely to have their work banned or severely edited to conform with government-set editorial policy and to appease powerful lobbyists. Nine years ago, the BBC presented a documentary which explored Israel's attack on the USS Liberty called *Dead in the Water*.

Until the current documentary, *Warzone* (now withdrawn from viewership on the BBC's website), I had not been aware that the BBC had attempted to present anything that close to documenting Israel's many war crimes.

The BBC has long been criticised for its bias towards Israel. But the very people who rely on the BBC to push the Israeli narrative could end up being the ones responsible for bringing it down.

Rulers' spiritual lockdown bid

SHANE FUDGE [SF]: Perhaps you'd like to tell the readers a bit about yourself, Elana.

Elana Freeland [EF]: I am a 60s holdover from a time when we were all suspicious of the establishment – of the Vietnam war, the Kennedy and King assassinations.

In summer 1963, I had tea with President Kennedy in the Rose Garden, and he had a huge impact on me. When he was killed three months later, I really began to come of age in a political sense. Later, I would write *Sub Rosa America: A Deep State History* – a 1,300-page fictional history format in four books of what America had become since John F. Kennedy's assassination.

Among my research files, I had one on chemtrails and one on HAARP, the High-frequency Active Auroral Research Project. I met independent scientist, Clifford Carnicom around this time. We began to talk about what had been dropped by jets flying over Northern New Mexico. We looked at the saliva and blood from a couple of dozen people through a 300X microscope and realised that not only was the atmosphere under assault, but our blood was too.

A couple of decades later, Clifford and I came across the work of Dr Ana Mihalcea, MD, PhD, and Dr David Nixon, MD, in Australia, both of whom were doing live blood analysis from vaxxed and unvaxxed people.

Ana has worked extensively with Clifford ever since to understand the self-assembling synthetic biological nanotech entities in our blood which began with the covid-19 injections but increasingly has 'shed' into the unvaxxed, not to mention the nanotechnology that drops daily from the upper atmosphere from the chemtrails.

SF: Your books from 2014 right up to the recent *The Geoeingineered Transhuman* talk about 'the Space Fence lockdown'. Can you explain what this is?

EF: The Space Fence lockdown has several different components to it. It's run by the world's No.1 defence contractor Lockheed Martin that owns all the patents. The end agenda of what's known as the secret space programme (SSP) is to conquer space, including full-spectrum dominance over the Earth. This spectrum is basically the electromagnetic spectrum: full spectrum dominance over all of it, from gamma waves to radio waves and microwaves.

Given that wireless radiation is now everywhere, we are all plugged into this Space Fence lockdown in one way or another—through our behaviour, our thinking, and our feeling. If, however, we have access to our inner life and our own divinity as homo sapiens, then the Space Fence can't work as deeply into our bodies and souls as it otherwise would. But for people who don't have an inner life, their humanity is up for grabs.

Stargate AI is the name of the programme that President Trump is putting forward to the public. In a real sense, this is the Space Fence lockdown of the secret space programme. Investment analyst Catherine Austin Fitts and economist David Skidmore discovered in 2017 that at least US\$21 trillion of the U.S. budget is all unknown to the public. Did it go into the SSP?

SF: Why the jab rollout in 2020? Why did

it have to be injected?

EF: I think an aerosol delivery would have been too unreliable to depend upon for this aspect of the planned transhuman takeover of homo sapiens. By creating a so-called pandemic, the World Economic Forum, World Health Organisation, United Nations and other players were able to get the 'operating system' (nano hardware and software) directly into billions of people. (One nano measures one billionth of a meter.) Nanotechnology and synthetic biology work well together, all the way past the blood-brain barrier.

Our natural biology is gradually being replaced with self-assembling synthetic bioengineered nanotechnology.

In 2020, the year of the jab, we all noticed the big push to get 5G up and running everywhere, along with Elon Musk's Q SATs (small satellites). The 60-gigahertz oxygen-intake frequency of 5G is what we initially saw in the Wuhan footage of people dropping over in the street – their oxygen intake was lethally compromised. Wuhan was, of course, one of the first places to have premium 5G activation.

SF: How have elites been able to understand human consciousness to implement all of this?

EF: Unfortunately, because Americans have been programmed to be so

materialistic in their perception of life, people don't understand the power wielded in this nation and in western Europe by secret societies – yes, even in Big Pharma and Big Medicine. Once the jabs began, you started to hear how relatives and friends talked about how their loved ones changed after the inoculations. The soul or psyche was being impacted by what was in the serum.

The inoculated then became transmitters of frequencies that belonged to the serums so that the unvaccinated fell under their influence with symptoms of headache, nausea, long covid, etc.

The one thing the controlled media do not want is for people to pay attention to the role of electromagnetics and the Bluetooth 'satellite leash' that the vaxxed are on, as their biometrics are continuously transmitted. Activating this electromagnetic field anywhere can be done by satellite or by triangulating with microwave towers or masts.

EF: You must use your intellect to understand that our environment has been weaponised. Scientia est potentia: knowledge is power. We need to understand at least the rudiments of how this full-spectrum dominance technology works so we can make decisions.

Rudolf Steiner warned us 100 years ago that Western doctors would come up with a vaccination that would separate us from our divinity. And now we are there. We must minimise our electromagnetic footprint. Secondly, what about our inner life? When you own your will, you can evolve your consciousness in a way that serves the divine evolution of humankind. When you look at others and you are filled with empathy and love, your drop in the ocean of consciousness carries all of humanity forward.

TO find oneself in a make-believe world of altered reality and severe, draining, emotional intensity must have been exceedingly uncommon in the era before the internet.

But now, it is the order of our day and I fear that unless the human race finds a way of stopping the reflex scrolling that has become our lodestar of reality, we will meet a savage end when the actual world collides with the artificial one we have constructed around ourselves.

The modern phrase for this special ability of modern man to live in his own, manufactured environment, which can alter from day to day and even hour to hour, appears to be to ‘live in a bubble’. It is an inadequate term for two reasons. A bubble, by definition, is invested with the imminent possibility of bursting and terminating its existence - and we all know that the particular bubble/s the internet is capable of constructing around us can last for days, even years!

The other problem with the living in a bubble idea is the implication of there being just one bubble – not a mass of coalescing, squishy bubbles, amalgamated together, enabling us to skip (or leap) into another related bubble and back again to our original bubble, or to a closely related one!

Actually, the poison of this phenomenon was present in very much smaller doses in the era dominated by the idiot box (otherwise known as the TV), when the internet played a relatively minor role in our lives. I remember the era well, and in the context of the emotional intensity that would often envelop the watching of NHL hockey games, together with a newly married friend and his wife. My friends would erupt in cheers, leaping from their chairs and punching the air with their fists – and this was all very well and a lot of fun, although I did not really support their team.

On the whole, such indulgences were quite harmless, and the imaginary world we inhabited would end with the conclusion of the game (or movie, or cookery class). But with the internet, there is no reprieve and no respite. Anybody may, with a few clicks and scrolls, transport themselves to another world, inhabit the world and continue to inhabit it for weeks, before jumping to a related world with several more available podcasts, videos, X-feeds, Facebook posts and Instagram messages.

The actual, cold reality of all this expended energy is that there is absolutely nothing we can do that will affect the outcome or in any way influence the artificial world we have constructed around ourselves. Just as the moving and rearranging of chairs that my friend demanded had absolutely no impact upon the outcome of the hockey game, our constant scrolling and constructing of several overlapping layers of make-believe reality on the internet does not and cannot influence this artificial world that holds us in its thrall.

It would not be a make-believe version of reality if we were actually able to influence or change the particular, constructed world we weave around ourselves. The events we partake in are themselves true to greater or lesser degree. But like the old Indian tale in which blind men believe an elephant to be like a rope when feeling its trunk; like a wall, when feeling its body; or like a pillar when feeling its legs, the world as the internet presents it to us is always a particular version of reality that it wants us to embrace.

When we embrace that particular version of reality and, by incessant scrolling and clicking, construct our own, individual versions of our own world, we become robotic automatons who are not in control of our own destinies. The terrifying thing in fact, is that rather than we embracing this so called bubble world, it embraces and overpowers us and renders us ineffective.

Even the best podcasts, feeds and posts on the internet share this ability to lure us away from the real world we live and move and breathe in – and into the virtual world we construct for ourselves. Endlessly following what the MAGA movement under Trump is doing; or how the Middle East is blowing up; or how Ukraine and Russia are near or far away from peace; or how exasperating Canadian politics is – all this does not make us able in any way to influence the course of events. But all this does make us utterly ineffective and emotionally and spiritually drained.

The printed page, whether it be a book, a magazine or a newspaper does not share this sinister and dastardly ability to take over our minds and bodies and souls. It beats in synchronicity with the pulse of the universe and does not race away erratically and dangerously like the internet. It is the stuff of crisp pages turning and lingering memories. And if we are to survive much longer as a race, it must reclaim its ancient place in our lives and homes.

The pen is indeed mightier than the sword, both being acknowledged as mighty in their own way.

But a digital, virtual, make-believe world is as far away from the mighty pen as a pondering podcast is far, far away from the flashing steel of a sword.

The attack on the USS Liberty

The Six-Day War cover-up

On Thursday June 8, 1967, Israeli air and naval forces promulgated a concentrated, unprovoked attack upon America's most advanced surveillance ship, the virtually undefended USS Liberty, killing 35 of its crew and wounding 171, many seriously.

Israel insisted that its attack on the Liberty was an unfortunate 'accident', and a case of 'mistaken identity'. This incident went unreported by the world's media. Had it been an Arab attack on an American vessel, there would have been saturation coverage with demands for retaliation and in fact, the Johnson administration's subsequent cover-up was led by the President himself.

The Liberty was a 'floating listening post'. It had a very sophisticated system of radio antennae including a sonar-radio listening device with a range of over 500 miles and, up to that distance, the Liberty could intercept virtually any form of wireless communication and could then decode and process the intercepted messages and relay them back to the U.S. The USS Liberty was in fact America's most advanced 'spy ship'.

The aim of U.S. counter-intelligence was to prevent Israel from attacking Syria and this was the Liberty's mission, and therefore as long as the Liberty was in place and still functioning, the U.S. would have control over Israel. But from Israel's perspective, before it could order its planned invasion of Syria, the

Liberty had to be silenced.

On June 8, without any warning, the Israeli Navy and Air Force attacked the ship with torpedoes, rockets, cannons, armour-piercing bullets and napalm, which turned the Liberty's deck into a 3,000° firestorm. 35 Americans were killed and 171 others were seriously wounded.

The first wave of attacks destroyed the transformers and this was a premeditated strategy to prevent the Liberty from alerting the world to the attack, but the main objective was to slaughter the crew and sink the ship. When the crew launched the lifeboats, Israeli torpedo boats even attacked those.

It was impossible that Israel had been unaware of the identity of their target. The Liberty was flying the standard American flag, the ship's U.S. Navy markings were displayed in letters ten feet high and the ship's name was clearly visible.

The U.S. Dept. of Defense had received information that the IDF was planning to attack the Liberty; it's unbelievable that this threat was not relayed immediately and that it was surely only a matter of minutes before everybody in Washington who needed to know, knew about it.

At 14.05 pm, three Israeli Mirages

made multiple attacks, hitting the Liberty hard and destroying the ship's antennae. Then, for about another 20 minutes, the attack was continued by several Mystere fighters which dropped canisters of napalm. The Israelis wanted no survivors.

The USS Saratoga received a message from the Liberty: "Liberty is under attack by unknown enemy air and surface units. Request assistance." Saratoga was only 20 minutes away but according to a leaked report, the White House deliberately prevented a rescue by recalling support while the ship was under attack.

According to Admiral Geis, President Johnson told him, "I want that goddamn ship going to the bottom. No help - recall the wings." If the Liberty had been sunk, Egypt would have been blamed, all of which clearly demonstrates the utter contempt for ordinary people shown by these ruthless, war-mongering, self-serving, mass-murderers.

And what happened next was yet more evidence that LBJ and Israel wanted no survivors. At 14.35 pm, torpedo boats launched five torpedoes at the Liberty. One torpedo struck the comms area, causing 25 deaths, and torpedo boats then machine-gunned the

ship with armour-piercing shells for another 40 minutes.

The order "Prepare to abandon ship!" was given, accompanied by the lowering of the first lifeboats, but as they touched the water the Israeli MTBs shot them to pieces.

The Liberty now had no rudder and no power and was taking on water when two Israeli helicopters arrived and circled the ship—but this was no rescue mission. The crewmen could see that both helicopters were filled with armed Israeli Special Forces troops and a machine gun was mounted in each of the cargo bays.

They intended to kill any survivors lying helpless in the water. There were meant to be no survivors to witness what really happened and, just as critically, no survivors to reveal any of the information that the Liberty had gathered about Israel's preparations for a Syrian invasion.

However Israel, realising that their intention to kill everyone had failed, began 'damage limitation' and transmitted an 'apology' that an 'unidentified ship had been erroneously attacked'.

Liberty then managed to slowly begin moving away from the area. There had been 851 rocket strikes and at least 15 planes had attacked it. One hit could be excused as an

accident, but not 851!

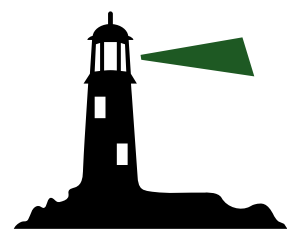
The plan was to sink the Liberty with no survivors, blame it on Egypt and provide the alibi for the U.S. to enter the war on Israel's side. America and Israel would then have seized control of all Middle-east oil production and Israel's borders would have expanded from the Nile to the Euphrates River.

Then, a Soviet guided-missile destroyer sent a message by Aldiss Lamp in English, "Do you need help?" and Liberty responded, "No thank you." The Soviets then replied, "I will stand by in case you need me." Few people are aware today of the crucial role played by the Soviet Navy. This ship guarded the Liberty after the attack and stayed around until U.S. forces approached several hours later. In fact, the American submarine, USS Amberjack, was tasked with sinking the Liberty and 'saving' the false flag operation, but ironically the presence of the Russians prevented this.

On June 14, Liberty arrived in Malta and Admiral Kidd warned the crew that: "You are never to discuss this with anyone, not even your wives. If you do, you will be court-martialled and will end your lives in prison or worse."

USS Liberty Survivor Phil Tourney said: "If the truth ever came out, it would change history and how people felt about the Israeli state. If the mainstream media devoted an entire week of stories to the Liberty and exactly what happened, the American people would be up in arms, begging for blood. Liberty crew members did not murder anyone, the State of Israel did. The truth will change history."


