1400 DEATHS, One million injured from covid injections

Injuries include blindness, blood clots, paralysis, MS, and stillbirths and they are being censored by media and big tech.

MORE than 1400 deaths have been reported following covid injections in the UK.

Official Government data also reveals one million serious adverse reactions to the experimental shots. These include blindness, blood clots, paralysis, MS and stillbirths. Yet it is generally accepted that reporting to the Government's Yellow Card scheme reflects less than 10% of actual incidences and could be as low as 1%.

into compliance, and the mortality figures plus every other piece of data show us there was no deadly disease called 'covid-19' that you can have without showing symptoms, and even pass on to someone else. Non pharmapayroll scientists such as ex-Pfizer VP Mike Yeadon, Prof Carl Heneghan and Prof Sunetra Gupta (both Oxford University) say it is Influenza A and B, and that the government and media have been manipulating the general public with shock, awe and deception again.



'Climate Emergency' driven by faulty models and fake news

SCIENCE and the scientific method is a wonderful way of objectively testing theories and discovering facts about the real world. I should know as I did my PhD in Physical Chemistry. Facts have emerged which dismiss the distant scary futures predicted by climate models. The scariest scenarios are based on RCP8.5 (representative concentration pathways) with the greenhouse gas theory built into the models. The RCP8.5 scenario would require the world to burn 5 times the amount of coal per annum than we currently burn. That scenario is not credible.

I have worked with many of the so called 'greenhouse gases' before they were called 'greenhouse gases' and many are in fact liquids at room temperature (e.g. chlorofluoro hydrocarbons) and they did not display any unusual physical or chemical properties. They certainly did not get warmer than the ambient temperature in the laboratory, so I always wondered where this greenhouse gas scare came from.

It turns out it comes from faulty climate models which have been heavily criticised for being unable to forecast our present climate conditions from a previous starting point (called 'hindcasting') and which use circular reasoning by assuming the (proven wrong) greenhouse gas theory is at work with carbon dioxide as the main culprit, assisted by the much stronger effect of water vapour. These climate models ignore over 200 years of physics looking at solar cycles of varying lengths, which are completely natural. The cyclic nature of climate was well known in ancient China circa 3200BC and these cycles affect weather conditions in a predictable way. Noting that climate is the average of weather conditions over a 30 year period, physicists have been unable to reproduce the greenhouse effect in laboratory experiments and they conclude that it is falsified and does not exist.

The IPCC stopped calling their forecasts a 'climate forecast' after criticism and they are now called 'projections' which perhaps has less veracity than a real forecast as it is simply a mathematical model run on a computer that has been allowed

to generate output with no physical meaning for any potential incarnation in the distant future. It is like running a cash flow forecast for a business over the next 80 or 100 years and setting your corporate strategy based on that. Many things can happen in 80 or 100 years and if there is no physical mechanism related to carbon dioxide and the climate then it simply won't happen. The models are wrong.

The so called 'Climate Emergency' and policies to tackle it are all based on these faulty mathematical models. Things are not what we are told, nor will they be far into the future. Things are not getting worse. That's right things are getting better! Scientific investigation looking at measurable facts tells us that storms and hurricanes are fewer and less severe, droughts are fewer, floods are not increasing, and forest fires are fewer and less severe. NASA photos tell us that there has been a greening of Earth in recent decades and the OECD and UN Food and Agriculture Organisation tell us that food production has increased, benefitting from slightly increased temperatures since the Little Ice Age and of course, increased fertilisation from slightly more carbon dioxide in the atmosphere.

The 415ppm of carbon dioxide in air is a trace gas which is at a much lower concentration than the trace gas Argon (at \sim 1% which is 10.000ppm). If things are getting better (e.g. fewer hurricanes and their intensity is getting less severe) and carbon dioxide concentration is increasing then there is a negative correlation between the two and not a positive one as the activists and politicians would have us believe. The fact is that there is no real mechanism for carbon dioxide to seriously influence the climate, so why are we being told there is a 'Climate Emergency' and to get away from cheap, plentiful fuels which we have learned to burn cleanly?


All evidence is in the public domain and easily accessed via web sites for NASA, NOAA, GISS and via other groups busy analysing the data. Thank goodness there are think tanks such as the Global Warming Policy Foundation in the UK (https://www.thegwpf.org), the Heartland Institute in the USA (https://www.heartland.org/topics/climate-change), the Science and Public Policy Institute

(www.scienceandpublicpolicy.org) looking critically at the data and coming to broadly similar conclusions in their publications. The data and evidence tell us that there is no climate emergency.

500 scientists have written to the United Nations explaining this (https://clintel.org/world-climate-declaration/), again declaring that there is no climate emergency. Some 90 Italian scientists wrote in similar vein to the Italian government yet the 'Climate

dioxide emissions by all political parties? The bulk of the population do not believe in a 'Climate Emergency' and many scientists have said there is no emergency. Farmers in my area are even less convinced since carbon dioxide is the fundamental basis of the entire food supply chain and most arable farms will have net negative emissions (i.e. they will absorb carbon dioxide to make our food).

The highly expensive remedies for this non-existent emergency

What happened to following the science? Whose science were they following? It was rhetoric and of no serious value in furthering debate on such a complicated matter where the proposed solutions are excruciatingly expensive (in the trillions of £s) and will achieve nothing for the future, but plenty for their bank balances.

There are numerous books often with 'False Alarm' and 'Fraud' in the title which correctly describe our current position on climate. That is, we are not facing any sort of catastrophe or crisis and there never was a 'climate emergency'. In fact we are living in a period of time which is highly beneficial and to make claims to the contrary is fraudulent and criminal.

So why is it necessary to have a Climate Change Act or expensive proposals to fight the non-existent 'Climate Emergency'? Why the stampede towards 'Net Zero' carbon

are bad news for the consumer, businesses and the economy and will cost households and businesses dearly. The proposals to build more expensive intermittent and variable renewables such as wind turbines and solar panels because they are claimed to be 'low carbon' sources of energy will destabilise the electricity grid system and lead to blackouts. An economy relying heavily on information technology which requires electricity is extremely vulnerable to blackouts. Recovery from blackouts is not easy with so-called renewable energy and if the amount of renewable energy on the grid increases significantly it may prove impossible to restart the grid without conventional fuel energy generation.

One acquaintance was telling me that when the power goes off, which it has a couple of times quite recently, so does their water supply. In a future with heavy reliance on renewables, if the wind does not blow strongly enough to generate electricity we could be facing serious problems with power cuts. The so-called 'Smart Meters' can be used to turn off your electricity supply when there is insufficient energy generated to maintain frequency and voltage on the grid. He also noted that in the winter and summer in the UK the wind often does not blow strongly enough to generate energy for weeks at a time and solar panels generate little or no energy in winter and none in the dark.

So what we now see is the perfect storm of political lying and fake news. The politicians are hardly qualified to speak of anything to do with science and most politicians have no clue about energy generation. Worse is that government now does not have access to impartial experts as it closed the Central Electricity Generating Board (CEGB) research centres in the early 1990s and ended the slow death of the CEGB in 2001 (Central Electricity Generating Board (Dissolution) Order 2001). A very unhappy 20th anniversary.

Fact checking by any reasonably competent person can establish that the idea of a 'Climate Emergency' is a deception of the most egregious and dangerous kind. Yet all political parties have signed up to it to 'save the planet'. A noble cause perhaps, but to save it from what exactly? The idea that in 80 or 100 years' time there will be a small increase in temperature and fewer storms and hurricanes constitutes a 'Climate Emergency' is risible. It is even less credible when we realise there has been a statistically significant pause in the rise in average temperatures for over 20 years. Maybe we need to save the Earth from politicians, activists and the fake news media.

Masks do more harm than good

WHILST masks are a successful psychological tool to remind the public to remain alert, they are not effective in preventing the community spread of disease.

In the summer of 2020, mandates were introduced to compel healthy people to wear masks in the community, purportedly to reduce the spread of covid-19. Prior to this time, the World Health Organisation (WHO) and UK politicians alike did not originally support face coverings for the healthy but then u-turned, apparently in response to heavy political lobbying.

In the early stages of the novel coronavirus in the United Kingdom, public health advice remained that masks for the general public were of little benefit, and could even be harmful. There is emerging evidence that cloth masks can amplify the spread of particles by acting as a 'microniser', transforming large droplets, which would ordinarily fall swiftly to the ground close to the person, into smaller, truly airborne and respirable droplets.

As has been established in another of our articles on asymptomatic spread, for a person to be 'clinically relevant' in public health terms, they must have symptoms. The mandating of mask-wearing for the majority of the population who are perfectly healthy is not an effective public health measure to contain the spread of any disease. Prior to 2020 this was not a controversial position. Whilst masks have undoubtedly been a successful psychological tool to remind the public to remain alert, they have not achieved their primary objective, that is, to act as a safe and effective measure to curb the spread of disease.

Contrary to the government message that it 'follows the science', the sudden change in advice by the WHO was not based on any new, high-quality scientific studies. By summer 2020, there was substantial evidence that non-medical masks for the general public did not reduce the transmission of respiratory illnesses. A review of 14 controlled studies had concluded that masks did not significantly lessen the spread of seasonal 'flu in the community.

A Norwegian Institute for Public Health review found that nonmedical masks achieve no benefit for healthy individuals, particularly when viral prevalence is low. From a common sense angle, scientists by Dr GARY SIDLEY

had argued that cloth masks contain perforations that are far too big to act as a viral barrier and therefore 'offer zero protection against covid-19'.

Inevitably, the public often wear masks incorrectly, or improperly handle them when putting them on, or removing them, constituting an additional infection hazard. There has been recognition of this contamination risk in the scientific literature and other researchers have cautioned against the use of cloth face coverings. Potential harms to the wearer include exhaustion, headaches, fatigue and dehydration. Some doctors have suggested an increased risk of pneumonia. Furthermore, the widely varying physical characteristics of the face coverings used by people in the community, that are not standardised for material, fit, length of wearing, changes after washing and drying, and disposal, means that laboratory research on mask efficacy cannot be generalised to real world situations.

With particular reference to covid-19, the only large randomised controlled trial exploring the benefits of adopting face coverings in the community found that masks (even the surgical variety) did not result in a significant reduction in infection risk for the wearer. A detailed analysis of all research investigations, including those purported to suggest that masks might achieve some benefits, led to the view that there is 'little to no evidence' that cloth masks in the general population are effective.

Masks impair verbal communication, render lip-reading impossible for the deaf, and stymie emotional expression, the latter effect potentially constituting a gross impediment to children's social development. Acting as a crude, highly visible reminder that danger is all around, face coverings are maintaining widespread, irrational fear.

Wearing a mask will heighten the distress of many people with existing mental health problems and may trigger 'flashbacks' for those historically traumatised by physical and/or sexual abuse. Sadly, going without a mask (even as a means of avoiding psychological distress) can often attract harassment and further victimisation. In response to this, 'exemption lanyards' have been developed, which further stigmatise those who cannot

wear face coverings due to health conditions or psychological trauma.

The government are already talking about requiring secondary-school pupils to wear masks in indoor areas for the entire day. In addition to the lack of demonstrable benefits as described above, it is most concerning that no comprehensive risk assessment of potential harms has been carried out before making these demands. Prior to imposing this requirement for masks, a full assessment should have been conducted, incorporating the following areas:

- Assessment of oxygen levels in mask wearer at the beginning and end of the day
- Assessment of impairments to concentration and ability to learn
- Assessment of impairment to children with hearing difficulties and special educational needs
- Assessment of impairment to psychological well-being
- Assessment of possible damages from inhalation of micro-fibres
- Assessment of potential harms of repeated use of dirty cloth masks
- Assessment of impairment to non-verbal communication

Many of the potential harms may only become apparent in the long-term, thereby casting yet more doubt on the assumption that, for children, the benefits outweigh the risks. What is even more puzzling is that the masking requirement has been introduced at the time of year when there is almost no circulating covid-19 in the community due to its seasonality. There is no justification for this move from the Department for Education. It should be rapidly retracted for the safety and well-being of all children.

Wearing a mask is not a benign intervention. Making masks mandatory would only be justified if science had shown they achieved a marked reduction in transmission. The evidence is simply not there. On the contrary, it is clear that face coverings for healthy people do more harm than good. Additionally, evidence demonstrating that asymptomatic, healthy members of society are unlikely to spread the disease strengthens the conclusion that mask mandates are unnecessary.

Covid: most successful rebranding ever

WHAT happened to the 'flu? For as long as anyone can remember, this seasonal respiratory illness has taken a heavy toll on the frail and elderly. Typically, the ultimate cause of death is pneumonia, traditionally known as the 'old man's friend'. But since the covid-19 outbreak, official records show that influenza has almost disappeared. Many sceptics suspect that one virus has simply been renamed as another, driven by a worldwide campaign that has exploited public health to launch the 'Great Reset'.

Twenty-one years ago, Canadian journalist Naomi Klein wrote 'No Logo', a polemic against the use of marketing for predatory capitalism by NIALL McRAE

and cultural appropriation. An illusion of choice fooled the mostly youthful targets of advertising into accepting a society where everything is designed for them by corporate strategists.

'Products are made in the factory, but brands are made in the mind', said marketing man Walter Landor. A pandemic created by a huge marketing campaign on an old illness has been sold with the same tactics of big brands: flood the media and all public spaces with snappy messages, reinforced by influential figures. In the same way that Nike and Michael Jordan gained mutual publicity, so has US government scientist Anthony Fauci from covid-19.

Nike may have started with sneakers, but through the ubiquitous 'swoosh' logo, became a way of life. 'Just do it', the adverts implored: wear the logo, live the logo. Mass marketing is an industry of deceit, more sophisticated in methods but of similar scruples as the second-hand car dealer on the Old Kent Road: "Honest, gov - one lady driver".

Covid-19, like Heineken, has reached the parts other diseases can not reach. Previous outbreaks such as swine flu and bird flu didn't catch on, because in reality they could not match the scaremongering. The lesson was clear: focus not only on deaths, but also on contagion. The grossest market is neither the healthy nor the ill, but in defining everyone on Earth as a potential carrier. By deliberately misusing the PCR laboratory procedure for mass testing, millions of 'asymptomatic' cases were found, with daily reports in every nation highlighting the invisible pathogenic spread.

It's how Walt Disney would do a fever: Imagery is everything. Masks were mandated not to prevent infection or transmission but for the constant visual reinforcement of a contrived plague. Morality is prominent in the marketing campaign: complying with the rules demonstrates a good person, someone who listens to experts and follows the science, but more importantly shows concern for others. Skeptics are thus 'reckless ignoramuses', readily identified by their uncovered and free-breathing mouths.

Like the Walmart expansion that destroyed America's Main Street, covid-19 has overshadowed all other healthcare, turning the NHS into the National Covid Service, at the expense of other more serious and prevalent conditions such as cancer. Massive resources have been channelled into testing, track

'n' trace and universal vaccination for a disease that is no worse than influenza. And as many suspect, maybe it is influenza simply rebranded.

The goal, however, is more sinister than brand monopolisation. The protagonists of the covid-19 regime want total control. What they have tried to do for decades with climate alarmism has been achieved in months, by manipulating fear. They have largely succeeded.

When Klein wrote No Logo at the turn of the millennium, mainstream media were sympathetic to anti-globalisation activism, but in this century the globalists have tightened their grip. Corrupted media organisations demonise ordinary people who try to fight the power. A custard pie thrown in Bill Gates' face in the 1990s was reported humorously; today it would be censored.

A brief history of our fiat money

IN 1861 Colonel Dick Taylor from Illinois had a revolutionary idea to help the North American Union win the civil war against the Confederate South. His friend, President Abraham Lincoln listened to his idea and implemented it. Not only did it win the war it enabled an extraordinary period of economic growth which scared the wits out of the British.

Having run out of funds for the war effort, Lincoln had tried to borrow money from the banks(ters), but they wanted to charge up to 36% interest. Lincoln knew if he agreed to those terms the US people would be yoked to a debt that would strangle the economy for years and that might never be paid off.

As Dick Taylor reminded him, the US Treasury was perfectly within its rights to print its own money based on the wealth, or economic output, of the nation, whether the banks liked it or not.

They didn't like it. If a government treasury produced its own notes the private banking industry couldn't make any profit on their interest-bearing government loans. Lincoln went ahead anyway and printed, instead of a banknote, a treasury note, called a 'Greenback' because it was green on one side. The Legal Tender Act 1862 was passed by Congress, declaring the Greenback dollar a fiat currency. Fiat, from the Latin, 'let it be done.' means 'by decree' a legal tender which has no intrinsic value. [It is argued by many that Britain today has a fiat currency, though the 'promise

to pay the bearer on demand' written on our banknotes actually makes it a fiduciary currency, because another commodity is promised in exchange. That commodity is described by the UK Treasury as 'securities', but that's a whole other circular argument.]

The Greenback's birth was not without difficulty. California for one wouldn't agree to it, but then gold glinted richly in the Californian mud. Initially the value of the Greenback fell, but when the Union secured victory the value rose and stabilised.

The banks saw what was at stake. The London Times called it Lincoln's "mischievous financial policy". The editorial went on to say the U.S. government will "furnish its own money without cost. It will pay off debts and be without a debt. It will have all the money necessary to carry on its commerce. It will become prosperous beyond precedent." It added, "That government must be destroyed." In 1865, a month after announcing the Greenback dollar a success worth keeping, Abraham Lincoln was assassinated. Shortly afterwards the Greenback was abandoned.

Fast forward to 1914 in Britain. The banksters faced financial ruin at the outbreak of war when customers demanded their savings back in gold. To stop a run on the banks, the government extended the August bank holiday by 3 days. When the banks opened their doors again the public were allowed their savings, but not in gold.

David Lloyd George, then treasurer, issued treasury notes signed by the

permanent secretary, John Bradbury. Just like the Greenback dollar, the 'Bradbury' Pound was a fiat currency based not on gold, but on the economic output of the nation. It was an interest-free, debt-free currency.

Britain accepted this treasurybacked currency and there was stability. However, soon after the treasury issued the Bradbury notes that saved the banks from financial ruin, the banksters demanded a return to the debt-based currency on which their profits depended. The Bradbury Pound was abandoned.

It wasn't the first time Britain had used a fiat currency. During the Napoleonic Wars William Pitt the Younger also had to move quickly to stop a run on banks' gold reserves.

Fractional reserve banking (the practise of decreasing the amount of gold that supported paper notes) meant that by 1797 banknotes in circulation

had a collective face value of over £28 million, while the banks' reserves of gold amounted to only £2 million. Pitt created the Bank Restriction Act to release the banks from having to exchange banknotes for gold, in effect creating a fiat currency, a currency that relied on its accepted face value only.

Economists feared this would lead to hyperinflation and Pitt was heavily criticised. What was observed over the 24 years of the restriction was that GDP rose significantly, inflation fell, precious metals (real money) flowed into Britain and foreign exchange rates remained in Britain's favour. Paper money did not have to rely on precious metals. In fact it did better without them. How was this possible? An article from 1867 was equally surprised:

"If irredeemable government paper had been forced upon the public... it scarcely admits of a doubt that the result would have been a rise in prices and an increase of speculation. According to all the old currency theories, such ought now to have been the case with England. In fact, directly the contrary result took place".

The restriction lasted until 1821 during which time Britain overtook the Netherlands to become the largest economy in Europe.

History has shown it is possible for government treasuries to print money without causing hyperinflation. Look at the last decade of Quantitative Easing — in 2009 economists talked nervously of hyperinflation. That hasn't happened and western governments are still using QE to print money. QE, however, borrows with interest from private banks and we the people pay it back through high taxation. Governments and banksters collude in this stitch up, and in the end we are saddling our children with these debts while they get richer and richer.

Economists who argue for hyperinflation usually point to the Weimar Republic. In the Weimar Republic devaluation of the German Mark began with massive borrowing from banks for its failed war effort in WW1, was exacerbated by the payment of reparations to the victorious nations, and lost all control through the wild speculation of banksters. Similar uncontrolled speculation caused the 2008 'credit crunch'.

Perhaps we should reflect upon Henry Ford's words: "It is well enough that people of the nation do not understand our banking and monetary system, for if they did, I believe there would be a revolution before tomorrow morning."

What happened to rebellious artists?

Virtually every film maker, actor and musician promotes the establishment narrative on every subject

Health professionals ask Government not to vaccinate children under 18

WE are writing as professionals, medics, academics, parents, grandparents, and members of the public to express our grave concerns about suggestions to extend the covid-19 vaccination programme to children. We believe this to be a hasty step that is uncalled for under present circumstances.

You have been clear that society can reopen once the vulnerable have been offered vaccination against covid-19. This has now been achieved. All the highest risk groups have now been vaccinated and the government's own data confirms that 98% of over 60s have antibodies from either vaccination or infection. The NHS has been protected and we are no longer in a crisis situation. Whilst the very old and very frail will, sadly, always be at risk of serious illness, our children are the future. Children's lives have been put on hold for over a year already at great cost to their physical and mental wellbeing and education. We must not ask them to suffer further harm for the sake of adults.

Thankfully, the evidence shows that children and young people are minimally affected by covid-19. Vaccinating children, then, is of limited direct benefit to them but for the primary purpose of protecting adults. However, medical treatment cannot be justified if it poses a risk to the individual which is greater than the harm it protects against, and this approach would mark a significant departure from established principles of medical ethics. Kate Bingham of the Government Vaccine

Task Force said last October, "we just need to vaccinate everyone at risk...there's going to be no vaccination of people under 18."

Furthermore, many of the covid-19 vaccines involve new technology that represents a radical departure from previous forms of vaccine. We should be especially cautious about using new technologies on our children.

to children from covid-19 vaccines. In particular, we refer you to the Open Letter written to the Medicines and Healthcare products Regulatory Agency (MHRA) as reported in the Daily Telegraph on 18 May 2021, which described the plan to vaccinate children as "irresponsible, unethical and unnecessary". We urge you to re-read that letter.

It was further reported in the press on 23rd May that some teenagers and young adults who received covid-19 but by contrast, a general assumption towards vaccinating young people against covid-19 is already being created. Examples include the statement by Professor John Edmunds, a member of the Scientific Advisory Group for Emergencies (SAGE), that "there will continue to be a major disruption in schools until we have vaccinated our children". Similarly, Mark Drakeford, First Minister of Wales, said "we might, by the autumn, be able to have young people

to schooling itself as the statements above of Professor Edmunds and Mark Drakeford imply? The broader implications are disturbing.

To deploy a significant stock of vaccines on a very low risk group in the UK when many parts of the developing world are struggling to vaccinate even high risk groups is morally fragile. It has been heavily criticised by experts and has been labelled a "moral catastrophe" by World Health Organization's Executive Director Tedros Adhanom Ghebreyesus. However, even after vulnerable adults worldwide have been offered the vaccine, it still would be inappropriate to inject healthy children.

We are profoundly concerned that you are considering taking the UK down this road. As a society, we have striven over this last year to protect the vulnerable, but vulnerability comes in many forms and absolutely now includes children. We simply must not put children in unnecessary danger, nor in the situations described above. There is no need to rush to vaccinate children for covid-19, and there may never be any need to do so. Individual children at very high risk can already receive vaccination on compassionate grounds.

No covid-19 vaccines should be approved or licensed for use in children until the current clinical trials are complete, all adult safety data is fully published and reviewed, and potentially serious long-term side effects have been conclusively ruled out. There must be an open scientific debate, including ordinary ethical standards with a routine assessment of potential conflicts of interest, as well as due process and parliamentary scrutiny. Informed questions and criticisms should not only be welcomed but encouraged in order to prevent tragedies from occurring.

In conclusion, we join together in urging you to call a halt to the roll out of the covid-19 vaccination programme to children.

'This is a decision of generational significance. We do not believe you will ever regret a decision to be cautious when it comes to the health and welfare of the 12 million children of this nation.'

The company financial statement, ending March 2020, shows annual accrued income increasing from £24,000 to £1.1million.

Imminent financial year accounts are awaited with eagle eyes - legitimate questions may arise about the need for more transparency about where the fines that are paid by unsuspecting victims actually go to. Any potential, if only perceived by the public, of possible conflicts of interest with policing and enforcement in these difficult times needs clarification.

Gates' money cancels expert investigating aluminium and brain disease link

ONE of the leading experts in the effects of aluminium on animal and human health (and not least the use of aluminium since the 1930s in vaccines) Dr Christopher Exley of Keele University has been 'cancelled' by his University.

In recent years the University has accepted funding from the Foundation run by Bill Gates whose investments in vaccines are huge (he has even boasted how profitable they are) and would find research showing the dangerous contents of vaccines a blow to his organisations and their vast profits, not to mention his reputation as a 'philanthropist'.

While accepting Gates' money, Keele has shut down Exley's website and prevented those funds which have for years supported his work from reaching him.

In 2021, Keele University's Dean of natural sciences wrote to Dr. Exley: "the university will no longer provide facilities to solicit or enable restricted charitable donations for research on the bio-inorganic chemistry of aluminum and its links to neurodegenerative disease."

Dr. Exley's research group has



published important scientific insights in more than 200 peer-reviewed publications. The latest indicate a stronger connection between Aluminium and Alzheimers.

Dr. Exley: "The new research confirms my resolve that within the normal lifespan of humans, there would not be any AD (Alzheimers) if there were no aluminium in the brain tissue. No aluminum, no AD."

But big money talks – and suppresses and cancels someone who could provide scientific proof of the dangers of the aluminium which is so critical in Gates' push for world vaccination. While accepting Gates' money, the University rejected a \$15,000 donation from Robert F. Kennedy Jr's 'Children's Health Defense' organisation. Explaining the rejection the University's anti-science and pro-money attitude was clear:

"Prominent public figures or Foundations could place the institution in an ethical and reputational predicament" and "could generate potentially negative media coverage and may also jeopardise the strong relationships it holds with its existing major funders and partners."

If that is not a precise description of the money distortion of science we don't know what is.

Showing how corporatist influence is disfiguring not only business and political life but also academic research, Keele University partnered over recent years with the UK's largest pharmacy company, Well Pharmacy.

"The University's Pharmacy
School was radically transformed in
2019 as well, and was reconfigured
as the School of Pharmacy and
Bioengineering. The pharmaceutical
and biotech industries were given
precedence and exclusive influence
over the science and technology
department at Keele - Dr. Exley's
research was quickly targeted
by the growing pharmaceutical

influence at the university because his research team was brave enough to study the health impacts of aluminium adjuvants in vaccines."

We have seen a similar distortion of modern 'science' in the hundreds of millions of pounds devoted to 'Climate Research' when that other side of the anti democratic (and anti science) corporatist coalition, the increasingly unaccountable state, made questioning a totalitarian climate orthodoxy tantamount to a crime!

As Robert F. Kennedy Jr. wrote to Keele in 2020: "Allowing industry to quash science for fear that it might expose profitable practices as harmful to public health is offensive to every tenet of academic freedom, scientific integrity, ethics and morality."

As future generations of state and corporate managers play their 'cancel culture' games at universities, the government should make the Cabinet Office responsible for (and give power to enforce) objectivity and academic freedom in business, government and academic life, ensuring state funding itself does not bias any kind of research or business development.

NHS guilty of horrifying experiments on humans in the post-war era

AFTER World War II, trials began in Nuremberg, Germany, in late 1945, including the prosecution of scientists and doctors who carried out grossly unethical medical experiments on people without their consent, most of the victims being those in Nazi concentration camps. But, contrary to common belief, these trials did NOT bring an end to the use of human beings as guinea pigs. Quite unbelievably, the UK's NHS was a hot-bed for such unethical medical experiments, even as recently as the 1960s.

Yes, you read that correctly right here in Britain in our own National Health Service!

Back in the 60s, a British physician, Maurice H. Pappworth, exposed a long list of unethical human experiments going on in both the U.K. and America. According to a 2018 article in New Scientist, after investigating many medical journals describing unethical experiments within the NHS, Pappworth delved deeper to discover that "abuses were happening on a shocking scale, involving thousands of victims."

After writing letters to numerous medical journals about these seriously concerning issues, Pappworth found that very few journals would print his letters. No small surprise that he got little response, as some of those he wrote to were those physicians carrying out these experiments.

So, not satisfied with this, and unwilling to drop the matter, in 1967 he wrote a book in which he revealed these experiments in graphic detail, as well as revealing the names of those who carried them out. His book, 'Human Guinea Pigs; Experimentation on Man', highlighted the horrific disregard for medical ethics of some of those working in Britain's NHS, as all of these experiments - all of them barbaric - were carried out WITHOUT the patient's consent.

The experiments that Pappworth referred to mostly involved those on the vulnerable and the incarcerated, such as hospital and psychiatric patients, prisoners, and even more alarmingly, children in orphanages too. Pappworth's work on exposing the truth described doctors as "treating their patients with as much respect as lab rats, and sometimes

killing them in the process." One day you're in for routine surgery, the next you're a lab rat. 'Do no harm' was clearly the last thing on these physicians minds. The New Scientist article mentioned above goes on to detail some of the studies that are mentioned in Pappworth's book:

In one study, doctors reported boring holes into the skulls of 18

children, had their insulin withheld so that they became comatose, after which samples of their liver and kidney were taken for analysis.

Pappworth was considered a heretic by the medical establishment for revealing such outrageous experimentation in the NHS, and a great deal of pressure was placed on him to remain silent about his findings. including America's Federal Drug Administration (FDA) and the UK's Medicines and Healthcare Regulatory Authority (MHRA).

They are being used under 'Emergency Use Authorisation' only, meaning that they have NOT been properly tested, so they cannot possibly be claimed as being either safe or effective. They can only truthfully be described as 'experimental'.

Therefore, and quite obviously, anyone who has had one or more is a participant in the largest medical experiment in the history of mankind. We may not be having our skulls drilled into (well, not physically anyway), and nor are catheters going into our children's hearts, but nonetheless, the world is now awash with millions of walking, talking, human guinea pigs, many of whom

will include children soon too - is the scandal-tainted World Health Organisation (WHO), the same WHO featured in a revealing 2018 documentary called 'trustWHO'. Black Lives Matter leader quits

A BLACK Lives Matter chapter founder in Minnesota has resigned, claiming that the organisation isn't concerned about helping black communities or helping improve the education quality in Minneapolis, according to a video published in the middle of June.

Rashard Turner, the founder of a Black Lives Matter chapter in neighbouring St. Paul, said he started the branch in 2015 but became disillusioned roughly a year after becoming "an insider" within the far left organisation, according to a video by JACK PHILLIPS

released by TakeCharge - a group that rejects various provisions promoted by Black Lives Matter, including critical race theory-linked claims that the United States is inherently racist.

"After a year on the inside, I learned they had little concern for rebuilding black families, and they cared even less about improving the quality of education for students in Minneapolis," Turner said in the video.

"That was made clear when they publicly denounced charter schools alongside the teachers' union. I was an insider in Black Lives Matter, and I learned the ugly truth. The moratorium on charter schools does not support rebuilding the black family. But it does create barriers to a better education for black children. I resigned from Black Lives Matter after a year and a half. But I didn't quit working to improve black lives and access to a great education."

Representatives for Black Lives Matter didn't respond to a request for comment by press time.

Approximately a year after George Floyd's death in Minneapolis, support for the group has plummeted in the United States, according to a recent poll from Morning Consult. Only 48 percent hold favorable views about the organisation, down from 61 percent last May.

A USA Today survey found that 36 percent of Americans now would describe Floyd's death as a murder, down from 60 percent last summer.

A poll in May conducted by the newspaper revealed that the Black Lives Matter call to 'defund the police' has even less support, with only 18 percent of respondents supporting it.

It comes amid recent controversies surrounding Patrisse Cullors, a co-founder of the organisation who resigned after a series of reports about her real estate portfolio and finances. Following the reports' publication last month, Cullors asserted that she didn't misuse any donations to Black Lives Matter, despite now owning properties worth over \$3 million.

In a statement last week, Cullors
- a self-described "trained Marxist" said, "With smart, experienced, and
committed people supporting the
organisation during this transition, I
know that BLMGNF is in good hands
...the foundation's agenda remains
the same - eradicate white supremacy
and build life-affirming institutions."

Cullors told The Associated Press that her departure was planned more than a year in advance and wasn't related to the reports about her finances and her multiple homes, claiming they "were right-wing attacks" meant to defame her character.

Reporter who broke key Clinton story dead of apparent suicide

THE body of a Birmingham, Alabama journalist who broke the story about the controversial 2016 tarmac meeting in Phoenix between former President Bill Clinton and then-Attorney General Loretta Lynch was found on Saturday morning of an 'apparent suicide,' according to AL.com.

Veteran TV newsman and former University of Alabama football player Christopher Sign died Saturday morning in an apparent suicide, according to police.

At 8:13 a.m. Saturday, the Hoover 911 center received a call of a person down at a residence on Scout Trace. Hoover police and fire personnel arrived to find the 45-year-old Sign dead.

Hoover police Lt. Keith Czeskleba said the death is being investigated as a suicide but gave no more details.

The tarmac bombshell, which gave the appearance that Bill Clinton was secretly pleading his wife's email case after then-FBI James Comey launched a new investigation, is thought to have contributed to Hillary Clinton's loss in 2016.

Sign, meanwhile, had complained last year of receiving 'significant' death threats, having his credit cards hacked, and having to create codewords to use with his children in a clear indication he viewed the threats as serious with regards to his family.

Sign, an Emmy-award winning reporter, made national headlines over the June 27, 2016 tarmac meeting at Phoenix Sky Harbor Airport amid the FBI's investigation into Hillary Clinton's use of an unauthorised server at home whilst serving as Obama's Secretary of State. The meeting between Clinton and Lynch occurred days before Comey announced that the bureau would not press charges against Hillary - after the agency changed internal language describing Clinton's conduct from "gross negligence" to "extremely careless."

"Gross negligence" is a legal term of art in criminal law often associated with recklessness.

According to Black's Law
Dictionary, gross negligence is a severe degree of negligence taken as reckless disregard," and "Blatant indifference to one's legal duty, other's safety, or their rights. "Extremely careless," on the other hand, is not a legal term of art.

In addition to the "gross negligence" softening to "extremely careless" edit (performed by disgraced FBI agent Peter Strzok), the FBI removed a key justification for elevating Clinton's actions to the standard of "gross negligence" - that being the "sheer volume" of classified material on Clinton's server. In the



original draft, the "sheer volume" of material "supports an inference that the participants were grossly negligent in their handling of that information."

Also removed from Comey's statement were all references to the Intelligence Community's involvement in investigating Clinton's private email server, as well as changing the language to downgrade the probability that Clinton's server was hacked by hostile actors, changing their language from "reasonably likely" to "possible" - an edit which eliminated yet another justification for the phrase "Gross negligence." To put it another way, "reasonably likely" means the probability of a

hack due to Clinton's negligence is above 50 percent, whereas the hack simply being "possible" is any probability above zero.

In short, Bill Clinton's exposed clandestine tarmac meeting appears to have had quite the effect on his wife's investigation, despite the fact that she still lost. And now the respected journalist who broke the story is dead.

ABC 33/40 in 2017 announced Sign was returning to Birmingham from Phoenix as the evening anchor, replacing Dave Baird after he retired.

Sign, who grew up near Dallas, previously worked as a reporter for ABC 33/40 from 2000 to 2005, where he covered the 2001 Brookwood

mine disaster and hurricanes Charlie, Frances and Ivan.

While a reporter and morning anchor at ABC affiliate KNXV-TV in Phoenix, Sign broke the story of the June 2016 secret tarmac meeting between former President Bill Clinton and then-Attorney General Loretta Lynch.

"Our deepest sympathy is shared with Christopher's loving family and close friends. We have lost a revered colleague who's indelible imprint will serve forever as a hallmark of decency, honesty and journalist integrity. We can only hope to carry on his legacy. May his memory be for blessing," said ABC 33/40 Vice President and General Manager Eric Land in a statement.

Sign wrote a book about his experience called 'Secret on the Tarmac' in which he tells his full story.

Sign also won a 2014 Emmy Award for breaking news for his coverage of the shooting of two Phoenix police officers, as well as an Edward R. Murrow Award for spot news, for his coverage of the search for the "Baseline Killer" and "Serial Shooter" who terrorised Phoenix in the summer of 2016.

He attended the University of Alabama in the 1990s and spent four years as an offensive lineman for the Crimson Tide under former coach Gene Stallings.

While at Alabama, he met his wife, Laura, an All-SEC volleyball player. He leaves three sons.

Lebanon in the grip of hyperinflation

A NEW downward turn means that the Lebanese pound has lost more than 90 percent of its value on the informal market since October 2019. The World Bank has called it one of the worst financial crunches worldwide since the mid-19th century. Lebanon's currency hit a new low against the dollar on the black market Monday. The pound, officially at 1,507 to the US dollar since 1997, was selling for 15,400 to 15,500 on the black market, several money changers stated.

After hovering around 15,000 to the dollar in mid-March, the unofficial exchange rate dropped to between 12,000 and 13,000 later that month before soaring back up in recent days. The last time the pound hit a low of 15,000 in March protesters took to the streets across Lebanon for over a week, blocking roads by burning tires.

Lebanon has been without a fully-functioning government for ten months since the last one stepped down after a deadly port explosion in Beirut last summer. Politicians were unable to form a new cabinet even as foreign currency cash reserves plummeted, causing fuel, electricity and medicine shortages.

According to thearabweekly.com, the country, where more than half the population now lives in poverty, is in desperate need of financial aid but the international community has made any such assistance conditional on the formation of a new government to launch sweeping reforms.

Largely locked out of their dollar deposit accounts since late 2019 when the Lebanese pound crashed and the banking system buckled amid widespread political protests, some savers see investments in export-focused companies as a way to access hard currency and get something for their "lollars", the nickname for U.S. dollar-denominated deposits 'trapped' in Lebanon's banks.

Alcohol exporters, including craft brewers and gin merchants, are a popular choice.

"If you invest with me today trapped dollars I'll give it back to you in fresh dollars," said Kamal Fayad, chief executive of 961 Beer, a Lebanese beer exporter.

Under informal capital controls, depositors can still write cheques on their U.S. dollar-denominated accounts but those cheques cannot be used abroad and if sold at local exchanges they lose at least 75% of their value.

The steep discount reflects the predicament of having dollars parked at Lebanese banks. Starved

of dollar funding, the banks limit customers' access to their funds and currently pay out at a rate of 3,900 Lebanese pounds to the greenback, around a quarter of the value of dollars on the black market.

Fayad said he was in talks with investors to raise the equivalent of over \$1 million which would include between \$3 million to \$4 million lollars.

"It's really political and financial surrealism," said Toufic Gaspard, an economist who has worked as an adviser at the International Monetary Fund and as an adviser to a former finance minister.

"If a patient refuses to take any medications for 20 months, what do we expect will happen? Of course the health of the patient will deteriorate. This is exactly what we are witnessing in Lebanon, the dwindling of reserves, more depreciation of the currency and more shortages of basic commodities." he said.

Import shortages are now impacting the daily life of ordinary Lebanese. Long queues for fuel recently led to clashes in north Lebanon, while pharmacies went on a two-day strike last week as medicines ran out.

Many importers are facing delays in subsidy payments from the central bank, straining cash flows, said Hani Bohsali, head of the Syndicate of Importers of Foodstuffs, Consumer Products and Drinks.

"From just speaking to traders, I can tell you that there are \$50 million to \$100 million of unpaid

since the government defaulted and branches, barricaded with metal plates, have become a target for protests. The financial sector, the state's biggest creditor, is estimated to have losses in excess of \$80 billion, according to estimates by the outgoing government last year, a figure that dwarfs Lebanon's annual economic output of around \$50 billion. Fearing for their savings, many Lebanese have tried to move their money out of banks by repaying individual and company debt.

An executive at a Beirut-based financial services firm, who spoke on condition of anonymity, said he had seen a spike in investor demand to finance exporters and manufacturers, resulting in some of those companies closing their bank credit facilities. Andre Malak of The Three Brothers, a Lebanese gin producer, has seen a 30% jump in outside investment since the crisis. "We started seeing an increase in interest since the beginning of the recession when people wanted to remove their money from the bank and put it in free space", he said.

Mike Azar, a Beirut-based financial adviser, said Lebanon's financial system had seen a deleveraging of more than \$20 billion since October 2019 and the use of trapped dollars to repay outstanding debt contributed further to devaluing the currency, as selling cheques in exchange for U.S. dollars was lifting demand for an already dwindling supply.

The central bank, meanwhile, is planning to allow depositors to withdraw some of their trapped dollars through a new scheme with a limit of \$800 per month, half of it in dollars and the rest in Lebanese pounds at a government rate of around 12,000 to the U.S. dollar.

Some observers believe that the increase in the money supply via the withdrawal of Lebanese pounds against foreign currencies at the exchange rate of the Sayrafa electronic platform of the Banque du Liban would largely explain the deterioration in the value of the local currency, in addition to the political crisis which continues while awaiting the Prime Minister designate Saad Hariri to recuse himself due to increasingly critical disputes with the Presidency of the Republic.

As a reminder, the establishment of a new government is necessary for the relaunch of negotiations with the IMF and the implementation of economic, monetary and fiscal reforms deemed essential for the release of international aid, while the crisis that Lebanon is going through is worsening with a poverty rate that could now reach more than 75% of the population.

"Investors prefer to take the risk on me rather than keep money in the bank, at least I'm doing something good for the industry. I'm safer today to them than a bank," he said.

The willingness to take the financial hit reflects despair over Lebanon's path out of crisis, which has been blocked by political in-fighting compounded by a devastating unexplained explosion at the capital's port last year.

Economic meltdown has driven half the population of 6 million into poverty, wiped out savings and slashed consumer purchasing power.

International donors have said they will only help if major reforms are implemented to fight widespread corruption but a near year-long standoff over the make-up of a new government means they are nowhere near being introduced.

The offices of the finance minister and the economy minister did not respond to a request for comment.

Lebanon depends on imports and for years the central bank helped finance the trade deficit by offering high interest rates on dollar deposits at commercial banks. The banks passed these rates on to clients, attracting a flood of deposits and hefty profits for a banking system with assets that swelled to as much as 167% of the country's economic output in 2015.

The system imploded when the government defaulted on its debt last year. Foreign reserves at the central bank dropped from over \$30 billion prior to the crisis to about \$15 billion in March, and an expensive subsidy programme for imports is pushing usable reserves to the point of exhaustion.

invoices for food imports. The goods have come, they have been sold, but they have not been covered by the central bank," he said.

He said such delays had become a real threat as importers did not know when they would be paid and could not rely on banks to finance imports.

"You need to finance your purchases from your own financial strength, using money from your own personal accounts, or fresh dollars you take from foreign accounts," he said.

The central bank did not respond to a request for comment.

The government is looking to reform the subsidy system but it has stopped short of ending it until an alternative cash subsidy system is approved by parliament.



Iranian hardliner elected

EBRAHIM Raisi, a hardline judge who is under U.S. sanctions for human rights abuses, secured victory as expected on June 19 in Iran's presidential election, in a contest marked by voter apathy over economic hardships and political restrictions.

With all 28.9 million ballots counted, Raisi was elected with a tally of 17.9 million, Interior Minister Abdolreza Rahmani Fazli said on state TV.

Turnout in the June 18 four-man race was a record low of around 48.8 percent, and there were 3.7 million invalid ballots that were likely to have been mostly protest votes.

Appointed by Supreme Leader Ayatollah Ali Khamenei to the high-profile job of judiciary chief in 2019, Raisi was placed under U.S. sanctions a few months later over human rights violations.

Those included the role that human rights groups say Raisi played in the executions of thousands of political prisoners in 1988 and in the violent suppression of unrest in 2009.

Seen by analysts and insiders as representing the security establishment at its most fearsome, Raisi, 60, had been widely tipped to win the contest, thanks to Khamenei's endorsement.



Chinese city proposes licenses for self-driving vehicles

THE southern boomtown of Shenzhen is preparing to issue special license plates for selfdriving vehicles, in a first for China that will allow the vehicles to run legally on public roads and promote the industry's development.

The regulation on 'intelligent and connected vehicles (ICVs)' would help promote commercialisation of self-driving vehicles, such as their use as taxis, instead of being limited to tests, industry experts said. So far, ICVs are technically not legal because national laws stipulate that vehicles must be driven by a human driver.

The proposed regulation will be sent for approval by the Standing Committee of Shenzhen People's Congress at the end of June.

If the regulation passes, the "Shenzhen government will issue a list of ICVs that can be sold, driven on roads and used for transportation business," the report says.



Skull & Crossbones sign given to unvaccinated in rural India

POLICE in rural India have made some citizens who have not been injected with experimental genetic drugs wear signs with a skull and crossbones, the universal symbol for danger, stoking anger in a country where the shots are in short supply.

Officers in the Niwari district of central Madhya Pradesh state said they introduced the policy to encourage more vaccinations.

"Watching the low vaccination rate in our district we decided to honour the people who got vaccinated, but then we also found a large number of people who were not vaccinated," Santosh Patel, a sub-divisional police officer posted.

Those who were vaccinated were given a sign with the colours of the Indian flag reading "I am a nationalist."

Those who were not vaccinated were given a skull and crossbones sign saying "Do not come near me, I am not vaccinated. Please stay away from me," according to Patel and video footage from the district. Some people were seen wearing the signs taped to their chest.

The policy has provoked anger online, with social media users calling it an "insult" and "stigmatising".

Canadian political leader arrested for attending anti-lockdown protest

MAXIME Bernier, the leader of the People's Party of Canada (PPC), was arrested last Friday after speaking at an antilockdown protest in St-Pierre-Jolys, Manitoba. He was arrested for violating provincial health orders, which prohibit indoor and outdoor gatherings on both public and private property and mandate 14 days of self-isolation for anyone entering the province.

The arrest was hardly a surprise. Before his trip, he received a letter from the Manitoba Department of Health informing him that attending the planned rallies would be illegal. He also received two citations at a different rally earlier that day, and the officer issuing the ticket warned him that he could be arrested if he continued attending rallies.

Undeterred, Bernier continued with his plans. Upon arriving in St-Pierre-Joly, a town of about 1,000, Bernier addressed those who had gathered to hear him speak. There were less than a dozen people in attendance. The whole event was outdoors and physically distanced.

Shortly after the protest, his truck was pulled over and he was arrested on the spot. "Do you have anything on you that's going to hurt me?" the arresting officer asks.

"Only my words. Only my philosophy. Only what I believe in." Bernier replied.

Florida pardons all covid fines and arrests

FLORIDA Gov. Ron DeSantis on Wednesday announced that all Floridians who were were arrested or fined for violating mask mandates or social distancing requirements will be pardoned.

In a 3-1 vote, the four-member Board of Executive Clemency approved the Republican governor's decision to officially pardon those who were arrested or fined for violating local government orders.

"This action is necessary so that we can recover, have a good transition to normal operations, and also just a recognition that a lot of by **ISABEL VAN BRUGEN**

this stuff was way, way overboard," DeSantis said of the move.

DeSantis said the pardon applies to civil and criminal penalties handed to individuals or businesses "punished for breaking unscientific, unnecessary directives".

Voting to deny the pardons was Democrat Nikki Fried, who is currently State Agriculture Commissioner and is running to unseat DeSantis next year.

"Our local governments stepped up to protect the people of our state. They did what was best for the interests of their communities," Fried said. It isn't clear how many
Floridians will be pardoned as a
result of the state clemency board's
decision. DeSantis' office did not
immediately respond to a request for
comment by The Epoch Times.

The decision to pardon Floridians who violated local government orders follows an executive order issued by the governor on May 3 that suspends all local pandemic emergency mandates effective July 1.

DeSantis signed Senate Bill 2006 last month, passed by Florida state lawmakers in April, granting the governor the ability to override local emergency orders. The bill also includes a ban on vaccine passports that were

to levy fines of \$5,000 per violation.

The Republican governor at the time described his executive orders as the "evidence-based thing to do," adding that proponents of lockdowns "really are saying you don't believe in the vaccines, you don't believe in the data, you don't believe in the science." He added: "We've embraced the vaccines. We've embraced the science on it."

The order suspending local emergency mandates only affects governments, not businesses.

In announcing the official pardons, DeSantis highlighted a case which saw the arrest of Mike Carnevale, a Broward County gym owner who refused to enforce mask orders. DeSantis granted clemency to him and his wife.

"Floridians like Mike and Jillian Carnevale should have never faced criminal charges for not requiring mask in their businesses," the governor said. "Today, we took action in Florida to reject the overreach of local authorities through unnecessary and unscientific mask mandates."

He added: "No business should face economic ruin and be punished for alleged violations of local orders that are unreasonably restrictive of rights and liberties."

"Spike protein a toxin and pathogenic" - Canadian university professor

NEW research shows that the coronavirus spike protein from covid-19 vaccination unexpectedly enters the bloodstream, which is a plausible explanation for the millions of reported side-effects from blood clots and heart disease, to brain damage and reproductive issues, a Canadian cancer vaccine researcher said last week.

"We made a big mistake. We didn't realize it until now," said Byram Bridle, a viral immunologist and associate professor at University of Guelph. Ontario, in an interview with Alex Pierson, in which he warned listeners that his message was "scary."

"We thought the spike protein was a great target antigen, we never knew the spike protein itself was a toxin and was a pathogenic protein. So by vaccinating people we are inadvertently inoculating them with a toxin," Bridle said.

Bridle, a vaccine researcher who was awarded a \$230,000 government grant in 2020 for research on covid vaccine development, said that he and a group of international scientists filed a request for information from the Japanese regulatory agency to get access to what's called the 'biodistribution study.'

"It's the first time ever scientists have been privy to seeing where these messenger RNA [mRNA] vaccines go after injection," said Bridle. "Is it a safe assumption that it stays in the shoulder muscle? The short answer is: absolutely not. It's very disconcerting.'

Vaccine researchers had assumed that novel mRNA covid vaccines would behave like 'traditional' vaccines and the spike protein responsible for infection and its most severe symptoms — would remain mostly in the vaccination site at the shoulder muscle. Instead, the Japanese data showed that the infamous spike protein of the coronavirus gets into the blood where it circulates for several days and then accumulates in organs and tissues including the spleen, bone marrow, the liver, adrenal glands, and in 'quite high concentrations' in the ovaries.

"We have known for a long time that the spike protein is a pathogenic protein. It is a toxin. It can cause damage in our body if it gets into circulation," Bridle said.

The SARS-CoV-2 spike protein is what allows it to infect human

cells. Vaccine manufacturers chose to target the unique protein, making cells in the vaccinated person manufacture the protein which would then, in theory, evoke an immune response to the protein, preventing it from infecting cells.

A large number of studies has shown that the most severe effects of SARS-CoV-2, the virus that allegedly causes covid-19, such as blood clotting and bleeding, are due to the effects of

which detected SARS-CoV-2 protein in the blood plasma of 11 of 13 young healthcare workers that had received Moderna's covid-19 vaccine, including three with detectable levels of spike protein. A 'subunit' protein called S1, part of the spike protein, was also detected. Spike protein was detected an average of 15 days after the first injection. Bridle said the discovery of vaccine-induced spike protein in blood circulation would have implications for blood donation programs. "We don't want transfer of these pathogenic spike proteins to fragile patients who are being transfused with that blood," he said.

The vaccine scientist also said the findings suggested that nursing babies whose mothers had been vaccinated were at risk of getting covid spike proteins from her breast milk.

Bridle said that "any proteins in the blood will get concentrated in breast milk," and "we have found evidence of suckling infants experiencing bleeding disorders in the gastrointestinal tract" in VAERS.

Given the small number of young research subjects in Pfizer's vaccine trials and the limited duration of clinical trials, the Canadian Covid Care Alliance (CCCA) — a group of independent Canadian doctors, scientists, and professionals whose declared aim is "to provide top quality, evidence-based information about covid-19, intent on reducing hospitalizations and saving more lives." said questions about the spike protein and another vaccine protein must be answered before children and teens are vaccinated, including whether the vaccine spike protein crosses the blood-brain barrier, whether the vaccine spike protein interferes with semen production or ovulation, and whether the vaccine spike protein crosses the placenta and impacts a developing baby or is in breast milk.

What has been discovered by the scientific community is the spike protein on its own is almost entirely responsible for the damage to the cardiovascular system, if it gets into circulation," Bridle told listeners.

Lab animals injected with purified spike protein into their bloodstream developed cardiovascular problems, and the spike protein was also demonstrated to cross the blood brain barrier and cause damage to the brain.

A grave mistake, according to Bridle, was the belief that the spike protein would not escape into the blood circulation. "Now, we have clear-cut evidence that the vaccines that make the cells in our deltoid muscles manufacture this protein that the vaccine itself, plus the protein gets into blood circulation," he said.

Bridle cited the recent study

which disappeared two days later.

Once in circulation, the spike protein can attach to specific ACE2 receptors that are on blood platelets and the cells that line blood vessels. "When that happens it can do one of two things: it can either cause platelets to clump, and that can lead to clotting. That's exactly why we've been seeing clotting disorders associated with these vaccines. It can also lead to bleeding." Bridle also said the spike protein in circulation would explain recently reported heart problems in youths who had received the shots.

"The results of this leaked Pfizer study tracing the biodistribution of the vaccine mRNA are not surprising, but the implications are terrifying,' Stephanie Seneff, a senior research scientist at Massachusetts Institute of Technology, told LifeSiteNews. "It is now clear that vaccine content is being announced it was studying reports of "mild" heart conditions following covid-19 vaccination, and last week 18 teenagers in the state of Connecticut alone were hospitalised for heart problems that developed shortly after they had covid-19 vaccines.

AstraZeneca's vaccine was halted in a number of countries and is no longer recommended for younger people because of its link to lifethreatening and fatal blood clots, but mRNA covid vaccines have been linked to hundreds of reports of blood clotting events as well.

- 3. Although the injection is usually given into a shoulder muscle it can, and invariably will, enter the blood stream. If you have a bruise after a jab then that's proof of bleeding. Rubbing the site after this vaccine could, in my view, speed up the rate at which the toxin enters the blood. Many of those giving the jabs know little or nothing about the substance they're injecting. Some vaccinators undoubtedly put the tip of the needle into a small blood vessel thereby squirting the material directly into the circulatory system. Is it possible that the people suffering the most immediate, dramatic consequences are those in whom this has happened? How many vaccinators check that the needle tip isn't in a blood vessel? How many vaccinators realise that these jabs are like no other they have ever given? (I've been writing about vaccines and vaccination for over half a century and these are very different weapons.)

Less than 1 in 100 adverse events in the US is reported. In the UK there had also been 859,481 total adverse reactions. With the Astra Zeneca vaccine alone 192 people had gone blind.
- 8. Over half of GPs in the UK said they would not have the vaccine. In the UK the Government has

- 9. Perfectly healthy children are probably no more at risk of dying of covid 19 than they are of being killed by lightning. No previously healthy child under the age of 15 has died of covid 19 in the UK. Most children have hardly any symptoms.

- 10. Claims for so-called 'long covid' have been wildly exaggerated.

- 11. Even if they get it children don't transmit covid 19 as readily as adults. Teachers are less at risk of covid 19 than other working age adults.

- Rheumatoid arthritis / osteoarthritis / osteoporosis
- Low calcium levels / calcium stones
- Sound and light sensitivity
- Insomnia and sleep apnoea
- Nausea / vomiting / loss of appetite

- Migraines / headaches
- Low serum potassium and parathyroid levels
- Kidney disease
- Potential death from heart failure

Magnesium Benefits

Whilst magnesium is vital to address the above deficiency symptoms, ensuring the body has a plentiful supply can be life changing. My own experience of curing my arthritis is testament to the healing power of this miracle mineral.

Stress / Anxiety

Also known as "nature's chill pill", sufficient magnesium levels restrict the release of stress hormones such a cortisol, and acts as a filter to prevent them from entering the brain. Excess cortisol contributes to anxiety, brain fog, depression, memory loss, insomnia and many other mental disorders.

When the body is under stress it creates stress hormones which cause a cascade of physical effects which quickly consume magnesium.

Another way that magnesium helps to combat stress is by binding to and stimulating GABA receptors in the brain. GABA (gamma-aminobutyric acid) is an inhibitory neurotransmitter that slows down brain activity. When

Heart Health

The most extreme example of chronic magnesium deficiency is a heart attack. When the body's supply of magnesium runs out, the heart is unable to relax its contractions which results in heart failure. This is known in emergency rooms the world over – if a heart attack patient survives long enough to get to hospital, they are immediately injected with magnesium sulphate.

Magnesium helps to regulate heart rhythm, co-ordinating the activity of the heart muscle and the nerves that initiate heartbeat. Low magnesium levels can cause heart palpitations and arrhythmias (irregular heartbeats).

It stops the coronary arteries from having spasms which can cause the intense chest pains known as angina. Magnesium relaxes the muscles that control blood vessels, allowing the blood to flow more freely, whilst helping to equalise the levels of potassium and sodium in the blood.

Brain Boosting

With the highest concentrations of magnesium found in the brain and

the heart, it is known that decreased brain electrical activity is correlated with low magnesium levels. In his book, "Magnesium, What Your Doctor Needs to Know", author Nolan Edwards states, "For maintaining plasticity of synapses, adequate magnesium content in cerebrospinal fluid is essential. Magnesium is used for the proper activity of many enzymes within brain cells that control memory and cellular function."

Long and short-term memory are also reliant on an adequate supply of magnesium. Dr Timothy Sheehan describes the mechanism of magnesium in the brain in his book, "The Oscillating Brain": "Magnesium ions are the 'gatekeepers' between NMDA (short for N-methyl D aspartate) neuroreceptors and the cell membranes. These neuroreceptors are responsible for both short-term and long-term memory. Without adequate magnesium, there is essentially no 'soldiers at the gate' to block the free flow of ions, and this can lead to cell death, and issues related to short and long-term recall."

Supplementing with magnesium might be the most life changing thing you can do right now! The most dangerous side effect is smiling.

Have you taken the magnet challenge?

AS children, we all played with magnets. Delighted to see them jump and spin. To test what they stuck to, and what objects they didn't. And, when we let go of them, no magnet ever stuck to our fingers.

When I first saw a video of a magnet sticking to the arm of somebody, I smiled and quickly flicked by to something of real interest. Then someone sent me another magnet video. I hesitated slightly and moved on to something else. That evening, two friends called me to confirm their findings. Anne had been at a dinner party and had waited until the guests were relaxed on their second bottle of wine before pulling her magnet out. Carl had filmed himself attaching a magnet to the arm of his mother and it had gone viral.

A quick search on the internet found the usual suspect 'fact checkers' debunking this magnet phenomenon - a clear telltale sign of a cover-up. My 'favourite' fact checker of all,

Snopes, had featured Carl's video of his mother, calling it fake. There was only one thing to do - I packed my camera, jumped on the train down to the South Coast to find out for myself whether a magnet would be attracted to his mother's arm, or not.

Carl quickly demonstrated the spot of magnetism on his mother. Even though I was inches away, I asked Carl to take the camera so I could try for myself. Feeling a magnet being tugged out of your hand, by a subtle yet defined magnetic force from under the skin of a living human being, is quite a shock.

Sensing the magnet being repelled, and trying to flip so that the correct polarity was in contact with the skin, was mind-blowing.

We had just established the basics on camera. The magnet had stuck to Carl's mother's arm due to an indisputable magnetic attraction. The fact checkers, including Snopes,

Reuters, the BBC reality check and Fact Check-alongside a multitude of US main stream TV channels—were deceiving the public.

Magnet Challenge - True or False?'

The call out for people to take up the #magnetchallenge using neodymium magnets was working and the videos were appearing on social media from all over the world. Our next step was to take a team to St James Park, London on the day of the 29th of May Freedom protest to ask random people to take part in the Magnet Challenge on film. We were joined by Dr T.

As we were setting up, news came in that the BBC had made a joint announcement with the NHS, calling for the banning of neodymium magnets claiming they were now deemed a risk to children. A coincidence? Maybe. However, we suspected that drawing such flack with such precise timing, confirmed that we were over the target.

Our walk-about challenge within the park caused mixed reactions. Some were near tears, two young Israelis refused to accept the fact staring them in the face and others laughed it off - even if nervously. Importantly, Dr T., a UK trained doctor, had now verified our findings on camera.

Birth - when push comes to shove

BIRTH. The mind conjures images of women screaming in agony, the sound of dramatic midwives shouting at women to 'PUSH', beepy machines, white coats, stirrups, women pushing 'uphill' on their backs, episiotomies and tears. We are told during pregnancy not to smoke, not to drink, not to dye our hair, most pain killers are out of bounds, no sushi or unpasteurised milk. However, the second we go into labour we are pumped full of drugs, told to give birth in hospital as our bodies are no longer trusted to do their job unsupervised. We are connected to machines and experience uncomfortable vaginal exams. We are put on a time scale acceptable for the hospital, experience trauma as a standard and we have become conditioned to think it's normal?

So why has a physiological process become so dangerous? Why on earth do we hear about so many traumatic births? Is birth inherently

dangerous? As an experienced birth worker, I would say a profound no!

It saddens me to see countless women handing over their births to the medical profession. I must stress, we are very lucky to have medical intervention when we need it. For the most part midwives are doing an exceptional job. I am not discussing the hard working birth workers here, only the 'system' in which they work

In my experience I have noticed 3 main reasons why birth 'goes wrong'

- Poverty A rare situation now, most women are well nourished and do not live in overcrowded accommodation where they are prone to infection
- A genuine medical complication This is rare
- Unnecessary medical intervention. - This being the most common reason by far.

The WHO states that if a hospital's cesarean rate exceeds 10% there is no better outcome for mother and

baby. So why do 1 in 3 humans 'need' surgery to be born?

Research is clear. Home birth is safer for healthy women (Hutton et al 2019) In fact we have evidence to suggest that home birth isn't just for the lucky few who manage to tick all the boxes for 'low risk'. Studies show that home birth is also safer for 'high risk' women. (Li et al 2015) and (Halfdansdottir et al 2015)

I must pause for reflection on how offensive unhelpful and even inaccurate this language of 'high risk' can be. For example, being told you are 'high risk' because of your age, is laughable. We must take into consideration that hospital guidelines are as low as 9% evidence based. In 1979 Professor Cochrane stated that obstetrics was the least evidenced based medical speciality. Studies that suggest 'older' women are high risk are based on the assumption that as we get older our health naturally declines. Yes of course this can be true, but to label every woman over 35 'high risk' is insulting. It is more helpful for practitioners to look away from their piece of paper and look at the woman in front of them. A 42 year old yoga instructor with an impeccable diet will certainly not fall into this category of 'high risk' just because she happens

to fall into this age bracket. So ladies, please question everything! It is not up to you to prove your body will work normally, it is up to them to prove it wont! You are not on trial! Needless caesarean sections and inductions, which can cause an obscene amount of trauma both emotionally and physically, are on the rise.

That is why I created 'When Push Comes To Shove'. An EBE award nominated company. Not for profit and soon to be charity. We are here to ensure you are empowered in your choices!

Social media has so many benefits, but one of its downsides - and perhaps one of the many reasons why participation in these outlets is openly encouraged by so many businesses and governments (aside from the purposes of data mining and financial gain) is that it keeps 'the masses' complacent. It makes us feel like we are participating in the issues we feel passionate about when really, all we're doing is sending out a bunch of 'me too' posts that might make us and the post-recipients feel good, but do nothing to remedy any problems or right any wrongs.

These outlets are a tyrannical government's dream! Yes, on the one hand, they do allow us to share

information quickly, efficiently and with little government interference (Twitter and Facebook being the notable exceptions with censorship and algorithm fiddling constantly suppressing anti-government and anti-corporate interest posts), but on the other hand, they keep us in front of our computers and off the street.

In the mid-1800s when the UK Parliament first passed compulsory vaccination legislation, without any media or social media, England organised massive protests which were eventually successful at overturning that draconian legislation which, like today's No Jab, No Pay laws in Oz, unfairly targeted those on lower incomes whilst not touching the wealthy.

In the Leicester rally of 1885, as many as 100,000 people marched in protest to these laws – 100,000 people who found out about the protest and got off their arses to publicly protest against government murder!

Rallies in Sydney, Brisbane and other capital cities last year – with all the benefits of media and social media – only attracted a maximum of 1,000 individuals in each location

– far less the second time around.

Why is this? Why is it so difficult today to get people out of their houses to physically attend protests against injustices which, if allowed to continue, may harm or even kill us? Why are we so unwilling to show up, even when we know that NOT showing up will appear to uninformed outsiders to indicate tacit approval or even support of these laws?

I believe that social media is one of the reasons.

Say it to my face

After speaking with many people who fully intended to come to these anti-No Jab, No Pay rallies last year, but who never actually got there, a single theme appeared. I have paraphrased some of the reasons below:

- 1. I was busy, but I did share it with my friends on Facebook.
- 2. I was afraid to come, but I emailed a couple of people. Did they turn up?
- 3. I am SO behind this event, but I just couldn't make it. I put it out on Twitter and I'm sure lots of my friends would have been there.

4. Great event! Would have loved to have come. I support it 100%. Saw it on Pinterest and did share it with a few friends who I know are on side. Didn't want to have any blowback from my other friends though.

All of these people believed they were supporting the events and the cause. In their heart, they were actively involved in advancing informed choice because they shared information on social media. Don't get me wrong – sharing is important, but it will take so much more than that to overturn discriminatory legislation; to change the minds of an uninformed public, to make people understand how wrong it is to coerce parents into doing something to their child that is not (according to the parents) in their best interests.

- It takes action physical action.
- It takes letter writing not just emailing.
- It takes protests where tens of thousands turn up.
- It takes people getting outside of their comfort zones to speak with friends, family and associates and

explain why they support free and informed health choice.

If, like me, you have been a keyboard warrior who hasn't gotten out much of late, don't despair! That false sense of action hasn't been a complete loss. Sharing information and support is one plank in a vital effort to raise the consciousness of people everywhere about the dangers facing them, their families and their basic, inalienable human rights.

But it is just ONE plank. There is so much more that needs to be done.

Social media can be instrumental in advancing causes and achieving goals. It has brought down governments and informed the world. Without social media, the Arab Spring never would have happened. While it may have started on Twitter, it was only successful because people got out and marched and protested in their hundreds of thousands. We are missing that important final step.

Please don't stop your social media chatter – it's important. But don't feel that it's the be-all and end-all. When the call comes to go to a seminar or a protest march or to visit your Members of Parliament, please do it! Be there in the flesh – and make your voices heard.

What is remarkable about this unique book is the way it avoids the



Infiltration in the protest movement

AN important new book has just been published that shines a light on the erosion of our protest rights with the help of state actors and police infiltration in campaign movements. The Road to Kill the Bill: Standing up for our Rights to Protest by environmentalist Joseph Boyd is a bold and honest expose of all he experienced and discovered during his time on the antifracking frontlines in the north of England, from late 2013 onwards.

Joining protection camps at Barton Moss, Salford, Upton in Cheshire and at Marriot Drilling Company, North East Derbyshire, among others, Liverpool-born Boyd took direct action in the form of slow walks and lock-ons. He was arrested eight times, yet only convicted twice, in his bid to stop the onshore oil and gas industry getting a foothold in the countryside.

He took his fight further than most by opposing a wide-ranging injunction against protest brought by global chemical company INEOS at the High Court and then the Court of Appeal, London. Defending Articles 10 and 11 of the Human Rights Act, the freedoms of expression, assembly and association, Boyd, represented by the

country's best human rights lawyers, successfully defeated the richest man in Britain at the time, Sir Jim Ratcliffe.

But the battle for our human rights didn't end there. Boyd witnessed and closely examined the manipulation and gaslighting of certain people positioning themselves as leaders, as they stifled genuine protest, particularly at Preston New Road, Lancashire. His various legal proceedings revealed that key demonstrations were allowed to happen to create the evidence the courts needed to shut down protest further.

Boyd cleverly highlights how this pattern of corrupt influence has continued with the likes of climate change action group Extinction Rebellion. In 2018 and '19, they were able to shut down London for a lengthy ten days at a time, apparently catching the Met police off-guard, according to Commissioner Cressida Dick. In fact, their actions gave the Home Office exactly what they needed to justify even more draconian police powers and restrictions to our rights to protest in the Police, Crime and Sentencing and Courts Bill.

The Road to Kill the Bill comes at the very time we need it the most if we are to halt Britain's slide into further authoritarianism.

Why did you write this book?

I had to share my story, which many others have corroborated, to show the wealth of clear, detailed evidence I have from my experience on the ground, researching online and in various court cases. It all shows that there is corruption right at the heart of protest movements in the UK steering us into diminishing protest rights. I wanted to reveal the proof that not everyone is who they say they are and to warn that our human rights are blatantly bring eroded and have been for many years, step by step, by change agents.

Are these change agents instrumental in manipulating Non-Governmental Organisations (NGOs) such as Reclaim the Power and Extinction Rebellion?

Correct. They steer these groups with a discourse of consensus and cooperation, which suits wealthy private backers wanting to keep business-asusual with a light greenwashing to appear as if something's being done to protect our Earth. Meanwhile, legitimate grassroots protest, to disrupt unethical businesses and protect the local environment, is stifled.

Until I started researching this more

for myself, I thought NGOs were for the good. In fact, there's a 'revolving door' of mutual support between governments and NGOs advocating for lucrative carbon-offsetting, for example, rather than the radical system change humanity needs to thrive.

As my time in the movement progressed, I became aware of a growing number of people acting on behalf of a climate change agenda, working to change local and national policies and minds on behalf of big international business and finance. These large global institutions do not want radical change, such as developing self-sufficient communities with a decentralised approach, as this gives the power back to the people.

How does this agenda restrict our protest rights?

At one court hearing I witnessed, challenging fracking company Cuadrilla's injunction, a plan was revealed in court to put protestors in a designated pen, like a sheep pen, from where you were allowed to protest. This severely limits people's right to protest in any effective way they choose. We've just seen the same kind of 'managed protest' with a protest pen being allowed in Plymouth Central Park some 76 miles away (nearly a two hour drive) from the G7 summit

in St Ives, Cornwall. It's ridiculous. The more protest is managed like this, the more governments and industries can get away with anything without effective opposition.

What do you want to see happen with the information in your book now?

My aim is to emphasise the importance of personal sovereignty in the challenges that lie ahead. In these strange chaotic times, I want to show that local, grassroots resistance and personal responsibility can and must create the change we need.

I want to inspire others to share their stories to fully expose similar corruption Just as I have, and continue to do, we must all keep questioning what we are presented with by the mainstream media, big business and governments. We are in a precarious position in England, right now, and I hope my story highlights the corruption in even the supposedly most well-meaning of movements and wakes people up in time to stop the slide into Stasi Britain.


