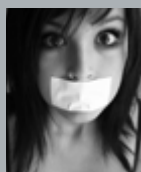

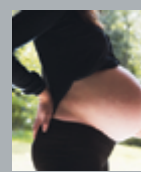

Grand jury investigates crimes against humanity

THE State-Corporation is stripping our rights at alarming pace and it is becoming increasingly apparent that we cannot rely on the government, police or courts to protect our interests or administer justice.

In December 2021, a case lodged with the Metropolitan Police presented cast iron evidence of criminality in relation to the UK's covid 'vaccine' program, but the Met astonishingly announced that its 'assessments found no evidence of an offence'.

This is a stark reminder that nobody is coming to save us — we must do it for ourselves. We can reinstate our sovereign power with knowledge and application of our unalienable rights and appropriate peaceful political action, but we must do this as a matter of urgency.

Taking the lead is the People's Court of Public Opinion (PCPO) - a group of 11 international lawyers and a judge, who, unable to find a court to hear evidence of crimes against humanity, are conducting their own investigation modelled on United States Grand Jury proceedings. It is an investigation of the people, by the people, for the people, and has already held lengthy hearings to showcase evidence of covid-related crimes levied on the world by leaders and their accomplices.

The PCPO seeks to empower public conscience through natural law - that is, the unalienable rights every one of us has at birth. These rights existed before the creation of the state and cannot be removed by legislation.

Natural law confers legitimacy to the people to defend fundamental rights

and freedoms if their state has become tyrannical. It is now clear there is a failure of justice systems to protect the people from tyranny. It is our duty to future generations to resist such oppression and tyranny.

The aims of the PCPO include raising awareness of the impending collapse of hijacked systems, and the actions that we can take to build new systems of education, health care, economics, and justice.

It is alleged that world governments have come under the controlling influence of corrupt and criminal power structures, and the people are to be the jury in this groundbreaking case which is supported by a large number of respected scientists, economists, and medical experts worldwide.

There is extensive evidence of collusion to stage a false pandemic, driven by deceptive statements, unfit-for-purpose PCR tests, and socially-engineered psychological programming

through corporate media and the most expensive advertising campaign ever.

Expert witnesses have given a complete and clear picture of the history and geopolitical backdrop of the current situation, and the future we are now facing.

Attorney-at-Law, Reiner Fuellmich, stated: "Our governments are not *our* governments any more; they have been infiltrated by the World Economic Forum through the Young Leaders program, which began in 1992 and spawned Bill Gates, Angela Merkel, Justin Trudeau, and Jacinda Arden.

Your rights and freedoms are in danger - respond

Sinister reality behind the UK's proposed repeal of the Human Rights Act

THE Human Rights Act (1998) is an 'Enabling Act'. It makes the Articles of the European Convention on Human Rights part of UK law.

The European Convention on Human Rights (ECHR) [https://www.echr.coe.int/documents/convention_eng.pdf] sets out fundamental rights for all European citizens. Among them are the right to life, the right not to be tortured, the right to privacy and the right to freedom of expression.

The ECHR is a multinational treaty, and the UK government has no power to amend it. Spearheaded by Dominic Raab, our government has proposed repealing the Human Rights Act and replacing it with a 'British Bill of Rights'. A public consultation on this is underway.

Behind the appeal to nationalism - the idea that Britons should not have to follow 'European laws' - is a more sinister reality; a British Bill of Rights would be under the complete control of the UK government. Due to weaknesses in the constitution of the United Kingdom, a British Bill of Rights could easily fail to protect our rights.

The Constitution of the United States sets out the foundations of American law. To amend the constitution, a supermajority - more than two-thirds - of U.S. states must vote in favour of amendment. This makes the constitution difficult to change. This is a good thing; any document that sets out the fundamental basis of the legal system and protects people's rights *should* be difficult to change.

In the UK, a ruling party with a strong majority can pass laws with little scrutiny; their Bills are almost guaranteed to pass through the House

of Commons without challenge, and while the House of Lords can scrutinise government Bills, they cannot block laws indefinitely.

A Bill of Rights sets the foundations of law - we need an assurance that something more than the usual lawmaking process will be required to change it. We need to ask what would be required to amend what would effectively become Britain's constitution.

In the U.S., laws that do not comply with the constitution can be declared unconstitutional and struck down by the Supreme Court.

In the UK, the doctrine of 'parliamentary supremacy' means that the UK Supreme Court cannot overturn an Act of Parliament. This means that if an Act of Parliament conflicts with the proposed Bill of Rights, the UK Supreme Court cannot make parliament change the conflicting Act.

The government has expressed a clear concern about its legislation being 'interfered with' by the Human Rights Act (<https://rozenberg.substack.com/p/a-bill-of-rights-search-section-3>) - but if a Bill of Rights cannot 'interfere' with bad law, then why bother with a Bill of Rights at all?

The UK Supreme Court should be empowered to strike down laws that conflict with the Bill of Rights; if they cannot do so then there is no guarantee the Bill of Rights will be applied consistently in practice.

This proposal for a 'British Bill of Rights' is not new - the idea has been making the rounds in Westminster for more than a decade now. A consistent trend in discussions is the idea that the some or all of the rights contained in the Bill should depend upon 'good behaviour'.

This latest proposal includes a 'permission stage' - a person alleging the government has violated their rights will have to prove they have "suffered a significant disadvantage" before they can bring their case. This is dangerous because 'undeserving' claimants might be left without remedy if their rights are violated.

The purpose of a Bill of Rights

is to ensure not just that private individuals respect each others rights but that the government respects the rights of individuals too.

If the government decides who is 'deserving' enough to get permission to appeal to the courts, then the Bill of Rights does not guarantee anybody's human rights at all (<https://rozenberg.substack.com/p/a-bill-of-rights-search-permissions-stage>).

After all, groups that have attracted the ire of government are those that most need their rights protected. Of course claims need vetting, but we need assurances that the 'permissions stage' is handled by an impartial entity that does not represent the government's interests. It certainly should not be up to government ministers.

Some of the questions may be difficult to understand as they are written in legalese. Do not worry - you do not have to answer all of them; you can just give your opinion on issues you think are important, in plain English.

Here are some examples of

questions you may want to ask:

- The Bill of Rights proposal aims to make it clear that "the UK Supreme Court is the ultimate judicial arbiter of our laws in the implementation of human rights". But considering the doctrine of parliamentary supremacy, how will the UK Supreme Court be able to arbitrate such issues? If the Supreme Court cannot overrule parliament, then how can it ensure Acts of Parliament abide by the Bill of Rights?
- The consultation paper portrays the Human Rights Act as a threat to free expression in the UK. Defamation laws pose a greater threat to free speech in the UK than the Human Rights Act - in fact, they are so broad that 'libel tourism' (people coming to the UK just to sue somebody for defamation) is common. How will the Bill of Rights prevent the 'chilling effect' of the UK's overly-generous defamation laws promoting self-censorship?
- The 'permission stage' clause could be used to prevent people from effectively exercising their rights. What procedure will be used to determine if someone has suffered 'significant disadvantage'? What steps will be taken to ensure this procedure is fair and impartial?
- The 'permission stage' clause hinges on the idea that 'frivolous' human rights cases are wasting the courts' time. What evidence is there that 'frivolous' human rights cases have actually placed a significant burden on the courts?
- The consultation paper states that the imposition of human rights obligations upon public bodies has been 'costly'. What obligations have been imposed upon public bodies, and how costly have they been?

Of course, these are only examples of questions you might wish to ask. If you have other questions you should ask those too. Do not worry about making sure your question is in the 'right box' - all responses to the consultation are valuable, so just do what you can.

The truth about ‘vaccine’ harm cannot be stopped

Leaked ‘vaccine’ information raises many questions

INFORMATION leaked from Big Pharma combined with independent analysis of actual vials of ‘vaccine’ have discovered four - Pfizer, Moderna, AstraZeneca and Johnson & Johnson - containing graphene oxide.

Another investigation suggests that small amounts were previously added to 2019 flu jabs and the effects monitored by high tech.

One of the reasons graphene oxide is dangerous is very simple. It is like ground glass, but on a much smaller scale. It will be abrasive to connective tissue and the smooth epithelial lining of blood vessels.

There may be some minor bleeding but more importantly, it will establish a level of inflammation that will prompt an immune response.

Inflammation is the issue. Human biology has many methods for

the removal of foreign particles (insufficiently appreciated by the pharmaceutical industry and the public at large), and graphene oxide will also be removed naturally by a healthy body.

Should graphene reach the lungs it may come out on the breath and become relatively harmless, or alternatively, it may result in the extreme auto-immune reaction called a cytokine storm, which is where the lungs fill with fluid (as with pneumonia) and is now the principle cause of ‘covid fatalities’ in hospital.

Now, many people have a certain amount of sludge in their blood vessels; hard fat, calcium soap and cholesterol. Anything which might add to these deposits would be dangerous for anyone with advanced atherosclerosis and associated hypertension, but for the average person with a modest level of fatty deposit, it could be fortunate.

The nano scale graphene flakes - a few billionths of a metre in width - will get stuck in the sludge and rendered less harmful with

respect to this particular purely physical property.

The potential would then follow for the removal of the offending ‘razor blades’ by natural process, supported by nutritional protocol, over several weeks, making the incidence of inflammation more manageable.

Some of the offending substance may even be wrapped up in molecules of fat and passed out through lymph and bowel.

Glutathione produced in the liver can help with the removal of many ionic substances including heavy metals, and is thought to work with graphene oxide. This is one of many natural substances that can be supplemented to assist with detoxification.

However, there are people who do not have much in the way of fatty deposits in their pipes... for example, athletes. These fitter than average folk are at greater risk post-jab - acutely if they get a shot into the vein.

As the athlete returns to training and competition, raising the pulse and increasing the flow, the nano particles rip the unprotected epithelial

lining to shreds. Suddenly they are prone to acute severe inflammation. Highly active children could suffer this same effect.

Sergio Aguero is among professional footballers who have lost their careers from post-jab vascular events. Tennis player Jeremy Chardy has also been affected.

These are the famous ones - hard to keep out of the news - but there are so many sportspeople who have suffered, and their story has simply not been reported by controlled media. Some lost their lives.

Another fact that has been discovered, by analysis of actual ‘vaccine’ vials, are three distinct variations of content. Some ‘vaccines’ out there are no more than salt water (placebo) with vials and batches covertly labelled.

This may simply be logistics (and fraud) since the production and worldwide distribution of so many vials would be challenging to say the least. But it is just as probable that the priority at this time was to prepare, or train the population, to roll up their sleeve and comply on demand.

Although the entire jab

programme should be treated with suspicion and extreme caution, for it has nothing evidently to do with protection from any contagious illness, at this juncture, it is not yet an attempt at wholesale genocide. A lesser amount is still likely.

It could also just be that elite psychopaths and scientists with a Josef Mengele mindset are being careful with the experiment. After all, if they were to kill too many people too quickly, the game would be up.

It is feasible therefore that some placebo has been in distribution with absolute purpose. This would serve to convince children and parents that there is nothing to worry about. So then you line up for your booster every six months, just like visiting the dentist.

Maybe they have also dispatched some old stock flu jabs, but the intent in any case now appears to be to inject the global population with a regular dose of graphene oxide.

Only a few people know what really goes on at the chemistry plant, but more information will reveal itself in time. The truth will out. So will the graphene eventually.

Why we should reject CBDCs

Repressive laws remain, as does the rulers’ plan for a digital currency

The UK and Ireland have abandoned some restrictions while France and Italy still toughen.

Capitalism fronted by Lynn Forester de Rothschild and Pope Francis, and finally the Central Bank Digital Currency (CBDC)?

A monetary crisis coincided with, and is much more serious than, the pandemic. The economy has been locked down, frozen and many businesses destroyed. Covid did not do this. The plan was laid out in August 2019 at a meeting of central bankers in Wyoming, in which they decided to bail out the richest with massive money creation.

Such a redistribution of wealth is itself a form of tyranny. Repression is essential if you are taking people’s wealth, removing their rights and shifting them to a ‘new normal’, especially if that involves telling them that the pensions and social security, to which they contributed for 40 years, are not going to pay out.

Subjugation lies on a train line. At the last stop you will simply be killed, or worked to death. One stop before that, you will own nothing and you will be happy. That’s the plantation. Another station prior to that is the reservation, where you will be free to do the available jobs, and earn vouchers at the company store.

That is the CBDC. The only law now is the law of unintended consequences.

Governments are insolvent, in that their liabilities far exceed assets. They cannot meet pension obligations. While the petrodollar survives, governments can keep flooding the system with ever-bigger numbers. But those big numbers tell you something’s afoot: it has no value, or they wouldn’t have to print barrowloads of it just to stoke the engine.

They have known this for 20

years. They tried to get rid of anybody with a claim on the social security system. If they could remove those with a claim on treasury bonds they could keep the banking cartel afloat. They attempted to reduce the population, starting with the pensioners. They have bungled this attempt at a psychopathic solution.

The banking system is in a crisis that could take down all of us. Not the bank that holds your salary or issues your credit card. The one that lends to governments - in which the banks create money, lend to governments, who tax the people to pay the interest back to the banks. Those are called central banks and most of them are privately owned. That is important because private institutions answer to their owners, not to you and not to the government.

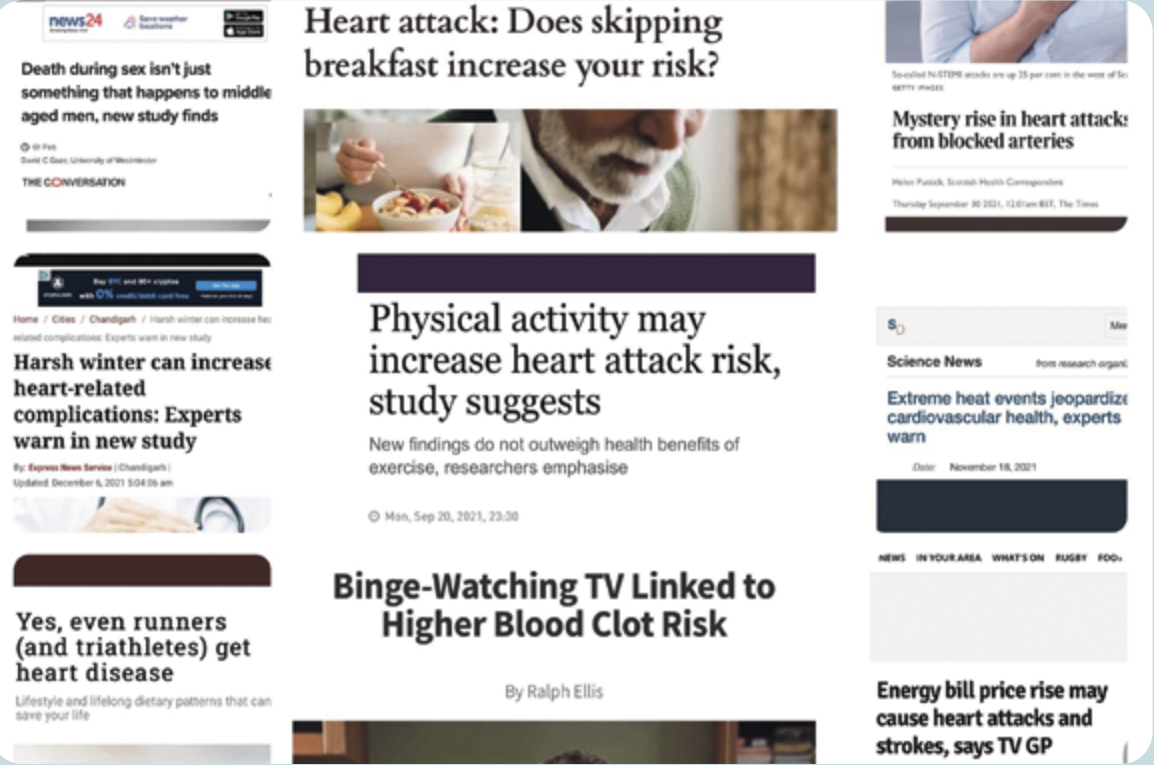
A few paragraphs ago I mentioned CBDC. That’s right. A private body would issue you with credits, that

might expire each month. It would be linked to your digital identity, which will come with a social credit score. If there is a recession, the bank would add credits to your account; if inflation, take them away. It would not be money as you now know it. It would not be a store of wealth; more like an allowance.

By ending the petrodollar economy, the resource wars do not disappear, they just move to new locations and minerals. The nature of war changes, to become permanent, hybrid, cybernetic - directed less at foes abroad and more at the domestic population.

The world’s biggest industries and sources of wealth are drugs, slavery, war and energy. They are becoming more important, not less, and their impact will be felt not just in the badlands and back roads but the towns and cities near you.

Media gaslighting on heart problems and blood clots



FROM extreme heat to shovelling snow in the extreme cold, to sex toys and skipping breakfast... even heart attack preventing exercise is now being rebranded as a risk.

Anything and everything seems to be the cause of heart attacks. Except one potential cause, that seems largely absent from the news - the covid ‘vaccines’.

Cardiologist Dr. Aseem Malhotra posted a selection of these headlines on Twitter saying, “I’m a cardiologist with over 20 years experience. I’ve published articles in high impact medical journals shifting

the understanding of how heart disease develops. Most of the media headlines are BS - either coincidental or deliberate distraction from the real cause”.

Back in November Dr. Malhotra appeared on *GB News* discussing research that suggested covid vaccines increased inflammation of the coronary arteries that could potentially increase the risk of heart attack in one group of patients from 11-25%. Malhotra mentioned that he was also contacted by a whistleblower from the British

Institution’s cardiology department. Researchers there had also made similar findings, but had apparently decided not to publish them because ‘they are worried about losing money from the drug industry’.

Malhotra also said: “anecdotally I’ve been told by colleagues that younger and younger people are coming in with heart attacks.”

In the latter half of 2021 there were almost 10,000 excess non-covid deaths, a significant proportion of which were from heart attack and stroke. There was also a 30% increase of people dying at home - according to Dr. Malhotra, this can often be due to cardiac arrest.

Welsh sex education curriculum faces court challenge

Case is being brought for the sake of childhood innocence

IN 2017, the government of the UK unanimously signed an agreement to deliver a new form of sex education into schools.

It has various titles throughout the country, *Relationships and Sexuality Education* (RSE) being one of them.

The arguments in favour of overhauling the previous curriculum seemed convincing; after all, which caring parent would not want to educate their child about the potential harm of sexually transmitted infections, unwanted pregnancy, the dangers of pornography and the onset of radical physical and emotional changes that puberty brings?

The same would apply to discouraging a child from discrimination against others.

So, what could go wrong with such a well-meaning and comprehensive educational tool? In theory, nothing. Parents should be able to fold their arms and feel confident in the educational process, relieved that much of the information they have passed on to their child in this regard will be sensibly and effectively fleshed out by the teachers they know and trust.

Unfortunately, despite its recent introduction, there have been grave concerns expressed in the UK and Ireland, and there are growing numbers who have been shocked by the explicit nature of their child’s syllabus and by the diminishing rights of parents to defend their own values.

A stark illustration of this would be the recent announcement that Scottish children as young as four are now able to choose both their name and gender in school without their parents being notified.

One group among many who have

been vociferous in their opposition is Public Child Protection Wales (PCPW) which is spearheaded by criminologist Kimberley Isherwood, who is well-qualified in the safeguarding of children. She and her colleagues have relentlessly pursued those responsible in the Senedd for answers and accountability.

Despite achieving a target of 10,000 signatures on their petition, and appealing for transparency and civilised debate in a series of emails and Freedom of Information Requests, their concerns were batted away by the Senedd like annoying flies.

The women of PCPW had peeled the RSE onion and had discovered that its roots appeared to lie in a policy emanating from the UN and the WHO rather than from Wales, and that consequently it would be more appropriate to call it Comprehensive Sexuality Education, which is the name the NGOs endowed it with.

Furthermore, Isherwood could spot areas in the WHO curriculum that could be described as ‘models of offending’, that is, the kind of behaviour or language a sexual predator might use in order to perpetrate a crime. Some might call it ‘grooming’.

That is just one cause for concern, and anyone who takes the time to read the document will find more. By now, the Welsh Senedd has stated that the sexual education curriculum will be implemented in schools from September, with no parental opt-out.

Desperate times call for desperate measures, so to this end PCPW are being represented by a barrister, Paul Diamond, and aim to take the Welsh government to court.

Paul is staunchly committed to protecting human rights (his mother having arrived in the UK by way of the Kindertransport), and he has the track record to prove it.

He is perhaps better known for the ‘BA cross case’ in which he defended a worker’s right to wear a cross and chain in the workplace.

He is also heavily involved with Lawyers for Liberty. The court case could, if unsuccessful, attract crippling costs. Their website has a donation link for anyone who wants to support them and a wealth of resources for those that seek more evidence and information.

We only have one shot at this, and for the sake of childhood innocence, this needs to be a seminal case in legal history.

Police may be committing perjury and even treason

The 'policing by consent' philosophy sustaining our democracy must not be abandoned

WITHIN this manufactured crisis, we have witnessed disturbing actions undertaken by the government's phalanx of underling enforcers, whether controlled directly or indirectly.

The Police Federation's own publication available to all their staff titled, 'The Office of Constable the bedrock of modern-day British policing' states on its opening page: "Every constable is an independent legal entity; the public's guarantee of impartiality..."

Page two of this document further explains: 'On appointment each police officer makes a declaration to "faithfully discharge the duties of the Office of Constable". Further stating: 'Each sworn constable is an independent legal official and each police officer has personal liability for their actions or inaction.'

'It is from the Office of Constable that each officer derives their powers.' Here is clear reference to their expected behaviour, obligations and



responsibilities, plus reference to the combined role of being a lawfully operating constable plus a legally-empowered corporation police officer. The underlying Office of Constable must remain untainted as the base from which the derivation takes place to then provide for policing officer powers.

THE CONSTABLE OATH OF OFFICE

'I...of...do solemnly and sincerely declare and affirm that I will well and truly serve the Queen in the office of constable, with fairness, integrity, diligence and impartiality, upholding fundamental human rights and according equal respect to all people; and that I will, to the best of my power, cause the peace to be kept and preserved and prevent all offences against people and property; and that while I continue to hold the said office I will, to the best of my skill and knowledge, discharge all the duties thereof faithfully according to law.'

THIS OATH CONTAINS ABSOLUTES. TO BREAK AN OATH IS AN ACT OF PERJURY.

Continuing, the Act of Union 1707 - Article 4 contains absolute rights to unhindered travel unless otherwise expressly identified within that Act.

It states: 'That the Subjects of the United Kingdom of Great Britain shall from and after the Union have full Freedom and Intercourse of Trade and Navigation to and from any port or place within the said United Kingdom and the Dominions and Plantations thereunto belonging. And that there be a Communication of all other Rights, Privileges and Advantages which do or may belong to the Subjects of either Kingdom except where it is otherwise expressly agreed in these Articles.'

Please note the following points:

- 1 Refers to 'subjects' and not 'persons'.
- 2 Refers to 'United Kingdom of Great Britain' as a geographical not a PLC (i.e., in capitals).

- 5 'Any port or place' is an absolute.
- 6 'Thereunto belonging' refers to rights already existing and is an absolute.
- 7 'Thereunto belonging' refers to existing common law rights and privileges as an absolute.
- 8 'Except where it is 'otherwise expressly agreed' is an absolute.
- 9 'In these articles' defers to no other law, regulations or guidelines and is an absolute.
- 10 'Communication of all other rights, privileges and advantages' is an absolute.
- 11 It is the foundational document for the UK plus the basis of the Crown's authority.
- 12 It is a recognised internationally treaty and remains unamended and an absolute.
- 13 A constable oath of office is to uphold the law and is an absolute.
- 14 A constable oath of office is vitiated if the absolute of upholding law is violated.
- 15 A constable oath of office is to serve the Queen and is an absolute.
- 16 A constable oath of office is vitiated if the absolute to serve the Queen is violated.
- 17 A Crown organisation, individual or servant that violates this article is potentially treasonous.
- 18 Any Crown organisation that violates this article vitiates their authority.

Is the tail wagging the dog when it comes to scientific advisers and government policy?

Should the public really be following the science when science is following the money?

AT the beginning of the pandemic there was a clear mantra coming from the government when it came to justifying their draconian decisions - follow the science.

In Prime Minister Boris Johnson's statement on coronavirus (18 March 2020), he said that they would 'follow the best scientific advice'. Former Health Secretary Matt Hancock also described how UK government policy was 'guided by the expert recommendations' of the Scientific Advisory Group for Emergencies (SAGE).

In April 2020 Tom Peck, political writer for the *Independent* argued that the repetition of the 'led by science' slogan ran deeper into 10 Downing Street, with 'every single senior member of the government' singing off the same hymn sheet.

However, a research article in *Frontiers in Political Science* argues that when UK government ministers state that their covid-19 policy is guided by the science, what it really means is that they are guided by scientists. They go on to say that their analysis of SAGE minutes and meeting papers shows a high consistency between SAGE advice and subsequent government policy.

In contrast, SAGE claims that they simply provide coordinated scientific advice and that this advice does not represent official government policy. Furthermore, their advisors are 'leading specialists' cherry-picked to suit the emergency at hand. In theory, this should mean that the expert advice is impartial, transparent and suited for the situation.

But just because the experts are hand-picked for the job, doesn't mean they are they right people. A case in point is that SAGE chose to round up four times more modellers/statisticians and experts in behaviour manipulation on the committee than virologists, and employed no immunologists.

One of the modellers, Neil Ferguson, was part of the Imperial College Covid-19 Response Team that predicted 510,000 deaths in the UK. The somewhat pessimistic and wildly inaccurate computer coding led to stricter measures being introduced, including the first UK lockdown, rules which Ferguson himself broke and led to his resignation from SAGE.

Nevertheless, the main driving forces behind SAGE - Chief Scientific Adviser Sir Patrick Vallance and England's Chief Medical Officer, Professor Chris Whitty - seem to

be bigger advocates of behaviour manipulation. They were frequently seen showcasing doomsday graphs to the public; Vallance claimed the virus was doubling its spread every week, and that if this continued, there could be 50,000 new infections a day during October 2020.

A report published by the NCBI showed how a group of behavioural and social scientists advising the UK government on covid-19 advocated the application of the Behaviour

Blind eyes are still turned to gang rapes

Suggest cultural and religious attitudes towards women are to blame and you are labelled 'racist'

ALMOST a decade ago, a staggering statistic was revealed in Norway. A series of extremely violent stranger-rapes had been reported in the capital Oslo, and all of them had been committed by 'non-western immigrants'.

Such was the alarm, that Norway began to offer voluntary classes to just such immigrants, pleading with them not to rape Norwegian women.

They sought to teach these men (and almost all such immigrants are men) that attitudes to women vastly differ in Norway than in their home countries.

In doing this, Norway acknowledged something very important; that attitudes to women are so awful in many countries that men grow up feeling entitled to rape women who dress a certain way or who frequent the public sphere unaccompanied.

Norway also acknowledged something else - that in allowing such immigration to continue, it was knowingly putting its own women in danger. The same is true for the UK and Ireland.

It is not easy to speak about these things. The automatic response from so many is to shout 'racist', but there is nothing racist about recognising cultural difference. It is not about skin colour, but culture - that is the starting point.

For many years, I have investigated the misogynistic cultures that have been arriving in Western countries over recent decades, and the inevitable

consequence. That consequence is rape. That consequence is rape that would not have taken place without the immigration. That is the truth, whether it is comfortable or not.

In Telford on January 29, I joined Tommy Robinson as he revealed the extent of this rape in that town. In his documentary *The Rape of Britain*, Robinson showed us the scale of the abuse, and the corruption that allows it to continue.

Police have known about rape-gangs - made up almost exclusively of Muslims - in Telford for 40 years. They have done nothing about it.

This story has been repeated in Rotherham, Rochdale, Oxford, Bradford, Leeds, Newcastle, Birmingham, London... the list goes on and on.

In *The Rape of Britain*, serious allegations about pay-offs to the police were made, but this goes even higher. Labour councils are known to have turned a blind eye to this for years, and the Tory government has done nothing to stop it either.

In researching my book *Beyond Terror*, I spoke to women who have worked in rape crisis and domestic violence centres for decades. They told me of the high incidence of rape committed by immigrants mainly from Muslim countries. They told me also of domestic violence. One said, "For every white woman, there were about eight Pakistani/Bangladeshi women. Violence towards women in those communities is normal."

This woman was on the political left. She said that at the time they blamed everything but the cause. They blamed austerity, Margaret Thatcher, poverty, everything except cultural and religious attitudes towards women.

In 2016, in the wake of the *Jay Report* that revealed that 1,400 girls in the town of Rotherham had been raped and prostituted by gangs of Muslim men, I spent the year trying to find out how many girls had suffered this appalling fate.



I found that police kept no accurate records, nor did local councils, and there was a veil of petrified silence keeping these crimes under wraps (you can read my report at www.forbritain.uk/storm). People were, and still are, so petrified of being labelled racist that they are willing to turn a blind eye to torture of often very young girls.

In Telford, this was repeated. A counter-protest organised by so-called 'anti-racist' groups, as well as trade unions and others, held up placards calling Tommy Robinson a 'racist' and 'fascist'. On social media afterwards, they called me the same. They do so matter-of-factly, as if it is true.

There is nothing fascist or racist about recognising the truth. This is the truth; the Western world has opened its doors to cultures, largely inspired by

religious teachings, which are simply incompatible with women's rights and freedoms. Western women are paying the price.

Those who oppose myself and Tommy Robinson on this will argue that white men rape too. This is true,

but why are we knowingly, as Norway did, inviting more and more rape to our society? We know it will happen, and we continue the immigration regardless. We do not punish offenders either.

In Cologne on New Year's Eve 2015, more than 1,200 women were assaulted and only two men were ever punished. Nobody was deported from Germany despite the fact that these assaults were carried out by recent immigrants.

In Telford, 200 men were reported to police for these crimes and only ten were charged. Men convicted of rape in Rochdale served short sentences and remain in the UK years later, despite being issued deportation orders. They used taxpayers' money to fight deportation (victims do not receive any help) and still wander freely around Rochdale.

January 29 was a day to show our disgust. We are tired of these horrors carrying on with impunity, and we are tired of those in authority covering up the truth.

The day was a huge success. When I arrived at the meeting point, thousands had already gathered and we led a peaceful (but loud!) march to our destination - a large screen set up to show Tommy's documentary.

It was peaceful, it was pleasant and it was powerful. Needless to say, the mainstream press turned a blind eye, just as it has turned a blind eye to gang-rape for decades.

It must stop. We must be open and honest about this. If what I say, or what Tommy Robinson says, is not true, then why the censorship? Why not allow open and honest debate?

Nobody, least of all me, is suggesting that Islamic culture is uniquely problematic for women, but we must ask ourselves why so many rape gangs, across Europe, are comprised of Muslim men.

It is well known that the treatment of women in countries like Saudi Arabia, Pakistan, Afghanistan, and Iran are among the very worst in the world. We must ask why this is, and we must be honest about the answer.

Politicians in the UK have got this all wrong. Sajid Javid, when Home Secretary, promised an inquiry in to these notorious 'grooming gangs', but he looked at race, not religion. The evidence does not reveal that these gangs are of the same race, but they are of the same religion. That very religion continues to be excluded from discussion. If we do not have that discussion, if we cannot ask these questions, the truth can never be revealed.

Soaring electricity bills will continue to shock us

UK is paying the price of repeated failures over energy policy decisions

TO understand recent events, where crippling energy costs are being inflicted onto consumers, we need to examine the past decade, if not the decades before.

What has happened recently was predictable and also avoidable, had there been sound government policy in place. The premature closing of most coal power stations was foolish as stocks of winter coal would normally be available.

UK gas storage is at critically low levels in comparison to continental practice. There had been several events when the slender backstop of restricting gas supplies to industry had occurred, so experience had been ignored.

Safety constraints for the domestic consumer prevented further disconnection, leaving only gas turbines as being an unwanted last resort. Coal should never have been rejected.

The absurdity of conversion to burning wood had seen 1GW of capacity lost through fire risk, having a similar amount diverted onto the most recent coal-fired power station at Drax.

Energy policy really began to unravel with measures introduced by Ed Miliband in the decade after the millennium with the introduction of renewable subsidies.

Change came in the past decade when the Renewable Obligation was replaced by a Contract for Difference regime that enabled a more proactive policy to be implemented.

It was when the May administration came to power that it failed to promote tidal storage, a means of avoiding constraint payments as well as providing essential inertia to the grid system (it would also have given immediate balancing support for grid system frequency control).

In addition, gas storage failed to be supported by government, nor was there any prospect of refurbishment with coal-fired plants.

By failing to promote these measures it became inevitable that substantial interconnection to the continent was

necessary, thereby embedding the GB system into the very much larger continental grid system.

We are now reliant on the continent for meeting peak demands on the grid. The critical requirement for interconnection is to absorb the scale of installed wind capacity on the grid system at times of minimum demand, otherwise constraint payments become a regular feature.

The new Brexit administration came under Andrea Leadsom's stewardship giving three promising announcements. First, the promotion of Small Modular Reactor (SMR) nuclear technology that fortunately is still in place. Second, delaying approval for a Hornsea offshore wind farm and third, the promotion of a gas turbine installation at Drax power station.

Following her elevation to the House of Lords these last two decisions were reversed by her successors. The long-term consequences are now being much reinforced under the Net Zero programme.

Consequently, reliance on interconnection has become embedded. System balancing becomes an imported service with dual control, stimulated by ever-expanding intermittence from wind resource.

The sustained role of gas turbines for replacing fickle renewable resource is essential, now coal has almost become discarded. The operational life of dispatchable gas turbines is half of that for coal where the initial 20GW of installation following privatisation, due for replacement by 2025, has already begun in earnest.

The near absence of new gas turbine installations over the last decade is significant. Even up to 2015, half of installed generation capacity came from nationalised investment, and today most of the remaining legacy is with nuclear AGR power stations, due to close by the end of this decade.

Electricity supply has an essential characteristic of security being a highly brittle commodity. Electric power is generated immediately on demand.

Security for any power engineer is an essential constraint but understanding what this means is not a discipline held by those making the decisions. Private utilities are no longer accountable in any long-term sense as the scale of state-driven subsidy has removed this responsibility.

Over the past decade all generation supply has been driven by state decision. It has become much worse, as now a fifth of our bills cover green subsidies and social payments - items that should properly be made through general taxation and thereby being subject to parliamentary scrutiny. This structure is a legacy from EU membership, yet nothing has happened to rectify this serious anomaly.

A decade ago, peak demands on the GB grid system were at 60GW. Now that figure is at 45GW and is a consequence of electricity prices doubling over that period. That is the principal factor why consumers have not had to face power shortages as since 2013, Ofgem have declared insufficient capacity margins to cover

peak demands.

While there is no provision for conventional dispatchable generation, government policy only promotes wind resource yet at the same time, further electricity demand is inevitable with the push for electric cars and home heating. Such policy makes any household entirely reliant upon electrical supply.

Increasingly, power supply is becoming more insecure and vulnerable to foreign events.

The recent announcement to develop 25GW of Scottish wind resource is a clear indication of this mindset. For the jobs created we might as well build pyramids. Without doubt we would embed the UK into Europe; that would be the opposite of what Brexit was about.

What are the implications behind this decision? Such a scale of power transfer would demand a corresponding capacity with transmission infrastructure yet having a significantly lower utilisation factor.

Currently, Scottish consumer demand has a peak below 5GW and a cross border capacity of 3.3GW, to include an unreliable undersea cable link of 1GW. This needed infrastructure produces no power and is there just to move peak power out of Scotland and then there is the cost of accepting this power transfer in England and beyond to the continent.

As for transmission losses it would join the merry go round of circular transfers between the nation states of Europe. This investment would transgress the basic principle of siting

generation at the point of demand.

On January 29, storm Malik broke the wind supply record with 19.6GW of wind generation which is 78% of the wind portfolio. How many wind turbines were disabled?

Any investigation of faults has serious problems, especially offshore in winter. The level of bulk transmission would become a compromise with installed capacity, establishing constraint payments as a permanent feature. Technical advances are introducing a much higher range of output for wind turbines that would be above the current capacity of existing vessels - a certain indication of future delays.

By now it should be clear that there is a serious failure of energy policy, where the state has interfered on such a scale so as to deny any prospect of private initiative being able to relieve the situation, at least in the short term.

Generation supply takes years to develop, so the position can only become worse although some relief may come *if* fuel costs stabilise.

What might be a source of optimism is the development of nuclear SMR technology, although it is unlikely to be available on any scale this decade.

Renewable hysteria has been a disaster for Europe, and the UK should have had the courage to make its own decisions to develop its own resources and reverse current energy policy. Sadly, politicians have followed a media narrative that is international and unless this changes, living standards can only continue to decline. The lights will go out at some point.

Former X Factor winner and Corrie star SEAN WARD tells of his struggles after speaking out against covid injections

TWO years after a long deliberation I decided I could no longer stay quiet. I raised my head from the trenches and joined the ranks of those many would consider 'conspiracy theorists' and tin foil hat-wearing fools.

I stood my ground, did my research, spending hours and hours reading peer-reviewed studies and following data happening in real time. I tried to track adverse reactions around the world - connecting with people from Australia to Japan.

I opened my inbox to anyone struggling, was always available to help 24/7, and still am.

For over a year, I spent all day, every day on Instagram messages, debating and trying to show my findings to anyone who would listen. I made myself very ill taking on other people's problems, such as someone's depression or feeling alone at home in all this. Or the fear that by posting such outrageous information I was responsible for innocent deaths - which many people have accused me of, as well as having a God-complex and doing this all for my ego.

I travelled from Manchester to London every month for over a year, spending all my savings on supporting the movement and protests and meeting some of the most incredible people.

However, no one really knows how much this has affected me and I want to try and explain just a little of the things I've gone through. Firstly the work dried up. No one would hire me. Whether in front of or behind the camera, all my usual ways of making money just stopped, and eventually I couldn't afford my rent.

So I gave up my four-bedroom house and moved onto my friend's couch. I had to put all my belongings into storage. After a while, I couldn't afford to pay the storage bill and after four weeks of missing the payments - equating to about £500 - Safe Store UK sold all my belongings. My sofa, my bed frame, my office equipment, desk, chair, wardrobes, mirrors, all my coats and clothes and my projector. Everything to fill a full family house.

My whole life was in that storage unit. I lost it all.

I was devastated but couldn't ask anyone for help because it was my choice to speak out. Luckily, I got my mattress out in time and I've been sleeping on that in a friend's spare room for over a year now. I can't thank him enough. He has given me a safe space when I really needed it. I haven't paid any rent to this man. And it makes me extremely tearful when I think how amazing that actually is. You know who you are and I'm eternally grateful!

Again, I accepted the loss and I pushed on. A few months passed and I now couldn't afford to keep my car. My Honda Civic (my beautiful Jenny) was taken and destroyed by the DVLA. Again, my fault for not being on top of my own shit, but it's because I didn't care about myself or my life.

So no car, no belongings, no hope. But I kept pushing on.

Then the stress mounted so much my teeth began to fall out. I lost so much weight, I was mentally drained and felt so lost on my own. Was it all worth it? Yes! If I've saved one life then, yes - it doesn't end there though.

Then the wonderful BBC (my biggest employer for the last seven years of my acting career) decided to commission a documentary about me. They harassed my sister, asking her to come on the show to speak with the BBC's very own 'conspiracy agony aunt' to help me with my 'delusions'. They implied that I'm suffering from mental health and even celebrities can fall down rabbit holes and lose touch with reality.

They found my sister on Facebook, somehow found her work, and sent lengthy emails trying to get my own family to discredit me on national TV. I was heartbroken. Luckily my sister is on my team and would never sell me

out, but it felt like a personal attack and bringing my family into it made me extremely angry.

All I have ever tried to do is create a safe space for people to discuss their concerns and/or their fears of being called crazy.

The press published articles about me saying I'll never work again. The police arrested me and that was front page news.

It's really been hard for me, and when people say 'thanks for speaking out it means so much', but it's come at a steep price for me. I'm not hiding this reality any more; I need support and I need help to move forward with my life.

I've set up @onlyfactstelevision and plan to work really hard to build a new life for myself. I want to go to every major city and speak to people on the street. We need genuine public opinion now to push this shitshow over the edge. If you can support me in any way then please let me know.

I want to keep helping people, as the clean-up of this mess will be even worse than the last two years we've all endured. Thank you for reading all this, it really means a lot. I can't lie, I'm knackered; we are all in this fight, and I can't and won't stop.

I've always used my social media to show the reality of my life and remove the veil of deceit that comes with these apps. Life is fake. Social media even more so, and now moving into a metaverse it's going to be even easier for people to lie and cheat and delude themselves into pretending their life is something it isn't, while sitting alone, deep in depression, projecting the dream.

We all need to do better. We all need to be braver and stronger and support each other. It's not weakness to admit everything isn't perfect. And you're not alone because we all feel the same way. Thanks for all the love and support.

A call from the wild

AS an intrepid explorer of health and wellness, my findings often lead to the same conclusion: the human body is an astounding life form.

It is time to view yourself in a renewed light, one that forms a new foundation for what really counts as health.

Research has made it clear that the symbiosis you share with the millions of microorganisms within and around you is integral to life itself. According to Carolyn Bohach, a microbiologist at the University of Idaho (U.I.), there are ten times more bacterial cells in your body than human cells. However, as bacterial cells are much smaller, they'll fill about a half-gallon jug!

It is undeniable that human function is interwoven into the tapestry of nature's diverse array of organisms, a crucial connection that many have lost in everyday living. Modern life has seen us divided and reduced, packed into concrete boxes, watching boxes, becoming more separated from this green life-stream. Social engineering has left us self-centred and far removed from the interconnection we share with all life.

It is sheer arrogance by biotech corporations trying to decide for us what constitutes human function, banging hammers and chisels into our DNA, trying to outdo the nature of life itself.

How can the sound of woodland leaves or the salt-scent of the sea be so delicately tuned to our senses if we hadn't grown and evolved with it?

Forest medicine expert, Dr Qing Li, conducts his own research in his book *Shinrin-Yoku: The Art and Science of Forest Bathing*. He describes the scent when walking through pine trees as phytoncides, or the natural oils within a plant or tree. These are released as part of the defence system of trees, as protection against insects, fungi and bacteria, and they vary between species.

One of the best ways to examine the health of our immune system is by observing the activity of our natural killer cells (NK). These are white blood cells that destroy unwanted cells, such as virus or cancer cells, helped by anti-cancer proteins. People with a higher NK activity have less disease.

Dr Qing Li found after three days and two nights in the forest, NK activity increased by 53.2%, NK cell numbers increased by 50% and the anti-cancer proteins present increased significantly.

His further studies revealed these effects lasted as long as 30 days.

Exposure to these wonderful phytoncides has also been shown to decrease stress hormones, increase sleep, improve mental health and lower blood pressure throughout various studies.

When the scale and scope of our true nature opens up, suddenly the practice of popping pills for health seems insignificant, and rather it is the very environment we are part of that defines how well we function.

We find ourselves at a fork in the path. One that will take us deeper into a virtual existence, further away from our true nature, or one where we consciously and resolutely define what it means to be human and what must be preserved.

There is an urgency to define mental and physical boundaries regarding how much we allow Big Tech to infiltrate the human experience, shaping our moral code of ethics.

If you were to step into a parallel universe, what other ways of living do you imagine are possible? What should your Earth experience look like? Let's design our living spaces with permaculture, forest gardens, edibles and medicinal plants. Tech can be steered in so many other directions for the collective greater good of all life.

The alternative could be having no health choices over your own body. Smart cities will mean not being permitted to live in the country, be close to nature or even grow your own food. Will you lose the right to even know what's being injected into your own body?

On January 22nd, *The Exposé* reported worldwide data suggesting fully vaccinated Americans, Brits, Canadians and Germans are developing Acquired Immunodeficiency Syndrome. It suggests people who have received two shots are showing signs of immune system degradation.

Isn't the innate immune system the most incredible biological intelligence we already have?

Real health is flow; a fluctuating balance with our environment, a dance at a cellular level to sound and frequencies, one where we partner with the organisms that move through us and with us.

Let's dance again. Nature's wisdom is waiting for us.

Silence of our artists is deafening

Art can heal through showing and mocking the absurdities that have been forced upon us these past two years

WHEN the plandemic began, I became an activist because I felt knowledge of the fraud comes with the responsibility to attempt to spread the truth.

As a trained artist, this has always been one of my motivations, as beauty is the manifestation of truth from nature.

From the outset I found that most of my artist friends did not share my convictions at all. This was extremely shocking. Straight away I was evicted from my studio community in Hackney because someone in the management saw a photograph in the newspaper of me in a group hug at one of the first protests in May 2020.

In response to this sickening culture of cancellation and silent compliance, I have decided to curate an art exposition about the blatant lies of the alleged pandemic.

This group show will be called *The Cure is Worse Than the Disease*. It will be opening for a week only on May 11 in the Secret Art gallery, London.

As soon as I got going with my own activism in 2020, it was not long before I met Piers Corbyn and started to volunteer my time for his group *Stop New Normal* with my main focus being creative tasks due to my fine art background.

I made the two-metre big sculpture of the syringe that was taken to the London protests, and the giant iPhone vaccine pass that was taken to Wembley during the government's first beta-test of vaccine passports.

Last year I made a drawing of the Auschwitz gates, which read "vaccines are safe path to freedom". This was published on the back of some leaflets giving informed consent about the real risks of the mRNA injections.

At the behest of a Twitter storm which soon ensued, I was violently arrested in my own home.

Accusations of antisemitism and hate crimes were laid at my door by the establishment. What was never acknowledged in the mainstream was the intention of my drawing, being a warning from history to never allow again the horrors of medical experimentation which took place during the second world war in concentration camps upon specific ethnic and religious groups.

The recent targeted advertising of the mRNA needle weapon towards people of black and Asian backgrounds which I see every day on huge billboards on

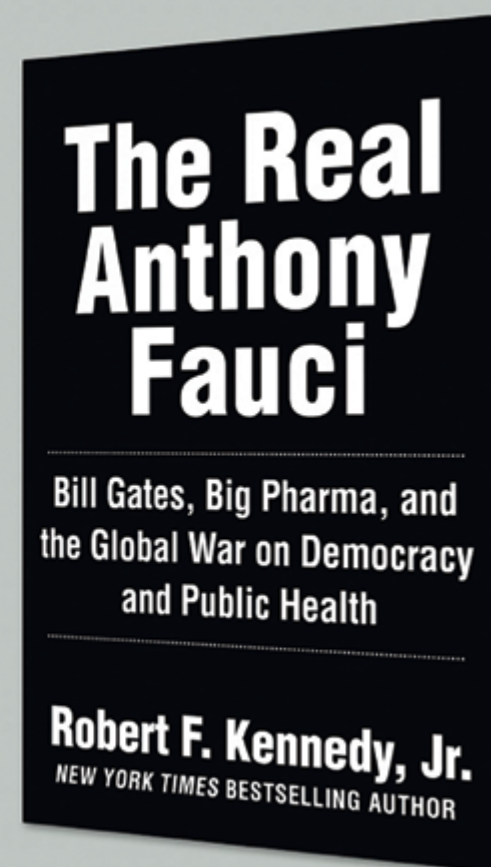

Dr Fauci's largesse' and organisations including the Association of American Physicians & Surgeons, the Front Line Critical Care Alliance, and America's FrontLine Doctors, galvanised to repurpose long-established drugs to intervene at the onset of symptoms, to slow down the virus and enable patients to recover before they needed hospitalisation.

Exchanging information on successes and studies with other doctors around the world, they built networks and information banks outside of the government agency and university hegemony. Foremost among the readily available repurposed drugs were Hydroxychloroquine (HCQ) and Ivermectin (IVM), but for Emergency Use Authorisation to be granted for a highly experimental injectable there had to be no alternatives, no therapeutics, no cure.

Dr Fauci had invested years and six billion taxpayer dollars in the Moderna vaccine. All effective therapeutics had to be suppressed, discredited and eliminated.

The book catalogues peer-reviewed observational studies by physician researchers in multiple countries on the benefits of HCQ in dramatically reducing mortality from covid.

It costs less than \$10 for an entire course and is quick and easy to manufacture. It explains that a standard treatment dose is 400 mg per day administered within five to seven days of symptoms.

In response, Dr Fauci, Bill Gates and the WHO finance a series of studies by mercenaries using fraudulent protocols of 2,400 mg on Day 1, and 800 mg per day thereafter, resulting in the deaths of elderly patients from toxic overdose and enabling Dr Fauci to declare HCQ

'dangerous'; a therapeutic drug used all over the world for 65 years, including in the U.S. for a variety of illnesses.

Dr Fauci mandated treatment with Remdesivir, costing \$3,000 per course and manufactured by Gilead Science in which he has a large stake.

Remdesivir has a catastrophic safety record, causing extreme toxicity to lungs and kidneys, and many doctors believe covid deaths were indistinguishable from Remdesivir overdoses.

Detailed research and studies of the benefits of IVM in the combat of covid, both as a prophylactic and therapeutic, are provided; a medicine considered on a par with penicillin and aspirin for its impact on the health of hundreds of millions of people for its versatility and safety. A campaign to suppress and outlaw IVM ensued.

Dr Tess Lawrie, a world-renowned scientific data researcher dubbed 'the conscience of medicine' for her competence, precision and integrity, dispatched an urgent letter to Matt Hancock on January 4, 2021 attaching her review of multiple studies confirming the efficacy of IVM against covid. Three days later she made a video appeal to Boris Johnson summarising her evidence and urging him to roll out IVM immediately, all to

no avail.

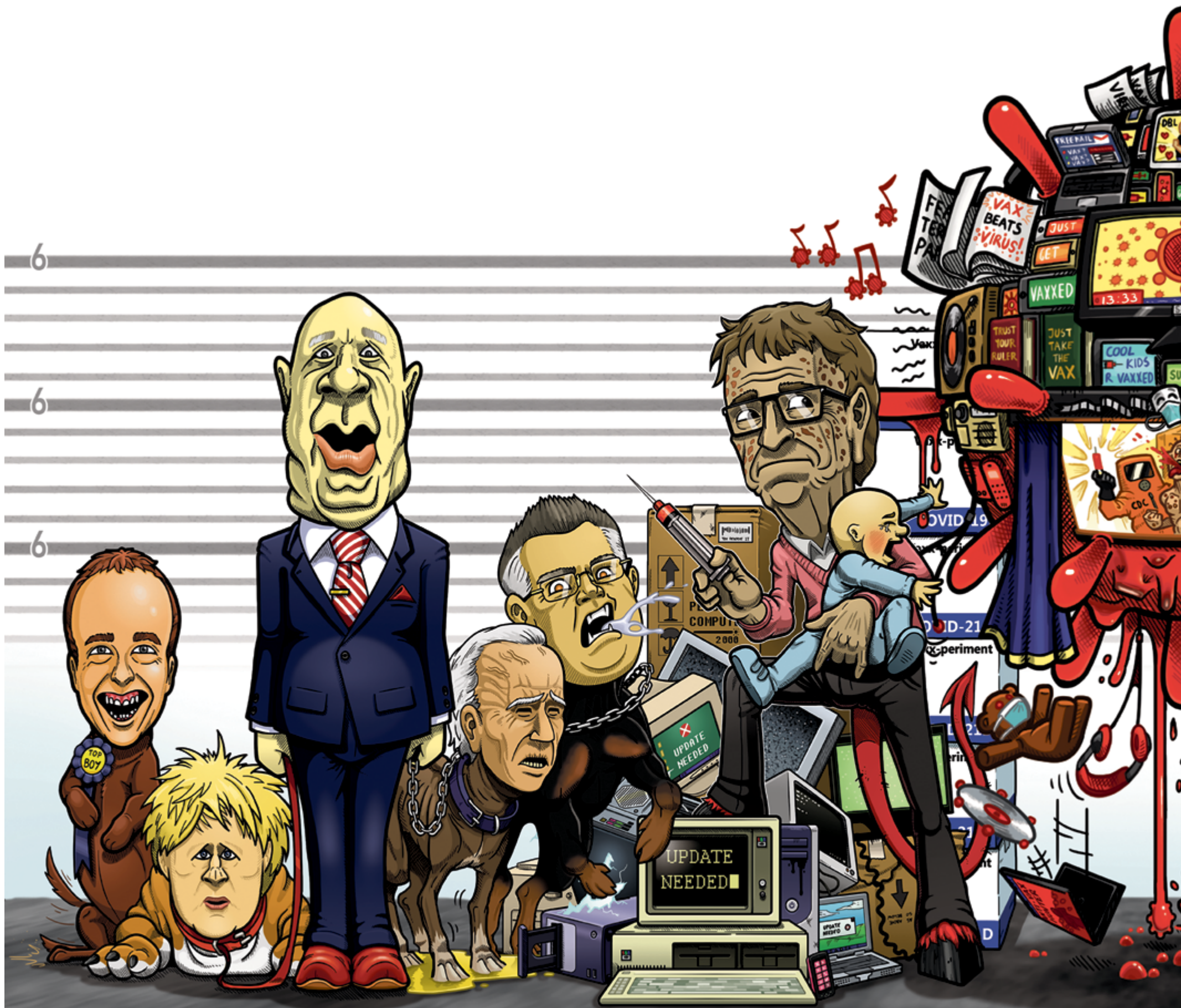

Israel and China: is it a marriage made in heaven?

CHINA has emerged as the world's latest superpower and its vast population is matched by an equally vast economy that stretches across the world.

And as the fortunes of the U.S. - a long-time ally of Israel - tumble year after year, is it surprising that this small Middle Eastern state directs some of its diplomatic affections to the Far East?

As reported in a blog written by Christina Lin for *The Times of Israel* in October 2016: "The rise of Israel as a key node in China's Silk Road grand strategy not only elevates Jerusalem in China's strategic calculus, but... also presents a new status of Israel from a 'protected power' of the U.S. to an 'integrated regional power' in its own right, transforming Israel's traditional narrative of seeking 'protectors' to one of seeking partners."

Lin, a former visiting fellow at The Washington Institute where she focused on China's increasing footprint in the Middle East, goes on to state Israel's outreach to the eastern hemisphere was "slowly creating new regional and international systems of shared interest" between Middle East countries and China.

However, is there something more sinister at play? Some commentators have alleged Israel is acquiring U.S. technology and selling it to China, a country in the midst of an economic war with America.

According to an article written for *Asia Times Online* in December 2004, Israel was the second-largest exporter of arms to China after Russia, and that "for years, the U.S. government has expressed concerns over Israel illegally transferring technology to China".

The report by Sudha Ramachandran continued: "During the Gulf War, the U.S. gave Israel Patriot missiles as protection against Iraqi Scud missiles. In 1992, a U.S. intelligence report revealed that soon after the end of the Gulf War, Israel had sold Patriot anti-missile data to China. Israel denied the intelligence report."

"Washington has also alleged on several occasions that Israel violated agreements by exporting restricted U.S. technology it buys with yearly U.S. subsidies. This was the case with the largely U.S.-funded Lavi fighter-plane programme. Israel, the Americans believe, passed on technology to Beijing. China's F-10 fighter jet is believed to be almost

identical to the Lavi.

"Washington has also expressed concern from time to time that Israel's arms trade with China could result in its military technology falling into the 'wrong hands' - such as Iran's, for instance."

In more recent times, *Haaretz* - Israel's longest-running newspaper - reported how two-time Israeli Prime Minister Benjamin Netanyahu had told a Beijing audience that Israel-China ties were a "marriage made in heaven".

In the opinion piece written by Charles Dunst in June 2020, he stated: "The U.S.-China storm, rather than blow over, has only intensified. Now, as we approach the eye of the storm, countries like Israel are being forced to choose between two Great Powers."

"And while Israel has folded twice to U.S. pressure in recent memory - the desalination plant (Sorek 2) and Huawei - some in Jerusalem may yet be considering Beijing's patronage preferable."

When charting the ties between Israel and China, it may appear to some that it is a legitimate question to ask if this is more than just an alliance of convenience for mere profit.

The relationship between the two countries does not, perhaps, stop at military and infrastructure trading. Some commentators have reported on high-end surveillance technology being supplied by Israel to Central Asia.

The *Financial Times* reported in an article titled 'Unit 8200: Israel's cyber spy agency' that Privacy International, a human rights watchdog group, alleged two multi-national companies with Israeli roots, Verint and Nice Systems, were supplying surveillance technology to repressive Central

Asian countries.

The article from July 2015, written by John Reed, continued that this allowed "unchecked access to citizens' telephone calls and internet activity on a mass, indiscriminate scale."

The report added that in response to the article, Verint said it only did business with countries with which Israel had commercial ties and in accordance with government regulations, while Nice Systems did not comment.

The *Washington Report on Middle East Affairs* magazine reported in August 2020: "Chinese investment in Israeli high-tech firms tripled between 2013 and 2017, reaching \$25 billion."

"China may overtake the U.S. as the largest source of foreign direct investment. Over 1,000 Israeli start-ups have set up branches in China, while Chinese firms such as Huawei, Legend, and Xiaomi have research centres in Israel."

When considering this vast level of Chinese funding - and the surveillance tech being supplied in return by Israel - it is perhaps concerning that the Chinese philosophy for control of its populace has been lauded by some in the Israeli leadership.

As reported in *Haaretz* in December 2018, lawmaker and politician Oren Hazan expressed support for "China's method of incarcerating members of its Muslim minority in 're-education camps'" and suggested Israel should follow suit.

Can it then, perhaps, be argued that some of Israel's politicians are aligned more with the totalitarian control methods of China than with the more freedom-focused approaches in the West?

Despite the arms and technology trading between Israel and China - and their possible alignment in political philosophies - there is a painful thorn in the side of their relationship, with that thorn being Israel's neighbour, Syria.

The U.S. and Israel both wish to have Bashar al-Assad overthrown and for the long-serving Syrian president to be replaced with a pro-Western leader.

For Israel, a destabilised

Syria could give the Jewish state opportunities to expand its borders to the east. And for the U.S., having Assad replaced is a vital stepping stone in decades-long plans to bring about regime change in Iran, either through war or political manipulation.

Such is the desperation to have Assad removed, an alleged fake chemical attack was launched in the Syrian city of Douma for which Assad was blamed.

Soon after the attack in April 2018 it became apparent from eyewitness reports and testimony from whistleblowers working for the Organisation for the Prohibition of Chemical Weapons that no nerve agents had been used. Some commentators suggested the incident was a 'false flag' attack fabricated by U.S. and UK-funded emergency responders known as the 'White Helmets'.

However, having Assad replaced with someone sympathetic to the West is the last thing China wants as it makes inroads into the Middle East.

Lin, in her *Times of Israel* article referenced above, observed: "It is important for Israel to establish a cooperative platform for deconfliction and crisis management with China regarding Syria... especially now that Chinese military advisors are on the ground and will likely increase its footprint with the recent military agreement with Damascus."

So where does this leave the diplomatic courtship between Israel and China? Can they agree to disagree on the matter of Syria?

As the media in the West stokes up tensions between the U.S. and China, perhaps Israel - with its established relationship with America - will play a key role in whether worldwide conflict will erupt or be avoided.

And when considering the links Israel also has with China and Russia, as covered by this and the previous article, it can be argued that this geographically tiny country is far more than a pawn on the world chessboard.

Are Israel's leaders perhaps looking to influence both sides in the political battles ahead between the West and the East to suit their own ends? Only time will tell but questions should continue to be asked about Israel and its influence on geopolitics.

Canada uses martial law and police violence to clear truckers' protest in Ottawa

PRIME Minister of Canada Justin Trudeau has revoked the draconian 'Emergencies Act' that he aggressively used to end the peaceful truckers' Freedom Convoy in Ottawa. The protest was in response to vaccine mandates requiring truckers to show proof of vaccination on cross-border routes. Beginning on January 29th, truckers from all over Canada travelled to the capital to voice their concerns regarding the new travel rules.

Conveniently, in the early days of the protest, Trudeau tested positive for covid and had to quarantine. He reacted to the protests via Twitter by desperately trying to tarnish the hardened truckers by stating: "Over the past few days, Canadians have been shocked-and frankly, disgusted-by the behaviour displayed by some people protesting in our nation's capital. I want to be clear: We're not intimidated by those who hurl abuse at small business workers and steal from the homeless. We won't give in to those who fly racist flags."

The baseless tirade from Trudeau is ironic coming from a leader who was photographed wearing racist blackface makeup at a party. Trudeau is still unable to recollect how many times he has had blackface makeup on.

As the weeks passed and the protests grew bigger, the Canadian government began the process of initiating the disturbing Emergencies Act. Ironically, Trudeau became the first Canadian leader to declare a state of emergency since his father Pierre Elliot Trudeau when he declared emergency powers during the October Crisis that took place in Quebec in the 70s.

Police in Ottawa initially used scare tactics and emotional blackmail

by issuing unlawful notices to truckers on the ground. The notice by the Ottawa Police Service stated: "You must leave the area now. Anyone blocking streets, or assisting others in blocking streets, are committing a criminal offence and you may be arrested. You must immediately cease further unlawful activity, or you will face charges. If you are arrested, you may be released on bail depending on factors contained in Part XVI of the Criminal code. The people of Ottawa are being denied the lawful use, enjoyment and operation of their property and you are causing businesses to close. That is mischief under the Criminal Code."

The aptly named Deputy Prime Minister of Canada Chrystia Freeland said: "The government is issuing an order with immediate effect under the Emergencies Act, authorizing Canadian financial institutions to temporarily cease providing financial services where the institution suspects that an account is being used to further the illegal blockades and occupations. This order covers both personal and corporate accounts."

Under the Emergencies Act, bank accounts were frozen without a court order. The Trudeau regime froze and cancelled over 200 bank accounts of people who either took part in the convoy freedom protest or who financially supported the truckers on the ground in Ottawa.

New independent people powered media outlet 'Druthers' who courageously reported daily on the unfolding situation in Ottawa had their accounts frozen from the federal government. According to Press for Truth in Canada, "Druthers News raised over \$100,000 to give Directly to the truckers but when their editor in

chief Shawn Jason went to his bank to prepare the checks, he was informed that the government had blocked him from using his own personal bank account."

Tamara Lich, one of the main organizers of the protest who is currently in prison because of the freedom protest also had her bank account frozen. GoFundMe suspended Lich's fundraising account for the truckers. GoFundMe said: "This fundraiser is now in violation of our Terms of Service (Term 8, which prohibits the promotion of violence and harassment) and has been removed from the platform." It is estimated that over \$8 million was raised on the popular fundraising platform.

Aside from freezing the accounts of key players involved in the protest, police in riot gear towed trucks and arrested non-violent protestors. In a horrific scene that the mainstream media failed to cover, a Tyendinaga Mohawk Wolf Clan Woman called Candy Sero was among those trampled and injured by a police horse charge. Brave Sero had been on the front lines in Ottawa from the very beginning supporting the truckers against the mandates.

In what must be a kick in the teeth for the freedom fighting truckers to hear, shameful Trudeau moralised about the ongoing situation in Ukraine by stating: These are deeply disturbing times for the international community and for people everywhere who care about freedom and democracy."

Despite the media blackout about the uprising in Ottawa and disgraceful utterances from government officials, Canada's defining moment has garnered huge support from all over the world and is an inspiration for many. Similar protests and blockades have been seen in New Zealand and in the United States.



Spain to treat covid like the flu



SPAIN is re-evaluating its response to covid in the wake of the weaker variant 'omicron'.

Sweden will not jab children aged five to 11 years

SWEDEN is taking a cautious approach by deciding not to jab children aged five to 11 with the experimental covid 'vaccines'.

Throughout the past two years, the common-sensical Scandinavian country has opted against harsh lockdowns and imposed only minimal restrictions on its people.

Swedish Health Agency official Britta Bjorkholm told a news conference: "With the knowledge we have today, with a low risk for serious disease for kids, we

arise at a distant time.

"There is little individual benefit for most children, and the Norwegian Institute of Public Health has not recommended that all children aged 5-11 be vaccinated. However, it is agreed that all parents and guardians may be offered a vaccine for their children; this will be most relevant to only a few groups of children."

In recent weeks, Sweden has lifted almost all of its remaining

Robots are on the march amid labour credit crunch

THE impending takeover of the American labour market by robots now has a trade group to represent its interests.

For robots, none of this is true.

"With human labor, what they produce depends on if they're hungry or are they tired or have they had their coffee," said Brian Tu, chief revenue officer for DCL Logistics in Fremont, California, which started installing robots on e-commerce fulfillment lines during the pandemic. Robots are dependably fast and do not take breaks.

Factories and other industrial users ordered 39,708 robots in 2021, 28% more than in 2020, according to the A3. The previous annual record for robot orders was set in 2017, when North American companies ordered 34,904 robots valued at \$1.9 billion.

As recently as 2016, more than twice as many robots were sold to auto makers as to all other industry sectors combined. But in 2020, other businesses eclipsed automakers as buyers of the advanced machines, and the share of robots going to non-auto companies grew further in 2021.

The list of industries that have seen the biggest increase in robot usage corresponds with those that have experienced the biggest disruptions from the pandemic: food processing plants, and e-commerce (as demand for packages soared).

E-commerce is another fast growth sector. At DCL, which has five U.S.

fulfilment centres and will soon open a sixth, the lines that have gotten robots can operate with fewer people - yet produce 200% more, according to Tu.

"We still have employees working around the robots," he added, "but we can reduce labour by roughly half."

Setting aside the question of efficiency, the biggest driver of automation in manufacturing remains necessity amid a paucity of workers.

"The number-one driver for automation is the labour shortage in manufacturing," said Joe Campbell, a senior manager for applications development at Universal Robots, a unit of Massachusetts-based Teradyne Inc (TER.O), which specialises in cobots (human-robot collaboration).

The pandemic is not the only factor driving the change. Universal estimates 2,000 Baby Boomers are retiring daily in manufacturing, robbing factory floors of veteran expertise.

Last month in the U.S., employers had 10.9 million vacant positions, nominally below the record 11.1 million from earlier in 2021.

There is an alternative to fear-based childbirth

Women of Earth, take back your birth

I WOULD like to introduce you to a rabbit hole that you perhaps have not climbed down yet. One that will likely be the missing piece of the puzzle and the ‘Eureka’ moment for many of you.

I am sure that you are already well aware that there is no money in healthy people for big pharma. So if you were a sociopath and had the agenda to make as much money as possible at the expense of human health, where would be the best place to start? Childbirth.

Millions of women enter the system healthy and happy but leave downtrodden, abused and traumatised. They are told their bodies have failed them and have subsequently suffered unimaginable trauma.

Did you know a huge majority of trauma cases were unnecessary?

Soon after the baby goes into distress, the doctor saves the baby and they want you to thank them for saving them after an unnecessary intervention that caused the trauma in the first place.

Now, I am aware that sometimes there are genuine medical emergencies in childbirth. I have been doing this for 13 years. I am not daft, but know this: obstetrics is the lowest evidence-based practice there is. So when you are next

told “you are not allowed” to have a home birth, or you are “not allowed” to have a vaginal breech birth, ask them for some evidence.

Guidelines are not law and often guidelines are based on absolutely nothing. You are an individual, not a statistic. You deserve to be heard and respected.

So how on earth have they managed to convince us that birth is a medical procedure? Ever heard of The Milgram Experiment? This fascinating experiment could go some way to explain how we have ended up with a fear-based maternity service.

Stanley Milgram conducted a very important experiment in obedience. He discovered that a large number of people will blindly obey an ‘authority’ figure even if it resulted in hurting another person. His research demonstrates just how far people are willing to go to obey authority. The study showed that participants were willing to administer electric shocks to a ‘learner’ when instructed to do so by an authority figure.

Although the participants did not realise the shocks were fake, they increased in strength to the point where they would have been fatal. Albeit reluctantly, they did it anyway.

His experiment certainly shines a light on today’s state of affairs. I would hope we could learn from the past, but it appears people will blindly follow authority without stopping to question anything.

There are many layers to how birth has become medicalised, and I can see why women have ‘handed it over’ to the system. We are bombarded with horror stories about how dangerous birth is. The insinuation is that birth is a huge disaster. The truth is, it is a physiological process that has been intercepted. Yes occasionally there are issues that arise, and in which case we are very lucky to have medical intervention when we genuinely need it.

However, medical intervention is overused to catastrophic ends. Women should not be subjected to this torture without good reason. The mere fact that ‘vaginal exams’ have become normalised during birth is criminal.

Having a stranger insert their hand into your vagina during the most private and sacred moment of your life is not acceptable. A vaginal exam as a

routine procedure needs your consent.

Do you even want one? Is your cervix a crystal ball? Will it tell your attendant where in your labour you will be in an hour or even 10 minutes’ time? No. Your cervix can go from four to ten centimetres in days, hours or minutes. All the exam tells you is where you are in that moment of time.

The procedure can introduce infection and can even cause your cervix to close. Your body is very clever. If your body is receiving messages that it is not safe to give birth right now because you are releasing adrenaline, your body will do what it is told. It will stop. Then we are told by the medical ‘professionals’ that our labour has ‘failed to progress’. More coercive language to convince women that they have failed. The truth is, your environment will fail you, not your body.

You have the right to decline any intervention offered to you. You are well within your rights to make an informed decision about what happens to your body. What are the risks and benefits with any procedure offered to you? You have the right to choose what happens during your birth experience.
